

HOUSE AMENDMENTS TO A-ENGROSSED SENATE BILL 583

1 On page 1 of the printed A-engrossed bill, line 2, after “ORS” delete the rest of the line and
2 insert “471.186, 471.220, 471.223, 471.242, 471.282 and 471.404.”.

3 Delete lines 4 through 11 and delete pages 2 through 5 and insert:

4 “**SECTION 1.** ORS 471.186 is amended to read:

5 “471.186. (1) The holder of an off-premises sales license may sell factory-sealed containers of
6 **malt beverages**, wine[, *malt beverages*] and cider. Factory-sealed containers of malt beverages sold
7 under the license may not hold more than two and one-quarter gallons.

8 “(2) The holder of an off-premises sales license may sell for consumption off the licensed prem-
9 ises malt beverages, wines and cider in securely covered containers supplied by the consumer and
10 having capacities of not more than two gallons each.

11 “(3) The holder of an off-premises sales license may provide sample tasting of alcoholic
12 beverages on the licensed premises if the licensee makes written application to the Oregon Liquor
13 Control Commission and receives approval from the commission to conduct tastings on the premises.
14 Tastings must be limited to the alcoholic beverages that may be sold under the privileges of the li-
15 cense.

16 “(4) An off-premises sales license may not be issued for use at a premises that is mobile.

17 “(5) Except as provided in ORS 471.402, a manufacturer or wholesaler may not provide or pay
18 for sample tastings of alcoholic beverages for the public on premises licensed under an off-premises
19 sales license.

20 “(6) The holder of an off-premises sales license may deliver **malt beverages**, wine or cider that
21 is sold under the privileges of the license to retail customers in this state without a direct shipper
22 permit issued under ORS 471.282. Any deliveries by the holder of an off-premises sales license are
23 subject to any rules adopted by the commission relating to deliveries made under this subsection.
24 Deliveries under this subsection:

25 “(a) May be made only to a person who is at least 21 years of age;

26 “(b) May be made only for personal use and not for the purpose of resale; and

27 “(c) Must be made in containers that are conspicuously labeled with the words: ‘CONTAINS
28 ALCOHOL: SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED FOR DELIVERY.’

29 “(7) The holder of an off-premises sales license that makes deliveries of **malt beverages**, wine
30 or cider under subsection (6) of this section must take all actions necessary to ensure that a carrier
31 used by the licensee does not deliver any **malt beverages**, wine or cider unless the carrier:

32 “(a) Obtains the signature of the recipient of the **malt beverages**, wine or cider upon delivery;

33 “(b) Verifies by inspecting government-issued photo identification that the recipient is at least
34 21 years of age; and

35 “(c) Determines that the recipient is not visibly intoxicated at the time of delivery.

1 “(8) Any person who knowingly or negligently delivers **malt beverages**, wine or cider under the
2 provisions of this section to a person under 21 years of age, or who knowingly or negligently de-
3 livers **malt beverages**, wine or cider under the provisions of this section to a visibly intoxicated
4 person, violates ORS 471.410.

5 “(9) If a court determines that deliveries of **malt beverages**, wine or cider under subsection (6)
6 of this section cannot be restricted to holders of off-premises sales licenses, and the decision is a
7 final judgment that is no longer subject to appeal, the holder of an off-premises sales license may
8 not make deliveries of **malt beverages**, wine or cider under the provisions of subsection (6) of this
9 section after entry of the final judgment.

10 “**SECTION 2.** ORS 471.220 is amended to read:

11 “471.220. (1) A brewery license shall allow the manufacture, importation, storage, transportation,
12 wholesale sale and distribution to licensees of the Oregon Liquor Control Commission, and the ex-
13 port of malt beverages. A brewery licensee may not sell within the State of Oregon any beer con-
14 taining more than six percent alcohol by volume. Except as provided in subsection (2) of this section,
15 a brewery licensee may not sell malt beverages for consumption on the licensed premises.

16 “(2) A brewery licensee may:

17 “(a) Sell malt beverages brewed on the licensed premises **at retail** for consumption on **or off**
18 the licensed premises; *[and]*

19 “**(b) Sell in securely covered containers supplied by the consumer and having a capacity**
20 **of not more than two gallons each, malt beverages brewed on the licensed premises, for**
21 **off-premises consumption; and**

22 “[*(b)*] **(c) Sell [*malt beverages brewed on the licensed premises*], in quantities of not less than four**
23 **gallons, malt beverages brewed on the licensed premises, to an unlicensed organization, lodge,**
24 **picnic party or private gathering. An unlicensed organization, lodge, picnic party or private gath-**
25 **ering may not resell the malt beverages that a brewery licensee sells under this paragraph.**

26 “**SECTION 3.** ORS 471.223 is amended to read:

27 “471.223. (1) As used in this section, ‘control’ means that the licensee:

28 “(a) Owns the brand under which the wine or cider is labeled; or

29 “(b) Performs or has the legal right to perform all of the acts common to a brand owner under
30 the terms of a trademark license or similar agreement that for the brand under which the wine or
31 cider is labeled has a term of at least three years.

32 “(2) A winery license shall allow the licensee:

33 “(a) To import wine or cider in containers that have a capacity of more than four liters.

34 “(b) To import wine or cider in containers that have a capacity of four liters or less if the brand
35 of wine or cider is under the control of the licensee.

36 “(c) To bottle, produce, blend, store, transport or export wines or cider.

37 “(d) To sell wines or cider at wholesale to the Oregon Liquor Control Commission or to
38 licensees of the commission.

39 “(e) To sell wines or cider at retail directly to the consumer for consumption on or off the li-
40 censed premises.

41 “(f) To sell malt beverages at retail for consumption on or off the licensed premises.

42 “(g) To sell for consumption off the premises malt beverages, wines and cider in securely cov-
43 ered containers supplied by the consumer and having capacities of not more than two gallons each.

44 “(h) To conduct any activities described in paragraphs (a) to (g) of this subsection at a second
45 or third premises as may be designated by the commission.

1 “(i) To purchase from or through the commission brandy or other distilled liquors for fortifying
2 wines.

3 “(j) To obtain a special events winery license that shall entitle the holder to conduct the ac-
4 tivities allowed under paragraphs (e) to (g) of this subsection at a designated location other than the
5 one set forth in the winery license for a period not to exceed five days.

6 “(3) A winery licensee shall allow a patron to remove a partially consumed bottle of wine from
7 the licensed premises if the patron is not a minor and the patron is not visibly intoxicated.

8 “(4) In order to hold a winery license the licensee shall:

9 “(a) Possess at a bonded premises within Oregon a valid producer and blender basic permit is-
10 sued by the federal Alcohol and Tobacco Tax and Trade Bureau; or

11 “(b) Possess a valid wine blender or valid wholesaler basic permit issued by the federal Alcohol
12 and Tobacco Tax and Trade Bureau and have a written contract with a winery licensed under par-
13 agraph (a) of this subsection that authorizes the winery to produce for the licensee a brand of wine
14 or cider that is under the control of the licensee.

15 “(5) A winery licensee may sell and ship **malt beverages**, wine or cider directly to a resident
16 of this state only if the licensee has a direct shipper permit issued under ORS 471.282.

17 “(6)(a) Except as provided in paragraph (b) of this subsection, a winery licensee, or any person
18 having an interest in the licensee, may also hold a full on-premises sales license. If a person holds
19 both a winery license and a full on-premises sales license, nothing in this chapter shall prevent the
20 sale by the licensee of both distilled liquor and wine or cider bottled and produced under the winery
21 license.

22 “(b) The commission may not issue a full on-premises sales license to a winery licensee under
23 the provisions of this subsection if the winery licensee, or any person having an interest in the
24 licensee or exercising control over the licensee, is a brewery that brews more than 200,000 barrels
25 of malt beverages annually or a winery that produces more than 200,000 gallons of wine or cider
26 annually.

27 “(7) More than one winery licensee may exercise the privileges of a winery license at a single
28 location. The commission may not refuse to issue a winery license to a person for the production
29 of wine or cider on specified premises based on the fact that other winery licensees also produce
30 wine or cider on those premises.

31 “(8) If a winery licensee does not possess at a bonded premises within Oregon a valid producer
32 and blender basic permit issued by the federal Alcohol and Tobacco Tax and Trade Bureau, the
33 licensee may exercise the privileges described in this section only for wine and cider brands that
34 are under the control of the licensee.

35 “**SECTION 4.** ORS 471.242 is amended to read:

36 “471.242. (1) A warehouse license shall allow the licensee to store, import, bottle, produce, blend,
37 transport and export nontax paid, bonded wine or wine on which the tax is paid and to store, import
38 and export nontax paid malt beverages and cider, or malt beverages and cider on which the tax is
39 paid. Wine, cider and malt beverages may be removed from the licensed premises only for:

40 “(a) Sale for export;

41 “(b) Sale or shipment to a wholesale malt beverage and wine licensee;

42 “(c) Sale or shipment to another warehouse licensee;

43 “(d) Sale or shipment to a winery licensee;

44 “(e) Shipment of wine or cider produced by a winery licensee to a licensee of the Oregon Liquor
45 Control Commission authorized to sell wine or cider at retail if the shipment is made pursuant to

1 a sale to the retail licensee by the holder of a winery license issued under ORS 471.223, a grower
2 sales privilege license issued under ORS 471.227 or a wholesale malt beverage and wine license is-
3 sued under ORS 471.235; or

4 “(f) Shipment of **malt beverages**, wine or cider to a person for personal use, as described in
5 subsection (7) of this section.

6 “(2) A license applicant must hold an approved registration for a bonded wine cellar or winery
7 under federal law.

8 “(3) For the purposes of tax reporting, payment and record keeping, the provisions that shall
9 apply to a manufacturer under ORS chapter 473 shall apply to a warehouse licensee.

10 “(4) A warehouse must be physically secure in an area zoned for the intended use and be phys-
11 ically separated from any other use.

12 “(5) For purposes of ORS 471.392 to 471.400, a warehouse licensee shall be considered a man-
13 ufacturer.

14 “(6) For purposes of ORS 473.045, a warehouse licensee shall be considered a winery licensee.

15 “(7) **Malt beverages**, wine or cider may be removed from the premises licensed under this sec-
16 tion for shipment pursuant to a sale under ORS 471.282. The warehouse licensee shall take reason-
17 able steps to ensure that shipments are made in containers that are conspicuously labeled with the
18 words: ‘CONTAINS ALCOHOL: SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED
19 FOR DELIVERY.’ In addition, the warehouse licensee shall take reasonable steps to ensure that any
20 carrier used by the licensee does not deliver any **malt beverages**, wine or cider unless the carrier:

21 “(a) Obtains the signature of the recipient of the **malt beverages**, wine or cider upon delivery;

22 “(b) Verifies by inspecting government-issued photo identification that the recipient is at least
23 21 years of age; and

24 “(c) Determines that the recipient is not visibly intoxicated at the time of delivery.

25 “**SECTION 5.** ORS 471.282 is amended to read:

26 “471.282. (1) Notwithstanding any other provision of this chapter and except as provided by ORS
27 471.186 (6), a person may sell and ship **malt beverages**, wine or cider directly to a resident of
28 Oregon only if the person holds a direct shipper permit. The Oregon Liquor Control Commission
29 shall issue a direct shipper permit only to:

30 “(a) A person that holds a license issued by this state or another state that authorizes the
31 manufacture of **malt beverages**, wine or cider;

32 “(b) A person that holds a license issued by this state or another state that authorizes the sale
33 of wine or cider produced only from grapes or other fruit grown under the control of the person;

34 “(c) A person that holds a license authorizing the sale of **malt beverages**, wine or cider at re-
35 tail; or

36 “(d) A nonprofit trade association that holds a temporary sales license under ORS 471.190 and
37 that has a membership primarily composed of persons holding winery licenses issued under ORS
38 471.223 or grower sales privilege licenses issued under ORS 471.227.

39 “(2) **The holder of a direct shipper permit that is a licensee of another state may deliver**
40 **malt beverages under the permit only if that other state makes direct shipper permits, or**
41 **the equivalent, available for the delivery of malt beverages by persons holding a license is-**
42 **sued by the commission authorizing the manufacture or retail sale of malt beverages.**

43 “[2)(a)] (3)(a) A person may apply for a direct shipper permit by filing an application with the
44 commission. The application must be made in such form as may be prescribed by the commission.

45 “(b) If the application is based on a license issued by this state, the person must include in the

1 application the number of the license issued to the person.

2 “(c) If the application is based on a license issued by another state, the person must include in
3 the application a true copy of the license issued to the person by the other state or include sufficient
4 information to allow verification of the license by electronic means or other means acceptable to the
5 commission.

6 “(d) If the application is based on a license issued by another state, or the application is by a
7 nonprofit trade association described in subsection (1)(d) of this section, the person or association
8 must pay a \$50 registration fee and maintain a bond or other security described in ORS 471.155 in
9 the minimum amount of \$1,000.

10 “[3] (4) Sales and shipments under a direct shipper permit:

11 “(a) May be made only to a person who is at least 21 years of age;

12 “(b) May be made only for personal use and not for the purpose of resale; and

13 “(c) May not exceed two cases, containing not more than nine liters per case, to any resident
14 per month.

15 “[4] (5) Sales and shipments under a direct shipper permit must be made directly to a resident
16 of this state in containers that are conspicuously labeled with the words: ‘CONTAINS ALCOHOL:
17 SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED FOR DELIVERY.’

18 “[5] (6) A person holding a direct shipper permit must take all actions necessary to ensure that
19 a carrier used by the permit holder does not deliver any **malt beverages**, wine or cider unless the
20 carrier:

21 “(a) Obtains the signature of the recipient of the **malt beverages**, wine or cider upon delivery;

22 “(b) Verifies by inspecting government-issued photo identification that the recipient is at least
23 21 years of age; and

24 “(c) Determines that the recipient is not visibly intoxicated at the time of delivery.

25 “[6](a) (7)(a) A person holding a direct shipper permit must report to the commission **on a**
26 **quarterly basis** all shipments of **malt beverages**, wine or cider made to Oregon residents under
27 the permit [*as required by ORS chapter 473*]. The report must be made in a form prescribed by the
28 commission.

29 “(b) A person holding a direct shipper permit must allow the commission to audit the permit
30 holder’s records upon request and shall make those records available to the commission in this state.

31 “(c) A person holding a direct shipper permit consents to the jurisdiction of the commission and
32 the courts of this state for the purpose of enforcing the provisions of this section and any related
33 laws or rules.

34 “[7](a) (8)(a) A person holding a direct shipper permit must timely pay to the commission all
35 taxes imposed under ORS chapter 473 on **malt beverages**, wine and cider sold and shipped under
36 the permit. For the purpose of the privilege tax imposed under ORS chapter 473, all **malt**
37 **beverages**, wine or cider sold and shipped pursuant to a direct shipper permit is sold in this state.

38 “(b) A person holding a direct shipper permit based on a license issued by another state must
39 timely pay to the commission all taxes imposed under ORS chapter 473 on all **malt beverages**, wine
40 or cider sold and shipped directly to Oregon residents under the permit. The permit holder, not the
41 purchaser, is responsible for the tax.

42 “[8] (9) A direct shipper permit must be renewed annually. If the person holds the permit
43 based on an annual license issued by another state, the person may renew the permit by paying a
44 \$50 renewal fee and providing the commission with a true copy of a current license issued to the
45 person by the other state or with sufficient information to allow verification of the license by elec-

1 tronic means or other means acceptable to the commission. If the person holds the permit based on
2 an annual license issued by this state, the person may renew the permit at the same time that the
3 person renews the license.

4 “[9] (10) The commission may refuse to issue or may suspend or revoke a direct shipper permit
5 if the permit holder fails to comply with the provisions of this section. A person may sell and ship
6 **malt beverages**, wine or cider under a direct shipper permit only for as long as the person has the
7 license issued by this state or another state that authorizes the person to hold a direct shipper
8 permit. **A direct shipper permit does not authorize the shipment of malt beverages by a per-
9 mit holder described in subsection (1)(b) of this section or lacking authority as provided un-
10 der subsection (2) of this section.**

11 “[10] (11) Any person who knowingly or negligently delivers **malt beverages**, wine or cider
12 under the provisions of this section to a person under 21 years of age, or who knowingly or
13 negligently delivers **malt beverages**, wine or cider under the provisions of this section to a visibly
14 intoxicated person, violates ORS 471.410.

15 “[11] (12) A person may not make sales and shipments of **malt beverages**, wine or cider di-
16 rectly to Oregon residents unless the person holds a direct shipper permit issued under this section.
17 Any person who knowingly makes, participates in, transports, imports or receives a shipment of
18 **malt beverages**, wine or cider that is in violation of this section commits a misdemeanor as pro-
19 vided in ORS 471.990 (1).

20 “**SECTION 6.** ORS 471.404 is amended to read:

21 “471.404. (1) Alcoholic liquor may not be imported into this state by any person other than a
22 holder of a brewery, winery, distillery or wholesaler’s license, except as follows:

23 “(a) Alcoholic liquor ordered by and en route to the Oregon Liquor Control Commission, under
24 a certificate of approval issued by the commission.

25 “(b) Wines for sacramental purposes according to rules adopted by the commission.

26 “(c) Alcoholic liquor that is in transit on a common carrier to a destination outside Oregon.

27 “(d) Alcoholic liquor coming into Oregon on a common carrier according to orders placed by a
28 licensed brewery, winery or wholesaler.

29 “(e) Grain and ethyl alcohol for scientific, pharmaceutical, manufacturing, mechanical or indus-
30 trial use, under a certificate of approval issued by the commission.

31 “(f) Wine or cider that is sold and transported by the holder of a wine self-distribution permit
32 to a retail licensee that has the endorsement described in ORS 471.274 (5).

33 “(g) **Malt beverages**, wine or cider shipped directly to a resident of this state under a direct
34 shipper permit issued pursuant to ORS 471.282.

35 “(2) The commission may require importers of alcoholic liquor to pay a reasonable handling fee
36 based on the quantity and type of alcoholic liquor being imported.”.
