

Senate Bill 586

Sponsored by COMMITTEE ON WORKFORCE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases age of youth for whom Youth Development Council may oversee unified system of services from 20 years to 24 years.

A BILL FOR AN ACT

2 Relating to the Youth Development Council; amending ORS 417.847 and 417.852.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 417.847 is amended to read:

5 417.847. (1) The Youth Development Council is established. The council shall function under the
6 direction and control of the Oregon Education Investment Board established by section 1, chapter
7 519, Oregon Laws 2011.

8 (2) The council is established for the purpose of assisting the board in overseeing a unified
9 system that provides services to school-age children through youth [20] **24** years of age in a manner
10 that supports educational success, focuses on crime prevention, reduces high risk behaviors and is
11 integrated, measurable and accountable. The council shall provide direction to the Youth Develop-
12 ment Division.

13 (3) The council consists of no fewer than 15 members who are appointed by the Governor. The
14 Governor shall ensure that membership of the council satisfies any federal requirements for mem-
15 bership of a state advisory committee on juvenile justice.

16 (4) The council shall:

17 (a) Determine the availability of funding to support community-based youth development pro-
18 grams, services and initiatives with demonstrated outcomes and strategic objectives established by
19 the council by rule.

20 (b) Prioritize funding for services related to:

21 (A) The prevention of and intervention in the risk factors that lead to juvenile delinquency and
22 the promotion of protective factors that improve the health and well-being of children and youth,
23 as supported by evidence-based program models and other research-based models; and

24 (B) The prevention of and intervention in gang violence and gang involvement.

25 (5) The council may:

26 (a) Enter into performance-based intergovernmental agreements with regional and county enti-
27 ties, and tribal governments, to contract for the provision of youth development programs, services
28 and initiatives that will achieve demonstrated outcomes and strategic objectives established by the
29 council by rule.

30 (b) Determine the means by which services to children and youth may be provided effectively
31 and efficiently across multiple programs to improve the academic and social outcomes of children

8 (f) Ensure implementation of best practices that:

9 (A) Are evidence based;

10 (B) Are culturally, gender and age appropriate;

11 (C) Address individual risk factors;

12 (D) Build upon factors that improve the health and well-being of children and youth; and

13 (E) Include tribal best practices.

14 (6) The Governor may designate one member of the council to serve as the chairperson or, if the
15 Governor chooses not to designate a chairperson, the council may elect one of its members to serve
16 as chairperson.

17 (7) In accordance with applicable provisions of ORS chapter 183, the council may adopt rules
18 necessary for the administration of the laws that the council is charged with administering.

19 **SECTION 2.** ORS 417.847, as amended by section 5, chapter 623, Oregon Laws 2013, is amended
20 to read:

21 417.847. (1) The Youth Development Council is established.

22 (2) The council is established for the purpose of overseeing a unified system that provides ser-

18 **SECTION 3.** ORS 417.852 is amended to read:

19 417.852. (1) The Youth Development Division is established in the Department of Education. The
20 purpose of the division is to ensure that services are provided to school-age children through youth
21 [20] **24** years of age in a manner that supports educational success, focuses on crime prevention,
22 reduces high risk behaviors and is integrated, measurable and accountable.

23 (2) The division shall function under the direction and control of the Youth Development
24 Council with the Youth Development Director serving as the administrative officer.
