SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Repeals former provisions of Uniform Interstate Family Support Act. Incorporates most recent version of federal Uniform Interstate Family Support Act into Oregon law.

11 **Be It Enacted by the People of the State of Oregon:**

12 **SECTION 1. Sections 2 to 79 of this 2015 Act are added to and made a part of ORS**
13 **chapter 110.**

14
15 **UNIFORM INTERSTATE FAMILY SUPPORT ACT**

16 **ARTICLE 1**

17 **(General Provisions)**

18
19 **SECTION 2. This chapter may be cited as the Uniform Interstate Family Support Act.**

20 **SECTION 3. As used in this chapter:**

21 **(1) "Child" means an individual, whether over or under the age of majority, who is or is**
22 **alleged to be owed a duty of support by the individual's parent or who is or is alleged to be**
23 **the beneficiary of a support order directed to the parent.**

24 **(2) "Child support order" means a support order for a child, including a child who has**
25 **attained the age of majority under the law of the issuing state or foreign country.**

26 **(3) "Convention" means the Convention on the International Recovery of Child Support**
27 **and Other Forms of Family Maintenance, concluded at The Hague on November 23, 2007.**

28 **(4) "Duty of support" means an obligation imposed or imposable by law to provide support**

1 for a child, spouse or former spouse, including an unsatisfied obligation to provide support.

2 (5) "Foreign country" means a country, or a political subdivision of a country, other than
3 the United States, that authorizes the issuance of support orders and:

4 (a) That has been declared under the law of the United States to be a foreign
5 reciprocating country;

6 (b) That has established a reciprocal arrangement for child support with this state as
7 provided in section 25 of this 2015 Act;

8 (c) That has enacted a law or established procedures for the issuance and enforcement
9 of support orders that are substantially similar to the procedures under this chapter; or

10 (d) In which the Convention is in force with respect to the United States.

11 (6) "Foreign support order" means a support order of a foreign tribunal.

12 (7) "Foreign tribunal" means a court, administrative agency or quasi-judicial entity of a
13 foreign country that is authorized to establish, enforce or modify support orders or to de-
14 termine parentage of a child. "Foreign tribunal" includes a competent authority under the
15 Convention.

16 (8) "Home state" means the state or foreign country in which a child lived with a parent
17 or a person acting as parent for at least six consecutive months immediately preceding the
18 time of filing of a petition or comparable pleading for support and, if a child is less than six
19 months old, the state or foreign country in which the child lived from birth with the parent
20 or person acting as parent. A period of temporary absence of the child, parent or person
21 acting as parent is counted as part of the six-month or other period.

22 (9) "Income" includes earnings or other periodic entitlements to money from any source
23 and any other property subject to withholding for support under the law of this state.

24 (10) "Income withholding order" means an order or other legal process directed to an
25 obligor's employer or other debtor issued pursuant to ORS 25.372 to 25.427 to withhold sup-
26 port from the income of the obligor.

27 (11) "Initiating tribunal" means the tribunal of a state or foreign country from which a
28 petition or comparable pleading is forwarded or in which a petition or comparable pleading
29 is filed for forwarding to another state or foreign country.

30 (12) "Issuing foreign country" means the foreign country in which a tribunal issues a
31 support order or a judgment determining parentage of a child.

32 (13) "Issuing state" means the state in which a tribunal issues a support order or a
33 judgment determining parentage of a child.

34 (14) "Issuing tribunal" means the tribunal of a state or foreign country that issues a
35 support order or a judgment determining parentage of a child.

36 (15) "Law" includes decisional and statutory law and rules and regulations having the
37 force of law.

38 (16) "Obligee" means:

39 (a) An individual to whom a duty of support is or is alleged to be owed or in whose favor
40 a support order or a judgment determining parentage of a child has been issued;

41 (b) A foreign country, state or political subdivision of a state to which the rights under
42 a duty of support or support order have been assigned or which has independent claims based
43 on financial assistance provided to an individual obligee in place of child support;

44 (c) An individual seeking a judgment determining parentage of the individual's child; or

45 (d) A person that is a creditor in a proceeding under sections 62 to 74 of this 2015 Act.

1 (17) "Obligor" means an individual, or the estate of a decedent, that:

2 (a) Owes or is alleged to owe a duty of support;

3 (b) Is alleged but has not been adjudicated to be a parent of a child;

4 (c) Is liable under a support order; or

5 (d) Is a debtor in a proceeding under sections 62 to 74 of this 2015 Act.

6 (18) "Outside this state" means a location in another state or a country other than the
7 United States, whether or not the country is a foreign country.

8 (19) "Person" means an individual, corporation, business trust, estate, trust, partnership,
9 limited liability company, association, joint venture, public corporation, government, gov-
10 ernmental subdivision, agency, instrumentality or any other legal or commercial entity.

11 (20) "Record" means information that is inscribed on a tangible medium or that is stored
12 in an electronic or other medium and is retrievable in perceivable form.

13 (21) "Register" means to file in a tribunal of this state a support order or judgment de-
14 termining parentage of a child issued in another state or a foreign country.

15 (22) "Registering tribunal" means a tribunal in which a support order or judgment de-
16 termining parentage of a child is registered.

17 (23) "Responding state" means a state in which a petition or comparable pleading for
18 support or to determine parentage of a child is filed or to which a petition or comparable
19 pleading is forwarded for filing from another state or a foreign country.

20 (24) "Responding tribunal" means the authorized tribunal in a responding state or foreign
21 country.

22 (25) "Spousal support order" means a support order for a spouse or former spouse of the
23 obligor.

24 (26) "State" means a state of the United States, the District of Columbia, Puerto Rico,
25 the United States Virgin Islands, any territory or insular possession under the jurisdiction
26 of the United States or an Indian nation or tribe.

27 (27) "Support enforcement agency" means a public official, governmental entity or pri-
28 vate agency authorized to:

29 (a) Seek enforcement of support orders or laws relating to the duty of support;

30 (b) Seek establishment or modification of child support;

31 (c) Request determination of parentage of a child;

32 (d) Attempt to locate obligors or their assets; or

33 (e) Request determination of the controlling child support order.

34 (28) "Support order" means a judgment, decree, order, decision or directive, whether
35 temporary, final or subject to modification, issued in a state or foreign country for the ben-
36 efit of a child, a spouse or a former spouse, that provides for monetary support, health care,
37 arrearages, retroactive support or reimbursement for financial assistance provided to an
38 individual obligee in place of child support. The term may include related costs and fees, in-
39 terest, income withholding, automatic adjustment, reasonable attorney fees and other relief.

40 (29) "Tribunal" means a court, administrative agency or quasi-judicial entity authorized
41 to establish, enforce or modify support orders or to determine parentage of a child.

42 **SECTION 4.** (1) The tribunals of this state are the circuit court, the administrator as
43 defined in ORS 25.010, the Department of Justice or an administrative law judge of the Em-
44 ployment Department, as appropriate.

45 (2) The Division of Child Support of the Department of Justice is the support enforce-

1 **ment agency of this state.**

2 **SECTION 5. (1) Remedies provided by this chapter are cumulative and do not affect the**
3 **availability of remedies under other law or the recognition of a foreign support order on the**
4 **basis of comity.**

5 **(2) This chapter does not:**

6 **(a) Provide the exclusive method of establishing or enforcing a support order under the**
7 **law of this state; or**

8 **(b) Grant a tribunal of this state jurisdiction to render judgment or issue an order re-**
9 **lating to child custody or visitation in a proceeding under this chapter.**

10 **SECTION 6. (1) A tribunal of this state shall apply sections 2 to 61 of this 2015 Act and,**
11 **as applicable, sections 62 to 74 of this 2015 Act to a support proceeding involving:**

12 **(a) A foreign support order;**

13 **(b) A foreign tribunal; or**

14 **(c) An obligee, obligor or child residing in a foreign country.**

15 **(2) A tribunal of this state that is requested to recognize and enforce a support order on**
16 **the basis of comity may apply the procedural and substantive provisions of sections 2 to 61**
17 **of this 2015 Act .**

18 **(3) Sections 62 to 74 of this 2015 Act apply only to a support proceeding under the Con-**
19 **vention. In such a proceeding, if a provision of sections 62 to 74 of this 2015 Act is incon-**
20 **sistent with sections 2 to 61 of this 2015 Act, sections 62 to 74 of this 2015 Act control.**

22 **ARTICLE 2**
23 **(Jurisdiction)**
24

25 **SECTION 7. (1) In a proceeding to establish or enforce a support order or to determine**
26 **parentage of a child, a tribunal of this state may exercise personal jurisdiction over a non-**
27 **resident individual or the individual's guardian or conservator if:**

28 **(a) The individual is personally served with notice within this state;**

29 **(b) The individual submits to the jurisdiction of this state by consent in a record, by en-**
30 **tering a general appearance or by filing a responsive document having the effect of waiving**
31 **any contest to personal jurisdiction;**

32 **(c) The individual resided with the child in this state;**

33 **(d) The individual resided in this state and provided prenatal expenses or support for the**
34 **child;**

35 **(e) The child resides in this state as a result of the acts or directives of the individual;**

36 **(f) The individual engaged in sexual intercourse in this state and the child may have been**
37 **conceived by that act of intercourse; or**

38 **(g) There is any other basis consistent with the Constitutions of the State of Oregon and**
39 **the United States for the exercise of personal jurisdiction.**

40 **(2) The bases of personal jurisdiction set forth in subsection (1) of this section or in any**
41 **other law of this state may not be used to acquire personal jurisdiction for a tribunal of this**
42 **state to modify a child support order of another state unless the requirements of section 56**
43 **of this 2015 Act are met or, in the case of a foreign support order, unless the requirements**
44 **of section 60 of this 2015 Act are met.**

45 **SECTION 8. Personal jurisdiction acquired by a tribunal of this state in a proceeding**

1 under this chapter or other law of this state relating to a support order continues as long
2 as a tribunal of this state has continuing, exclusive jurisdiction to modify its order or con-
3 tinuing jurisdiction to enforce its order as provided by sections 11, 12 and 17 of this 2015 Act.

4 **SECTION 9.** Under this chapter, a tribunal of this state may serve as an initiating
5 tribunal to forward proceedings to a tribunal of another state, and as a responding tribunal
6 for proceedings initiated in another state or a foreign country.

7 **SECTION 10.** (1) A tribunal of this state may exercise jurisdiction to establish a support
8 order if the petition or comparable pleading is filed after a pleading is filed in another state
9 or a foreign country only if:

10 (a) The petition or comparable pleading in this state is filed before the expiration of the
11 time allowed in the other state or the foreign country for filing a responsive pleading chal-
12 lenging the exercise of jurisdiction by the other state or the foreign country;

13 (b) The contesting party timely challenges the exercise of jurisdiction in the other state
14 or the foreign country; and

15 (c) If relevant, this state is the home state of the child.

16 (2) A tribunal of this state may not exercise jurisdiction to establish a support order if
17 the petition or comparable pleading is filed before a petition or comparable pleading is filed
18 in another state or a foreign country if:

19 (a) The petition or comparable pleading in the other state or foreign country is filed be-
20 fore the expiration of the time allowed in this state for filing a responsive pleading chal-
21 lenging the exercise of jurisdiction by this state;

22 (b) The contesting party timely challenges the exercise of jurisdiction in this state; and

23 (c) If relevant, the other state or foreign country is the home state of the child.

24 **SECTION 11.** (1) A tribunal of this state that has issued a child support order consistent
25 with the law of this state has and shall exercise continuing, exclusive jurisdiction to modify
26 its child support order if the order is the controlling order and:

27 (a) At the time of the filing of a request for modification, this state is the residence of
28 the obligor, the individual obligee or the child for whose benefit the support order is issued;
29 or

30 (b) Even if this state is not the residence of the obligor, the individual obligee or the child
31 for whose benefit the support order is issued, the parties consent in a record or in open court
32 that the tribunal of this state may continue to exercise jurisdiction to modify its order.

33 (2) A tribunal of this state that has issued a child support order consistent with the law
34 of this state may not exercise continuing, exclusive jurisdiction to modify the order if:

35 (a) All of the parties who are individuals file consent in a record with the tribunal of this
36 state that a tribunal of another state that has jurisdiction over at least one of the parties
37 who is an individual or that is located in the state of residence of the child may modify the
38 order and assume continuing, exclusive jurisdiction; or

39 (b) The tribunal's order is not the controlling order.

40 (3) If a tribunal of another state has issued a child support order pursuant to the Uni-
41 form Interstate Family Support Act or a law substantially similar to that Act which modifies
42 a child support order of a tribunal of this state, tribunals of this state shall recognize the
43 continuing, exclusive jurisdiction of the tribunal of the other state.

44 (4) A tribunal of this state that lacks continuing, exclusive jurisdiction to modify a child
45 support order may serve as an initiating tribunal to request a tribunal of another state to

1 **modify a support order issued in that state.**

2 **(5) A temporary support order issued ex parte or pending resolution of a jurisdictional**
3 **conflict does not create continuing, exclusive jurisdiction in the issuing tribunal.**

4 **SECTION 12. (1) A tribunal of this state that has issued a child support order consistent**
5 **with the law of this state may serve as an initiating tribunal to request a tribunal of another**
6 **state to enforce:**

7 **(a) The order if the order is the controlling order and has not been modified by a tribunal**
8 **of another state that assumed jurisdiction pursuant to the Uniform Interstate Family Sup-**
9 **port Act; or**

10 **(b) A money judgment for arrears of support and interest on the order accrued before a**
11 **determination that an order of a tribunal of another state is the controlling order.**

12 **(2) A tribunal of this state having continuing jurisdiction over a support order may act**
13 **as a responding tribunal to enforce the order.**

14 **SECTION 13. (1) If a proceeding is brought under this chapter and only one tribunal has**
15 **issued a child support order, the order of that tribunal controls and must be recognized.**

16 **(2) If a proceeding is brought under this chapter and two or more child support orders**
17 **have been issued by tribunals of this state, another state or a foreign country with regard**
18 **to the same obligor and same child, a tribunal of this state having personal jurisdiction over**
19 **both the obligor and individual obligee shall apply the following rules and by order shall de-**
20 **termine which order controls and must be recognized:**

21 **(a) If only one of the tribunals would have continuing, exclusive jurisdiction under this**
22 **chapter the order of that tribunal controls.**

23 **(b) If more than one of the tribunals would have continuing, exclusive jurisdiction under**
24 **this chapter:**

25 **(A) An order issued by a tribunal in the current home state of the child controls; or**

26 **(B) If an order has not been issued in the current home state of the child, the order most**
27 **recently issued controls.**

28 **(c) If none of the tribunals would have continuing, exclusive jurisdiction under this**
29 **chapter, the tribunal of this state shall issue a child support order, which controls.**

30 **(3) If two or more child support orders have been issued for the same obligor and same**
31 **child, upon request of a party who is an individual or that is a support enforcement agency,**
32 **a tribunal of this state having personal jurisdiction over both the obligor and the obligee who**
33 **is an individual shall determine which order controls under subsection (2) of this section. The**
34 **request may be filed with a registration for enforcement or registration for modification**
35 **pursuant to sections 46 to 61 of this 2015 Act or may be filed as a separate proceeding.**

36 **(4) A request to determine which is the controlling order must be accompanied by a copy**
37 **of every child support order in effect and the applicable record of payments. The requesting**
38 **party shall give notice of the request to each party whose rights may be affected by the de-**
39 **termination.**

40 **(5) The tribunal that issued the controlling order under subsection (1), (2) or (3) of this**
41 **section has continuing jurisdiction to the extent provided in section 11 or 12 of this 2015 Act.**

42 **(6) A tribunal of this state that determines by order which is the controlling order under**
43 **subsection (2)(a) or (b) or (3) of this section or that issues a new controlling order under**
44 **subsection (2)(c) of this section shall state in that order:**

45 **(a) The basis upon which the tribunal made its determination;**

1 (b) The amount of prospective support, if any; and

2 (c) The total amount of consolidated arrears and accrued interest, if any, under all of the
3 orders after all payments made are credited as provided by section 15 of this 2015 Act.

4 (7) Within 30 days after issuance of an order determining which is the controlling order,
5 the party obtaining the order shall file a certified copy of it in each tribunal that issued or
6 registered an earlier order of child support. A party or support enforcement agency obtaining
7 the order that fails to file a certified copy is subject to appropriate sanctions by a tribunal
8 in which the issue of failure to file arises. The failure to file does not affect the validity or
9 enforceability of the controlling order.

10 (8) An order that has been determined to be the controlling order, or a judgment for
11 consolidated arrears of support and interest, if any, made pursuant to this section must be
12 recognized in proceedings under this chapter.

13 **SECTION 14.** In responding to registrations or petitions for enforcement of two or more
14 child support orders in effect at the same time with regard to the same obligor and different
15 individual obligees, at least one of which was issued by a tribunal of another state or a for-
16 eign country, a tribunal of this state shall enforce those orders in the same manner as if the
17 orders had been issued by a tribunal of this state.

18 **SECTION 15.** A tribunal of this state shall credit amounts collected for a particular pe-
19 riod pursuant to any child support order against the amounts owed for the same period un-
20 der any other child support order for support of the same child issued by a tribunal of this
21 state, another state or a foreign country.

22 **SECTION 16.** A tribunal of this state exercising personal jurisdiction over a nonresident
23 in a proceeding under this chapter, under other law of this state relating to a support order
24 or recognizing a foreign support order may receive evidence from outside this state pursuant
25 to section 33 of this 2015 Act, communicate with a tribunal outside this state pursuant to
26 section 34 of this 2015 Act and obtain discovery through a tribunal outside this state pursu-
27 ant to section 35 of this 2015 Act. In all other respects, sections 18 to 61 of this 2015 Act do
28 not apply and the tribunal shall apply the procedural and substantive law of this state.

29 **SECTION 17.** (1) A tribunal of this state issuing a spousal support order consistent with
30 the law of this state has continuing, exclusive jurisdiction to modify the spousal support or-
31 der throughout the existence of the support obligation.

32 (2) A tribunal of this state may not modify a spousal support order issued by a tribunal
33 of another state or a foreign country having continuing, exclusive jurisdiction over that or-
34 der under the law of that state or foreign country.

35 (3) A tribunal of this state that has continuing, exclusive jurisdiction over a spousal
36 support order may serve as:

37 (a) An initiating tribunal to request a tribunal of another state to enforce the spousal
38 support order issued in this state; or

39 (b) A responding tribunal to enforce or modify its own spousal support order.

40
41 **ARTICLE 3**

42 **(Civil Provisions of General Application)**

43
44 **SECTION 18.** (1) Except as otherwise provided in this chapter, sections 18 to 36 of this
45 2015 Act apply to all proceedings under this chapter.

1 (2) An individual petitioner or a support enforcement agency may initiate a proceeding
2 authorized under this chapter by filing a petition in an initiating tribunal for forwarding to
3 a responding tribunal or by filing a petition or a comparable pleading directly in a tribunal
4 of another state or a foreign country that has or can obtain personal jurisdiction over the
5 respondent.

6 **SECTION 19.** A minor parent, or a guardian or other legal representative of a minor
7 parent, may maintain a proceeding on behalf of or for the benefit of the minor's child.

8 **SECTION 20.** Except as otherwise provided in this chapter, a responding tribunal of this
9 state shall:

10 (1) Apply the procedural and substantive law generally applicable to similar proceedings
11 originating in this state and may exercise all powers and provide all remedies available in
12 those proceedings; and

13 (2) Determine the duty of support and the amount payable in accordance with the law
14 and support guidelines of this state.

15 **SECTION 21.** (1) Upon the filing of a petition authorized by this chapter, an initiating
16 tribunal of this state shall forward the petition and its accompanying documents:

17 (a) To the responding tribunal or appropriate support enforcement agency in the re-
18 sponding state; or

19 (b) If the identity of the responding tribunal is unknown, to the state information agency
20 of the responding state with a request that the petition and accompanying documents be
21 forwarded to the appropriate tribunal and that receipt be acknowledged.

22 (2) If requested by the responding tribunal, a tribunal of this state shall issue a certif-
23 icate or other document and make findings required by the law of the responding state. If
24 the responding tribunal is in a foreign country, upon request the tribunal of this state shall
25 specify the amount of support sought, convert that amount into the equivalent amount in
26 the foreign currency under applicable official or market exchange rate as publicly reported
27 and provide any other documents necessary to satisfy the requirements of the responding
28 foreign tribunal.

29 **SECTION 22.** (1) When a responding tribunal of this state receives a petition or compa-
30 rable pleading from an initiating tribunal or directly pursuant to section 18 (2) of this 2015
31 Act, the responding tribunal shall cause the petition or pleading to be filed and notify the
32 petitioner where and when it was filed.

33 (2) A responding tribunal of this state, to the extent not prohibited by other law, may
34 do one or more of the following:

35 (a) Establish or enforce a support order, modify a child support order, determine the
36 controlling child support order or determine parentage of a child;

37 (b) Order an obligor to comply with a support order, specifying the amount and the
38 manner of compliance;

39 (c) Order income withholding;

40 (d) Determine the amount of any arrearages and specify a method of payment;

41 (e) Enforce orders by civil or criminal contempt, or both;

42 (f) Set aside property for satisfaction of the support order;

43 (g) Place liens and order execution on the obligor's property;

44 (h) Order an obligor to keep the tribunal informed of the obligor's current residential
45 address, electronic mail address, telephone number, employer, address of employment and

1 telephone number at the place of employment;

2 (i) Issue a warrant for an obligor who has failed, after proper notice, to appear at a
3 hearing ordered by the tribunal and enter the warrant in any local and state computer sys-
4 tems for criminal warrants;

5 (j) Order the obligor to seek appropriate employment by specified methods;

6 (k) Award reasonable attorney fees and other fees and costs; and

7 (L) Grant any other available remedy.

8 (3) A responding tribunal of this state shall include in a support order issued under this
9 chapter, or in the documents accompanying the order, the calculations on which the support
10 order is based.

11 (4) A responding tribunal of this state may not condition the payment of a support order
12 issued under this chapter upon compliance by a party with provisions for visitation.

13 (5) If a responding tribunal of this state issues an order under this chapter, the tribunal
14 shall send a copy of the order to the petitioner and the respondent and to the initiating
15 tribunal, if any.

16 (6) If requested to enforce a support order, arrears or judgment or to modify a support
17 order stated in a foreign currency, a responding tribunal of this state shall convert the
18 amount stated in the foreign currency to the equivalent amount in dollars under the appli-
19 cable official or market exchange rate as publicly reported.

20 SECTION 23. If a petition or comparable pleading is received by an inappropriate tribunal
21 of this state, the tribunal shall forward the pleading and accompanying documents to an
22 appropriate tribunal of this state or another state and notify the petitioner where and when
23 the pleading was sent.

24 SECTION 24. (1) A support enforcement agency of this state, upon request, shall provide
25 services to a petitioner in a proceeding under this chapter.

26 (2) A support enforcement agency of this state that is providing services to the petitioner
27 shall:

28 (a) Take all steps necessary to enable an appropriate tribunal of this state, another state
29 or a foreign country to obtain jurisdiction over the respondent;

30 (b) Request an appropriate tribunal to set a date, time and place for a hearing;

31 (c) Make a reasonable effort to obtain all relevant information, including information as
32 to income and property of the parties;

33 (d) Within seven days, exclusive of Saturdays, Sundays and legal holidays, after receipt
34 of notice in a record from an initiating, responding or registering tribunal, send a copy of
35 the notice to the petitioner;

36 (e) Within seven days, exclusive of Saturdays, Sundays and legal holidays, after receipt
37 of communication in a record from the respondent or the respondent's attorney, send a copy
38 of the communication to the petitioner; and

39 (f) Notify the petitioner if jurisdiction over the respondent cannot be obtained.

40 (3) A support enforcement agency of this state that requests registration of a child sup-
41 port order in this state for enforcement or for modification shall make reasonable efforts:

42 (a) To ensure that the order to be registered is the controlling order; or

43 (b) If two or more child support orders exist and the identity of the controlling order has
44 not been determined, to ensure that a request for such a determination is made in a tribunal
45 having jurisdiction to do so.

1 (4) A support enforcement agency of this state that requests registration and enforce-
2 ment of a support order, arrears or judgment stated in a foreign currency shall convert the
3 amounts stated in the foreign currency into the equivalent amounts in dollars under the
4 applicable official or market exchange rate as publicly reported.

5 (5) A support enforcement agency of this state shall issue or request a tribunal of this
6 state to issue a child support order and an income withholding order that redirect payment
7 of current support, arrears and interest if requested to do so by a support enforcement
8 agency of another state pursuant to section 36 of this 2015 Act.

9 (6) This chapter does not create or negate a relationship of attorney and client or other
10 fiduciary relationship between a support enforcement agency or the attorney for the agency
11 and the individual being assisted by the agency.

12 **SECTION 25.** (1) If the Attorney General determines that the support enforcement
13 agency is neglecting or refusing to provide services to an individual, the Attorney General
14 may order the agency to perform its duties under this chapter or may provide those services
15 directly to the individual.

16 (2) The Attorney General may determine that a foreign country has established a recip-
17 rocal arrangement for child support with this state and take appropriate action for notifi-
18 cation of the determination.

19 **SECTION 26.** An individual may employ private counsel to represent the individual in
20 proceedings authorized by this chapter.

21 **SECTION 27.** (1) The Attorney General's office is the state information agency under this
22 chapter.

23 (2) The state information agency shall:

24 (a) Compile and maintain a current list, including addresses, of the tribunals in this state
25 that have jurisdiction under this chapter and any support enforcement agencies in this state
26 and transmit a copy to the state information agency of every other state;

27 (b) Maintain a register of names and addresses of tribunals and support enforcement
28 agencies received from other states;

29 (c) Forward to the appropriate tribunal in the county in this state in which the obligee
30 who is an individual or the obligor resides, or in which the obligor's property is believed to
31 be located, all documents concerning a proceeding under this chapter received from another
32 state or a foreign country; and

33 (d) Obtain information concerning the location of the obligor and the obligor's property
34 within this state not exempt from execution, by such means as postal verification and federal
35 or state locator services, examination of telephone directories, requests for the obligor's
36 address from employers and examination of governmental records including, to the extent
37 not prohibited by other law, those relating to real property, vital statistics, law enforcement,
38 taxation, motor vehicles, driver licenses and Social Security.

39 **SECTION 28.** (1) In a proceeding under this chapter, a petitioner seeking to establish a
40 support order, to determine parentage of a child or to register and modify a support order
41 of a tribunal of another state or a foreign country must file a petition. Unless otherwise
42 ordered under section 29 of this 2015 Act, the petition or accompanying documents must
43 provide, so far as known, the name, residential address and Social Security numbers of the
44 obligor and the obligee or the parent and alleged parent and the name, sex, residential ad-
45 dress, Social Security number and date of birth of each child for whose benefit support is

1 sought or whose parentage is to be determined. Unless filed at the time of registration, the
2 petition must be accompanied by a copy of any support order known to have been issued by
3 another tribunal. The petition may include any other information that may assist in locating
4 or identifying the respondent.

5 (2) The petition must specify the relief sought. The petition and accompanying documents
6 must conform substantially with the requirements imposed by the forms mandated by federal
7 law for use in cases filed by a support enforcement agency.

8 **SECTION 29.** If a party alleges in an affidavit or a pleading under oath that the health,
9 safety or liberty of a party or child would be jeopardized by disclosure of specific identifying
10 information, that information must be sealed and may not be disclosed to the other party
11 or the public. After a hearing in which a tribunal takes into consideration the health, safety
12 or liberty of the party or child, the tribunal may order disclosure of information that the
13 tribunal determines to be in the interest of justice.

14 **SECTION 30.** (1) The petitioner may not be required to pay a filing fee or other costs.

15 (2) If an obligee prevails, a responding tribunal of this state may assess against an obligor
16 filing fees, reasonable attorney fees, other costs and necessary travel and other reasonable
17 expenses incurred by the obligee and the obligee's witnesses. The tribunal may not assess
18 fees, costs or expenses against the obligee or the support enforcement agency of either the
19 initiating or responding state or foreign country except as provided by other law. Attorney
20 fees may be taxed as costs and may be ordered paid directly to the attorney, who may en-
21 force the order in the attorney's own name. Payment of support owed to the obligee has
22 priority over fees, costs and expenses.

23 (3) The tribunal shall order the payment of costs and reasonable attorney fees if it de-
24 termines that a hearing was requested primarily for delay. In a proceeding under sections
25 46 to 61 of this 2015 Act, a hearing is presumed to have been requested primarily for delay
26 if a registered support order is confirmed or enforced without change.

27 **SECTION 31.** (1) Participation by a petitioner in a proceeding under this chapter before
28 a responding tribunal, whether in person, by private attorney or through services provided
29 by the support enforcement agency, does not confer personal jurisdiction over the petitioner
30 in another proceeding.

31 (2) A petitioner is not amenable to service of civil process while physically present in this
32 state to participate in a proceeding under this chapter.

33 (3) The immunity granted by this section does not extend to civil litigation based on acts
34 unrelated to a proceeding under this chapter committed by a party while physically present
35 in this state to participate in the proceeding.

36 **SECTION 32.** A party whose parentage of a child has been previously determined by or
37 pursuant to law may not plead nonparentage as a defense to a proceeding under this chapter.

38 **SECTION 33.** (1) The physical presence of a nonresident party who is an individual in a
39 tribunal of this state is not required for the establishment, enforcement or modification of
40 a support order or the rendition of a judgment determining parentage of a child.

41 (2) An affidavit, a document substantially complying with federally mandated forms or a
42 document incorporated by reference in an affidavit or form that would not be excluded under
43 the hearsay rule if given in person is admissible in evidence if given under penalty of perjury
44 by a party or witness residing outside this state.

45 (3) A copy of the record of child support payments certified as a true copy of the original

1 by the custodian of the record may be forwarded to a responding tribunal. The copy is evi-
2 dence of the facts asserted in the record and is admissible to show whether payments were
3 made.

4 (4) Copies of bills for testing for parentage of a child and for prenatal and postnatal
5 health care of the mother and child that are furnished to the adverse party at least 10 days
6 before trial are admissible in evidence to prove the amount of the charges billed and that the
7 charges were reasonable, necessary and customary.

8 (5) Documentary evidence transmitted from outside this state to a tribunal of this state
9 by telephone, telecopier or other electronic means that do not provide an original record may
10 not be excluded from evidence on an objection based on the means of transmission.

11 (6) In a proceeding under this chapter, a tribunal of this state shall permit a party or
12 witness residing outside this state to be deposed or to testify under penalty of perjury by
13 telephone, audiovisual means or other electronic means at a designated tribunal or other
14 location. A tribunal of this state shall cooperate with other tribunals in designating an ap-
15 appropriate location for the deposition or testimony.

16 (7) If a party called to testify at a civil hearing refuses to answer on the ground that the
17 testimony may be self-incriminating, the trier of fact may draw an adverse inference from
18 the refusal.

19 (8) A privilege against disclosure of communications between spouses does not apply in
20 a proceeding under this chapter.

21 (9) The defense of immunity based on the relationship of husband and wife or parent and
22 child does not apply in a proceeding under this chapter.

23 (10) A voluntary acknowledgment of paternity, certified as a true copy, is admissible to
24 establish parentage of the child.

25 SECTION 34. A tribunal of this state may communicate with a tribunal outside this state
26 in a record or by telephone, electronic mail or other means to obtain information concerning
27 the laws of that tribunal, the legal effect of a judgment, decree or order of that tribunal and
28 the status of a proceeding. A tribunal of this state may furnish similar information by sim-
29 ilar means to a tribunal outside this state.

30 SECTION 35. A tribunal of this state may:

31 (1) Request a tribunal outside this state to assist in obtaining discovery; and

32 (2) Upon request, compel a person over which it has jurisdiction to respond to a discovery
33 order issued by a tribunal outside this state.

34 SECTION 36. (1) A support enforcement agency or tribunal of this state shall disburse
35 promptly any amounts received pursuant to a support order as directed by the order. The
36 agency or tribunal shall furnish to a requesting party or tribunal of another state or a for-
37 eign country a certified statement by the custodian of the record of the amounts and dates
38 of all payments received.

39 (2) If neither the obligor nor the obligee who is an individual nor the child resides in this
40 state, upon request from the support enforcement agency of this state or another state, the
41 support enforcement agency of this state or a tribunal of this state shall:

42 (a) Direct that the support payment be made to the support enforcement agency in the
43 state in which the obligee is receiving services; and

44 (b) Issue and send to the obligor's employer a conforming income withholding order or
45 an administrative notice of change of payee reflecting the redirected payments.

1 (a) The duration and amount of periodic payments of current child support, stated as a
2 sum certain;

3 (b) The person designated to receive payments and the address to which the payments
4 are to be forwarded;

5 (c) Medical support, whether in the form of a periodic cash payment, stated as a sum
6 certain or by ordering the obligor to provide health insurance coverage for the child under
7 a policy available through the obligor's employment;

8 (d) The amount of periodic payments of fees and costs for a support enforcement agency,
9 the issuing tribunal and the obligee's attorney, stated as sums certain; and

10 (e) The amount of periodic payments of arrearages and interest on arrearages, stated as
11 sums certain.

12 (4) An employer shall comply with the law of the state of the obligor's principal place of
13 employment for withholding from income with respect to:

14 (a) The employer's fee for processing an income withholding order;

15 (b) The maximum amount permitted to be withheld from the obligor's income; and

16 (c) The times within which the employer must implement the income withholding order
17 and forward the child support payment.

18 **SECTION 41.** If an obligor's employer receives two or more income withholding orders
19 with respect to the earnings of the same obligor, the employer satisfies the terms of the
20 orders if the employer complies with the law of the state of the obligor's principal place of
21 employment to establish the priorities for withholding and allocating income withheld for two
22 or more child support obligees.

23 **SECTION 42.** An employer that complies with an income withholding order issued in an-
24 other state in accordance with sections 39 to 45 of this 2015 Act is not subject to civil liability
25 to an individual or agency with regard to the employer's withholding of child support from
26 the obligor's income.

27 **SECTION 43.** An employer that willfully fails to comply with an income withholding order
28 issued in another state and received for enforcement is subject to the same penalties that
29 may be imposed for noncompliance with an order issued by a tribunal of this state.

30 **SECTION 44.** (1) An obligor may contest the validity or enforcement of an income with-
31 holding order issued in another state and received directly by an employer in this state by
32 registering the order in a tribunal of this state and filing a contest to that order as provided
33 in sections 46 to 61 of this 2015 Act or otherwise contesting the order in the same manner
34 as if the order had been issued by a tribunal of this state.

35 (2) The obligor shall give notice of the contest to:

36 (a) A support enforcement agency providing services to the obligee;

37 (b) Each employer that has directly received an income withholding order relating to the
38 obligor; and

39 (c) The person designated to receive payments in the income withholding order or, if no
40 person is designated, to the obligee.

41 **SECTION 45.** (1) A party or support enforcement agency seeking to enforce a support
42 order or an income withholding order, or both, issued in another state, or a foreign support
43 order, may send the documents required for registering the order to a support enforcement
44 agency of this state.

45 (2) Upon receipt of the documents, the support enforcement agency, without initially

1 seeking to register the order, shall consider and, if appropriate, use any administrative pro-
2 cedure authorized by the law of this state to enforce a support order or an income with-
3 holding order, or both. If the obligor does not contest administrative enforcement, the order
4 need not be registered. If the obligor contests the validity or administrative enforcement of
5 the order, the support enforcement agency shall register the order pursuant to this chapter.

6
7 **ARTICLE 6**

8 **(Registration, Enforcement and Modification of**
9 **Support Orders)**

10 **(Part 1. Registration for Enforcement of Support Order)**
11

12 **SECTION 46.** A support order or income withholding order issued in another state or a
13 foreign support order may be registered in this state for enforcement.

14 **SECTION 47.** (1) Except as otherwise provided in section 67 of this 2015 Act, a support
15 order or income withholding order of another state or a foreign support order may be reg-
16 istered in this state by sending the following records to the appropriate tribunal in this state:

17 (a) A letter of transmittal to the tribunal requesting registration and enforcement;

18 (b) Two copies, including one certified copy, of the order to be registered, including any
19 modification of the order;

20 (c) A sworn statement by the person requesting registration or a certified statement by
21 the custodian of the records showing the amount of any arrearage;

22 (d) The name of the obligor and, if known:

23 (A) The obligor's address and Social Security number;

24 (B) The name and address of the obligor's employer and any other source of income of
25 the obligor; and

26 (C) A description and the location of property of the obligor in this state not exempt from
27 execution; and

28 (e) Except as otherwise provided in section 29 of this 2015 Act, the name and address of
29 the obligee and, if applicable, the person to whom support payments are to be remitted.

30 (2) Upon receipt of a request for registration, the registering tribunal shall cause the
31 order to be filed as an order of a tribunal of another state or a foreign support order, to-
32 gether with one copy of the documents and information, regardless of their form.

33 (3) A petition or comparable pleading seeking a remedy that must be affirmatively sought
34 under other law of this state may be filed at the same time as the request for registration
35 or later. The pleading must specify the grounds for the remedy sought.

36 (4) If two or more orders are in effect, the person requesting registration shall:

37 (a) Furnish to the tribunal a copy of every support order asserted to be in effect in ad-
38 dition to the documents specified in this section;

39 (b) Specify the order alleged to be the controlling order, if any; and

40 (c) Specify the amount of consolidated arrears, if any.

41 (5) A request for a determination of which is the controlling order may be filed separately
42 or with a request for registration and enforcement or for registration and modification. The
43 person requesting registration shall give notice of the request to each party whose rights
44 may be affected by the determination.

45 **SECTION 48.** (1) A support order or income withholding order issued in another state,

1 or a foreign support order, is registered when the order is filed in the registering tribunal
2 of this state.

3 (2) A registered support order issued in another state or a foreign country is enforceable
4 in the same manner and is subject to the same procedures as an order issued by a tribunal
5 of this state.

6 (3) Except as otherwise provided in this chapter, a tribunal of this state shall recognize
7 and enforce, but may not modify, a registered support order if the issuing tribunal had ju-
8 risdiction.

9 **SECTION 49.** (1) Except as otherwise provided in subsection (4) of this section, the law
10 of the issuing state or foreign country governs:

11 (a) The nature, extent, amount and duration of current payments under a registered
12 support order;

13 (b) The computation and payment of arrearages and accrual of interest on the arrearages
14 under the support order; and

15 (c) The existence and satisfaction of other obligations under the support order.

16 (2) In a proceeding for arrears under a registered support order, the statute of limitation
17 of this state, or of the issuing state or foreign country, whichever is longer, applies.

18 (3) A responding tribunal of this state shall apply the procedures and remedies of this
19 state to enforce current support and collect arrears and interest due on a support order of
20 another state or a foreign country registered in this state.

21 (4) After a tribunal of this state or another state determines which is the controlling
22 order and issues an order consolidating arrears, if any, a tribunal of this state shall
23 prospectively apply the law of the state or foreign country issuing the controlling order, in-
24 cluding its law on interest on arrears, on current and future support and on consolidated
25 arrears.

26
27 (Part 2. Contest of Validity or Enforcement)
28

29 **SECTION 50.** (1) When a support order or income withholding order issued in another
30 state or a foreign support order is registered, the registering tribunal of this state shall no-
31 tify the nonregistering party. The notice must be accompanied by a copy of the registered
32 order and the documents and relevant information accompanying the order.

33 (2) A notice must inform the nonregistering party:

34 (a) That a registered support order is enforceable as of the date of registration in the
35 same manner as an order issued by a tribunal of this state;

36 (b) That a hearing to contest the validity or enforcement of the registered order must
37 be requested within 20 days after notice unless the registered order is under section 68 of
38 this 2015 Act;

39 (c) That failure to contest the validity or enforcement of the registered order in a timely
40 manner will result in confirmation of the order and enforcement of the order and the alleged
41 arrearages; and

42 (d) Of the amount of any alleged arrearages.

43 (3) If the registering party asserts that two or more orders are in effect, a notice must
44 also:

45 (a) Identify the two or more orders and the order alleged by the registering party to be

1 the controlling order and the consolidated arrears, if any;

2 (b) Notify the nonregistering party of the right to a determination of which is the con-
3 trolling order;

4 (c) State that the procedures provided in subsection (2) of this section apply to the de-
5 termination of which is the controlling order; and

6 (d) State that failure to contest the validity or enforcement of the order alleged to be the
7 controlling order in a timely manner may result in confirmation that the order is the con-
8 trolling order.

9 (4) Upon registration of an income withholding order for enforcement, the support
10 enforcement agency or the registering tribunal shall notify the obligor's employer pursuant
11 to the income withholding law of this state.

12 **SECTION 51.** (1) A nonregistering party seeking to contest the validity or enforcement
13 of a registered support order in this state shall request a hearing within the time required
14 by section 50 of this 2015 Act. The nonregistering party may seek to vacate the registration,
15 to assert any defense to an allegation of noncompliance with the registered order or to con-
16 test the remedies being sought or the amount of any alleged arrearages pursuant to section
17 52 of this 2015 Act.

18 (2) If the nonregistering party fails to contest the validity or enforcement of the regis-
19 tered support order in a timely manner, the order is confirmed by operation of law.

20 (3) If a nonregistering party requests a hearing to contest the validity or enforcement
21 of the registered support order, the registering tribunal shall schedule the matter for hear-
22 ing and give notice to the parties of the date, time and place of the hearing.

23 **SECTION 52.** (1) A party contesting the validity or enforcement of a registered support
24 order or seeking to vacate the registration has the burden of proving one or more of the
25 following defenses:

26 (a) The issuing tribunal lacked personal jurisdiction over the contesting party;

27 (b) The order was obtained by fraud;

28 (c) The order has been vacated, suspended or modified by a later order;

29 (d) The issuing tribunal has stayed the order pending appeal;

30 (e) There is a defense under the law of this state to the remedy sought;

31 (f) Full or partial payment has been made;

32 (g) The statute of limitation under section 49 of this 2015 Act precludes enforcement of
33 some or all of the alleged arrearages; or

34 (h) The alleged controlling order is not the controlling order.

35 (2) If a party presents evidence establishing a full or partial defense under subsection (1)
36 of this section, a tribunal may stay enforcement of a registered support order, continue the
37 proceeding to permit production of additional relevant evidence and issue other appropriate
38 orders. An uncontested portion of the registered support order may be enforced by all rem-
39 edies available under the law of this state.

40 (3) If the contesting party does not establish a defense under subsection (1) of this sec-
41 tion to the validity or enforcement of a registered support order, the registering tribunal
42 shall issue an order confirming the order.

43 **SECTION 53.** Confirmation of a registered support order, whether by operation of law or
44 after notice and hearing, precludes further contest of the order with respect to any matter
45 that could have been asserted at the time of registration.

(Part 3. Registration and Modification
of Child Support Order of Another State)

SECTION 54. A party or support enforcement agency seeking to modify, or to modify and enforce, a child support order issued in another state shall register that order in this state in the same manner provided in sections 46 to 53 of this 2015 Act if the order has not been registered. A petition for modification may be filed at the same time as a request for registration or later. The pleading must specify the grounds for modification.

SECTION 55. A tribunal of this state may enforce a child support order of another state registered for purposes of modification in the same manner as if the order had been issued by a tribunal of this state, but the registered support order may be modified only if the requirements of section 56 or 58 of this 2015 Act have been met.

SECTION 56. (1) If section 58 of this 2015 Act does not apply, upon petition a tribunal of this state may modify a child support order issued in another state that is registered in this state if, after notice and hearing, the tribunal finds that:

(a) The following requirements are met:

(A) Neither the child, nor the obligee who is an individual nor the obligor resides in the issuing state;

(B) A petitioner who is a nonresident of this state seeks modification; and

(C) The respondent is subject to the personal jurisdiction of the tribunal of this state;
or

(b) This state is the residence of the child, or a party who is an individual is subject to the personal jurisdiction of the tribunal of this state, and all of the parties who are individuals have filed consents in a record in the issuing tribunal for a tribunal of this state to modify the support order and assume continuing, exclusive jurisdiction.

(2) Modification of a registered child support order is subject to the same requirements, procedures and defenses that apply to the modification of an order issued by a tribunal of this state, and the order may be enforced and satisfied in the same manner.

(3) A tribunal of this state may not modify any aspect of a child support order that may not be modified under the law of the issuing state, including the duration of the obligation of support. If two or more tribunals have issued child support orders for the same obligor and same child, the order that controls and must be so recognized under section 13 of this 2015 Act establishes the aspects of the support order which are nonmodifiable.

(4) In a proceeding to modify a child support order, the law of the state that is determined to have issued the initial controlling order governs the duration of the obligation of support. The obligor's fulfillment of the duty of support established by that order precludes imposition of a further obligation of support by a tribunal of this state.

(5) On the issuance of an order by a tribunal of this state modifying a child support order issued in another state, the tribunal of this state becomes the tribunal having continuing, exclusive jurisdiction.

(6) Notwithstanding subsections (1) to (5) of this section and section 7 (2) of this 2015 Act, a tribunal of this state retains jurisdiction to modify an order issued by a tribunal of this state if:

(a) One party resides in another state; and

(b) The other party resides outside the United States.

(Support Proceeding Under Convention)

SECTION 62. As used in sections 62 to 74 of this 2015 Act:

(1) “Application” means a request under the Convention by an obligee or obligor, or on behalf of a child, made through a central authority for assistance from another central authority.

(2) “Central authority” means the entity designated by the United States or a foreign country described in section 3 (5)(d) of this 2015 Act to perform the functions specified in the Convention.

(3) “Convention support order” means a support order of a tribunal of a foreign country described in section 3 (5)(d) of this 2015 Act.

(4) “Direct request” means a petition filed by an individual in a tribunal of this state in a proceeding involving an obligee, obligor or child residing outside the United States.

(5) “Foreign support agreement” means:

(a) An agreement for support in a record that:

(A) Is enforceable as a support order in the country of origin;

(B) Has been:

(i) Formally drawn up or registered as an authentic instrument by a foreign tribunal; or

(ii) Authenticated by, or concluded, registered or filed with a foreign tribunal; and

(C) May be reviewed and modified by a foreign tribunal; and

(b) A maintenance arrangement or authentic instrument under the Convention.

(6) “United States central authority” means the Secretary of the United States Department of Health and Human Services.

SECTION 63. Sections 62 to 74 of this 2015 Act apply only to a support proceeding under the Convention. In such a proceeding, if a provision of sections 62 to 74 of this 2015 Act is inconsistent with sections 2 to 61 of this 2015 Act, sections 62 to 74 of this 2015 Act control.

SECTION 64. The Department of Justice is recognized as the agency designated by the United States central authority to perform specific functions under the Convention.

SECTION 65. (1) In a support proceeding under sections 62 to 74 of this 2015 Act, the Department of Justice shall:

(a) Transmit and receive applications; and

(b) Initiate or facilitate the institution of a proceeding regarding an application in a tribunal of this state.

(2) The following support proceedings are available to an obligee under the Convention:

(a) Recognition or recognition and enforcement of a foreign support order;

(b) Enforcement of a support order issued or recognized in this state;

(c) Establishment of a support order if there is no existing order, including, if necessary, determination of parentage of a child;

(d) Establishment of a support order if recognition of a foreign support order is refused under section 69 (2)(b), (d) or (i) of this 2015 Act;

(e) Modification of a support order of a tribunal of this state; and

(f) Modification of a support order of a tribunal of another state or a foreign country.

(3) The following support proceedings are available under the Convention to an obligor against whom there is an existing support order:

(a) Recognition of an order suspending or limiting enforcement of an existing support

1 order of a tribunal of this state;

2 (b) Modification of a support order of a tribunal of this state; and

3 (c) Modification of a support order of a tribunal of another state or a foreign country.

4 (4) A tribunal of this state may not require security, bond or deposit, however described,
5 to guarantee the payment of costs and expenses in proceedings under the Convention.

6 **SECTION 66.** (1) A petitioner may file a direct request seeking establishment or modifi-
7 cation of a support order or determination of parentage of a child. In the proceeding, the law
8 of this state applies.

9 (2) A petitioner may file a direct request seeking recognition and enforcement of a sup-
10 port order or support agreement. In the proceeding, sections 67 to 74 of this 2015 Act apply.

11 (3) In a direct request for recognition and enforcement of a Convention support order
12 or foreign support agreement:

13 (a) A security, bond or deposit is not required to guarantee the payment of costs and
14 expenses; and

15 (b) An obligee or obligor that in the issuing country has benefited from free legal as-
16 sistance is entitled to benefit, at least to the same extent, from any free legal assistance
17 provided for by the law of this state under the same circumstances.

18 (4) A petitioner filing a direct request is not entitled to assistance from the administrator
19 as defined in ORS 25.010.

20 (5) Sections 62 to 74 of this 2015 Act do not prevent the application of laws of this state
21 that provide simplified, more expeditious rules regarding a direct request for recognition and
22 enforcement of a foreign support order or foreign support agreement.

23 **SECTION 67.** (1) Except as otherwise provided in sections 62 to 74 of this 2015 Act, a
24 party who is an individual or a support enforcement agency seeking recognition of a Con-
25 vention support order shall register the order in this state as provided in sections 46 to 61
26 of this 2015 Act.

27 (2) Notwithstanding sections 28 and 47 (1) of this 2015 Act, a request for registration of
28 a Convention support order must be accompanied by:

29 (a) A complete text of the support order or an abstract or extract of the support order
30 drawn up by the issuing foreign tribunal, which may be in the form recommended by the
31 Hague Conference on Private International Law;

32 (b) A record stating that the support order is enforceable in the issuing country;

33 (c) If the respondent did not appear and was not represented in the proceedings in the
34 issuing country, a record attesting, as appropriate, either that the respondent had proper
35 notice of the proceedings and an opportunity to be heard or that the respondent had proper
36 notice of the support order and an opportunity to be heard in a challenge or appeal on fact
37 or law before a tribunal;

38 (d) A record showing the amount of arrears, if any, and the date the amount was calcu-
39 lated;

40 (e) A record showing a requirement for automatic adjustment of the amount of support,
41 if any, and the information necessary to make the appropriate calculations; and

42 (f) If necessary, a record showing the extent to which the applicant received free legal
43 assistance in the issuing country.

44 (3) A request for registration of a Convention support order may seek recognition and
45 partial enforcement of the order.

1 (4) A tribunal of this state may vacate the registration of a Convention support order
2 without the filing of a contest under section 68 of this 2015 Act only if, acting on its own
3 motion, the tribunal finds that recognition and enforcement of the order would be manifestly
4 incompatible with public policy.

5 (5) The tribunal shall promptly notify the parties of the registration or the order vacating
6 the registration of a Convention support order.

7 **SECTION 68.** (1) Except as otherwise provided in sections 62 to 74 of this 2015 Act,
8 sections 50 to 53 of this 2015 Act apply to a contest of a registered Convention support order.

9 (2) A party contesting a registered Convention support order shall file a contest not later
10 than 30 days after notice of the registration, but if the contesting party does not reside in
11 the United States, the contest must be filed not later than 60 days after notice of the regis-
12 tration.

13 (3) If the nonregistering party fails to contest the registered Convention support order
14 by the time specified in subsection (2) of this section, the order is enforceable.

15 (4) A contest of a registered Convention support order may be based only on grounds set
16 forth in section 69 of this 2015 Act. The contesting party bears the burden of proof.

17 (5) In a contest of a registered Convention support order, a tribunal of this state:

18 (a) Is bound by the findings of fact on which the foreign tribunal based its jurisdiction;
19 and

20 (b) May not review the merits of the order.

21 (6) A tribunal of this state deciding a contest of a registered Convention support order
22 shall promptly notify the parties of its decision.

23 (7) A challenge or appeal, if any, does not stay the enforcement of a Convention support
24 order unless there are exceptional circumstances.

25 **SECTION 69.** (1) Except as otherwise provided in subsection (2) of this section, a tribunal
26 of this state shall recognize and enforce a registered Convention support order.

27 (2) The following grounds are the only grounds on which a tribunal of this state may
28 refuse recognition and enforcement of a registered Convention support order:

29 (a) Recognition and enforcement of the order is manifestly incompatible with public pol-
30 icy, including the failure of the issuing tribunal to observe minimum standards of due pro-
31 cess, which include notice and an opportunity to be heard;

32 (b) The issuing tribunal lacked personal jurisdiction consistent with section 7 of this 2015
33 Act;

34 (c) The order is not enforceable in the issuing country;

35 (d) The order was obtained by fraud in connection with a matter of procedure;

36 (e) A record transmitted in accordance with section 67 of this 2015 Act lacks authenticity
37 or integrity;

38 (f) A proceeding between the same parties and having the same purpose is pending before
39 a tribunal of this state and that proceeding was the first to be filed;

40 (g) The order is incompatible with a more recent support order involving the same par-
41 ties and having the same purpose, if the more recent support order is entitled to recognition
42 and enforcement under this chapter in this state;

43 (h) Payment, to the extent alleged arrears have been paid in whole or in part;

44 (i) In a case in which the respondent neither appeared nor was represented in the pro-
45 ceeding in the issuing foreign country:

1 (A) If the law of that country provides for prior notice of proceedings, the respondent
2 did not have proper notice of the proceedings and an opportunity to be heard; or

3 (B) If the law of that country does not provide for prior notice of the proceedings, the
4 respondent did not have proper notice of the order and an opportunity to be heard in a
5 challenge or appeal on fact or law before a tribunal; or

6 (j) The order was made in violation of section 72 of this 2015 Act.

7 (3) If a tribunal of this state does not recognize a Convention support order under sub-
8 section (2)(b), (d) or (i) of this section:

9 (a) The tribunal may not dismiss the proceeding without allowing a reasonable time for
10 a party to request the establishment of a new Convention support order; and

11 (b) The Department of Justice shall take all appropriate measures to request a child
12 support order for the obligee if the application for recognition and enforcement was received
13 under section 65 of this 2015 Act.

14 SECTION 70. If a tribunal of this state does not recognize and enforce a Convention
15 support order in its entirety, the tribunal shall enforce any severable part of the order. An
16 application or direct request may seek recognition and partial enforcement of a Convention
17 support order.

18 SECTION 71. (1) Except as otherwise provided in subsections (3) and (4) of this section,
19 a tribunal of this state shall recognize and enforce a foreign support agreement registered
20 in this state.

21 (2) An application or direct request for recognition and enforcement of a foreign support
22 agreement must be accompanied by:

23 (a) A complete text of the foreign support agreement; and

24 (b) A record stating that the foreign support agreement is enforceable as an order of
25 support in the issuing country.

26 (3) A tribunal of this state may vacate the registration of a foreign support agreement
27 only if, acting on its own motion, the tribunal finds that recognition and enforcement would
28 be manifestly incompatible with public policy.

29 (4) In a contest of a foreign support agreement, a tribunal of this state may refuse re-
30 cognition and enforcement of the agreement if it finds:

31 (a) Recognition and enforcement of the agreement is manifestly incompatible with public
32 policy;

33 (b) The agreement was obtained by fraud or falsification;

34 (c) The agreement is incompatible with a support order involving the same parties and
35 having the same purpose in this state, another state or a foreign country if the support order
36 is entitled to recognition and enforcement under this chapter in this state; or

37 (d) The record submitted under subsection (2) of this section lacks authenticity or in-
38 tegrity.

39 (5) A proceeding for recognition and enforcement of a foreign support agreement must
40 be suspended during the pendency of a challenge to or appeal of the agreement before a
41 tribunal of another state or a foreign country.

42 SECTION 72. (1) A tribunal of this state may not modify a Convention child support order
43 if the obligee remains a resident of the foreign country where the support order was issued
44 unless:

45 (a) The obligee submits to the jurisdiction of a tribunal of this state, either expressly or

1 by defending on the merits of the case without objecting to the jurisdiction at the first
2 available opportunity; or

3 (b) The foreign tribunal lacks or refuses to exercise jurisdiction to modify its support
4 order or issue a new support order.

5 (2) If a tribunal of this state does not modify a Convention child support order because
6 the order is not recognized in this state, section 69 (3) of this 2015 Act applies.

7 **SECTION 73.** Personal information gathered or transmitted under sections 62 to 74 of
8 this 2015 Act may be used only for the purposes for which it was gathered or transmitted.

9 **SECTION 74.** A record filed with a tribunal of this state under sections 62 to 74 of this
10 2015 Act must be in the original language and, if not in English, must be accompanied by an
11 English translation.

14 **(Interstate Rendition)**

16 **SECTION 75.** (1) For purposes of this section and section 76 of this 2015 Act,
17 “governor” includes an individual performing the functions of governor or the executive au-
18 thority of a state covered by this chapter.

19 (2) The Governor of this state may:

20 (a) Demand that the governor of another state surrender an individual found in the other
21 state who is charged criminally in this state with having failed to provide for the support of
22 an obligee; or

23 (b) On the demand of the governor of another state, surrender an individual found in this
24 state who is charged criminally in the other state with having failed to provide for the sup-
25 port of an obligee.

26 (3) A provision for extradition of individuals not inconsistent with this chapter applies
27 to the demand even if the individual whose surrender is demanded was not in the demanding
28 state when the crime was allegedly committed and has not fled therefrom.

29 **SECTION 76.** (1) Before making a demand that the governor of another state surrender
30 an individual charged criminally in this state with having failed to provide for the support
31 of an obligee, the Governor of this state may require a prosecutor of this state to demon-
32 strate that at least 60 days previously the obligee had initiated proceedings for support pur-
33 suant to this chapter or that the proceeding would be of no avail.

34 (2) If, under this chapter or a law substantially similar to this chapter, the governor of
35 another state makes a demand that the Governor of this state surrender an individual
36 charged criminally in that state with having failed to provide for the support of a child or
37 other individual to whom a duty of support is owed, the Governor of this state may require
38 a prosecutor to investigate the demand and report whether a proceeding for support has
39 been initiated or would be effective. If it appears that a proceeding would be effective but
40 has not been initiated, the Governor of this state may delay honoring the demand for a
41 reasonable time to permit the initiation of a proceeding.

42 (3) If a proceeding for support has been initiated and the individual whose rendition is
43 demanded prevails, the Governor of this state may decline to honor the demand. If the
44 petitioner prevails and the individual whose rendition is demanded is subject to a support
45 order, the Governor of this state may decline to honor the demand if the individual is com-

1 **plying with the support order.**

3 **ARTICLE 9**
4 **(Miscellaneous Provisions)**

6 **SECTION 77.** In applying and construing this uniform act, consideration must be given
7 to the need to promote uniformity of the law with respect to its subject matter among states
8 that enact it.

9 **SECTION 78.** This chapter applies to proceedings begun on or after the effective date of
10 this chapter to establish a support order or determine parentage of a child or to register,
11 recognize, enforce or modify a prior support order, determination or agreement, whenever
12 issued or entered.

13 **SECTION 79.** If any provision of this chapter or its application to any person or circum-
14 stance is held invalid, the invalidity does not affect other provisions or applications of this
15 chapter that can be given effect without the invalid provision or application, and to this end
16 the provisions of this chapter are severable.

6 must contain a separate section clearly labeled as a money award. Any judgment in a civil action
