# Senate Bill 604

Sponsored by COMMITTEE ON JUDICIARY

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Repeals former provisions of Uniform Interstate Family Support Act. Incorporates most recent version of federal Uniform Interstate Family Support Act into Oregon law.

12	SECTION 1. Sections 2 to 79 of this 2015 Act are added to and made a part of ORS
13	chapter 110.

15	UNIFORM INTERSTATE FAMILY SUPPORT ACT
16	ARTICLE 1
17	(General Provisions)
18	
19	SECTION 2. This chapter may be cited as the Uniform Interstate Family Support Act.
20	SECTION 3. As used in this chapter:
21	(1) "Child" means an individual, whether over or under the age of majority, who is or is
22	alleged to be owed a duty of support by the individual's parent or who is or is alleged to be
23	the beneficiary of a support order directed to the parent.
24	(2) "Child support order" means a support order for a child, including a child who has
25	attained the age of majority under the law of the issuing state or foreign country.
26	(3) "Convention" means the Convention on the International Recovery of Child Support
27	and Other Forms of Family Maintenance, concluded at The Hague on November 23, 2007.
28	(4) "Duty of support" means an obligation imposed or imposable by law to provide support
29	for a child, spouse or former spouse, including an unsatisfied obligation to provide support.
30	(5) "Foreign country" means a country, or a political subdivision of a country, other than
31	the United States, that authorizes the issuance of support orders and:

1 (a) That has been declared under the law of the United States to be a foreign 2 reciprocating country;

3 (b) That has established a reciprocal arrangement for child support with this state as
4 provided in section 25 of this 2015 Act;

5 (c) That has enacted a law or established procedures for the issuance and enforcement 6 of support orders that are substantially similar to the procedures under this chapter; or

(d) In which the Convention is in force with respect to the United States.

7 8

(6) "Foreign support order" means a support order of a foreign tribunal.

9 (7) "Foreign tribunal" means a court, administrative agency or quasi-judicial entity of a 10 foreign country that is authorized to establish, enforce or modify support orders or to de-11 termine parentage of a child. "Foreign tribunal" includes a competent authority under the 12 Convention.

(8) "Home state" means the state or foreign country in which a child lived with a parent or a person acting as parent for at least six consecutive months immediately preceding the time of filing of a petition or comparable pleading for support and, if a child is less than six months old, the state or foreign country in which the child lived from birth with the parent or person acting as parent. A period of temporary absence of the child, parent or person acting as parent is counted as part of the six-month or other period.

(9) "Income" includes earnings or other periodic entitlements to money from any source
 and any other property subject to withholding for support under the law of this state.

(10) "Income withholding order" means an order or other legal process directed to an
obligor's employer or other debtor issued pursuant to ORS 25.372 to 25.427 to withhold support from the income of the obligor.

(11) "Initiating tribunal" means the tribunal of a state or foreign country from which a
petition or comparable pleading is forwarded or in which a petition or comparable pleading
is filed for forwarding to another state or foreign country.

(12) "Issuing foreign country" means the foreign country in which a tribunal issues a
 support order or a judgment determining parentage of a child.

(13) "Issuing state" means the state in which a tribunal issues a support order or a
 judgment determining parentage of a child.

(14) "Issuing tribunal" means the tribunal of a state or foreign country that issues a
 support order or a judgment determining parentage of a child.

(15) "Law" includes decisional and statutory law and rules and regulations having the
 force of law.

35 (16) "Obligee" means:

(a) An individual to whom a duty of support is or is alleged to be owed or in whose favor
 a support order or a judgment determining parentage of a child has been issued;

(b) A foreign country, state or political subdivision of a state to which the rights under
 a duty of support or support order have been assigned or which has independent claims based
 on financial assistance provided to an individual obligee in place of child support;

41 (c) An individual seeking a judgment determining parentage of the individual's child; or

42 (d) A person that is a creditor in a proceeding under sections 62 to 74 of this 2015 Act.

43 (17) "Obligor" means an individual, or the estate of a decedent, that:

44 (a) Owes or is alleged to owe a duty of support;

45 (b) Is alleged but has not been adjudicated to be a parent of a child;

(c) Is liable under a support order; or 1 2 (d) Is a debtor in a proceeding under sections 62 to 74 of this 2015 Act. (18) "Outside this state" means a location in another state or a country other than the 3 United States, whether or not the country is a foreign country. 4  $\mathbf{5}$ (19) "Person" means an individual, corporation, business trust, estate, trust, partnership, limited liability company, association, joint venture, public corporation, government, gov-6 ernmental subdivision, agency, instrumentality or any other legal or commercial entity. 7 (20) "Record" means information that is inscribed on a tangible medium or that is stored 8 9 in an electronic or other medium and is retrievable in perceivable form. (21) "Register" means to file in a tribunal of this state a support order or judgment de-10 termining parentage of a child issued in another state or a foreign country. 11 12(22) "Registering tribunal" means a tribunal in which a support order or judgment determining parentage of a child is registered. 13 (23) "Responding state" means a state in which a petition or comparable pleading for 14 15 support or to determine parentage of a child is filed or to which a petition or comparable pleading is forwarded for filing from another state or a foreign country. 16 (24) "Responding tribunal" means the authorized tribunal in a responding state or foreign 1718 country. 19 (25) "Spousal support order" means a support order for a spouse or former spouse of the 20obligor. (26) "State" means a state of the United States, the District of Columbia, Puerto Rico, 2122the United States Virgin Islands, any territory or insular possession under the jurisdiction 23of the United States or an Indian nation or tribe. (27) "Support enforcement agency" means a public official, governmental entity or pri-94 vate agency authorized to: 25(a) Seek enforcement of support orders or laws relating to the duty of support; 2627(b) Seek establishment or modification of child support; (c) Request determination of parentage of a child; 28(d) Attempt to locate obligors or their assets; or 2930 (e) Request determination of the controlling child support order. 31 (28) "Support order" means a judgment, decree, order, decision or directive, whether temporary, final or subject to modification, issued in a state or foreign country for the ben-32efit of a child, a spouse or a former spouse, that provides for monetary support, health care, 33 34 arrearages, retroactive support or reimbursement for financial assistance provided to an 35individual obligee in place of child support. The term may include related costs and fees, interest, income withholding, automatic adjustment, reasonable attorney fees and other relief. 36 37 (29) "Tribunal" means a court, administrative agency or quasi-judicial entity authorized 38 to establish, enforce or modify support orders or to determine parentage of a child. SECTION 4. The tribunals of this state are the circuit court, the administrator as defined 39 40 in ORS 25.010, the Department of Justice or an administrative law judge of the Employment Department, as appropriate. 41 SECTION 5. (1) Remedies provided by this chapter are cumulative and do not affect the 42 availability of remedies under other law or the recognition of a foreign support order on the 43 basis of comity. 44 (2) This chapter does not: 45

(a) Provide the exclusive method of establishing or enforcing a support order under the 1 2 law of this state; or (b) Grant a tribunal of this state jurisdiction to render judgment or issue an order re-3 lating to child custody or visitation in a proceeding under this chapter. 4 SECTION 6. (1) A tribunal of this state shall apply sections 2 to 61 of this 2015 Act and, 5 as applicable, sections 62 to 74 of this 2015 Act to a support proceeding involving: 6 (a) A foreign support order; 7 (b) A foreign tribunal; or 8 9 (c) An obligee, obligor or child residing in a foreign country. (2) A tribunal of this state that is requested to recognize and enforce a support order on 10 the basis of comity may apply the procedural and substantive provisions of sections 2 to 61 11 12of this 2015 Act. 13 (3) Sections 62 to 74 of this 2015 Act apply only to a support proceeding under the Convention. (1) In a proceeding to establish or enforce a support order or to determine 20parentage of a child, a tribunal of this state may exercise personal jurisdiction over a non-2122resident individual or the individual's guardian or conservator if: 23(a) The individual is personally served with notice within this state; (b) The individual submits to the jurisdiction of this state by consent in a record, by en-94 tering a general appearance or by filing a responsive document having the effect of waiving 25any contest to personal jurisdiction; 2627(c) The individual resided with the child in this state; (d) The individual resided in this state and provided prenatal expenses or support for the 28 child; 2930 (e) The child resides in this state as a result of the acts or directives of the individual; 31 (f) The individual engaged in sexual intercourse in this state and the child may have been conceived by that act of intercourse; 32(g) The individual asserted parentage of a child in the registry maintained in this state 33 34 by the Center for Health Statistics of the Oregon Health Authority by filing a voluntary acknowledgment of paternity under ORS 109.070; or 35(h) There is any other basis consistent with the Constitutions of the State of Oregon and 36 37 the United States for the exercise of personal jurisdiction. 38 (2) The bases of personal jurisdiction set forth in subsection (1) of this section or in any other law of this state may not be used to acquire personal jurisdiction for a tribunal of this 39 state to modify a child support order of another state unless the requirements of section 56 40 of this 2015 Act are met or, in the case of a foreign support order, unless the requirements 41 of section 60 of this 2015 Act are met. 42 SECTION 8. Personal jurisdiction acquired by a tribunal of this state in a proceeding 43 under this chapter or other law of this state relating to a support order continues as long 44 as a tribunal of this state has continuing, exclusive jurisdiction to modify its order or con-45

tinuing jurisdiction to enforce its order as provided by sections 11, 12 and 17 of this 2015 Act. 1  $\mathbf{2}$ SECTION 9. Under this chapter, a tribunal of this state may serve as an initiating tribunal to forward proceedings to a tribunal of another state, and as a responding tribunal 3 for proceedings initiated in another state or a foreign country. 4 SECTION 10. (1) A tribunal of this state that has issued a child support order consistent with the law of this state has and shall exercise continuing, exclusive jurisdiction to modify 23its child support order if the order is the controlling order and: 24 (a) At the time of the filing of a request for modification, this state is the residence of 25the obligor, the individual obligee or the child for whose benefit the support order is issued; 2627or (b) Even if this state is not the residence of the obligor, the individual obligee or the child 28for whose benefit the support order is issued, the parties consent in a record or in open court 2930 that the tribunal of this state may continue to exercise jurisdiction to modify its order. 31 (2) A tribunal of this state that has issued a child support order consistent with the law of this state may not exercise continuing, exclusive jurisdiction to modify the order if: 32(a) All of the parties who are individuals file consent in a record with the tribunal of this 33 34 state that a tribunal of another state that has jurisdiction over at least one of the parties 35who is an individual or that is located in the state of residence of the child may modify the order and assume continuing, exclusive jurisdiction; or 36 37 (b) The tribunal's order is not the controlling order. 38 (3) If a tribunal of another state has issued a child support order pursuant to the Uniform Interstate Family Support Act or a law substantially similar to that Act which modifies 39 a child support order of a tribunal of this state, tribunals of this state shall recognize the 40 continuing, exclusive jurisdiction of the tribunal of the other state. 41 42

(4) A tribunal of this state that lacks continuing, exclusive jurisdiction to modify a child
support order may serve as an initiating tribunal to request a tribunal of another state to
modify a support order issued in that state.

(5) A temporary support order issued ex parte or pending resolution of a jurisdictional

1 conflict does not create continuing, exclusive jurisdiction in the issuing tribunal.

2 <u>SECTION 12.</u> (1) A tribunal of this state that has issued a child support order consistent 3 with the law of this state may serve as an initiating tribunal to request a tribunal of another 4 state to enforce:

(a) The order if the order is the controlling order and has not been modified by a tribunal
of another state that assumed jurisdiction pursuant to the Uniform Interstate Family Support Act; or

(b) A money judgment for arrears of support and interest on the order accrued before a
 determination that an order of a tribunal of another state is the controlling order.

(2) A tribunal of this state having continuing jurisdiction over a support order may act
 as a responding tribunal to enforce the order.

12 <u>SECTION 13.</u> (1) If a proceeding is brought under this chapter and only one tribunal has 13 issued a child support order, the order of that tribunal controls and must be recognized.

(2) If a proceeding is brought under this chapter and two or more child support orders have been issued by tribunals of this state, another state or a foreign country with regard to the same obligor and same child, a tribunal of this state having personal jurisdiction over both the obligor and individual obligee shall apply the following rules and by order shall determine which order controls and must be recognized:

(a) If only one of the tribunals would have continuing, exclusive jurisdiction under this
 chapter the order of that tribunal controls.

(b) If more than one of the tribunals would have continuing, exclusive jurisdiction under
 this chapter:

(A) An order issued by a tribunal in the current home state of the child controls; or

(B) If an order has not been issued in the current home state of the child, the order most
 recently issued controls.

(c) If none of the tribunals would have continuing, exclusive jurisdiction under this
 chapter, the tribunal of this state shall issue a child support order, which controls.

(3) If two or more child support orders have been issued for the same obligor and same
child, upon request of a party who is an individual or that is a support enforcement agency,
a tribunal of this state having personal jurisdiction over both the obligor and the obligee who
is an individual shall determine which order controls under subsection (2) of this section. The
request may be filed with a registration for enforcement or registration for modification
pursuant to sections 46 to 61 of this 2015 Act or may be filed as a separate proceeding.

(4) A request to determine which is the controlling order must be accompanied by a copy
 of every child support order in effect and the applicable record of payments. The requesting
 party shall give notice of the request to each party whose rights may be affected by the de termination.

(5) The tribunal that issued the controlling order under subsection (1), (2) or (3) of this
section has continuing jurisdiction to the extent provided in section 11 or 12 of this 2015 Act.
(6) A tribunal of this state that determines by order which is the controlling order under

subsection (2)(a) or (b) or (3) of this section or that issues a new controlling order under subsection (2)(c) of this section shall state in that order:

43 (a) The basis upon which the tribunal made its determination;

44 (b) The amount of prospective support, if any; and

45 (c) The total amount of consolidated arrears and accrued interest, if any, under all of the

1 orders after all payments made are credited as provided by section 15 of this 2015 Act.

(7) Within 30 days after issuance of an order determining which is the controlling order, the party obtaining the order shall file a certified copy of it in each tribunal that issued or registered an earlier order of child support. A party or support enforcement agency obtaining the order that fails to file a certified copy is subject to appropriate sanctions by a tribunal in which the issue of failure to file arises. The failure to file does not affect the validity or enforceability of the controlling order.

8 (8) An order that has been determined to be the controlling order, or a judgment for 9 consolidated arrears of support and interest, if any, made pursuant to this section must be 10 recognized in proceedings under this chapter.

SECTION 14. In responding to registrations or petitions for enforcement of two or more child support orders in effect at the same time with regard to the same obligor and different individual obligees, at least one of which was issued by a tribunal of another state or a foreign country, a tribunal of this state shall enforce those orders in the same manner as if the orders had been issued by a tribunal of this state.

16 <u>SECTION 15.</u> A tribunal of this state shall credit amounts collected for a particular pe-17 riod pursuant to any child support order against the amounts owed for the same period un-18 der any other child support order for support of the same child issued by a tribunal of this 19 state, another state or a foreign country.

<u>SECTION 16.</u> A tribunal of this state exercising personal jurisdiction over a nonresident in a proceeding under this chapter, under other law of this state relating to a support order or recognizing a foreign support order may receive evidence from outside this state pursuant to section 33 of this 2015 Act, communicate with a tribunal outside this state pursuant to section 34 of this 2015 Act and obtain discovery through a tribunal outside this state pursuant to section 35 of this 2015 Act. In all other respects, sections 18 to 61 of this 2015 Act do not apply and the tribunal shall apply the procedural and substantive law of this state.

27 <u>SECTION 17.</u> (1) A tribunal of this state issuing a spousal support order consistent with 28 the law of this state has continuing, exclusive jurisdiction to modify the spousal support or-29 der throughout the existence of the support obligation.

(2) A tribunal of this state may not modify a spousal support order issued by a tribunal
 of another state or a foreign country having continuing, exclusive jurisdiction over that or der under the law of that state or foreign country.

(3) A tribunal of this state that has continuing, exclusive jurisdiction over a spousal
 support order may serve as:

(a) An initiating tribunal to request a tribunal of another state to enforce the spousal
 support order issued in this state; or

(b) A responding tribunal to enforce or modify its own spousal support order.

**ARTICLE 3** 

(Civil Provisions of General Application)

42 <u>SECTION 18.</u> (1) Except as otherwise provided in this chapter, sections 18 to 36 of this 43 2015 Act apply to all proceedings under this chapter.

44 (2) An individual petitioner or a support enforcement agency may initiate a proceeding
 45 authorized under this chapter by filing a petition in an initiating tribunal for forwarding to

a responding tribunal or by filing a petition or a comparable pleading directly in a tribunal 1 2 of another state or a foreign country that has or can obtain personal jurisdiction over the respondent. 3 SECTION 19. A minor parent, or a guardian or other legal representative of a minor 4 parent, may maintain a proceeding on behalf of or for the benefit of the minor's child.  $\mathbf{5}$ SECTION 20. Except as otherwise provided in this chapter, a responding tribunal of this 6 state shall: 7 (1) Apply the procedural and substantive law generally applicable to similar proceedings 8 9 originating in this state and may exercise all powers and provide all remedies available in 10 those proceedings; and (2) Determine the duty of support and the amount payable in accordance with the law 11 12and support guidelines of this state. 13 SECTION 21. tems for criminal warrants; (i) Order the obligor to seek appropriate employment by specified methods; (k) Award reasonable attorney fees and other fees and costs; and (L) Grant any other available remedy. (3) A responding tribunal of this state shall include in a support order issued under this chapter, or in the documents accompanying the order, the calculations on which the support order is based. (4) A responding tribunal of this state may not condition the payment of a support order issued under this chapter upon compliance by a party with provisions for visitation. (5) If a responding tribunal of this state issues an order under this chapter, the tribunal shall send a copy of the order to the petitioner and the respondent and to the initiating tribunal, if any. (6) If requested to enforce a support order, arrears or judgment or to modify a support order stated in a foreign currency, a responding tribunal of this state shall convert the amount stated in the foreign currency to the equivalent amount in dollars under the applicable official or market exchange rate as publicly reported. SECTION 23. If a petition or comparable pleading is received by an inappropriate tribunal of this state, the tribunal shall forward the pleading and accompanying documents to an appropriate tribunal of this state or another state and notify the petitioner where and when the pleading was sent. SECTION 24. (1) A support enforcement agency of this state, upon request, shall provide services to a petitioner in a proceeding under this chapter. (2) A support enforcement agency of this state that is providing services to the petitioner (a) Take all steps necessary to enable an appropriate tribunal of this state, another state or a foreign country to obtain jurisdiction over the respondent; (b) Request an appropriate tribunal to set a date, time and place for a hearing; (c) Make a reasonable effort to obtain all relevant information, including information as to income and property of the parties; (d) Within two days, exclusive of Saturdays, Sundays and legal holidays, after receipt of notice in a record from an initiating, responding or registering tribunal, send a copy of the notice to the petitioner; (e) Within two days, exclusive of Saturdays, Sundays and legal holidays, after receipt of communication in a record from the respondent or the respondent's attorney, send a copy of the communication to the petitioner; and (f) Notify the petitioner if jurisdiction over the respondent cannot be obtained. (3) A support enforcement agency of this state that requests registration of a child support order in this state for enforcement or for modification shall make reasonable efforts:

(a) To ensure that the order to be registered is the controlling order; or

(b) If two or more child support orders exist and the identity of the controlling order has 41 not been determined, to ensure that a request for such a determination is made in a tribunal 42 having jurisdiction to do so. 43

(4) A support enforcement agency of this state that requests registration and enforce-44 ment of a support order, arrears or judgment stated in a foreign currency shall convert the 45

(6) This chapter does not create or negate a relationship of attorney and client or other
fiduciary relationship between a support enforcement agency or the attorney for the agency
and the individual being assisted by the agency.

10 <u>SECTION 25.</u> (1) If the appropriate state official or agency determines that the support 11 enforcement agency is neglecting or refusing to provide services to an individual, the state 12 official or agency may order the agency to perform its duties under this chapter or may 13 provide those services directly to the individual.

(2) The appropriate state official or agency may determine that a foreign country has
 established a reciprocal arrangement for child support with this state and take appropriate
 action for notification of the determination.

17 <u>SECTION 26.</u> An individual may employ private counsel to represent the individual in

<u>SECTION 27.</u> (1) The Attorney General's office is the state information agency under this

(2) The state information agency shall:

(a) Compile and maintain a current list, including addresses, of the tribunals in this state

and transmit a copy to the state information agency of every other state;

(b) Maintain a register of names and addresses of tribunals and support enforcement
 agencies received from other states;

(c) Forward to the appropriate tribunal in the county in this state in which the obligee

25 <u>SECTION 31.</u> (1) Participation by a petitioner in a proceeding under this chapter before 26 a responding tribunal, whether in person, by private attorney or through services provided 27 by the support enforcement agency, does not confer personal jurisdiction over the petitioner 28 in another proceeding.

(2) A petitioner is not amenable to service of civil process while physically present in this
 state to participate in a proceeding under this chapter.

(3) The immunity granted by this section does not extend to civil litigation based on acts
 unrelated to a proceeding under this chapter committed by a party while physically present
 in this state to participate in the proceeding.

34 <u>SECTION 32.</u> A party whose parentage of a child has been previously determined by or
 35 pursuant to law may not plead nonparentage as a defense to a proceeding under this chapter.

 establish parentage of the child.
