## SENATE AMENDMENTS TO SENATE BILL 612

1	In line 2 of the printed bill, after "dyslexia" insert "; creating new provisions; amending ORS
2	342.950; and declaring an emergency".
3	Delete lines 4 through 26 and insert:
4	" <u>SECTION 1.</u> The Department of Education shall designate a dyslexia specialist for the
5	department to provide school districts with support and resources that are necessary to as-
6	sist students with dyslexia and their families.
7	" <u>SECTION 2.</u> (1) The Department of Education shall develop a plan to:
8	"(a) Ensure that every student who is first enrolled at a public school in this state for
9	kindergarten or first grade receives a screening for risk factors of dyslexia; and
10	"(b) Provide guidance for notifications sent by school districts to parents of students who
11	are identified as being at risk for dyslexia based on a screening of risk factors.
12	"(2) The plan required under subsection (1) of this section must be developed
13	collaboratively with experts on dyslexia, including representatives of nonprofit entities with
14	expertise in issues related to dyslexia and the dyslexia specialist for the department.
15	"(3) When developing the plan required under subsection (1) of this section, the depart-
16	ment shall identify screening tests that are cost effective and that screen for the following
17	factors:
18	"(a) Phonological awareness;
19	"(b) Rapid naming skills;
20	"(c) The correspondence between sounds and letters; and
21	"(d) Family history of difficulty in learning to read.
22	"(4) The department shall submit a report on the plan required under subsection (1) of
23	this section, and any proposed legislation, to the interim legislative committees on education
24	no later than September 15, 2016.
25	"SECTION 3. Section 2 of this 2015 Act is repealed on December 31, 2016.
26	"SECTION 4. Section 1 of this 2015 Act is amended to read:
27	"Sec. 1. (1) The Department of Education shall designate a dyslexia specialist for the depart-
28	ment to provide school districts with support and resources that are necessary to:
29	"(a) Assist students with dyslexia and their families[.]; and
30	"(b) Comply with the requirements of this section.
31	"(2) Each school district shall ensure that at least one kindergarten through grade five
32	teacher in each kindergarten through grade five school has received training related to
33	dyslexia.
34	"(3) The training required under this section must:
35	"(a) Comply with the knowledge and practice standards of an international organization

1 on dyslexia;

"(b) Enable the teacher to understand and recognize dyslexia; and

"(c) Enable the teacher to implement instruction that is systematic, explicit and
evidence-based to meet the educational needs of students with dyslexia.

5 "(4) The department shall annually develop a list of training opportunities that satisfy the 6 requirements described in subsection (3) of this section. The list must:

"(a) Be developed in collaboration with the Teacher Standards and Practices Commission
to ensure that the training opportunities also satisfy professional development requirements;
and

"(b) Include at least one opportunity that is provided entirely online.

"(5)(a) A school district that does not comply with the requirements of this section and
 that does not secure a waiver from the department within the time required by the State
 Board of Education by rule is considered nonstandard under ORS 327.103.

14 "(b) The board shall adopt by rule the criteria for a waiver from the requirements of this 15 section to address instances when noncompliance is outside the control of the school district.

"<u>SECTION 5.</u> (1) The amendments to section 1 of this 2015 Act by section 4 of this 2015
 Act become operative on July 1, 2017.

(2) The requirements of the amendments to section 1 of this 2015 Act by section 4 of this
 2015 Act first apply to the 2017-2018 school year.

Any rules adopted by the 9 10 State Board of Education must be consistent with this section and with actions taken by the Oregon 11 Education Investment Board to implement this section.

44 Any rules adopted by the State Board of Education must be consistent with this section.

45 "SECTION 8. This 2015 Act being necessary for the immediate preservation of the public

- 1 peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect
- 2 on its passage.".
