

# Senate Bill 663

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes governmental framework for conducting public health activities in this state and for providing public health services to residents of this state.

Provides mechanism by which local health departments may implement provisions of Act separately and at different times.

Becomes operative January 1, 2016.

Declares emergency, effective on passage.

12 **Be It Enacted by the People of the State of Oregon:**

## FINDINGS

13  
14  
15  
16 **SECTION 1. The Legislative Assembly of the State of Oregon finds and declares that:**

17 (1) **Each resident of this state is entitled to the basic public health services that are**  
18 **necessary to preserve life and health;**

19 (2) **A framework for public health services provided by the government is necessary for**  
20 **applying the foundational capabilities and implementing the foundational programs by which**  
21 **the state or a local government may assess, protect or improve the health of the residents**  
22 **of this state; and**

23 (3) **The purpose of sections 10 to 24 of this 2015 Act is to provide the framework described**  
24 **in subsection (2) of this section.**

## DEFINITIONS

25  
26  
27  
28 **SECTION 2. As used in sections 10 to 24 of this 2015 Act:**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (1) “Foundational capability” means the knowledge, skill or ability that is necessary to  
 2 carry out a public health activity.

3 (2) “Foundational program” means a public health program that is necessary to assess,  
 4 protect or improve the health of the residents of this state.

5 (3) “Governing body of a local public health authority” means a board described in ORS  
 6 431.410 or 431.414 (2) or established under ORS 431.412 or 431.414 (3).

7 (4)(a) “Local health department” means the agency established by the local public health  
 8 authority that is responsible for administering public health programs and public health ac-  
 9 tivities within the local public health authority’s jurisdiction.

10 (b) “Local health department” includes a person that has contracted with a county or  
 11 health district formed under ORS 431.414 to perform a duty of the county or health district  
 12 under sections 10 to 24 of this 2015 Act or any other public health law of this state.

13 (5) “Local health officer” means:

14 (a) A local public health administrator appointed under ORS 431.418; or

15 (b) If the local public health administrator appointed under ORS 431.418 is not a physician  
 16 licensed by the Oregon Medical Board, the physician who is employed by or who enters a  
 17 contract with a local public health administrator under ORS 431.418.

18 (6) “Local public health administrator” means an individual appointed under ORS 431.418  
 19 to supervise the public health programs and public health activities of a local health depart-  
 20 ment.

21 (7)(a) “Local public health authority” means:

22 (A) A county; or

23 (B) A health district formed under ORS 431.414.

24 (b) “Local public health authority” includes a person that has contracted with a county  
 25 or health district formed under ORS 431.414 to perform a duty of the county or health dis-  
 26 trict under sections 10 to 24 of this 2015 Act or any other public health law of this state.

27  
 28 **DUTIES OF THE OREGON HEALTH AUTHORITY**

29  
 30 **SECTION 3.** (1) Sections 1, 2 and 5 of this 2015 Act are added to and made a part of  
 31 sections 10 to 24 of this 2015 Act.

32 (2) ORS 431.110 is added to and made a part of sections 10 to 24 of this 2015 Act.

33 **SECTION 4.** ORS 431.110 is amended to read:

34 431.110. [*Subject to ORS 417.300 and 417.305,*] The Oregon Health Authority shall:

35 (1) Have direct supervision of all matters relating to the preservation of life and health of the  
 36 people of [*the*] **this** state.

37 [*(2) Keep the vital statistics and other health related statistics of the state.*]

38 (2) **Ensure the statewide and local application of the foundational capabilities established**  
 39 **under section 10 of this 2015 Act and described in sections 11, 12, 13, 14, 15 and 16 of this 2015**  
 40 **Act.**

41 (3) **At the state level of governance, administer the foundational programs established**  
 42 **under section 17 of this 2015 Act and described in sections 18, 19, 20 and 21 of this 2015 Act.**

43 (4) **At the local level of governance, oversee and provide support for the implementation**  
 44 **of the foundational programs established under section 17 of this 2015 Act and described in**  
 45 **sections 18, 19, 20 and 21 of this 2015 Act.**

1 [(3)] (5) [*Make*] **Conduct** sanitary surveys **about** and investigations [*and inquiries respecting*] **on**  
2 the causes and prevention of diseases[, *especially of epidemics*].

3 [(4)] (6) Investigate, conduct hearings and issue findings in connection with annexations pro-  
4 posed by cities as provided in ORS 222.840 to 222.915 **and 431.705 to 431.760**.

5 [(5)] (7) Have full power in the control of all communicable diseases.

6 [(6)] (8) Have **the** authority to send a representative of the authority to any part of the state  
7 [*when deemed necessary*].

8 [(7)] (9) From time to time, publish and distribute to the public [*in such form as the authority*  
9 *determines, such information as in its judgment may be useful in carrying on the work or purposes for*  
10 *which the authority was established*] **information related to the functions and duties of the au-**  
11 **thority.**

12 **SECTION 5. (1) For the purpose of fulfilling its duties under ORS 431.110 (2), (3) and (4),**  
13 **the Oregon Health Authority shall:**

14 (a) **Adopt and update as necessary a statewide community health assessment;**

15 (b) **In consideration of the statewide community health assessment, develop and modify**  
16 **as necessary a statewide community health improvement plan;**

17 (c) **Implement the statewide community health improvement plan;**

18 (d) **Subject to the provisions of ORS 431.380, develop and modify as necessary plans for**  
19 **the distribution of funds to local public health authorities;**

20 (e) **Implement plans for the distribution of funds to local public health authorities;**

21 (f) **Coordinate state and local administration of the foundational programs established**  
22 **under section 17 of this 2015 Act;**

23 (g) **Approve local plans for applying the foundational capabilities established under sec-**  
24 **tion 10 of this 2015 Act and implementing the foundational programs established under sec-**  
25 **tion 17 of this 2015 Act as required by ORS 431.385;**

26 (h) **Monitor the progress of local health departments in meeting statewide public health**  
27 **goals, including applying the foundational capabilities established under section 10 of this**  
28 **2015 Act and implementing the foundational programs established under section 17 of this**  
29 **2015 Act;**

30 (i) **Use incentives adopted under ORS 431.380 to encourage the effective and equitable**  
31 **provision of public health services by local health departments;**

32 (j) **Seek funding, including in the form of federal grants, for sections 10 to 24 of this 2015**  
33 **Act; and**

34 (k) **Coordinate and collaborate with federal agencies in implementing sections 10 to 24**  
35 **of this 2015 Act.**

36 (2) **The Oregon Health Authority shall solicit input from the Conference of Local Health**  
37 **Officials and local health departments in:**

38 (a) **Adopting and updating a statewide community health assessment under subsection**  
39 **(1)(a) of this section;**

40 (b) **Developing and modifying a statewide community health improvement plan under**  
41 **subsection (1)(b) of this section; and**

42 (c) **Developing and modifying plans for the distribution of funds under subsection (1)(d)**  
43 **of this section.**

1       **SECTION 6. (1) ORS 431.195 is added to and made a part of sections 10 to 24 of this 2015**  
 2 **Act.**

3       **(2) Section 9 of this 2015 Act is added to and made a part of sections 10 to 24 of this 2015**  
 4 **Act.**

5       **SECTION 7.** ORS 431.195 is amended to read:

6       431.195. *[(1) There is established the Oregon Public Health Advisory Board to serve as an advisory*  
 7 *body to the Oregon Health Authority.]*

8       *[(2) The members of the board shall be residents of this state and shall be appointed by the Gov-*  
 9 *ernor. The board shall consist of 15 members at least one-half of whom shall be public members*  
 10 *broadly representing the state as a whole and the others to include representatives of local government*  
 11 *and public and private health providers.]*

12       *[(3) The board shall:]*

13       *[(a) Advise the authority on policy matters related to public health programs.]*

14       *[(b) Provide a review of statewide public health issues and make recommendations to the*  
 15 *authority.]*

16       *[(c) Participate in public health policy development.]*

17       *[(4) Members shall be appointed for four-year terms. No person shall serve more than two consec-*  
 18 *utive terms.]*

19       *[(5) The board shall meet at least quarterly.]*

20       *[(6) Members of the board shall be entitled to compensation and expenses as provided in ORS*  
 21 *292.495.]*

22       *[(7) Vacancies on the board shall be filled by appointments of the Governor for the unexpired*  
 23 *term.]*

24       **(1)(a) The Oregon Public Health Advisory Board is established within the Oregon Health**  
 25 **Authority, consisting of:**

26       **(A) 13 members appointed by the Governor;**

27       **(B) The Public Health Director or the Public Health Director's designee;**

28       **(C) If the Public Health Director is not the State Health Officer, the State Health Officer**  
 29 **or the State Health Officer's designee; and**

30       **(D) If the Public Health Director is the State Health Officer, a representative from the**  
 31 **authority familiar with public health programs and public health activities in this state.**

32       **(b) The Governor shall appoint at least one of each of the following individuals to the**  
 33 **board:**

34       **(A) A state employee who has technical expertise in the field of public health;**

35       **(B) A local public health administrator;**

36       **(C) A local health officer who is not a local public health administrator;**

37       **(D) An individual who represents the Conference of Local Health Officials created under**  
 38 **ORS 431.330;**

39       **(E) An individual who represents coordinated care organizations;**

40       **(F) An individual who represents health care organizations that are not coordinated care**  
 41 **organizations;**

42       **(G) An individual who represents individuals who provide public health services directly**  
 43 **to the public;**

44       **(H) An expert in the field of public health who has a background in academia;**

45       **(I) An expert in population health metrics; and**

1 (J) Four at-large members.

2 (2)(a) The term of office for a board member appointed under this section is four years,  
 3 but a member serves at the pleasure of the Governor. Before the expiration of the term of  
 4 a member, the Governor shall appoint a successor whose term begins on January 1 next  
 5 following. A member is eligible for reappointment. If there is a vacancy for any cause, the  
 6 Governor shall make an appointment to become immediately effective for the unexpired  
 7 term.

8 (b) Members of the board described in subsection (1)(a)(B) and (C) of this section are  
 9 nonvoting ex officio members of the board.

10 (3) A majority of the voting members of the board constitutes a quorum for the trans-  
 11 action of business.

12 (4) Official action by the board requires the approval of a majority of the voting members  
 13 of the board.

14 (5) The board shall elect one of its voting members to serve as chairperson.

15 (6) The board shall meet at times and places specified by the call of the chairperson or  
 16 of a majority of the voting members of the board.

17 (7) The board may adopt rules necessary for the operation of the board.

18 (8) The board may establish committees and subcommittees necessary for the operation  
 19 of the board.

20 (9) Voting members of the board are entitled to compensation and expenses as provided  
 21 in ORS 292.495.

22 **SECTION 8.** The term of membership for a person who is a member of the Oregon Public  
 23 Health Advisory Board immediately before the operative date specified in section 116 of this  
 24 2015 Act expires on the operative date specified in section 116 of this 2015 Act. A member  
 25 whose term expires under this section is eligible for reappointment. Of the members first  
 26 appointed to the board on or after the operative date specified in section 116 of this 2015 Act:

27 (1) Four shall serve for terms ending January 1, 2017.

28 (2) Three shall serve for terms ending January 1, 2018.

29 (3) Three shall serve for terms ending January 1, 2019.

30 (4) Three shall serve for terms ending January 1, 2020.

31 **SECTION 9.** The Oregon Public Health Advisory Board shall:

32 (1) Advise the Director of the Oregon Health Authority on the development of statewide  
 33 public health policies and goals;

34 (2) Advise the director on how other statewide priorities, such as the provision of early  
 35 learning services and the delivery of health care services, affect and are affected by state-  
 36 wide public health policies and goals;

37 (3) Advise the Oregon Health Authority on the establishment of the foundational capa-  
 38 bilities under section 10 of this 2015 Act, the foundational programs under section 17 of this  
 39 2015 Act and any other public health program or activity under section 22 of this 2015 Act;

40 (4) Advise and provide feedback to the authority on the adoption and updating of the  
 41 statewide community health assessment under section 5 of this 2015 Act;

42 (5) Advise and provide feedback to the authority on the development of and any modifi-  
 43 cation to the statewide community health improvement plan developed under section 5 of  
 44 this 2015 Act;

45 (6) Advise and provide feedback to the authority on the development of and any modifi-

1 cation to plans developed under section 5 of this 2015 Act for the distribution of funds to local  
2 public health authorities;

3 (7) Advise and provide feedback to the Oregon Health Authority on the use of incentives  
4 by the authority under ORS 431.380 and section 5 of this 2015 Act to encourage the effective  
5 and equitable provision of public health services by local health departments;

6 (8) Provide support to local public health authorities in developing local plans to apply the  
7 foundational capabilities established under section 10 of this 2015 Act and implement the  
8 foundational programs established under section 17 of this 2015 Act as required by ORS  
9 431.385;

10 (9) Monitor the progress of local health departments in meeting statewide public health  
11 goals, including employing the foundational capabilities established under section 10 of this  
12 2015 Act and implementing the foundational programs established under section 17 of this  
13 2015 Act;

14 (10) Assist the Oregon Health Authority in seeking funding, including in the form of  
15 federal grants, for sections 10 to 24 of this 2015 Act; and

16 (11) Assist the authority in coordinating and collaborating with federal agencies.

17  
18 **FOUNDATIONAL CAPABILITIES AND PROGRAMS**

19  
20 **SECTION 10.** (1) The Oregon Health Authority, in consideration of any advice provided  
21 by the Oregon Public Health Advisory Board, shall establish by rule the foundational capa-  
22 bilities necessary to protect and improve the health of the residents of this state and to  
23 achieve effective and equitable health outcomes for the residents of this state.

24 (2) At a minimum, the authority shall establish the following foundational capabilities:

25 (a) Assessment and epidemiology, as described in section 11 of this 2015 Act;

26 (b) Emergency preparedness and response, as described in section 12 of this 2015 Act;

27 (c) Communications, policy and planning, as described in section 13 of this 2015 Act;

28 (d) Leadership and organizational competencies, as described in section 14 of this 2015  
29 Act;

30 (e) Health equity and cultural responsiveness, as described in section 15 of this 2015 Act;  
31 and

32 (f) Community partnership development, as described in section 16 of this 2015 Act.

33 **SECTION 11.** (1) For the purpose of establishing the foundational capabilities under sec-  
34 tion 10 of this 2015 Act, assessment and epidemiology include the knowledge, skills and abil-  
35 ities necessary to:

36 (a) Identify and respond to disease outbreaks and epidemics;

37 (b) Analyze and respond to information related to disease outbreaks and epidemics;

38 (c) Conduct and assess surveys about health behaviors and practices;

39 (d) Collect and maintain vital records and statistics;

40 (e) Process data from a variety of sources, including vital records, health records, hos-  
41 pital data, insurance data and indicators of community or environmental health;

42 (f) Analyze key indicators of a community's health;

43 (g) Analyze data related to the causes and burdens of disease, injury, disability and death;

44 (h) Prioritize and respond to requests for data processed and analyzed as described in  
45 this section and communicate the response in a manner that is accurate, statistically valid

1 and usable by the requester;

2 (i) Identify how disease, injury, disability and death disproportionately affect certain  
3 populations, including populations specific to sex, race, ethnicity and socioeconomic status;

4 (j) Conduct a community health assessment and identify priorities arising from that as-  
5 sessment, as required by ORS 431.416 or section 5 of this 2015 Act; and

6 (k) Use relevant data to implement, monitor, evaluate and modify the statewide com-  
7 munity health improvement plan under section 5 of this 2015 Act.

8 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-  
9 tiating between the knowledge, skills and abilities that are necessary for state governance  
10 and that are necessary for local governance.

11 **SECTION 12.** (1) For the purpose of establishing the foundational capabilities under sec-  
12 tion 10 of this 2015 Act, emergency preparedness and response include the knowledge, skills  
13 and abilities necessary to:

14 (a) Develop, exercise, improve and maintain preparedness and response plans in the event  
15 that either a natural or man-made disaster or an emergency occurs;

16 (b) Communicate and coordinate with health care providers, emergency service providers  
17 and other agencies and organizations that respond to disasters and emergencies;

18 (c) Activate emergency response personnel during a disaster or emergency, and recognize  
19 if public health has a primary, secondary or ancillary role in response activities;

20 (d) Use communications systems effectively and efficiently during a disaster or emer-  
21 gency;

22 (e) Maintain and execute a plan providing for continuity of operations during a disaster  
23 or emergency, including a plan for accessing resources necessary to recover from or respond  
24 to a disaster or emergency;

25 (f) Issue and enforce emergency health orders;

26 (g) Be notified of and respond to potential disasters and emergencies; and

27 (h) Address the needs of vulnerable populations during a disaster or emergency.

28 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-  
29 tiating between the knowledge, skills and abilities that are necessary for state governance  
30 and that are necessary for local governance.

31 **SECTION 13.** (1) For the purpose of establishing the foundational capabilities under sec-  
32 tion 10 of this 2015 Act:

33 (a) Communications include the knowledge, skills and abilities necessary to:

34 (A) Engage in two-way communications with the public through the use of a variety of  
35 accessible methods of communication;

36 (B) Effectively use mass media and social media to transmit communications to and re-  
37 ceive communications from the public;

38 (C) Communicate with specific populations in a manner that is culturally and linguis-  
39 tically appropriate;

40 (D) Develop and implement educational programs and preventive strategies; and

41 (E) During a disease outbreak or other disaster or emergency, provide accurate, timely  
42 and understandable information, recommendations and instructions to the public.

43 (b) Policy and planning include the knowledge, skills and abilities necessary to:

44 (A) Enable the Oregon Health Authority and local health departments to serve as a pri-  
45 mary and expert resource for using science and evidence-based best practices to inform the

1 development and implementation of public health policies;

2 (B) Provide guidance and coordinate planning for the purpose of developing, adopting and  
3 implementing public health policies;

4 (C) Develop public health policy options necessary to protect and improve the health of  
5 the public and specific adversely impacted populations;

6 (D) Understand and use the principles of public health law to improve and protect the  
7 health of the public;

8 (E) Analyze and disseminate findings on the intended and unintended impacts of public  
9 health policies; and

10 (F) Implement, monitor, evaluate and modify the statewide community health improve-  
11 ment plan under section 5 of this 2015 Act.

12 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-  
13 tiating between the knowledge, skills and abilities that are necessary for state governance  
14 and that are necessary for local governance.

15 **SECTION 14.** (1) For the purpose of establishing the foundational capabilities under sec-  
16 tion 10 of this 2015 Act, leadership and organizational competencies include the knowledge,  
17 skills and abilities necessary to:

18 (a) Define the strategic direction necessary to achieve public health goals and align and  
19 lead stakeholders in achieving those goals;

20 (b) Use the principles of public health law, including relevant agency rules and the con-  
21 stitutional guarantee of due process, in planning, implementing and enforcing public health  
22 initiatives;

23 (c) Promote and monitor organizational objectives while sustaining a culture of quality  
24 of service;

25 (d) Maintain a competent workforce necessary to ensure the effective and equitable pro-  
26 vision of public health services;

27 (e) Provide continuing education and other training opportunities necessary to maintain  
28 a competent workforce;

29 (f) Develop partnerships with institutions of higher education necessary to maintain a  
30 competent workforce;

31 (g) To the extent practicable, ensure that local public health administrators, local health  
32 officers and individuals who work in the field of public health reflect the demographics of the  
33 community being served and the changing demographics of this state;

34 (h) Implement and maintain the technology needed to support public health operations  
35 while simultaneously protecting personally identifiable information and other confidential  
36 health information; and

37 (i) Use accounting and business best practices in budgeting, tracking finances, billing,  
38 auditing, securing grants and other sources of funding and distributing moneys to govern-  
39 mental and nongovernmental partners.

40 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-  
41 tiating between the knowledge, skills and abilities that are necessary for state governance  
42 and that are necessary for local governance.

43 **SECTION 15.** (1) For the purpose of establishing the foundational capabilities under sec-  
44 tion 10 of this 2015 Act, health equity and cultural responsiveness includes the knowledge,  
45 skills and abilities necessary to:



- 1 (a) Support public health policies that promote health equity;
- 2 (b) Implement processes within public health programs that create health equity;
- 3 (c) Recognize and address health inequities that are specific to certain populations, in-
- 4 cluding populations specific to sex, race, ethnicity and socioeconomic status;
- 5 (d) Communicate with the public and stakeholders in a transparent and inclusive manner;
- 6 (e) When appropriate, provide the public and stakeholders with access to the data and
- 7 findings described in section 11 of this 2015 Act; and
- 8 (f) Engage diverse populations in community health planning.

9 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-

10 tiating between the knowledge, skills and abilities that are necessary for state governance

11 and that are necessary for local governance.

12 **SECTION 16.** (1) For the purpose of establishing the foundational capabilities under sec-

13 tion 10 of this 2015 Act, community partnership development includes the knowledge, skills

14 and abilities necessary to:

15 (a) Convene and sustain relationships with traditional and nontraditional governmental

16 partners and stakeholders and traditional and nontraditional nongovernmental partners and

17 stakeholders;

18 (b) Foster and support community involvement and partnerships in developing, adopting

19 and implementing public health policies;

20 (c) Engage members of the community in implementing, monitoring, evaluating and

21 modifying the statewide community health improvement plan under section 5 of this 2015

22 Act; and

23 (d) Develop, strengthen and expand connections across disciplines, such as education and

24 health care, and with members of the community who work in those disciplines.

25 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-

26 tiating between the knowledge, skills and abilities that are necessary for state governance

27 and that are necessary for local governance.

28 **SECTION 17.** (1) The Oregon Health Authority, in consideration of any advice provided

29 by the Oregon Public Health Advisory Board, shall establish by rule the foundational pro-

30 grams through which the authority and local health departments administer public health

31 services in this state.

32 (2) At a minimum, the authority shall establish the following foundational programs:

33 (a) Communicable disease control programs, as described in section 18 of this 2015 Act;

34 (b) Environmental public health programs, as described in section 19 of this 2015 Act;

35 (c) Prevention of injury and disease and promotion of health programs, as described in

36 section 20 of this 2015 Act; and

37 (d) Clinical preventive services, as described in section 21 of this 2015 Act.

38 **SECTION 18.** Communicable disease control programs established under section 10 of this

39 2015 Act must identify, prevent and control infectious diseases that pose a threat to the

40 health of the public and must include:

41 (1) Recognizing, identifying and responding to communicable disease outbreaks;

42 (2) Maintaining a list of communicable diseases;

21 (g) “Public provider” means:

22 (A) The Blue Mountain Recovery Center and the Oregon State Hospital campuses;

23 (B) Department of Corrections institutions as defined in ORS 421.005;

24 (C) A contractor of the Department of Corrections or the Oregon Health Authority that provides  
25 health care to individuals residing in a state institution operated by the agencies;

26 (D) A community mental health program or community developmental disabilities program as  
27 described in ORS 430.610 to 430.695 and the public and private entities with which it contracts to  
28 provide mental health or developmental disabilities programs or services;

29 (E) A program or service provided under ORS 431.250[, 431.375 to 431.385] or 431.416 **or**  
30 **sections 10 to 24 of this 2015 Act;**

31 (F) A program or service established or maintained under ORS 430.630 or 430.664;

32 (G) A program or facility providing an organized full-day or part-day program of treatment that  
33 is licensed, approved, established, maintained or operated by or contracted with the Oregon Health  
34 Authority for alcoholism, drug addiction or mental or emotional disturbance;

39 (h) “Written account” means records containing only individually identifiable health information.

40 (2) Except as provided in subsections (3), (4), (6), (7), (8), (9), (11), (12), (14), (15), (16) and (17) of  
41 this section or unless otherwise permitted or required by state or federal law or by order of the  
42 court, written accounts of the individuals served by any health care services provider maintained  
43 in or by the health care services provider by the officers or employees thereof who are authorized  
44 to maintain written accounts within the official scope of their duties are not subject to access and  
45 may not be disclosed. This subsection applies to written accounts maintained in or by facilities of

1 the Department of Corrections only to the extent that the written accounts concern the medical,  
2 dental or psychiatric treatment as patients of those under the jurisdiction of the Department of  
3 Corrections.

4 (3) If the individual or a personal representative of the individual provides an authorization, the  
5 content of any written account referred to in subsection (2) of this section must be disclosed ac-  
6 cordingly, if the authorization is in writing and is signed and dated by the individual or the personal  
7 representative of the individual and sets forth with specificity the following:

8 (a) Name of the health care services provider authorized to make the disclosure, except when  
9 the authorization is provided by recipients of or applicants for public assistance or medical assist-

12 (b) Name or title of the persons or organizations to which the information is to be disclosed or  
13 that information may be disclosed to the public;

17 that action has been taken in reliance thereon, and a specification of the date, event or condition

5 (B) Visual and aural acuity consistent with the child's age;

7 (D) Effects of rubella, if any;

9 (F) The hereditary or congenital effects of parental use of drugs or controlled substances.

10 (5) Within six months prior to the transfer for adoption of the custody of a child by a child-  
11 caring agency to the prospective adoptive parents of such child, the child-caring agency shall pro-

5 **SECTION 119. This 2015 Act being necessary for the immediate preservation of the public**  
6 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**  
7 **on its passage.**
