10 “**SECTION 1. Definitions. As used in sections 1 to 11 of this 2015 Act:**

11 “(1)(a) ‘Inhalant delivery system’ means:

12 “(A) A device that can be used to deliver nicotine in the form of a vapor or aerosol to a
13 person inhaling from the device; or

14 “(B) A component of a device described in this paragraph or a substance in any form sold
15 for the purpose of being vaporized or aerosolized by a device described in this paragraph,
16 whether the component or substance is sold separately or is not sold separately.

17 “(b) ‘Inhalant delivery system’ does not include:

18 “(A) Any product that has been approved by the United States Food and Drug Adminis-
19 tration for sale as a tobacco cessation product or for any other therapeutic purpose, if the
20 product is marketed and sold solely for the approved purpose; and

21 “(B) Tobacco products.

22 “(2) ‘Tobacco products’ means:

23 “(a) Bidis, cigars, cheroots, stogies, periques, granulated, plug cut, crimp cut, ready
24 rubbed and other smoking tobacco, snuff, snuff flour, cavendish, plug and twist tobacco,
25 fine-cut and other chewing tobaccos, shorts, refuse scraps, clippings, cuttings and sweepings
26 of tobacco and other forms of tobacco, prepared in a manner that makes the tobacco suitable
27 for chewing or smoking in a pipe or otherwise, or for both chewing and smoking; or

28 “(b) Cigarettes as defined in ORS 323.010 (1).

29 “**SECTION 2. Licensure requirement. (1) A person may not make a retail sale of a to-
30 bacco product or an inhalant delivery system in this state unless the person sells the tobacco
31 product or inhalant delivery system at a premises for which a license has been issued under
32 section 4 of this 2015 Act.**

33 “(2) This section does not prohibit the governing body of a local government from
34 adopting additional licensing requirements for the retail sale of tobacco products or inhalant
35 delivery systems, or from adopting ordinances or rules that further restrict the retail sale

1 of tobacco products or inhalant delivery systems.

2 **SECTION 3. Premises to which Act does not apply.** Sections 1 to 11 of this 2015 Act do
3 not apply to a person making a retail sale of an inhalant delivery system at a medical
4 marijuana facility registered under ORS 475.314 or a premises for which a retail license has
5 been issued under section 22, chapter 1, Oregon Laws 2015 (Ballot Measure 91 (2014)), unless
6 the person makes a retail sale of a component or substance described in section 1 (1)(a)(B)
7 of this 2015 Act that contains nicotine.

8 **SECTION 4. Licensure qualifications.** (1) The Oregon Liquor Control Commission shall
9 license qualified premises for the retail sale of tobacco products or inhalant delivery systems.

10 **“(2)(a) To be qualified for licensure under this section, a premises:**

11 **“(A) Must have a physical address;**

12 **“(B) May not be located at the same address as a residence; and**

13 **“(C) May not be located within 1,000 feet of any part of the premises of:**

14 **“(i) A public school for which attendance is compulsory under ORS 339.020; or**

15 **“(ii) A private or parochial school that teaches children as described in ORS 339.030 (1)(a).**

16 **“(b) Paragraph (a)(C) of this subsection does not apply to a premises for which a license**
17 **has been issued under this section before the date on which the school is first attended by**
18 **students unless the commission has revoked or refused to renew the license pursuant to**
19 **section 7 of this 2015 Act.**

20 **“(3) For the purpose of licensing premises under this section, the commission shall adopt**
21 **rules establishing:**

22 **“(a) The term of licensure;**

23 **“(b) Procedures for applying for and renewing licenses; and**

24 **“(c) Licensure application, issuance and renewal fees that are reasonably calculated to**
25 **pay the costs of administering sections 1 to 11 of this 2015 Act.**

26 **“(4) Amounts collected pursuant to subsection (3)(c) of this section shall be deposited in**
27 **the Tobacco Control Fund established under section 9 of this 2015 Act.**

28 **“(5) The commission may inspect the proposed premises of an applicant under this sec-**
29 **tion to ensure compliance with this section and rules adopted under this section.**

30 **SECTION 5. Prohibitions.** (1) A person that makes retail sales of tobacco products or
31 inhalant delivery systems may not:

32 **“(a) Sell, offer for sale or allow to be sold a tobacco product or an inhalant delivery sys-**
33 **tem for free or at a nominal price for the purpose of promoting the tobacco product or**
34 **inhalant delivery system;**

35 **“(b) Sell, offer for sale or allow to be sold a tobacco product or a component or substance**
36 **described in section 1 (1)(a)(B) of this 2015 Act at a reduced price if the buyer of the tobacco**
37 **product, component or substance purchases multiple packets of the tobacco product, com-**
38 **ponent or substance during a single transaction; or**

39 **“(c) Redeem a coupon for a tobacco product or an inhalant delivery system.**

40 **“(2) A person that makes retail sales of inhalant delivery systems and allows customers**
41 **of the person to sample inhalant delivery system products at the premises of the person’s**
42 **business:**

43 **“(a) Must be primarily engaged in the sale of inhalant delivery systems, with at least 75**
44 **percent of gross revenues of the business resulting from the sales of inhalant delivery sys-**
45 **tems;**

1 “(b) May not sell tobacco products or alcohol; and

2 “(c) May not permit a person under 18 years of age to enter the premises.

3 “(3) The Oregon Liquor Control Commission is required to verify that a person that
4 makes retail sales of inhalant delivery systems and allows customers of the person to sample
5 inhalant delivery system products at the premises of the person’s business is in compliance
6 with subsection (2)(a) of this section only upon receiving a complaint that the person is not
7 in compliance with subsection (2)(a) of this section.

8 “**SECTION 6. Inspections and enforcement.** (1) The Oregon Liquor Control Commission
9 may inspect a premises licensed under section 4 of this 2015 Act to ensure compliance with
10 sections 1 to 11 of this 2015 Act and rules adopted under sections 1 to 11 of this 2015 Act.

11 “(2) The state police, sheriffs and other police officers within this state shall assist the
12 commission in enforcing sections 1 to 11 of this 2015 Act and rules adopted under sections 1
13 to 11 of this 2015 Act.

14 “**SECTION 7. Discipline.** Subject to the applicable provisions of ORS chapter 183, the
15 Oregon Liquor Control Commission may revoke, suspend or refuse to issue or renew a li-
16 cense under section 4 of this 2015 Act if any individual who owns the premises or participates
17 in the management of the premises or any individual who is employed for the purpose of
18 making sales at the premises:

19 “(1) Violates a provision of sections 1 to 11 of this 2015 Act or a rule adopted under
20 sections 1 to 11 of this 2015 Act;

21 “(2) Violates ORS 431.840 or any rule adopted under ORS 431.840;

22 “(3) Violates any applicable state rule, local ordinance or federal law or regulation that
23 imposes a duty on or otherwise governs the retail sale of tobacco products or inhalant de-
24 livery systems; or

25 “(4) Makes a false statement to the commission.

26 “**SECTION 8. Civil penalty.** (1) The Oregon Liquor Control Commission may impose a civil
27 penalty for each violation of sections 1 to 11 of this 2015 Act. A civil penalty imposed under
28 this section may not be more than \$5,000 for each violation.

29 “(2) Amounts collected under subsection (1) of this section shall be deposited in the To-
30 bacco Control Fund established under section 9 of this 2015 Act.

31 “**SECTION 9. Tobacco Control Fund.** There is established the Tobacco Control Fund,
32 separate and distinct from the General Fund. Moneys deposited in the Tobacco Control Fund
33 are continuously appropriated to the Oregon Liquor Control Commission for carrying out the
34 duties, functions and powers of the commission under sections 1 to 11 of this 2015 Act.

35 “**SECTION 10. Rules.** The Oregon Liquor Control Commission shall adopt rules necessary
36 for the effective administration of sections 1 to 11 of this 2015 Act.

37 “**SECTION 11. Intergovernmental agreement.** (1) The Oregon Liquor Control Commission
38 shall enter into an agreement with the Oregon Health Authority for the purposes of admin-
39 istering and enforcing the provisions of ORS 433.835 to 433.875 and rules adopted under ORS
40 433.835 to 433.875 that are related to the regulation of cigar bars, as defined in ORS 433.835,
41 and smoke shops certified under ORS 433.835 to 433.875, including those provisions and rules
42 related to the certification process.

43 “(2) As part of the agreement entered into under subsection (1) of this section, the au-
44 thority shall transfer all moneys collected as a fee for certifying shops under ORS 433.835 to
45 433.875 to the commission.

1 “(3) An employer, except in those places described in subsection (2) of this section, shall post
2 signs that provide notice of the provisions of ORS 433.835 to 433.875.

6 “**SECTION 14.** If House Bill 2546 becomes law, ORS 433.850, as amended by section 18, chapter
7 ____, Oregon Laws 2015 (Enrolled House Bill 2546), and section 13 of this 2015 Act, is amended to
8 read:

9 “433.850. (1) An employer:

10 “(a) Shall provide for employees a place of employment that is free of all smoke, aerosols and
11 vapors containing inhalants; and

12 “(b) May not allow employees to smoke, aerosolize or vaporize inhalants at the place of em-
13 ployment.

14 “(2) Notwithstanding subsection (1) of this section:

15 “(a) The owner or person in charge of a hotel or motel may designate up to 25 percent of the
16 sleeping rooms of the hotel or motel as rooms in which the smoking, aerosolizing or vaporizing of
17 inhalants is permitted.

18 “(b) Smoking of noncommercial tobacco products for ceremonial purposes is permitted in spaces
19 designated for traditional ceremonies in accordance with the American Indian Religious Freedom
20 Act, 42 U.S.C. 1996.

21 “(c) The smoking of tobacco products is permitted in a smoke shop.

22 “(d) The smoking of cigars is permitted in a cigar bar that generated on-site retail sales of ci-
23 gars of at least \$5,000 for the calendar year ending December 31, 2006.

24 “(e) The aerosolizing or vaporizing of inhalants that do not contain cannabinoids is permitted
25 on the premises of a business that holds itself out to the public as being primarily engaged in the
26 business of selling inhalant delivery systems, as defined in ORS 431.840, provided that the
27 business[:] **is licensed under sections 1 to 11 of this 2015 Act and meets the requirements and**
28 **obligations described in section 5 (2) of this 2015 Act.**

29 “[*(A) Is not located at the same address as a residence;*]

30 “[*(B) Does not sell tobacco products or alcohol; and*]

31 “[*(C) Does not permit a person under 18 years of age to enter the premises.*]

32 “(f) A performer may smoke or carry a lighted smoking instrument that does not contain tobacco
33 or marijuana, and may aerosolize or vaporize a substance that does not contain nicotine or a
34 cannabinoid, while performing in a scripted stage, motion picture or television production if:

35 “(A) The production is produced by an organization whose primary purpose is producing scripted
36 productions; and

37 “(B) The act of smoking, aerosolizing or vaporizing is an integral part of the production.

38 “(g) The medical use of marijuana is permitted in the place of employment of a licensee of a
39 professional licensing board as described in ORS 475.328.

40 “(3) An employer, except in those places described in subsection (2) of this section, shall post
41 signs that provide notice of the provisions of ORS 433.835 to 433.875.

45 “**SECTION 15. Series placement. Sections 16 and 17 of this 2015 Act are added to and**

1 made a part of ORS 163.505 to 163.575.

2 **“SECTION 16. Violations. (1) As used in this section:**

3 **“(a)(A) ‘Inhalant delivery system’ means:**

4 **“(i) A device that can be used to deliver nicotine in the form of a vapor or aerosol to a**
5 **person inhaling from the device; or**

6 **“(ii) A component of a device described in this subparagraph or a substance in any form**
7 **sold for the purpose of being vaporized or aerosolized by a device described in this subpara-**
8 **graph, whether the component or substance is sold separately or is not sold separately.**

9 **“(B) ‘Inhalant delivery system’ does not include:**

10 **“(i) Any product that has been approved by the United States Food and Drug Adminis-**
11 **tration for sale as a tobacco cessation product or for any other therapeutic purpose, if the**
12 **product is marketed and sold solely for the approved purpose; and**

13 **“(ii) Tobacco products.**

14 **“(b) ‘Tobacco products’ means:**

15 **“(A) Bidis, cigars, cheroots, stogies, periques, granulated, plug cut, crimp cut, ready**
16 **rubbed and other smoking tobacco, snuff, snuff flour, cavendish, plug and twist tobacco,**
17 **fine-cut and other chewing tobaccos, shorts, refuse scraps, clippings, cuttings and sweepings**
18 **of tobacco and other forms of tobacco, prepared in a manner that makes the tobacco suitable**
19 **for chewing or smoking in a pipe or otherwise, or for both chewing and smoking; or**

20 **“(B) Cigarettes as defined in ORS 323.010.**

21 **“(2) A person commits the offense of selling tobacco products, tobacco product devices**
22 **or inhalant delivery systems to a person under 21 years of age if the person knowingly:**

23 **“(a) Distributes or sells, or causes to be sold, a tobacco product to a person under 21**
24 **years of age;**

25 **“(b) Distributes or sells, or causes to be sold, to a person under 21 years of age any de-**
26 **vice that is designed to contain burning tobacco for the purpose of delivering tobacco smoke**
27 **into a person’s respiratory system; or**

28 **“(c) Distributes or sells, or causes to be sold, an inhalant delivery system to a person**
29 **under 21 years of age.**

30 **“(3) Selling tobacco products, tobacco product devices or inhalant delivery systems to a**
31 **person under 21 years of age is a Class A violation.**

32 **“SECTION 17. Notice. (1) A person who sells a product, device, component or substance**
33 **prohibited as described in section 16 of this 2015 Act shall display a sign clearly stating that**
34 **the sale of the product, device, component or substance to persons under 21 years of age is**
35 **prohibited by law.**

36 **“(2) A person who violates this section commits a Class B violation.**

37 **“SECTION 18. ORS 163.575, as amended by section 1, chapter 20, Oregon Laws 2014, is**
38 **amended to read:**

39 **“163.575. (1) A person commits the offense of endangering the welfare of a minor if the person**
40 **knowingly:**

41 **“(a) Induces, causes or permits an unmarried person under 18 years of age to witness an act of**
42 **sexual conduct or sadomasochistic abuse as defined by ORS 167.060;**

43 **“(b) Permits a person under 18 years of age to enter or remain in a place where unlawful ac-**
44 **tivity involving controlled substances is maintained or conducted;**

45 **“(c) Induces, causes or permits a person under 18 years of age to participate in gambling as**

1 defined by ORS 167.117; **or**

2 *“(d) Distributes, sells, or causes to be sold, tobacco in any form to a person under 18 years of age;*
3 *or]*

4 *“(e) (d) Sells to a person under 18 years of age any device in which [tobacco,] marijuana,*
5 *cocaine or any controlled substance, as defined in ORS 475.005, is burned and the principal design*
6 *and use of which is directly or indirectly to deliver [tobacco smoke,] marijuana smoke, cocaine smoke*
7 *or smoke from any controlled substance into the human body, including but not limited to:*

8 *“(A) Pipes, water pipes, hookahs, wooden pipes, carburetor pipes, electric pipes, air driven pipes,*
9 *corncob pipes, meerschaum pipes and ceramic pipes, with or without screens, permanent screens,*
10 *hashish heads or punctured metal bowls;*

11 *“(B) Carburetion tubes and devices, including carburetion masks;*

12 *“(C) Bongs;*

13 *“(D) Chillums;*

14 *“(E) Ice pipes or chillers;*

15 *“(F) [Cigarette] Rolling papers and rolling machines; and*

16 *“(G) Cocaine free basing kits.*

17 *“(2) Endangering the welfare of a minor [by violation of subsection (1)(a), (b) or (c) of this section,*
18 *or by violation of subsection (1)(e) of this section involving other than a device for smoking tobacco,]*
19 *is a Class A misdemeanor.*

20 *“(3) Endangering the welfare of a minor by violation of subsection (1)(d) of this section is a Class*
21 *A violation.]*

22 *“(4) Endangering the welfare of a minor by violation of subsection (1)(e) of this section involving*
23 *a device for smoking tobacco is a Class A violation.]*

24 **“SECTION 19.** ORS 163.580 is amended to read:

25 *“163.580. (1) Any person who sells any of the smoking devices listed in ORS 163.575 [(1)(e)] (1)(d)*
26 *shall display a sign clearly stating that the sale of such devices to persons under 18 years of age*
27 *is prohibited by law.*

28 *“(2) Any person who violates this section commits a Class B violation.*

29 **“SECTION 20.** ORS 165.800 is amended to read:

30 *“165.800. (1) A person commits the crime of identity theft if the person, with the intent to de-*
31 *ceive or to defraud, obtains, possesses, transfers, creates, utters or converts to the person’s own use*
32 *the personal identification of another person.*

33 *“(2) Identity theft is a Class C felony.*

34 *“(3) It is an affirmative defense to violating subsection (1) of this section that the person*
35 *charged with the offense:*

36 *“(a) Was under 21 years of age at the time of committing the offense and the person used the*
37 *personal identification of another person solely for the purpose of purchasing **tobacco products or***
38 ***inhalant delivery systems, both as defined in section 16 of this 2015 Act, or** alcohol; **or***

39 *“(b) Was under 18 years of age at the time of committing the offense and the person used the*
40 *personal identification of another person solely for the purpose of purchasing tobacco products; or]*

41 *“(c) (b) Used the personal identification of another person solely for the purpose of misrepre-*
42 *senting the person’s age to gain access to a:*

43 *“(A) Place the access to which is restricted based on age; or*

44 *“(B) Benefit based on age.*

45 *“(4) As used in this section:*

1 “(a) ‘Another person’ means an individual, whether living or deceased, an imaginary person or
2 a firm, association, organization, partnership, business trust, company, corporation, limited liability
3 company, professional corporation or other private or public entity.

4 “(b) ‘Personal identification’ includes, but is not limited to, any written document or electronic
5 data that does, or purports to, provide information concerning:

6 “(A) A person’s name, address or telephone number;

7 “(B) A person’s driving privileges;

8 “(C) A person’s Social Security number or tax identification number;

9 “(D) A person’s citizenship status or alien identification number;

10 “(E) A person’s employment status, employer or place of employment;

11 “(F) The identification number assigned to a person by a person’s employer;

12 “(G) The maiden name of a person or a person’s mother;

13 “(H) The identifying number of a person’s depository account at a ‘financial institution’ or ‘trust
14 company,’ as those terms are defined in ORS 706.008, or a credit card account;

15 “(I) A person’s signature or a copy of a person’s signature;

16 “(J) A person’s electronic mail name, electronic mail signature, electronic mail address or elec-
17 tronic mail account;

18 “(K) A person’s photograph;

19 “(L) A person’s date of birth; and

20 “(M) A person’s personal identification number.

21 “**SECTION 21.** ORS 165.813 is amended to read:

22 “165.813. (1) A person commits the crime of unlawful possession of fictitious identification if the
23 person possesses a personal identification card containing identification information for a fictitious
24 person with the intent to use the personal identification card to commit a crime.

25 “(2) Unlawful possession of fictitious identification is a Class C felony.

26 “(3) It is an affirmative defense to violating subsection (1) of this section that the person
27 charged with the offense[.]

28 “[*a*] was under 21 years of age at the time of committing the offense and the person possessed
29 the personal identification card solely for the purpose of enabling the person to purchase **tobacco
30 products or inhalant delivery systems, both as defined in section 16 of this 2015 Act, or**
31 alcohol[; or].

32 “[*b*] *Was under 18 years of age at the time of committing the offense and the person possessed the*
33 *personal identification card solely for the purpose of enabling the person to purchase tobacco*
34 *products.*]

35 “**SECTION 22.** ORS 167.400 is amended to read:

36 “167.400. (1) It is unlawful for any person under [*18*] **21** years of age to possess tobacco
37 products[, *as defined in ORS 431.840*] **or inhalant delivery systems, both as defined in section**
38 **16 of this 2015 Act.**

39 “(2) Any person who violates subsection (1) of this section commits a Class D violation.

40 “**SECTION 23.** ORS 167.401 is amended to read:

41 “167.401. (1) Except as provided in subsection (4) of this section, [*no*] **a** person under [*18*] **21**
42 years of age [*shall*] **may not** purchase, attempt to purchase or acquire tobacco products [*as defined*
43 *in ORS 431.840*] **or inhalant delivery systems, both as defined in section 16 of this 2015 Act.**
44 Except when [*such minor*] **a person** is in a private residence accompanied by the parent or guardian
45 of the [*minor*] **person** and [*with*] **has** the consent of [*such*] **the** parent or guardian, [*no*] **a** person

1 under [18] **21** years of age [shall] **may not** have personal possession of tobacco products **or inhalant**
2 **delivery systems.**

3 “(2) Any person who violates subsection (1) of this section commits a Class B violation.

4 “(3)(a) In lieu of any other penalty established by law, a person who is convicted for the first
5 time of a violation of subsection (1) of this section may be ordered to participate in a [tobacco]
6 **nicotine use** education program or a [tobacco] **nicotine** use cessation program or to perform com-
7 munity service related to diseases associated with consumption of [tobacco products] **nicotine.** A
8 person may be ordered to participate in such a program only once.

9 “(b) In addition to and not in lieu of any other penalty established by law, a person who is
10 convicted of a second violation of subsection (1) of this section through misrepresentation of age
11 may be required to participate in a [tobacco] **nicotine use** education **program** or a [tobacco]
12 **nicotine** use cessation program or to perform community service related to diseases associated with
13 the consumption of [tobacco products,] **nicotine** and the court shall order that the person’s driving
14 privileges and right to apply for driving privileges be suspended for a period not to exceed one year.
15 If a court has issued an order suspending driving privileges under this subsection, the court, upon
16 petition of the person, may withdraw the order at any time the court deems appropriate. The court
17 notification to the Department of Transportation under this subsection may include a recommen-
18 dation that the person be granted a hardship permit under ORS 807.240 if the person is otherwise
19 eligible for the permit.

20 “(4) A [minor] **person under 21 years of age who is** acting under the supervision of an adult
21 may purchase, attempt to purchase or acquire tobacco products **or inhalant delivery systems** for
22 the purpose of testing compliance with a federal law, state statute, local law or retailer management
23 policy limiting or regulating the delivery of tobacco products **or inhalant delivery systems** to
24 [minors] **persons under 21 years of age.**

25 “**SECTION 24.** ORS 167.402 is amended to read:

26 “167.402. (1) As used in this section, ‘vending machine’ means a mechanical, electronic or similar
27 device that, upon the insertion of tokens, money or another form of payment, dispenses tobacco
28 products **or inhalant delivery systems.**

29 “(2) A person may not sell or dispense tobacco products[, *as defined in ORS 431.840,*] **or**
30 **inhalant delivery systems, both as defined in section 16 of this 2015 Act,** from a vending ma-
31 chine, except in an establishment where the premises are posted as permanently and entirely off-
32 limits to [minors under] **persons under 21 years of age as required by** rules adopted by the
33 Oregon Liquor Control Commission.

34 “(3) Violation of subsection (2) of this section is a Class B violation. Each day of violation
35 constitutes a separate offense.

36 “**SECTION 25.** ORS 167.404 is amended to read:

37 “167.404. Cities and counties by ordinance or resolution [shall] **may not** regulate vending ma-
38 chines that dispense tobacco products[, *as defined in ORS 431.840,*] **or inhalant delivery systems,**
39 **both as defined in section 16 of this 2015 Act,** in any form and that are in any manner accessible
40 to [minors] **persons under 21 years of age.**

41 “**SECTION 26.** ORS 167.407 is amended to read:

42 “167.407. (1) A person having authority over the location of [cigarettes and other] tobacco pro-
43 ducts **and inhalant delivery systems, both as defined in section 16 of this 2015 Act,** in a retail
44 store may not locate [cigarettes or other] **the** tobacco products **or inhalant delivery systems** in a
45 location in the store where the [cigarettes or other] tobacco products **or inhalant delivery systems**

1 are accessible by store customers without assistance by a store employee.

2 “(2) Violation of subsection (1) of this section is a Class B violation. Each day of violation
3 constitutes a separate offense.

8 “181.430. (1) As used in this section, ‘tobacco products’ has the meaning given that term in [ORS
9 *431.840*] **section 16 of this 2015 Act.**

10 “(2) The Oregon Health Authority may apply for and accept moneys from the United States
11 Government or other public or private sources for utilization of those moneys by the Department
12 of State Police in accordance with any federal restrictions or other funding source restrictions to
13 carry out the duties, functions and powers of the department under this section. Moneys received
14 as provided under this subsection shall be deposited into the State Treasury to the credit of the
15 State Police Tobacco Law Enforcement Fund. Moneys that are subject to funding source conditions

5 postal service to require:

6 “(i) The consumer placing the delivery sale order, or another individual of at least the legal
7 minimum purchase age residing at the residence of the consumer, to sign to accept delivery of the
8 shipping container; and

9 “(ii) Proof, in the form of a valid, government-issued identification bearing a photograph of the
10 individual who signs to accept delivery of the shipping container, demonstrating that the individual
11 who signs to accept delivery:

12 “(I) Is either the consumer or another individual residing at the residence of the consumer; and

31 for a late enrollee;

9 under subparagraph (A) of this paragraph if coverage is discontinued in the entire state or, except
10 as provided in subparagraph (C) of this paragraph, in a specified service area;

11 “(C) May not cancel coverage under the plans for 90 days after the date of the notice required
12 under subparagraph (A) of this paragraph if coverage is discontinued in a specified service area
13 because of an inability to reach an agreement with the health care providers or organization of

15 “(D) Must discontinue offering or renewing, or offering and renewing, all health benefit plans
16 issued by the carrier in the small employer market in this state or in the specified service area.

19 care providers or organization of health care providers to provide services under the plan within the

21 “(A) Must give notice to the department and to all policyholders covered by the plan;

22 “(B) May not cancel coverage under the plan for 90 days after the date of the notice required

24 “(C) Must offer in writing to each small employer covered by the plan, all other small employer
25 health benefit plans that the carrier offers to small employers in the specified service area. The
26 carrier shall issue any such plans pursuant to the provisions of ORS 743.733 to 743.737. The carrier
27 shall offer the plans at least 90 days prior to discontinuation.

28 “(g) The carrier discontinues offering or renewing, or offering and renewing, a health benefit
29 plan, other than a grandfathered health plan, for all small employers in this state or in a specified
30 service area within this state, other than a plan discontinued under paragraph (f) of this subsection.

31 “(h) The carrier discontinues renewing or offering and renewing a grandfathered health plan for
32 all small employers in this state or in a specified service area within this state, other than a plan
33 discontinued under paragraph (f) of this subsection.

34 “(i) With respect to plans that are being discontinued under paragraph (g) or (h) of this sub-
35 section, the carrier must:

36 “(A) Offer in writing to each small employer covered by the plan, all other health benefit plans
37 that the carrier offers to small employers in the specified service area.

39 “(C) Offer the plans at least 90 days prior to discontinuation.

6 one or more bona fide associations, the membership of an employer in the association ceases and
7 the termination of coverage is not related to the health status of any enrollee.

8 “(4) A carrier may modify a small employer health benefit plan at the time of coverage renewal.
9 The modification is not a discontinuation of the plan under subsection (3)(e), (g) and (h) of this sec-

11 “(5) Notwithstanding any provision of subsection (3) of this section to the contrary, a carrier
12 may not rescind the coverage of an enrollee in a small employer health benefit plan unless:

13 “(a) The enrollee or a person seeking coverage on behalf of the enrollee:

15 “(B) Makes an intentional misrepresentation of a material fact as prohibited by the terms of the

19 “(c) The carrier provides notice of the rescission to the department in the form, manner and
20 time frame prescribed by the department by rule.

21 “(6) Notwithstanding any provision of subsection (3) of this section to the contrary, a carrier
22 may not rescind a small employer health benefit plan unless:

23 “(a) The small employer or a representative of the small employer:

24 “(A) Performs an act, practice or omission that constitutes fraud; or
25 “(B) Makes an intentional misrepresentation of a material fact as prohibited by the terms of the
26 plan;

27 “(b) The carrier provides at least 30 days’ advance written notice, in the form and manner pre-
28 scribed by the department, to each plan enrollee who would be affected by the rescission of cover-
29 age; and

30 “(c) The carrier provides notice of the rescission to the department in the form, manner and
31 time frame prescribed by the department by rule.

32 “(7)(a) A carrier may continue to enforce reasonable employer participation and contribution
33 requirements on small employers. However, participation and contribution requirements shall be
34 applied uniformly among all small employer groups with the same number of eligible employees ap-
35 plying for coverage or receiving coverage from the carrier. In determining minimum participation
36 requirements, a carrier shall count only those employees who are not covered by an existing group
37 health benefit plan, Medicaid, Medicare, TRICARE, Indian Health Service or a publicly sponsored
38 or subsidized health plan, including but not limited to the medical assistance program under ORS
39 chapter 414.

40 “(b) A carrier may not deny a small employer’s application for coverage under a health benefit
41 plan based on participation or contribution requirements but may require small employers that do
42 not meet participation or contribution requirements to enroll during the open enrollment period
43 beginning November 15 and ending December 15.

44 “(8) Premium rates for small employer health benefit plans shall be subject to the following
45 provisions:

1 “(a) Each carrier must file with the department the initial geographic average rate and any
2 changes in the geographic average rate with respect to each health benefit plan issued by the car-
3 rier to small employers.

4 “(b)(A) The variations in premium rates charged during a rating period for health benefit plans
5 issued to small employers shall be based solely on the factors specified in subparagraph (B) of this
6 paragraph. A carrier may elect which of the factors specified in subparagraph (B) of this paragraph
7 apply to premium rates for health benefit plans for small employers. All other factors must be ap-
8 plied in the same actuarially sound way to all small employer health benefit plans.

9 “(B) The variations in premium rates described in subparagraph (A) of this paragraph may be
10 based only on one or more of the following factors as prescribed by the department by rule:

11 “(i) The ages of enrolled employees and their dependents, except that the rate for adults may
12 not vary by more than three to one;

13 “(ii) The level at which enrolled employees and their dependents [18] **21** years of age and older
14 engage in [*tobacco*] **nicotine** use, except that the rate may not vary by more than 1.5 to one; and

15 “(iii) Adjustments to reflect differences in family composition.

16 “(C) A carrier shall apply the carrier’s schedule of premium rate variations as approved by the
17 department and in accordance with this paragraph. Except as otherwise provided in this section, the
18 premium rate established by a carrier for a small employer health benefit plan shall apply uniformly
19 to all employees of the small employer enrolled in that plan.

20 “(c) Except as provided in paragraph (b) of this subsection, the variation in premium rates be-
21 tween different health benefit plans offered by a carrier to small employers must be based solely on
22 objective differences in plan design or coverage, age, [*tobacco*] **nicotine** use and family composition
23 and must not include differences based on the risk characteristics of groups assumed to select a
24 particular health benefit plan.

25 “(d) A carrier may not increase the rates of a health benefit plan issued to a small employer
26 more than once in a 12-month period. Annual rate increases shall be effective on the plan anniver-
27 sary date of the health benefit plan issued to a small employer. The percentage increase in the
28 premium rate charged to a small employer for a new rating period may not exceed the sum of the
29 following:

30 “(A) The percentage change in the geographic average rate measured from the first day of the
31 prior rating period to the first day of the new period; and

32 “(B) Any adjustment attributable to changes in age and differences in family composition.

33 “(e) Premium rates for small employer health benefit plans shall comply with the requirements
34 of this section.

35 “(9) In connection with the offering for sale of any health benefit plan to a small employer, each
36 carrier shall make a reasonable disclosure as part of its solicitation and sales materials of:

37 “(a) The full array of health benefit plans that are offered to small employers by the carrier;

38 “(b) The authority of the carrier to adjust rates and premiums, and the extent to which the
39 carrier will consider age, [*tobacco*] **nicotine** use, family composition and geographic factors in es-
40 tablishing and adjusting rates and premiums; and

41 “(c) The benefits and premiums for all health insurance coverage for which the employer is
42 qualified.

43 “(10)(a) Each carrier shall maintain at its principal place of business a complete and detailed
44 description of its rating practices and renewal underwriting practices relating to its small employer
45 health benefit plans, including information and documentation that demonstrate that its rating

1 methods and practices are based upon commonly accepted actuarial practices and are in accordance
2 with sound actuarial principles.

3 “(b) A carrier offering a small employer health benefit plan shall file with the department at
4 least once every 12 months an actuarial certification that the carrier is in compliance with ORS
5 743.733 to 743.737 and that the rating methods of the carrier are actuarially sound. Each certifica-
6 tion shall be in a uniform form and manner and shall contain such information as specified by the
7 department. A copy of each certification shall be retained by the carrier at its principal place of
8 business. A carrier is not required to file the actuarial certification under this paragraph if the de-
9 partment has approved the carrier’s rate filing within the preceding 12-month period.

10 “(c) A carrier shall make the information and documentation described in paragraph (a) of this
11 subsection available to the department upon request. Except as provided in ORS 743.018 and except

16 would encourage the insurance producer to market and sell health benefit plans of the carrier to
17 small employer groups based on a small employer group’s anticipated claims experience.

18 “(12) For purposes of this section, the date a small employer health benefit plan is continued
19 shall be the anniversary date of the first issuance of the health benefit plan.

20 “(13) A carrier must include a provision that offers coverage to all eligible employees of a small
21 employer and to all dependents of the eligible employees to the extent the employer chooses to offer
22 coverage to dependents.

23 “(14) All small employer health benefit plans shall contain special enrollment periods during
24 which eligible employees and dependents may enroll for coverage, as provided by federal law and
25 rules adopted by the department.

26 “(15) A small employer health benefit plan may not impose annual or lifetime limits on the dollar
27 amount of essential health benefits.

28 “(16) This section does not require a carrier to actively market, offer, issue or accept applica-
29 tions for a grandfathered health plan or from a small employer not eligible for coverage under such
30 a plan.

31 “**SECTION 34.** ORS 807.500 is amended to read:

32 “807.500. (1) A person commits the offense of unlawful production of identification cards, li-
33 censes, permits, forms or camera cards if the person, without the authority of the Department of
34 Transportation, advertises for the production of, produces in any way or causes to be produced any
35 facsimiles of the identification cards, licenses, permits, forms or camera cards upon which the de-
36 partment issues identification cards, licenses or driver permits under the vehicle code.

37 “(2) The offense described in this section, unlawful production of identification cards, licenses,
38 permits, forms or camera cards, is a Class C felony.

39 “(3) It is an affirmative defense to violating subsection (1) of this section that the person
40 charged with the offense[:]

41 “[*a*] was under 21 years of age at the time of committing the offense and the person produced
42 an identification card, license or permit solely for the purpose of enabling the person to purchase
43 **tobacco products or inhalant delivery systems, both as defined in section 16 of this 2015 Act,**
44 **or alcohol**[: or].

45 “[*b*] Was under 18 years of age at the time of committing the offense and the person produced an

1 *identification card, license or permit solely for the purpose of enabling the person to purchase tobacco*
2 *products.]*

3 **“SECTION 35.** ORS 811.193 is amended to read:

4 “811.193. (1)(a) A person commits the offense of smoking in a motor vehicle if the person smokes
5 in a motor vehicle while a person under [18] 21 years of age is in the motor vehicle.

6 “(b) As used in this subsection, ‘smokes’ means to inhale, exhale, burn or carry a lighted ciga-
7 rette, cigar, pipe, weed, plant, regulated narcotic or other combustible substance.

8 “(2) Notwithstanding ORS 810.410, a police officer may enforce this section only if the police
9 officer has already stopped and detained the driver operating the motor vehicle for a separate traffic
10 violation or other offense.

11 “(3) Smoking in a motor vehicle is a:

12 “(a) Class D traffic violation for a first offense.

13 “(b) Class C traffic violation for a second or subsequent offense.

17 **“SECTION 36. Applicability.** Sections 16 and 17 of this 2015 Act and the amendments to
18 **ORS 163.575, 163.580, 165.800, 165.813, 167.400, 167.401, 167.402, 167.404, 167.407, 181.430, 323.718,**
19 **339.883, 431.840, 431.853, 433.847, 743.737, 807.500 and 811.193 by sections 18 to 35 of this 2015**
20 **Act apply to conduct occurring on or after the effective date of this 2015 Act.**

21 **“SECTION 37. Operative date.** (1) Sections 1 to 11 of this 2015 Act and the amendments
22 **to ORS 433.850 by section 14 of this 2015 Act become operative on July 1, 2017.**

23 **“(2) The Oregon Liquor Control Commission may take any action before the operative**
24 **date specified in subsection (1) of this section that is necessary to enable the commission to**
25 **exercise, on and after the operative date specified in subsection (1) of this section, all the**
26 **duties, functions and powers conferred on the commission by sections 1 to 11 of this 2015**
27 **Act.**

28 **“SECTION 38. Report.** (1) The Oregon Liquor Control Commission shall make a report
29 **on any action taken by the commission pursuant to section 37 (2) of this 2015 Act that was**
30 **necessary to enable the commission to exercise, on and after the operative date specified in**
31 **section 37 (1) of this 2015 Act, the duties, functions and powers conferred on the commission**
32 **by sections 1 to 11 of this 2015 Act. The commission may include in its report recommen-**
33 **dations for legislation to better enable the commission to exercise those duties, functions**
34 **and powers.**

35 **“(2) The commission shall submit a report:**

36 **“(a) To an interim committee of the Legislative Assembly related to health on or before**
37 **September 15, 2016; and**

38 **“(b) To the Legislative Assembly in the manner provided by ORS 192.245 on or before**
39 **February 1, 2017.**

40 **“SECTION 39. Unit and section captions.** The unit and section captions used in this 2015
41 **Act are provided only for the convenience of the reader and do not become part of the stat-**
42 **utory law of this state or express any legislative intent in the enactment of this 2015 Act.**

43 **“SECTION 40. Emergency clause.** This 2015 Act being necessary for the immediate pres-
44 **ervation of the public peace, health and safety, an emergency is declared to exist, and this**
45 **2015 Act takes effect on its passage.”**
