SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Abolishes Oregon University System, office of Chancellor of the Oregon University System and State Board of Higher Education.

States that all public universities have institutional governing boards.

Abolishes Oregon University System Fund and subaccounts, Higher Education Donation Fund, Higher Education Academic Modernization Account and Oregon University System Capital Construction, Deferred Maintenance and Capital Repair Project Fund. Transfers moneys remaining in accounts or funds to Public University Fund. Limits use of transferred moneys to purposes specified for original funds or accounts.

Creates conforming amendments.

Declares emergency, effective on passage.

21 **DISSOLUTION OF OREGON UNIVERSITY SYSTEM AND**
22 **STATE BOARD OF HIGHER EDUCATION**
23

24 **SECTION 1.** ORS 352.054 is amended to read:

25 352.054. (1) A governing board is established for each of the following public universities:

26 (a) University of Oregon;

27 (b) Portland State University;

28 (c) Oregon State University[, *if the president of Oregon State University notifies the Governor that*
29 *the university will become a university with a governing board in the manner set forth in section 168*
30 *or 168a, chapter 768, Oregon Laws 2013*];

31 (d) Eastern Oregon University[, *if Eastern Oregon University becomes a university with a gov-*
32 *erning board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*];

33 (e) Oregon Institute of Technology[, *if Oregon Institute of Technology becomes a university with*
34 *a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*];

35 (f) Southern Oregon University[, *if Southern Oregon University becomes a university with a gov-*
36 *erning board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*]; and

37 (g) Western Oregon University[, *if Western Oregon University becomes a university with a gov-*
38 *erning board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

39 (2)(a) The University of Oregon governing board shall be known as the Board of Trustees of the
40 University of Oregon.

41 (b) The Portland State University governing board shall be known as the Board of Trustees of
42 Portland State University.

43 (c) The Oregon State University governing board shall be known as the Board of Trustees of
44 Oregon State University[, *if the president of Oregon State University notifies the Governor that the*
45 *university will become a university with a governing board in the manner set forth in section 168 or*

1 168a, chapter 768, Oregon Laws 2013].

2 (d) The Eastern Oregon University governing board shall be known as the Board of Trustees
3 of Eastern Oregon University[, *if Eastern Oregon University becomes a university with a governing*
4 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

5 (e) The Oregon Institute of Technology governing board shall be known as the Board of Trustees
6 of the Oregon Institute of Technology[, *if the Oregon Institute of Technology becomes a university*
7 *with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

8 (f) The Southern Oregon University governing board shall be known as the Board of Trustees
9 of Southern Oregon University[, *if Southern Oregon University becomes a university with a governing*
10 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

11 (g) The Western Oregon University governing board shall be known as the Board of Trustees
12 of Western Oregon University[, *if Western Oregon University becomes a university with a governing*
13 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

14 **SECTION 2. (1) The Oregon University System is abolished.**

15 **(2) The office of the Chancellor of the Oregon University System is abolished.**

16 **(3) The State Board of Higher Education is abolished.**

17 **(4)(a) The office of the Chancellor of the Oregon University System shall deliver to the**
18 **Higher Education Coordinating Commission or, as appropriate, the State Archives, all re-**
19 **ords and property within the jurisdiction or possession of the office of the chancellor that**
20 **relate to public universities listed in ORS 352.002.**

21 **(b) The Governor shall resolve any dispute between the office of the Chancellor of the**
22 **Oregon University System and the Higher Education Coordinating Commission or the State**
23 **Archives relating to transfers of records and property under this section, and the Governor's**
24 **decision is final.**

25 **SECTION 3. (1) Except as otherwise expressly provided in this section, all persons em-**
26 **ployed by a university with a governing board, as set forth in ORS 352.054, shall continue**
27 **their employment with the university and shall retain any seniority, contractual rights or**
28 **tenure granted prior to the effective date of this 2015 Act. Nothing in this section shall affect**
29 **any term or condition of any employment agreement or collective bargaining agreement in**
30 **effect on the effective date of this 2015 Act.**

31 **(2) All of the duties, functions, powers and lawfully incurred rights and obligations of the**
32 **State Board of Higher Education that pertain to a university with a governing board are**
33 **transferred to and vested in the governing board. The transfer shall include but not be lim-**
34 **ited to all applicable contractual rights and obligations and title to all applicable records,**
35 **property, supplies and materials, including equipment, books and papers. For the purpose of**
36 **succession to these rights and obligations, the governing board is considered to be a contin-**
37 **uation of the State Board of Higher Education and not a new authority, and the governing**
38 **board must exercise such rights and fulfill such obligations as if they had not been assigned**
39 **or transferred, except as otherwise provided by law.**

40 **(3) All unexpended moneys, including but not limited to General Fund appropriations,**
41 **gifts, bequests, other funds, assessments, liability and worker's compensation reserves and**
42 **premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise**
43 **available to a university with a governing board, are appropriated and transferred to the**
44 **university.**

45 **(4) A university with a governing board shall conduct and complete any proceeding,**

1 action, prosecution or other matter that the university commenced before the effective date
2 of this 2015 Act and that is pending on the effective date of this 2015 Act.

3 (5) The transfer of duties, functions and powers to a governing board or university with
4 a governing board does not affect any action, suit or proceeding relating to the university,
5 except that the university shall be substituted for the State Board of Higher Education and
6 the State of Oregon in any such action, suit or proceeding.

7 (6) Any action, proceeding or other matter that was commenced by a state agency, a
8 state officer, the State Board of Higher Education or an officer or employee of the State
9 Board of Higher Education before the effective date of this 2015 Act and relates to the gov-
10 erning board or university with a governing board and is still pending on the effective date
11 of this 2015 Act shall be conducted and completed by the governing board or university.

12 (7) Nothing in this 2015 Act relieves any person, public entity or private entity of any
13 obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture, rule,
14 policy, document, record or proceeding.

15 (8) Notwithstanding any other provision of this section, the lawfully adopted rules and
16 policies of the State Board of Higher Education pertaining to a university with a governing
17 board that are in effect on the effective date of this 2015 Act continue in effect until lawfully
18 superseded or repealed by the standards or policies of the governing board or the university.
19 References in rules or policies of the State Board of Higher Education to the state board or
20 an officer or employee of the state board are considered to be references to the governing
21 board or an officer or employee of a university with a governing board.

36 **BONDING AND FUND PROVISIONS**

37
38 **SECTION 5.** (1) The Oregon University System Fund established in ORS 351.506 is abol-
39 ished. Any moneys remaining in the Oregon University System Fund on the effective date
40 of this 2015 Act that are unexpended, unobligated and not subject to any conditions are
41 transferred to the Public University Fund established under section 7, chapter 83, Oregon
42 Laws 2014.

43 (2) The account in the Oregon University System Fund established in ORS 348.010 is
44 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
45 are unexpended, unobligated and not subject to any conditions are transferred to the Public

1 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
2 of granting loans under the terms established by the National Defense Education Act of 1958,
3 as amended, under the terms of the Health Professions Educational Assistance Act of 1963,
4 as amended, and under the terms of the Nurses Training Act of 1964, as amended.

5 (3) The account in the Oregon University System Fund established in ORS 351.210 is
6 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
7 are unexpended, unobligated and not subject to any conditions are transferred to the Public
8 University Fund established under section 7, chapter 83, Oregon Laws 2014.

9 (4) The account in the Oregon University System Fund established in ORS 351.250 is
10 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
11 are unexpended, unobligated and not subject to any conditions are transferred to the Public
12 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
13 of paying the agreed share, if any, to assignors, and for the advancement of research or for
14 the acquisition and development of intellectual property, or both.

15 (5) The account in the Oregon University System Fund established in ORS 351.545 is
16 abolished.

17 (6) The account in the Oregon University System Fund established in ORS 351.590 is
18 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
19 are unexpended, unobligated and not subject to any conditions are transferred to the Public
20 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
21 of disbursements for necessary expenses for supplies, services and equipment associated with
22 student activities including but not limited to recruiting, training and grant-in-aid to
23 intercollegiate athletes.

24 (7) The account in the Oregon University System Fund established in ORS 351.615 is
25 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
26 are unexpended, unobligated and not subject to any conditions are transferred to the Public
27 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the repair
28 and alteration of auxiliary enterprise buildings and replacement of equipment.

29 (8) The account in the Oregon University System Fund established in ORS 351.626 is
30 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
31 are unexpended, unobligated and not subject to any conditions are transferred to the Public
32 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the con-
33 struction, expansion and remodeling of public university facilities.

34 (9) The account in the Oregon University System Fund established in ORS 351.627 is
35 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
36 are unexpended, unobligated and not subject to any conditions are transferred to the Public
37 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
38 of capital construction.

39 (10) The account in the Oregon University System Fund established in ORS 351.638 is
40 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
41 are unexpended, unobligated and not subject to any conditions are transferred to the Public
42 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
43 of attracting new, outstanding faculty members to public universities.

44 (11) The account in the Oregon University System Fund established in ORS 351.875 is
45 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that

1 are unexpended, unobligated and not subject to any conditions are transferred to the Public
2 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
3 of providing grants for research.

4 (12) The account in the Oregon University System Fund established in ORS 352.360 is
5 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
6 are unexpended, unobligated and not subject to any conditions are transferred to the Public
7 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
8 of defraying the costs of constructing bicycle racks and bicycle lanes and of traffic control,
9 enforcement of traffic and parking regulations and maintenance and operation of parking
10 facilities.

11 (13) The account in the Oregon University System Fund established in ORS 352.650 is
12 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
13 are unexpended, unobligated and not subject to any conditions are transferred to the Public
14 University Fund established under section 7, chapter 83, Oregon Laws 2014.

15 (14) The subaccount in the Oregon University System Fund established in section 2,
16 chapter 624, Oregon Laws 2011, is abolished. Any moneys remaining in the subaccount on the
17 effective date of this 2015 Act that are unexpended, unobligated and not subject to any con-
18 ditions are transferred to the Public University Fund established under section 7, chapter
19 83, Oregon Laws 2014, to allow necessary compliance under the Internal Revenue Code.

20 **SECTION 6.** (1) The Higher Education Donation Fund established under ORS 351.130 is
21 abolished. Any moneys remaining in the fund on the effective date of this 2015 Act that are
22 unexpended, unobligated and not subject to any conditions are transferred to the Public
23 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
24 for which the moneys were donated.

25 (2) The Higher Education Academic Modernization Account established under ORS
26 351.628 is abolished. Any moneys remaining in the account on the effective date of this 2015
27 Act that are unexpended, unobligated and not subject to any conditions are transferred to
28 the Public University Fund established under section 7, chapter 83, Oregon Laws 2014, for
29 academic modernization, capital repair, deferred maintenance and making facilities
30 compliant with building and safety codes.

31 (3) The Oregon University System Capital Construction, Deferred Maintenance and Cap-
32 ital Repair Project Fund established in section 3, chapter 788, Oregon Laws 2005, is abolished.
33 Any moneys remaining in the fund on the effective date of this 2015 Act that are unexpended,
34 unobligated and not subject to any conditions are transferred to the Public University Fund
35 established under section 7, chapter 83, Oregon Laws 2014, for capital construction, deferred
36 maintenance and capital repair projects.

37 **SECTION 7.** Notwithstanding any other provision of law, the unexpended proceeds, and
38 any interest earnings thereon, of bonds issued by the State Treasurer for the benefit of a
39 university with a governing board that have not been transferred to a university prior to
40 July 1, 2015, and are not subject to transfer pursuant to a loan, grant or other agreement
41 entered into between the State of Oregon and a university with a governing board or the
42 Oregon University System, are transferred to and made available for expenditure by the
43 university with a governing board on whose behalf the bonds were issued before the effective
44 date of this 2015 Act.

45 **SECTION 8.** ORS 286A.035 is amended to read:

1 286A.035. (1) Each related agency shall report the plans of the related agency for the issuance
2 of bonds during the next biennium. The related agency shall submit the related agency's report to
3 the Governor by a date determined by the Governor and shall include in the report a description
4 of bonds that the related agency intends to retire or defease during the next biennium.

5 (2) On or before a date determined by the Governor, the State Treasurer shall advise the Gov-
6 ernor on the prudent maximum amount of bonds to be issued for each bond program. The State
7 Treasurer shall consider available economic and financial data in preparing advice to be given to
8 the Governor.

9 (3) As part of the Governor's budget report described in ORS 291.216, the Governor shall:

10 (a) Consider the prudent maximum amounts advised by the State Treasurer pursuant to sub-
11 section (2) of this section to determine the Governor's total recommended amount; and

12 (b) Recommend to the Legislative Assembly the total amount of bonds the State Treasurer may
13 issue for each bond program for a biennium.

14 (4) [*Except as otherwise provided in ORS 351.476,*] The Legislative Assembly shall determine the
15 amount of bonds the State Treasurer may issue for each state agency for a biennium. If the Legis-
16 lative Assembly fails to make the determination described in this subsection by the first day of the
17 biennium, the unused portion of the authorization the Legislative Assembly made for the preceding
18 biennium is deemed to carry forward for the current biennium at the amount authorized for the
19 preceding biennium until the earlier of:

20 (a) The date on which legislation authorizing the amount of bonds for the current biennium is
21 enacted; or

22 (b) The date on which the Legislative Assembly adjourns sine die.

23 (5) [*Except as otherwise provided in ORS 351.476,*] The amount of bonds that may be issued under
24 bond programs may be modified by the Governor. However, the Governor may not modify the
25 amount of bonds that may be issued under bond programs in a way that would cause the maximum
26 amount established by the Legislative Assembly for a category of bond programs to be exceeded if
27 the Legislative Assembly:

28 (a) Has categorized the bonds that may be issued under bond programs as general obligation,
29 direct revenue and pass-through revenue bonds; and

30 (b) Assigned a maximum amount to each category.

31 (6) This section applies to bonds:

32 (a) Unless the bonds are expressly exempted from the requirements of this section.

33 (b) Except refunding bonds.

34 **SECTION 9.** ORS 286A.700 is amended to read:

35 286A.700. (1) As used in this section:

36 (a) "Oregon Baccalaureate Bonds" means bonds of the State of Oregon issued by the State
37 Treasurer at the request of the [*Oregon University System*] **Higher Education Coordinating Com-**
38 **mission** that are designated as baccalaureate bonds.

39 (b) "Post-secondary education" means training and instruction provided by fully accredited
40 public universities or private institutions of higher learning, community colleges and post-high-
41 school career schools.

42 (2) The Legislative Assembly encourages citizens of the State of Oregon to avail themselves of
43 post-secondary education opportunities.

44 (3) The Legislative Assembly finds:

45 (a) For the benefit of its citizens, the state supports a system of common schools, public uni-

1 versities and community colleges.

2 (b) A post-secondary education advances a citizen's ability to pursue life, liberty and happiness
3 through a wide range of employment opportunities.

4 (c) A well-educated citizenry contributes to the economic well-being of the state and nation.

5 (d) A well-trained and skilled citizenry enhances economic development of the state.

6 (e) While students have just begun their education upon completion of a formal education, a
7 lifetime pursuit of learning contributes to a well-informed citizenry and to Oregon's cherished qual-
8 ity of life.

9 (f) Citizens educated in Oregon are more likely to pursue careers in Oregon.

10 (g) It is in the interest of this state to encourage its citizens to plan and save for a post-
11 secondary education.

12 (h) An Oregon Baccalaureate Bond program that provides citizens an opportunity to save for a
13 post-secondary education for their children, themselves or any citizen is in the social and economic
14 interest of the State of Oregon.

15 (i) A systematic way to save for post-secondary education can assist all of Oregon's higher ed-
16 ucation, community college and career schools to better project enrollments, thereby permitting the
17 prudent allocation of scarce resources.

18 (4) At the request of the Higher Education Coordinating Commission, the State Treasurer may:

19 (a) Issue bonds as Oregon Baccalaureate Bonds, to encourage investors to save for post-
20 secondary education opportunities.

21 (b) Investigate and implement the means and procedures to facilitate the participation by the
22 broadest practical range of investors in the Oregon Baccalaureate Bond program. The means and
23 procedures may include, but are not limited to, adjustments in the denominations in which the bonds

21 (e) An elected city official from a coastal city bordering the territorial sea to be appointed by

23 (f) A representative of each of the following ocean interests, to be appointed by the Governor,
24 and subject to confirmation by the Senate pursuant to section 4, Article III, Oregon Constitution:

25 (A) Commercial ocean fisheries of the North Coast from Newport north;

26 (B) Commercial ocean fisheries of the South Coast south of Newport;

27 (C) Charter, sport or recreation ocean fisheries of the North Coast from Newport north;

28 (D) Charter, sport or recreation ocean fisheries of the South Coast south of Newport;

29 (E) Ports marine navigation or transportation;

30 (F) Coastal nonfishing recreation interests of surfing, diving, kayaking or windsurfing;

31 (G) A coastal conservation or environmental organization;

32 (H) Oregon Indian tribes appointed after consultation with the Commission on Indian Services;

25 (c) Make recommendations to the director on the research, development and implementation of

34 (f) Investigate complaints and possible abuses of the certification program; and

36 ment that strengthen minority and women participation in the economic life of this state.

37 **SECTION 61.** ORS 200.055 is amended to read:

38 200.055. (1) Any disadvantaged, minority, women or emerging small business enterprise is enti-
39 tled to be certified as such upon application to the Oregon Business Development Department. If the
40 application is approved by the department, the department shall certify the applicant as a disad-
41 vantaged, minority, women or emerging small business enterprise. The enterprise shall be considered
42 so certified by any public contracting agency.

43 (2) In consultation with [*the State Board of Higher Education*] **public universities listed in ORS**
44 **352.002** and the Department of Transportation, and with the approval of the Advocate for Minority,

13 (1) "Appropriate bargaining unit" means the unit designated by the Employment Relations Board
14 or voluntarily recognized by the public employer to be appropriate for collective bargaining. How-
15 ever, an appropriate bargaining unit may not include both academically licensed and unlicensed or
16 nonacademically licensed school employees. Academically licensed units may include but are not
17 limited to teachers, nurses, counselors, therapists, psychologists, child development specialists and
18 similar positions. This limitation does not apply to any bargaining unit certified or recognized prior
19 to June 6, 1995, or to any school district with fewer than 50 employees.

20 (2) "Board" means the Employment Relations Board.

21 (3) "Certification" means official recognition by the board that a labor organization is the ex-
22 clusive representative for all of the employees in the appropriate bargaining unit.

23 (4) "Collective bargaining" means the performance of the mutual obligation of a public employer
24 and the representative of its employees to meet at reasonable times and confer in good faith with
25 respect to employment relations for the purpose of negotiations concerning mandatory subjects of
26 bargaining, to meet and confer in good faith in accordance with law with respect to any dispute
27 concerning the interpretation or application of a collective bargaining agreement, and to execute
28 written contracts incorporating agreements that have been reached on behalf of the public employer
29 and the employees in the bargaining unit covered by such negotiations. The obligation to meet and
30 negotiate does not compel either party to agree to a proposal or require the making of a concession.
31 This subsection may not be construed to prohibit a public employer and a certified or recognized
32 representative of its employees from discussing or executing written agreements regarding matters
33 other than mandatory subjects of bargaining that are not prohibited by law as long as there is mu-
34 tual agreement of the parties to discuss these matters, which are permissive subjects of bargaining.

35 (5) "Compulsory arbitration" means the procedure whereby parties involved in a labor dispute
36 are required by law to submit their differences to a third party for a final and binding decision.

37 (6) "Confidential employee" means one who assists and acts in a confidential capacity to a per-
38 son who formulates, determines and effectuates management policies in the area of collective bar-
39 gaining.

40 (7)(a) "Employment relations" includes, but is not limited to, matters concerning direct or indi-
41 rect monetary benefits, hours, vacations, sick leave, grievance procedures and other conditions of

43 (b) "Employment relations" does not include subjects determined to be permissive, nonmanda-
44 tory subjects of bargaining by the Employment Relations Board prior to June 6, 1995.

45 (c) After June 6, 1995, "employment relations" does not include subjects that the Employment

2 wages, hours, or other terms and conditions of employment.

3 (d) "Employment relations" does not include subjects that have an insubstantial or de minimis
4 effect on public employee wages, hours, and other terms and conditions of employment.

5 (e) For school district bargaining, "employment relations" excludes class size, the school or ed-
6 ucational calendar, standards of performance or criteria for evaluation of teachers, the school cur-
7 riculum, reasonable dress, grooming and at-work personal conduct requirements respecting smoking,
8 gum chewing and similar matters of personal conduct, the standards and procedures for student
9 discipline, the time between student classes, the selection, agendas and decisions of 21st Century
10 Schools Councils established under ORS 329.704, requirements for expressing milk under ORS
11 653.077, and any other subject proposed that is permissive under paragraphs (b), (c) and (d) of this
12 subsection.

13 (f) For employee bargaining involving employees covered by ORS 243.736, "employment
14 relations" includes safety issues that have an impact on the on-the-job safety of the employees or
15 staffing levels that have a significant impact on the on-the-job safety of the employees.

16 (g) For all other employee bargaining except school district bargaining and except as provided
17 in paragraph (f) of this subsection, "employment relations" excludes staffing levels and safety issues
18 (except those staffing levels and safety issues that have a direct and substantial effect on the on-

20 the minimum qualifications necessary for any position, criteria for evaluation or performance ap-

29 or more impartial individuals who review the positions of the parties, resolve factual differences and
30 make recommendations for settlement of the dispute.

31 (10) "Fair-share agreement" means an agreement between the public employer and the recog-
32 nized or certified bargaining representative of public employees whereby employees who are not
33 members of the employee organization are required to make an in-lieu-of-dues payment to an em-

3 arrange terms or conditions of employment relations, regardless of whether the disputants stand in
4 the proximate relation of employer and employee.

5 (13) "Labor organization" means any organization that has as one of its purposes representing
6 employees in their employment relations with public employers.

7 (14) "Last best offer package" means the offer exchanged by parties not less than 14 days prior
8 to the date scheduled for an interest arbitration hearing.

9 (15) "Legislative body" means the Legislative Assembly, the city council, the county commission
10 and any other board or commission empowered to levy taxes.

11 (16) "Managerial employee" means an employee of the State of Oregon or [*the Oregon University*
12 *System*] **a public university listed in ORS 352.002** who possesses authority to formulate and carry
13 out management decisions or who represents management's interest by taking or effectively recom-
14 mending discretionary actions that control or implement employer policy, and who has discretion in
15 the performance of these management responsibilities beyond the routine discharge of duties. A
16 "managerial employee" need not act in a supervisory capacity in relation to other employees.
17 Notwithstanding this subsection, "managerial employee" does not include faculty members at a
18 community college, college or university.

19 (17) "Mediation" means assistance by an impartial third party in reconciling a labor dispute
20 between the public employer and the exclusive representative regarding employment relations.

21 (18) "Payment-in-lieu-of-dues" means an assessment to defray the cost for services by the exclu-
22 sive representative in negotiations and contract administration of all persons in an appropriate
23 bargaining unit who are not members of the organization serving as exclusive representative of the
24 employees. The payment must be equivalent to regular union dues and assessments, if any, or must
25 be an amount agreed upon by the public employer and the exclusive representative of the employees.

26 (19) "Public employee" means an employee of a public employer but does not include elected
27 officials, persons appointed to serve on boards or commissions, incarcerated persons working under
28 section 41, Article I of the Oregon Constitution, or persons who are confidential employees, super-
29 visory employees or managerial employees.

30 (20) "Public employer" means the State of Oregon, and the following political subdivisions:
31 Cities, counties, community colleges, school districts, special districts, mass transit districts, metro-
32 politan service districts, public service corporations or municipal corporations and public and

2 commend such action, if in connection therewith, the exercise of the authority is not of a merely

18 243.800. (1) Notwithstanding any provision of ORS chapter 238 or 238A or ORS 243.910 to

19 including intellectual property, in its own name.

20 (5) Sue in its own name and be sued, plead and be impleaded in all actions, suits or proceedings
21 in any forum brought by or against it by any and all private or state, local, federal or other public
22 entities, agencies or persons.

23 (6) Encourage gifts and donations for the benefit of the university, and subject to the terms of
24 the gift, retain, invest and use such gifts as deemed appropriate by the university or the board.

4 ers, the university engages in activities that might otherwise be deemed anticompetitive within the

 20 from time to time by *[the State Board of Higher Education]* **Portland State University**; and

21 (B) For all distributions made from the Oregon Marijuana Account on or after July 1, 2017:
