SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Oregon Health Authority to prescribe by rule standards for integrating [mental] behavioral health services and physical health services in [coordinated care organizations] patient centered primary care homes and behavioral health homes. Defines "behavioral health home." Permits patient centered primary care homes and behavioral health homes to use billing codes applicable to [mental] physical and behavioral health services provided in primary care and urgent care settings.

Declares emergency, effective on passage.

3 414.655. (1) The Oregon Health Authority shall establish standards for the utilization of patient centered primary care homes [in] and behavioral health homes by coordinated care organizations. 4 (2) Each coordinated care organization shall implement, to the maximum extent feasible, patient 5 centered primary care homes and behavioral health homes, including developing capacity for ser-6 vices in settings that are accessible to families, diverse communities and underserved populations, 7 including the provision of integrated health care. The organization shall require its other health 8 9 and services providers to communicate and coordinate care with the patient centered primary care home or behavioral health home in a timely manner using electronic health information technol-10 11 ogy.

(3) Standards established by the authority for the utilization of patient centered primary care homes **and behavioral health homes** by coordinated care organizations may require the use of federally qualified health centers, rural health clinics, school-based health clinics and other safety net providers that qualify as patient centered primary care homes or **behavioral health homes** to ensure the continued critical role of those providers in meeting the needs of underserved populations.

(4) In order to promote the full integration of behavioral health and physical health services in primary care, behavioral health care and urgent care settings, providers in patient
 centered primary care homes and behavioral health homes may use billing codes applicable
 to the behavioral health and physical health services that are provided.

[(4)] (5) Each coordinated care organization shall report to the authority on uniform quality measures prescribed by the authority by rule for patient centered primary care homes **and behav**ioral health homes.

[(5)] (6) Patient centered primary care homes and behavioral health homes must participate

413.260. (1) The Oregon Health Authority, in collaboration with health insurers and purchasers of health plans including the Public Employees' Benefit Board, the Oregon Educators Benefit Board and other members of the patient centered primary care home learning collaborative and the patient centered primary care home program advisory committee, shall:

SECTION 8. ORS 442.210 is amended to read:

442.210. (1) There is established in the [Office for Oregon Health Policy and Research] Oregon
 Health Authority the patient centered primary care home program. Through this program, the [of fice] authority shall:

(a) Define core attributes of [*the*] **a** patient centered primary care home **and a behavioral health home** to promote a reasonable level of consistency of services provided by patient centered primary care homes **and behavioral health homes** in this state. In defining core attributes related to ensuring that care is coordinated, the [*office*] **authority** shall focus on determining whether these patient centered primary care homes **and behavioral health homes** offer comprehensive primary **and preventive** care, [*including prevention*] **integrated health care** and disease management services;

(4) The Legislative Assembly declares that collaboration among public payers, private health 19 carriers, third party purchasers and providers to identify appropriate reimbursement methods to 20align incentives in support of patient centered primary care homes and behavioral health homes 2122is in the best interest of the public. The Legislative Assembly therefore declares its intent to exempt 23from state antitrust laws, and to provide immunity from federal antitrust laws, the collaborative and associated payment reforms designed and implemented under subsection (3) of this section that might 94 otherwise be constrained by such laws. The Legislative Assembly does not authorize any person or 25entity to engage in activities or to conspire to engage in activities that would constitute per se vi-2627olations of state or federal antitrust laws including, but not limited to, agreements among competing health care providers or health carriers as to the prices of specific levels of reimbursement for 2829health care services.

37 414.018. (1) It is the intention of the Legislative Assembly to achieve the goals of universal access to an adequate level of high quality health care at an affordable cost. 38

(2) The Legislative Assembly finds: 39

(a) A significant level of public and private funds is expended each year for the provision of 40 health care to Oregonians; 41

(b) The state has a strong interest in assisting Oregon businesses and individuals to obtain 42 reasonably available insurance or other coverage of the costs of necessary basic health care ser-43 vices; 44

(c) The lack of basic health care coverage is detrimental not only to the health of individuals 45

1 lacking coverage, but also to the public welfare and the state's need to encourage employment 2 growth and economic development, and the lack results in substantial expenditures for emergency

3 and remedial health care for all purchasers of health care including the state; and

4 (d) The use of integrated and coordinated health care systems has significant potential to reduce 5 the growth of health care costs incurred by the people of this state.

6 (3) The Legislative Assembly finds that achieving its goals of improving health, increasing the 7 quality, reliability, availability and continuity of care and reducing the cost of care requires an in-8 tegrated and coordinated health care system in which:

9 (a) Medical assistance recipients and individuals who are dually eligible for both Medicare and
 10 Medicaid participate.

(b) Health care services, other than Medicaid-funded long term care services, are delivered through coordinated care contracts that use alternative payment methodologies to focus on prevention, improving health equity and reducing health disparities, utilizing patient centered primary care homes, **behavioral health homes**, evidence-based practices and health information technology to improve health and health care.

(c) High quality information is collected and used to measure health outcomes, health carequality and costs and clinical health information.

(d) Communities and regions are accountable for improving the health of their communities and
 regions, reducing avoidable health gaps among different cultural groups and managing health care
 resources.

(e) Care and services emphasize preventive services and services supporting individuals to live
 independently at home or in their community.

(f) Services are person centered, and provide choice, independence and dignity reflected in in dividual plans and provide assistance in accessing care and services.

(g) Interactions between the Oregon Health Authority and coordinated care organizations are
 done in a transparent and public manner.

(h) Moneys provided by the federal government for medical education are allocated to the in-stitutions that provide the education.

(4) The Legislative Assembly further finds that there is an extreme need for a skilled, diverse
workforce to meet the rapidly growing demand for community-based health care. To meet that need,
this state must:
