SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Declares that lobby message center in Oregon State Capitol shall be known as David S. Barrows Lobby Center.

CONCURRENT RESOLUTION

Whereas Oregon's physical and cultural landscape has been molded and shaped by policies continuously and publicly honed since statehood; and

Whereas through Oregon's history, Oregon's State Capitol buildings have witnessed 78 Legislative Assemblies, each striving to reflect the will of the people by continuously producing legislation aimed at providing a relative degree of certainty and an improved Oregon; and

Whereas this work occurs within an often chaotic but beautiful symphony involving lawmakers, the public and lobbyists; and

Whereas David S. Barrows was born on July 26, 1935, and first stepped foot into the Oregon State Capitol as a page for the House of Representatives in 1955; and

Whereas David S. Barrows received both a bachelor's degree and a law degree just steps from the Oregon State Capitol at Willamette University under the tutelage of Senator Mark O. Hatfield; and

Whereas David S. Barrows represented the Oregon Fairview Home as a lobbyist in the 1959 and 1961 legislative sessions while working at the Oregon Fairview Home and attending Willamette University College of Law; and

Whereas David S. Barrows began to represent clients as a registered lobbyist with the Oregon Legislative Assembly in 1963 and served a wide variety of clients at every Legislative Assembly held through March 2014; and

Whereas David S. Barrows conducted his life's work under a set of principles that he gladly shared with others and that he memorialized in "The Dos and Don'ts of Lobbying," which is the essential first and last read for those who seek to provide influence, and which was revised and reprinted by the Oregon Capitol Club as the *Oregon Lobbyist's Briefcase Companion*; and

Whereas the name "Dave Barrows" was synonymous throughout the Oregon State Capitol with quality, honesty, integrity, credibility and trust; now, therefore,

1 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

2 That we, the members of the Seventy-eighth Legislative Assembly, declare the following:

3 (1) That David S. Barrows was a leader in his own right, and his work in crafting public policy
4 will long influence the landscape of Oregon.

5 (2) That in appreciation for David S. Barrows' work and to ensure that his spirit is maintained,
6 the rooms in the Oregon State Capitol now collectively referred to as the lobby message center shall
7 be known as the David S. Barrows Lobby Center.

8 (3) That the planned renovation of the Oregon State Capitol basement and the expected reor-
9 ganization of the floor plan will not affect the intent of this resolution, and any formal gathering
10 space designed and built to be used by the members of the lobby at the Oregon State Capitol shall
11 be known as the David S. Barrows Lobby Center.
