

**PROPOSED AMENDMENTS TO
HOUSE BILL 2442**

1 On page 1 of the printed bill, line 4, after “456.571,” insert “456.572,”.

2 On page 7, delete line 14 and insert:

3 “(c) Provide policy direction and oversight to the department regarding
4 the department’s financial planning and biennial budget proposal prior to its
5 submittal to the Oregon Department of Administrative Services; and”.

6 In line 15, delete “(c)” and insert “(d)”.

7 In line 17, delete “department” and insert “Housing and Community Ser-
8 vices Department”.

9 On page 9, line 29, after the period insert “In appointing members, the
10 Governor shall seek to appoint persons from all geographic regions of the
11 state and with expertise in housing programs and related services to persons
12 experiencing poverty.”.

13 In line 42, after the period delete the rest of the line and line 43.

14 On page 10, line 1, after “to” insert a colon and delete the rest of the line
15 and line 2 and insert:

16 “(a) Aid in stimulating and increasing the supply of housing for persons
17 and families of lower income;

18 “(b) Address geographic and racial disparities; and

19 “(c) Ensure funds distributed by the Housing and Community Services
20 Department contribute to addressing other state priorities.”.

21 In lines 6 and 7, delete the boldfaced material.

22 In line 37, after “council” insert “, in conjunction with the Community

1 Action Partnership of Oregon.”.

2 In line 39, after “council” insert “, in conjunction with the Community
3 Action Partnership of Oregon.”.

4 After line 39, insert:

5 “(9) The council, in conjunction with the Community Action Partnership
6 of Oregon, shall advise the department regarding distribution of the delivery
7 system of federal antipoverty programs in Oregon as described in ORS
8 458.505.”.

9 On page 18, line 13, after “Council” insert “, in conjunction with the
10 Community Action Partnership of Oregon.”.

11 On page 19, line 31, after the second “Services” insert a comma and delete
12 “and”.

13 In line 32, after “Council” insert “and the Community Action Partnership
14 of Oregon”.

15 On page 45, after line 4, insert:

16 “**SECTION 51.** ORS 456.572 is amended to read:

17 “456.572. (1) The Housing and Community Services Department shall de-
18 velop a comprehensive state plan for responding to the needs of very low
19 income, low income and moderate income Oregonians for housing and ser-
20 vices, with the goal of providing affordable housing. The [*Housing and*
21 *Community Services*] department shall [*insure*] **ensure** that the development,
22 annual updating and implementation of [*this*] **the state housing** plan in-
23 volve substantial interagency coordination among appropriate federal, state
24 and local entities. **The department shall provide the Oregon Housing**
25 **Stability Council with adequate opportunity to review and provide in-**
26 **put on the state housing plan to the department prior to the develop-**
27 **ment, annual updating and implementation of the state housing plan.**

28 “(2) The state housing plan shall contain, at a minimum:

29 “(a) Information on market and inventory conditions including, but not
30 limited to, population trends, household composition, housing conditions and

1 an inventory of assisted housing and public housing;

2 “(b) A needs assessment that summarizes data on the housing needs of
3 homeless and income-eligible families and includes a five-year projection;

4 “(c) Strategies for a five-year period based upon a review of need and
5 conditions including, but not limited to, investment priorities, local and state
6 policies, local institutional structure and local activities for public housing
7 resident management and ownership;

8 “(d) A review of resources including, but not limited to, private, federal
9 and nonfederal resources, tax credits and a summary table of anticipated
10 funding from each federal program and any state or local resources available
11 to meet matching requirements;

12 “(e) A plan for coordination of resources reviewed under paragraph (d)
13 of this subsection; and

14 “(f) An implementation program translating the five-year strategy and
15 resource review into plans and goals for the number of families to be assisted
16 each year, specifying plans for homeless assistance and setting forth details
17 on monitoring, fair housing and relocation.

18 “(3) Before issuing the state housing plan, and before each annual update
19 of that plan, the Housing and Community Services Department shall hold
20 at least one public hearing to receive comments from public and private in-
21 terests.”.

22 In line 8, delete “51” and insert “52”.

23 In line 17, delete “52” and insert “53”.
