

**PROPOSED AMENDMENTS TO
HOUSE BILL 2442**

1 On page 1 of the printed bill, line 4, after “456.571,” insert “456.572,”.

2 In line 5, delete “458.505,”.

3 On page 7, delete line 14 and insert:

4 “(c) Provide policy direction and oversight to the department regarding
5 the department’s financial planning and biennial budget proposal prior to its
6 submittal to the Oregon Department of Administrative Services; and”.

7 In line 15, delete “(c)” and insert “(d)”.

8 In line 17, delete “department” and insert “Housing and Community Ser-
9 vices Department”.

10 On page 9, line 29, after the period insert “In appointing members, the
11 Governor shall seek to appoint persons from all geographic regions of the
12 state and with expertise in housing programs and related services to persons
13 experiencing poverty.”.

14 In line 42, after the period delete the rest of the line and line 43.

15 On page 10, line 1, after “to” insert a colon and delete the rest of the line
16 and line 2 and insert:

17 “(a) Aid in stimulating and increasing the supply of housing for persons
18 and families of lower income;

19 “(b) Address geographic and racial disparities; and

20 “(c) Ensure funds distributed by the Housing and Community Services
21 Department contribute to addressing other state priorities.”.

22 In lines 6 and 7, delete the boldfaced material.

1 In line 37, after “council” insert “, in conjunction with the Community
2 Action Partnership of Oregon,”.

3 In line 39, after “council” insert “, in conjunction with the Community
4 Action Partnership of Oregon,”.

5 On page 15, delete lines 29 through 45 and delete page 16.

6 On page 17, delete lines 1 through 21 and insert:

7 **“SECTION 16.** ORS 456.572 is amended to read:

8 “456.572. (1) The Housing and Community Services Department shall de-
9 velop a comprehensive state plan for responding to the needs of very low
10 income, low income and moderate income Oregonians for housing and ser-
11 vices, with the goal of providing affordable housing. The [*Housing and*
12 *Community Services*] department shall [*insure*] **ensure** that the development,
13 annual updating and implementation of [*this*] **the state housing** plan in-
14 volve substantial interagency coordination among appropriate federal, state
15 and local entities. **The department shall provide the Oregon Housing**
16 **Stability Council with adequate opportunity to review and provide in-**
17 **put on the state housing plan to the department prior to the develop-**
18 **ment, annual updating and implementation of the state housing plan.**

19 “(2) The state housing plan shall contain, at a minimum:

20 “(a) Information on market and inventory conditions including, but not
21 limited to, population trends, household composition, housing conditions and
22 an inventory of assisted housing and public housing;

23 “(b) A needs assessment that summarizes data on the housing needs of
24 homeless and income-eligible families and includes a five-year projection;

25 “(c) Strategies for a five-year period based upon a review of need and
26 conditions including, but not limited to, investment priorities, local and state
27 policies, local institutional structure and local activities for public housing
28 resident management and ownership;

29 “(d) A review of resources including, but not limited to, private, federal
30 and nonfederal resources, tax credits and a summary table of anticipated

1 funding from each federal program and any state or local resources available
2 to meet matching requirements;

3 “(e) A plan for coordination of resources reviewed under paragraph (d)
4 of this subsection; and

5 “(f) An implementation program translating the five-year strategy and
6 resource review into plans and goals for the number of families to be assisted
7 each year, specifying plans for homeless assistance and setting forth details
8 on monitoring, fair housing and relocation.

9 “(3) Before issuing the state housing plan, and before each annual update
10 of that plan, the Housing and Community Services Department shall hold
11 at least one public hearing to receive comments from public and private in-
12 terests.”.

13 On page 18, line 13, after “Council” insert “, in conjunction with the
14 Community Action Partnership of Oregon,”.

15 On page 19, line 31, after the second “Services” insert a comma and delete
16 “and”.

17 In line 32, after “Council” insert “and the Community Action Partnership
18 of Oregon”.

19 On page 20, delete line 24 and insert:

20 “(d) Oregon will strive to rank among the top states in the nation in
21 providing food security without hunger.”.

22 In line 35, delete the second “and”.

23 In line 36, delete the period and restore “; and”.

24 After line 38, insert:

25 “(g) The Hunger Task Force.”.

26 In line 40, delete “Relief” and restore “in the”.

27 In line 41, before the period insert “Department of Human Services”.

28 On page 21, after line 36, insert:

29 “(5) The Director of Human Services shall provide for the payment of
30 appropriate task force operating expenses, including but not limited to staff

1 support, based upon the availability of legislatively approved funding for
2 such purposes.”.

3 In line 38, delete “Relief”.

4 On page 22, line 5, after “(5)” delete the rest of the line and line 6 and
5 insert “Make recommendations and proposals that the task force deems ap-
6 propriate to the agencies and entities with member representatives on the
7 task force. The”.

8 In line 12, after the period insert “After the recommendations and pro-
9 posals have been reviewed and approved by the member representatives of
10 the task force, the task force shall submit the recommendations and pro-
11 posals to the Governor, the Legislative Assembly and others as deemed ap-
12 propriate by the task force.”.

13 On page 45, delete lines 6 through 13 and insert:

25 **and 23 of this 2015 Act are intended to change the name of the ‘Hunger**
26 **Relief Task Force’ to the ‘Hunger Task Force.’**

27 **“(b) For the purpose of harmonizing and clarifying statutory law,**
28 **the Legislative Counsel may substitute for words designating the**
29 **‘Hunger Relief Task Force,’ wherever they occur in statutory law,**
30 **other words designating the ‘Hunger Task Force.’”.**
