

**PROPOSED AMENDMENTS TO
HOUSE BILL 2234**

1 On page 1 of the printed bill, delete lines 5 through 21 and insert:

2 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part**
3 **of ORS chapter 414.**

4 **“SECTION 2. (1) As used in this section:**

5 **“(a) ‘Child’ means an individual under 18 years of age who is eligible**
6 **for medical assistance.**

7 **“(b) ‘Child abuse medical assessment’ has the meaning given that**
8 **term in ORS 418.782.**

9 **“(c) ‘Community assessment center’ has the meaning given that**
10 **term in ORS 418.782.**

11 **“(2) Notwithstanding ORS 414.690, the Oregon Health Authority**
12 **shall reimburse a community assessment center for the services the**
13 **center provides to a child in conducting a child abuse medical assess-**
14 **ment and the services related to the child abuse medical assessment**
15 **including, but not limited to:**

16 **“(a) A forensic interview; and**

17 **“(b) Mental health treatment.**

18 **“(3) The authority shall adopt billing and payment mechanisms to**
19 **ensure that the reimbursement is proportionate to the scope and in-**
20 **tensity of the services provided by the community assessment center.**

21 **“SECTION 3. Section 4 of this 2015 Act is added to and made a part**
22 **of the Insurance Code.**

1 **“SECTION 4. (1) As used in this section:**

2 **“(a) ‘Child’ means an individual under 18 years of age who is en-**
3 **rolled in a health benefit plan.**

4 **“(b) ‘Child abuse medical assessment’ has the meaning given that**
5 **term in ORS 418.782.**

6 **“(c) ‘Community assessment center’ has the meaning given that**
7 **term in ORS 418.782.**

8 **“(d) ‘Health benefit plan’ has the meaning given that term in ORS**
9 **743.730.**

10 **“(2) A health benefit plan shall reimburse a community assessment**
11 **center for the services the center provides to a child in conducting a**
12 **child abuse medical assessment and the services related to the child**
13 **abuse medical assessment including, but not limited to:**

14 **“(a) A forensic interview; and**

15 **“(b) Mental health treatment.**

16 **“(3) An insurer shall adopt billing and payment mechanisms to en-**
17 **sure that the reimbursement paid in accordance with this section is**
18 **proportionate to the scope and intensity of the services provided by the**
19 **community assessment center.**

20 **“(4) This section is exempt from ORS 743A.001.”.**

21 In line 22, delete “4” and insert “5”.

22 In line 29, delete “3” and insert “4”.

23 On page 2, line 38, delete “5” and insert “6”.

24 In line 45, delete “3” and insert “4”.

25 On page 3, line 38, delete “6” and insert “7”.

26 On page 4, line 1, delete “3” and insert “4”.

27 In line 38, delete “7” and insert “8”.

28 In line 45, delete “3” and insert “4”.
