

**PROPOSED AMENDMENTS TO  
HOUSE BILL 3027**

1 On page 1 of the printed bill, delete lines 25 through 29.

2 On page 2, delete lines 1 through 16 and insert:

4 **“FUNDING FOR TOURISM IN MT. HOOD AREA**

5

6 **“SECTION 3. (1) After the deduction of the cost of administration**  
7 **of the Mt. Hood registration plate program, the Department of**  
8 **Transportation shall deposit the net proceeds of the surcharge col-**  
9 **lected by the department under section 2 of this 2015 Act into the ac-**  
10 **count of the Oregon Tourism Commission established under ORS**  
11 **284.131. The department shall make deposits under this subsection at**  
12 **least quarterly.**

13 **“(2) Moneys deposited under subsection (1) of this section are con-**  
14 **tinuously appropriated to the Oregon Tourism Commission for the**  
15 **purposes set forth in ORS 284.131.**

16 **“(3) As used in this section, ‘the cost of administration of the Mt.**  
17 **Hood registration plate program’ means the sum of all department**  
18 **expenses for the issuance or transfer of Mt. Hood registration plates**  
19 **under section 2 of this 2015 Act that are above the normal costs of is-**  
20 **ssuing, renewing and transferring registration plates in the normal**  
21 **course of the business of the department. These expenses include, but**  
22 **are not limited to, the costs of collecting the Mt. Hood registration**

1 **plate surcharge and transferring Mt. Hood registration plates.**

2 **“SECTION 4. (1) As used in this section:**

3 **“(a) ‘Tourism promotion’ has the meaning given that term in ORS**  
4 **320.300.**

5 **“(b) ‘Tourism promotion agency’ has the meaning given that term**  
6 **in ORS 320.300.**

7 **“(2) After payment of the cost of production of the Mt. Hood reg-**  
8 **istration plates, including administrative expenses, the Oregon**  
9 **Tourism Commission shall distribute the moneys received from the**  
10 **Department of Transportation under section 3 of this 2015 Act as**  
11 **grants. The commission shall develop a grant program and shall award**  
12 **grants to tourism promotion agencies for tourism promotion of pe-**  
13 **destrian and bicycle tourism in the Mt. Hood area. The commission**  
14 **shall establish the maximum grant amount in the applicant guidelines**  
15 **prepared for the grant program in each biennium.**

16 **“(3) The commission shall adopt rules to carry out this section.**

20 **“SECTION 5. (1) The Department of Transportation, after consul-**  
21 **tation with the Oregon Tourism Commission, shall design the Mt.**  
22 **Hood registration plates issued under section 2 of this 2015 Act and**  
23 **shall ensure that the design includes an image of Mt. Hood.**

24 **“(2) Except as otherwise required by subsection (1) of this section,**  
25 **Mt. Hood registration plates must comply with the requirements of**  
26 **ORS 803.535.”.**
