PROPOSED AMENDMENTS TO SENATE BILL 885

- On page 1 of the printed bill, delete lines 5 through 30 and delete page 2 and insert:
- "SECTION 1. (1)(a) Notwithstanding ORS 294.060 (1), the first \$500,000 of moneys received by Lane County under ORS 293.560 that are directed to the school fund of the county shall be used by the county to fund career and technical education programs in the county.

- "(A) Enhance the ability of Lane County youth to secure gainful employment within the county.

- "(A) The amount of revenue actually received by the district from local option taxes imposed pursuant to ORS 280.040 to 280.145;

- "(B) Twenty percent of the total received by the school district from the general purpose grant, the transportation grant, the facility grant and the

- "SECTION 6. Sections 1 and 4 of this 2015 Act are repealed on July
- 30 **1, 2018.**

"SECTION 7. This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect on its passage."
