

**PROPOSED AMENDMENTS TO
HOUSE BILL 2150**

1 On page 1 of the printed bill, delete lines 24 through 28 and insert:

2 “(c) For the purpose of determining the amounts to be distributed to a
3 school district from the State School Fund for a public charter school, the
4 district extended ADMw described in ORS 327.013 shall be calculated:

5 “(A) Except as provided by subparagraph (B) of this paragraph, as though
6 the students enrolled at a public charter school are students enrolled at the
7 public schools of the school district in which the public charter school is
8 located.

9 “(B) By including only five percent of the portion of the ADM attribut-
10 able to the students who had been enrolled during the previous school year
11 at a public charter school that has ceased to operate because of dissolution
12 or closure or because of termination or nonrenewal of a charter.”.

13 On page 3, after line 3, insert:

14 **“SECTION 2. (1) In addition to amounts distributed to a public**
15 **charter school as provided by ORS 338.155 and for the 2015-2016 school**
16 **year only, an additional amount shall be available for distribution to**
17 **a school district that had been the sponsor of a public charter school**
18 **that operated during the 2014-2015 school year and that ceased to op-**
19 **erate following the 2014-2015 school year because of dissolution or clo-**
20 **sure or because of termination or nonrenewal of a charter.**

21 **“(2) The additional amount provided under subsection (1) of this**
22 **section shall be based on the district extended ADMw, described in**

1 **ORS 327.013, which shall be calculated by including only three percent**
2 **of the portion of the ADM attributable to the students who had been**
3 **enrolled during the previous school year at the public charter school.**

4 **“(3) The Department of Education shall set aside the additional**
5 **amount provided under subsection (1) of this section for distribution**
6 **to the school district described in subsection (1) of this section. The**
7 **amount shall be distributed to the school district upon a showing by**
8 **the school district of expenses incurred related to the public charter**
9 **school that ceased to operate. The department shall prescribe any re-**
10 **quirements related to a distribution under this section.**

11 **“(4)(a) For the 2015-2016 school year, the school district described**
12 **in subsection (1) of this section shall file with the department quar-**
13 **terly reports that describe expenses incurred by the school district**
14 **related to a public charter school that ceased to operate.**

15 **“(b) For the 2016-2017, 2017-2018 and 2018-2019 school years, the**
16 **school district described in subsection (1) of this section shall file with**
17 **the department annual reports that describe expenses incurred by the**
18 **school district related to a public charter school that ceased to oper-**
19 **ate.**

20 **“(c) The department shall prescribe any requirements for reports**
21 **filed under this subsection.**

22 **“SECTION 3. (1) Section 2 of this 2015 Act is repealed on July 1,**
23 **2019.**

24 **“(2) Any amounts not distributed as provided by section 2 of this**
25 **2015 Act by July 1, 2019, shall be transferred to the General Fund.”.**

26 In line 4, delete “2” and insert “4”.

27 In lines 17 through 19, restore the bracketed material.

28 In line 18, delete “(1)(b)”.

29 On page 4, line 32, delete “3” and insert “5” and delete “2” and insert
30 “4”.

- 2 In line 44, delete "5" and insert "6".
