

**PROPOSED AMENDMENTS TO
HOUSE BILL 3356**

1 In line 2 of the printed bill, after “shortage” insert “; creating new pro-
2 visions; amending ORS 348.350; and declaring an emergency”.

3 In line 5, after “hospitals” delete the rest of the line and insert “, of up
4 to \$3 million, for making capital expenditures to establish new primary care
5 residency programs that are sponsored by accredited medical schools and
6 osteopathic post-graduate training institutions.”.

7 After line 13, insert:

8 **“SECTION 3.** ORS 348.350 is amended to read:

9 “348.350. (1) The [*Executive*] Director of the [*Office of Student Access and*
10 *Completion*] **Oregon Health Authority** is authorized to establish and ad-
11 minister a cost-sharing program to train [*intern and*] residency physicians
12 as may be arranged by contract with [*an*] accredited training [*hospital*]
13 **hospitals** within this state. The cost sharing shall be limited to [*general*
14 *practice internships and*] **the start-up costs for family practice and psy-**
15 **chiatry residencies that are sponsored by accredited medical schools or**
16 **osteopathic post-graduate training institutions.** The [*commission*]
17 **Oregon Health Authority** may pay up to [*\$18,000*] **\$25,000** to an institution
18 for each intern or resident position [*which*] **that** is reserved for training
19 students who are planning to enter medical practice in rural areas. **An in-**
20 **stitution may not receive more than \$200,000 annually under this pro-**
21 **gram.**

22 “(2) Funds for programs established under subsection (1) of this section

1 shall be paid from the [*Rural Medical Education Loan Fund*] **Oregon Health**
2 **Authority Fund.**

3 “(3) No money appropriated under this section shall be used for any pro-
4 gram **located in a city with a population exceeding 400,000** [*at the Oregon*
5 *Health and Science University*]. The [*center*] **authority** shall be required to
6 give priority admissions to recipients under ORS 348.310 to 348.390 in its
7 family practice residency programs.

8 “**SECTION 4. In addition to and not in lieu of any other appropri-**
9 **ation, there is appropriated to the Oregon Health Authority Fund es-**
10 **tablished under ORS 413.101, for the biennium beginning July 1, 2015,**
11 **out of the General Fund, the amount of \$_____ for the purpose of**
12 **operating the cost-sharing program set forth in ORS 348.350, as**
13 **amended by section 3 of this 2015 Act.**

14 “**SECTION 5. ORS 348.350 is added to and made a part of ORS**
15 **chapter 413.**

16 “**SECTION 6. This 2015 Act being necessary for the immediate**
17 **preservation of the public peace, health and safety, an emergency is**
18 **declared to exist, and this 2015 Act takes effect on its passage.”.**
