

**PROPOSED AMENDMENTS TO
SENATE BILL 922**

1 On page 1 of the printed bill, line 2, delete “creating new provisions;
2 and” and after “750.505” insert “and 750.525”.

3 Delete lines 4 through 31 and delete page 2 and insert:

4 **“SECTION 1. ORS 750.505 is amended to read:**

5 **“750.505. As used in ORS 750.505 to 750.715:**

6 **“(1)(a) ‘Administration fee’ means a nominal fee that:**

7 **“(A) A legal access provider pays to an attorney for each customer**
8 **the legal access provider refers to the attorney;**

9 **“(B) Is not more than \$12 per month, or an amount the Director**
10 **of the Department of Consumer and Business Services specifies by**
11 **rule; and**

12 **“(C) Covers overhead expenses the attorney incurs in providing le-**
13 **gal consultations or other legal services to a legal access provider’s**
14 **customers.**

15 **“(b) ‘Administration fee’ does not include fees, charges or other**
16 **compensation that an attorney charges to the attorney’s client for le-**
17 **gal services or a reimbursement that a legal expense organization**
18 **provides under a legal expense plan.**

19 **“(2) ‘Legal access provider’ means a person that charges a fee to a**
20 **customer for the purpose of providing the customer with access to le-**
21 **gal consultations and other legal services and pays an administration**
22 **fee to an attorney for each customer that the person refers to the at-**

1 **torney for legal consultations or other legal services.**

2 “[1] (3)(a) ‘Legal expense organization’ or ‘organization’ means [any] a
3 person or group of persons [who] **that** provide or offer to provide a legal
4 expense plan, including [any] a person [who] **that** acts as [its] **the legal**
5 **expense plan’s** administrator.

6 “(b) ‘**Legal expense organization’ or ‘organization’ does not include**
7 **a legal access provider.**

8 “[2] (4) ‘Legal expense plan’ or ‘plan’ means [the] **an** agreement between
9 an organization and a person or a group of persons [whereby] **under which**
10 **the organization, in return for a specified payment as consideration,**
11 **reimburses the person or group of persons as members of the plan for**
12 **charges the person or group of persons incurs for** legal services [are to
13 *be provided to the person or group of persons as members, or whereby the*
14 *persons as members are to be reimbursed for charges incurred for legal ser-*
15 *vices, in consideration of a specified payment*].

16 “[3] (5) ‘Member’ means a person who is eligible to receive legal services
17 under a legal expense plan.

18 “[4] (6) ‘Membership agreement’ means [the] written evidence of cover-
19 age of a member under a plan between an organization and members.

20 “[5] (7) ‘Provider agreement’ means a written contract or agreement
21 between an organization and a providing attorney for [the] rendering [of]
22 legal services to a member or group of persons.

23 “[6] (8) ‘Providing attorney’ means any attorney licensed and in good
24 standing in this state who provides legal services [pursuant to the] **in ac-**
25 **cordance with a membership agreement or a provider agreement.**

26 “[7] (9) ‘Sales or marketing representative’ means [any] a person who
27 markets or solicits members for or on behalf of a plan.

28 “**SECTION 2.** ORS 750.525 is amended to read:

29 “750.525. ORS 750.505 to 750.715 do not apply to the following arrange-
30 ments:

1 “(1) A retainer [*contracts made by*] **contract that** an attorney or firm of
2 attorneys **makes** with a specific individual, [*pursuant to*] **under the terms**
3 **of which the attorney or firm bases** fees [*are based*] on reasonable esti-
4 mates of the nature and amount of services [*to be provided,*] **the attorney**
5 **or firm will provide,** and similar contracts [*made by*] **that** an attorney or
6 firm of attorneys **makes** with a group of clients involved in the same or
7 closely related legal matters.

8 “(2) Any two-party agreement [*providing for the delivery of*] **for delivering**
9 specified legal services in return for a specified payment, including [*an ad-*
10 *ministrative*] **a fee for administering the agreement or services related**
11 **to the agreement,** [*whereby an arrangement is made between*] **under the**
12 **terms of which** an attorney or firm of attorneys [*and*] **arranges to provide**
13 **legal services to** a group of individuals who are all members of the same
14 bona fide nonprofit membership organization, **such as a church, trade**
15 **group, credit union or association,** or a group of individuals who are all
16 employed by the same employer[, *the primary purpose of which is*] **and the**
17 **primary purpose of the nonprofit membership organization or the**
18 **employer is** other than [*the provision of legal services*] **providing legal**
19 **services.** [*Such groups of individuals may be but are not limited to churches,*
20 *trade groups, credit unions or associations. Under such an arrangement no*]
21 **An agreement is exempt from the application of ORS 750.505 to 750.715**
22 **under this subsection only if the agreement does not involve a third**
23 **party such as a legal expense organization or sales or marketing represen-**
24 **tative** [*may be involved*] in receiving any of the specified payments or in
25 overseeing the delivery of the specified legal services.

26 “(3) A referral of [*individual clients*] **a client** to an attorney, to the extent
27 that [*such referral is provided by*] a nonprofit lawyer referral service or
28 public corporation such as a state or local bar association[, *so long as there*
29 *is no*] **provides the referral and does not** charge for [*such*] **the referral.**

30 “(4) Employee welfare benefit plans to the extent that [*state regulation is*

1 *preempted by*] Section 514 of the federal Employee Retirement Income Secu-
2 rity Act of 1974, or successor legislation, **preempts state regulation.**

3 “(5) Legal assistance plans financed primarily by public funds, interest
4 on lawyers trust accounts funds under the regulation of the Oregon State
5 Bar or other public service funds.

6 “(6) Authorized insurers [*offering*] **that offer** legal expense insurance in
7 this state.

8 “(7) **A legal access provider that pays only an administration fee to**
9 **an attorney and does not pay for or reimburse a customer of the legal**
10 **access provider for legal services that the attorney provides to the**
11 **customer.”.**
