

**PROPOSED AMENDMENTS TO  
HOUSE BILL 3141**

1 On page 1 of the printed bill, delete lines 4 through 31 and delete page  
2 2 and insert:

3 **“SECTION 1.** ORS 646A.075 is amended to read:

4 “646A.075. (1) As used in this section:

5 “(a) ‘Dog’ means a member of the subspecies *Canis lupus familiaris* or a  
6 hybrid of that subspecies.

7 “(b) ‘Litter’ means one or more dogs, sold individually or together, that  
8 are all or part of a group of dogs born to the same mother at the same time.

9 “(c) ‘Retail pet store’ means a retail establishment open to the public  
10 that:

11 **“(A) Sells or offers to sell dogs[.];**

12 **“(B) Provides or offers to provide dogs on a lease or rental basis;**  
13 **or**

14 **“(C) Assumes ownership of dogs from persons who retain possession**  
15 **while paying a fee for dog supplies or services.**

16 “(d) ‘Retail pet store’ does not mean a person that sells [*or offers to*  
17 *sell*], **provides by lease or rental, assumes ownership of, offers to sell**  
18 **or offers to provide by lease or rental only dogs:**

19 “(A) That were bred or raised by the person; or

20 “(B) That are kept primarily for the purpose of reproduction.

21 “(2) A retail pet store that offers a dog for sale, **lease or rental** shall,  
22 prior to accepting an offer to purchase, **lease or rent** the dog, provide the

1 person making the offer with the following information, in writing, regarding  
2 the dog:

3 “(a) If known, the breed, age and date of birth for the dog.

4 “(b) The sex and color of the dog.

5 “(c) A list, and accompanying proof, of all inoculations that have been  
6 given to the dog by any person, and the date of those inoculations.

7 “(d) A list of all medical treatment provided to the dog by any person, the  
8 date or treatment and the reasons for the treatment.

9 “(e) **If known**, the name and business address of the breeder and of the  
10 facility where the dog was born.

11 “**(f) If the information described in paragraph (e) of this subsection**  
12 **is unknown, the name and address for the earliest source of the dog**  
13 **known to the retail pet store.**

14 “[*f*] **(g)** If the breeder holds a license issued by the United States De-  
15 partment of Agriculture, the breeder’s federal identification number.

16 “[*g*] **(h)** The retail price [*of*], **lease rate or rental rate for** the dog.

17 “[*h*] **(i)** Any congenital disorder or hereditary diseases in the parents  
18 of the dog known to the pet dealer.

19 “**(j) If the dog is being provided by lease or rental, a statement that**  
20 **the person obtaining possession is not the owner of the dog.**

21 “**(k) If the dog is being provided by lease or rental, a statement that**  
22 **the retail pet store retains ultimate authority to determine the level**  
23 **and source of veterinary care for the dog.**

24 “[*i*] **(L)** If the dog is being sold with the representation that the dog  
25 qualifies for registration with a pedigree organization:

26 “(A) The name and registration numbers of the parents of the dog; and

27 “(B) The name and address of the pedigree organization with which the  
28 parents of the dog are registered.

29 “[*j*] **(m)** If the dog has previously been sold by the retail pet store and  
30 returned by the purchaser, the reason for the return.

1       “[(k)] (n) A statement in substantially the following form, with the ap-  
2 plicable provision number circled:

3       “ \_\_\_\_\_

4       The facility in which this dog was born has produced:

5       1. 0 to 2 litters during the one-year period preceding the day this dog was  
6 born.

7       2. 3 to 10 litters during the one-year period preceding the day this dog  
8 was born.

9       3. 11 to 39 litters during the one-year period preceding the day this dog  
10 was born.

11       4. 40 or more litters during the one-year period preceding the day this dog  
12 was born.

13       “ \_\_\_\_\_

14       **“(3) A retail pet store that enters into an assumption of ownership**  
15 **described in subsection (1)(c)(C) of this section shall, prior to assuming**  
16 **ownership of the dog, provide the person who will be retaining pos-**  
17 **session of the dog with the following information, in writing, regard-**  
18 **ing the dog:**

19       **“(a) The total of one-time charges to be paid by the person and the**  
20 **periodic fee rate for dog supplies and services.**

21       **“(b) A statement that the person retaining possession is surren-**  
22 **dering ownership of the dog.**

23       **“(c) A statement that the retail pet store is acquiring ultimate au-**  
24 **thority to determine the level and source of veterinary care for the**  
25 **dog.”.**
