

**PROPOSED AMENDMENTS TO
HOUSE BILL 3141**

1 On page 1 of the printed bill, delete lines 4 through 31 and delete page
2 2 and insert:

3 **“SECTION 1.** ORS 646A.075 is amended to read:

4 “646A.075. (1) As used in this section:

5 “(a) ‘Dog’ means a member of the subspecies *Canis lupus familiaris* or a
6 hybrid of that subspecies.

7 “(b) ‘Litter’ means one or more dogs, sold individually or together, that
8 are all or part of a group of dogs born to the same mother at the same time.

9 “(c) ‘Retail pet store’ means:

10 **“(A) A retail establishment open to the public that sells or offers to sell**
11 **dogs[.];**

12 **“(B) A person that provides or offers to provide dogs on a lease or**
13 **rental basis; or**

14 **“(C) A person that assumes ownership of dogs from persons who**
15 **retain possession while paying a fee for dog supplies or services.**

16 “(d) ‘Retail pet store’ does not mean a person that sells [*or offers to*
17 *sell*], **provides by lease or rental, assumes ownership of, offers to sell**
18 **or offers to provide by lease or rental only dogs:**

19 “(A) That were bred or raised by the person; [*or*]

20 “(B) That are kept primarily for the purpose of reproduction; **or**

21 **“(C) That are provided by lease or rental for a period not exceeding**
22 **14 days under an agreement that does not provide for automatic ex-**

1 **tension or renewal of the lease or rental.**

2 “(2) A retail pet store that offers a dog for sale, **lease or rental** shall,
3 prior to accepting an offer to purchase, **lease or rent** the dog, provide the
4 person making the offer with the following information, in writing, regarding
5 the dog:

6 “(a) If known, the breed, age and date of birth for the dog.

7 “(b) The sex and color of the dog.

8 “(c) A list, and accompanying proof, of all inoculations that have been
9 given to the dog by any person, and the date of those inoculations.

10 “(d) A list of all medical treatment provided to the dog by any person, the
11 date or treatment and the reasons for the treatment.

12 “(e) **If known**, the name and business address of the breeder and of the
13 facility where the dog was born.

14 “**(f) If the information described in paragraph (e) of this subsection**
15 **is unknown, the name and address for the earliest source of the dog**
16 **known to the retail pet store.**

17 “[*f*] **(g)** If the breeder holds a license issued by the United States De-
18 partment of Agriculture, the breeder’s federal identification number.

19 “[*g*] **(h)** The retail price [*of*], **lease rate or rental rate for** the dog.

20 “[*h*] **(i)** Any congenital disorder or hereditary diseases in the parents
21 of the dog known to the pet dealer.

22 “**(j) If the dog is being provided by lease or rental, a statement that**
23 **the person obtaining possession is not the owner of the dog.**

24 “**(k) If the dog is being provided by lease or rental, a statement that**
25 **the retail pet store retains ultimate authority to determine the level**
26 **and source of veterinary care for the dog.**

27 “[*i*] **(L)** If the dog is being sold with the representation that the dog
28 qualifies for registration with a pedigree organization:

29 “(A) The name and registration numbers of the parents of the dog; and

30 “(B) The name and address of the pedigree organization with which the

1 parents of the dog are registered.

2 “[*j*] (m) If the dog has previously been sold by the retail pet store and
3 returned by the purchaser, the reason for the return.

4 “[*k*] (n) A statement in substantially the following form, with the ap-
5 plicable provision number circled:

6 “ _____

7 The facility in which this dog was born has produced:

8 1. 0 to 2 litters during the one-year period preceding the day this dog was
9 born.

10 2. 3 to 10 litters during the one-year period preceding the day this dog
11 was born.

12 3. 11 to 39 litters during the one-year period preceding the day this dog
13 was born.

14 4. 40 or more litters during the one-year period preceding the day this dog
15 was born.

17 **“(3) A retail pet store that enters into an assumption of ownership**
18 **described in subsection (1)(c)(C) of this section shall, prior to assuming**
19 **ownership of the dog, provide the person who will be retaining pos-**
20 **session of the dog with the following information, in writing, regard-**
21 **ing the dog:**

22 **“(a) The total of one-time charges to be paid by the person and the**
23 **periodic fee rate for dog supplies and services.**

24 **“(b) A statement that the person retaining possession is surren-**
25 **dering ownership of the dog.**

26 **“(c) A statement that the retail pet store is acquiring ultimate au-**
27 **thority to determine the level and source of veterinary care for the**
28 **dog.”.**
