

**PROPOSED AMENDMENTS TO
HOUSE BILL 2028**

1 On page 1 of the printed bill, line 18, after “pharmacist” insert “or phar-
2 macy”.

3 In line 19, delete “practitioner” and insert “physician as defined in ORS
4 677.010”.

5 In line 21, delete “practitioner” and insert “physician”.

6 On page 3, line 37, delete “medication therapy”.

7 In line 38, delete “management, comprehensive medication review and”.

8 On page 4, line 11, delete “and”.

9 After line 11, insert:

10 “(j) Patient care services, including medication therapy management and
11 comprehensive medication review; and”.

12 In line 12, delete “(j)” and insert “(k)”.

13 On page 5, line 11, delete “but not limited to”.

14 After line 31, insert:

15 **“SECTION 5. Section 6 of this 2015 Act is added to and made a part
16 of ORS chapter 414.**

17 **“SECTION 6. (1) The Oregon Health Authority may reimburse a
18 pharmacist or pharmacy for any health service:**

19 **“(a) Provided to a medical assistance recipient who is not enrolled
20 in a coordinated care organization or a prepaid managed care health
21 services organization;**

22 **“(b) That is within the lawful scope of practice of a pharmacist; and**

1 “(c) If the authority determines the service is within the types and
2 extent of health care and services to be provided to medical assistance
3 recipients under ORS 414.065.

4 “(2) A coordinated care organization may reimburse a pharmacist
5 or pharmacy for any health service:

6 “(a) Provided to a medical assistance recipient who is enrolled in
7 the coordinated care organization or a prepaid managed care health
8 services organization that enters into a clinical pharmacy agreement
9 with the pharmacist or pharmacy; and

10 “(b) That is within the lawful scope of practice of a pharmacist.”.

11 In line 32, delete “5” and insert “7” and delete “6” and insert “8”.

12 In line 33, delete “6” and insert “8”.

13 In line 37, delete “7” and insert “9”.

14 On page 6, line 15, delete “6” and insert “8”.

15 In line 37, delete “8” and insert “10”.
