

**PROPOSED AMENDMENTS TO
HOUSE BILL 3464**

1 On page 1 of the printed bill, delete lines 4 through 30.

2 On page 2, delete lines 1 through 7 and insert:

3 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part**
4 **of ORS chapter 414.**

5 **“SECTION 2. (1) The Oregon Health Authority shall prescribe by**
6 **rule appropriate time frames within which a pregnant medical assist-**
7 **ance recipient who needs general or specialty dental care must have**
8 **the opportunity to be seen, or referred for, and provided:**

9 **“(a) Emergency dental services;**

10 **“(b) Urgent dental services; and**

11 **“(c) Routine dental services.**

12 **“(2) The time frames prescribed by the authority for recipients**
13 **whose medical assistance is reimbursed on a fee-for-service basis shall**
14 **be consistent with the time frames for recipients enrolled in coordi-**
15 **nated care organizations and dental care organizations.**

16 **“(3) The authority shall adopt a procedure to ensure that a preg-**
17 **nant medical assistance recipient who is not enrolled in a coordinated**
18 **care organization or a dental care organization has the opportunity to**
19 **receive a dental screening within 30 days after the recipient reports**
20 **to the authority that she is pregnant.**

21 **“SECTION 3. (1) The Oregon Health Authority shall adopt proce-**
22 **dures to ensure that the authority collects and processes the infor-**

1 **mation necessary to determine if the requirements of section 2 of this**
2 **2015 Act are met.**

3 **“(2) No later than December 1, 2016, the authority shall report to**
4 **the Legislative Assembly, in the manner provided by ORS 192.245, on:**

5 **“(a) Whether the wait times for pregnant women to be seen, or re-**
6 **ferred for, and provided dental care are in accordance with the rules**
7 **prescribed by the authority under section 2 of this 2015 Act; and**

8 **“(b) The effectiveness of the procedure adopted by the authority**
9 **under section 2 of this 2015 Act to ensure that a pregnant medical as-**
10 **sistance recipient who is not enrolled in a coordinated care organiza-**
11 **tion or a dental care organization has the opportunity to receive a**
12 **dental screening within 30 days after the recipient reports to the au-**
13 **thority that she is pregnant.**

14 **“SECTION 4. (1) Section 2 of this 2015 Act becomes operative on**
15 **January 1, 2016.**

16 **“(2) The Oregon Health Authority shall take any action before the**
17 **operative date specified in subsection (1) of this section that is neces-**
18 **sary for the authority to implement the requirements of section 2 of**
19 **this 2015 Act on and after the operative date specified in subsection (1)**
20 **of this section.”.**

21 In line 8, delete “2” and insert “5” and delete “1” and insert “3” and de-
22 lete “December 31, 2016” and insert “January 2, 2017”.

23 In line 9, delete “3” and insert “6”.
