- "(a) Bidis, cigars, cheroots, stogies, periques, granulated, plug cut, crimp cut, ready rubbed and other smoking tobacco, snuff, snuff flour, cavendish, plug and twist tobacco, fine-cut and other chewing tobaccos, shorts, refuse scraps, clippings, cuttings and sweepings of tobacco and other forms of tobacco, prepared in a manner that makes the tobacco suitable for chewing or smoking in a pipe or otherwise, or for both chewing and smoking; or
- 8 "(b) Cigarettes as defined in ORS 323.010 (1).

- "SECTION 2. Licensure requirement. A person may not make a retail sale of a tobacco product or an inhalant delivery system in this state unless the person sells the tobacco product or inhalant delivery system at a premises for which a license has been issued under section 4 of this 2015 Act.
- "SECTION 3. Premises to which Act does not apply. Sections 1 to 14 11 of this 2015 Act do not apply to a person making a retail sale of an 15 inhalant delivery system at a medical marijuana facility registered 16 under ORS 475.314 or a premises for which a retail license has been 17 issued under section 22, chapter 1, Oregon Laws 2015 (Ballot Measure 18 91 (2014)), unless the person makes a retail sale of a component or 19 substance described in section 1 (1)(a)(B) of this 2015 Act that contains 20 nicotine. 21
 - "SECTION 4. Licensure qualifications. (1) The Oregon Liquor Control Commission shall license qualified premises for the retail sale of tobacco products or inhalant delivery systems.

- 27 "(B) May not be located at the same address as a residence; and
- 28 "(C) May not be located within 1,000 feet of any part of the premises of:

- "(b) Paragraph (a)(C) of this subsection does not apply to a premises for which a license has been issued under this section before the date on which the school is first attended by students unless the commission has revoked or refused to renew the license pursuant to section 7 of this 2015 Act.
- 9 "(3) For the purpose of licensing premises under this section, the 10 commission shall adopt rules establishing:
 - "(a) The term of licensure;
 - "(b) Procedures for applying for and renewing licenses; and
- "(c) Licensure application, issuance and renewal fees that are reasonably calculated to pay the costs of administering sections 1 to 11 of this 2015 Act.
- "(4) Amounts collected pursuant to subsection (3)(c) of this section shall be deposited in the Tobacco Control Fund established under section 9 of this 2015 Act.
- "(5) The commission may inspect the proposed premises of an applicant under this section to ensure compliance with this section and rules adopted under this section.
 - "SECTION 5. Prohibitions. (1) A person that makes retail sales of tobacco products or inhalant delivery systems may not:
 - "(a) Sell, offer for sale or allow to be sold a tobacco product or an inhalant delivery system for free or at a nominal price for the purpose of promoting the tobacco product or inhalant delivery system;
- "(b) Sell, offer for sale or allow to be sold a tobacco product or a component or substance described in section 1 (1)(a)(B) of this 2015 Act at a reduced price if the buyer of the tobacco product, component or substance purchases multiple packets of the tobacco product, com-

- 1 ponent or substance during a single transaction; or
- "(c) Redeem a coupon for a tobacco product or an inhalant delivery system.
- "(2) A person that makes retail sales of inhalant delivery systems and allows customers of the person to sample inhalant delivery system products at the premises of the person's business:
 - "(a) Must be primarily engaged in the sale of inhalant delivery systems, with at least 75 percent of gross revenues of the business resulting from the sales of inhalant delivery systems;
 - "(b) May not sell tobacco products or alcohol;

- "(c) May not permit a person who may not purchase inhalant delivery systems because the person is under the legal age limit for purchasing inhalant delivery systems to enter the premises; and
 - "(d) Must have a maximum seating capacity of four persons.
- "(3) The Oregon Liquor Control Commission is required to verify that a person that makes retail sales of inhalant delivery systems and allows customers of the person to sample inhalant delivery system products at the premises of the person's business is in compliance with subsection (2)(a) of this section only upon receiving a complaint that the person is not in compliance with subsection (2)(a) of this section.
- "SECTION 6. Inspections and enforcement. (1) The Oregon Liquor Control Commission may inspect a premises licensed under section 4 of this 2015 Act to ensure compliance with sections 1 to 11 of this 2015 Act and rules adopted under sections 1 to 11 of this 2015 Act.
- "(2) At the time of conducting an inspection pursuant to this section, the commission shall provide educational information to the holder of a license issued under section 4 of this 2015 Act or an employee of the holder of a license about the requirements of sections 1 to 11 of this 2015 Act and the health impacts of using nicotine derived products. If the holder of the license or the employee is not proficient

- in speaking English, the commission must make every reasonable ef-
- 2 fort to provide the holder or the employee with educational informa-
- 3 tion written in the language of the holder or the employee or to
- 4 communicate the information orally to the holder or the employee in

- "SECTION 10. Rules. The Oregon Liquor Control Commission shall adopt rules necessary for the effective administration of sections 1 to 11 of this 2015 Act.
 - "SECTION 11. Intergovernmental agreement. (1) The Oregon Liquor Control Commission shall enter into an agreement with the Oregon Health Authority for the purposes of administering and enforcing the provisions of ORS 433.835 to 433.875 and rules adopted under ORS 433.835 to 433.875 that are related to the regulation of cigar bars, as defined in ORS 433.835, and smoke shops certified under ORS 433.835 to 433.875, including those provisions and rules related to the certification process.

- ject to subsection (2) of this section, section 4 (2)(a)(C) of this 2015 Act does not apply to a premises that applies for a license under section 4 of this 2015 Act no later than one month after the operative date specified in section 15 of this 2015 Act.
 - (2) This section does not apply to a premises for which a license has been issued under section 4 of this 2015 Act if the business located on the premises changes ownership.
