PROPOSED AMENDMENTS TO HOUSE BILL 3402

- On page 1 of the printed bill, delete lines 4 through 30.
- On page 2, delete lines 1 through 39 and insert:
- 3 **"SECTION 1.** ORS 811.111 is amended to read:
- 4 "811.111. (1) A person commits the offense of violating a speed limit if the person:
- 6 "(a) Drives a vehicle on an interstate highway, except for the portions
 - of interstate highway described in subsection (2) of this section, at a
- 8 speed greater than 65 miles per hour or, if a different speed is posted under
- 9 ORS 810.180 [(3)], at a speed greater than the posted speed.
- 10 "(b) Notwithstanding paragraph (a) of this subsection, drives any of the
- 11 following vehicles at a speed greater than 55 miles per hour on any
- 12 highway, except for the portions of highway described in subsections
- 13 (2) to (11) of this section, or, if a different speed is posted under ORS
- 14 810.180 [(3)], at a speed greater than the posted speed:
- "(A) A motor truck with a gross vehicle weight rating of more than 10,000
- 16 pounds or a truck tractor with a gross vehicle weight rating of more than
- 17 8,000 pounds.

- 18 "(B) A school bus.
- "(C) A school activity vehicle.
- 20 "(D) A worker transport bus.
- "(E) A bus operated for transporting children to and from church or an
- 22 activity or function authorized by a church.

- "(F) Any vehicle used in the transportation of persons for hire by a nonprofit entity as provided in ORS 825.017 (9).
- "(c) Drives a vehicle or conveyance on any part of the ocean shore in this

 state at a speed greater than any of the following:
- 5 "(A) Any designated speed for ocean shores that is established and posted 6 under ORS 810.180.
- 7 "(B) If no designated speed is posted under ORS 810.180, 25 miles per 8 hour.
- "(d) Drives a vehicle upon a highway in any city at a speed greater than
 a speed posted by authority granted under ORS 810.180 or, if no **designated**speed is posted, the following:
- "(A) Fifteen miles per hour when driving on an alley or a narrow residential roadway.
- "(B) Twenty miles per hour in a business district.
- 15 "(C) Twenty-five miles per hour in a public park.
- 16 "(D) Twenty-five miles per hour on a highway in a residence district if 17 the highway is not an arterial highway.
- 18 "(E) Sixty-five miles per hour on an interstate highway.
- 19 "(F) Fifty-five miles per hour in locations not otherwise described in this 20 paragraph.
- "(e) Drives a vehicle in a school zone at a speed greater than 20 miles per hour if the school zone is:
- "(A) A segment of highway described in ORS 801.462 (1)(a) and:
- "(i) The school zone has a flashing light used as a traffic control device and operated under ORS 810.243 and the flashing light indicates that children may be arriving at or leaving school; or
- "(ii) If the school zone does not have a flashing light used as a traffic control device, the person drives in the school zone between 7 a.m. and 5 p.m. on a day when school is in session.
 - "(B) A crosswalk described in ORS 801.462 (1)(b) and:

- "(i) A flashing light used as a traffic control device and operated under 1 ORS 810.243 indicates that children may be arriving at or leaving school; or 2
- "(ii) Children are present, as described in ORS 811.124. 3
- "(2) A person commits the offense of violating a speed limit if the 4 person drives a vehicle on the portion of Interstate 84 beginning at the 5 eastern city limit of The Dalles and ending at the Idaho state line at 6 a speed greater than: 7
- "(a) Sixty-five miles per hour for vehicles described in subsection 8 (1)(b) of this section; or 9
- "(b) Seventy miles per hour for all other vehicles. 10

- "(3) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of State Highway 95 beginning 12 at the Idaho state line and ending at the Nevada state line at a speed 13 greater than: 14
- "(a) Sixty-five miles per hour for vehicles described in subsection 15 (1)(b) of this section; or 16
- "(b) Seventy miles per hour for all other vehicles. 17
- "(4) A person commits the offense of violating a speed limit if the 18 person drives a vehicle on the portion of State Highway 20 beginning 19 in Bend and ending in Ontario at a speed greater than: 20

- "(6) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of State Highway 31 beginning in Valley Falls and ending in La Pine at a speed greater than:
- 6 "(a) Sixty miles per hour for vehicles described in subsection (1)(b)
 7 of this section; or
- 8 "(b) Sixty-five miles per hour for all other vehicles.
- "(7) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of State Highway 78 beginning in Burns Junction and ending in Burns at a speed greater than:
- "(a) Sixty miles per hour for vehicles described in subsection (1)(b)
 of this section; or
- 14 "(b) Sixty-five miles per hour for all other vehicles.
- 15 "(8) A person commits the offense of violating a speed limit if the 16 person drives a vehicle on the portion of State Highway 395 beginning 17 in Burns and ending in John Day at a speed greater than:
- 18 "(a) Sixty miles per hour for vehicles described in subsection (1)(b)
 19 of this section; or
- 20 "(b) Sixty-five miles per hour for all other vehicles.
- "(9) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of State Highway 395 beginning in Riley and ending at the California state line at a speed greater than:
- 24 "(a) Sixty miles per hour for vehicles described in subsection (1)(b) 25 of this section; or
- 26 "(b) Sixty-five miles per hour for all other vehicles.
- "(10) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of Oregon Route 205 beginning in Burns and ending in Frenchglen at a speed greater than:
 - "(a) Sixty miles per hour for vehicles described in subsection (1)(b)

- 1 of this section; or
- 2 "(b) Sixty-five miles per hour for all other vehicles.
- "(11) A person commits the offense of violating a speed limit if the person drives a vehicle on the portion of State Highway 26 beginning
- 5 in John Day and ending in Vale at a speed greater than:
- 6 "(a) Sixty miles per hour for vehicles described in subsection (1)(b)
 7 of this section; or
- 8 "(b) Sixty-five miles per hour for all other vehicles.
- "(12) The speed limits described in subsections (3) to (5) of this section do not apply to portions of highways inside of a city in this state.
- "[(2)] (13) The offense described in this section, violating a speed limit, is punishable as provided in ORS 811.109.".
