

**PROPOSED AMENDMENTS TO
HOUSE BILL 2486**

1 On page 1 of the printed bill, line 3, after “ORS” delete the rest of the
2 line and insert “310.155; and prescribing an effective”.

3 Delete lines 6 through 28 and delete pages 2 through 11 and insert:

4 **“SECTION 1.** ORS 310.155 is amended to read:

5 “310.155. (1) For purposes of ORS 310.150, taxes are levied or imposed to
6 fund the public school system if the taxes will be used exclusively for edu-
7 cational services, including support services, provided by any unit of gov-
8 ernment, at any level from prekindergarten through post-graduate training.

9 “[~~(2)~~ *Taxes on property levied or imposed by a unit of government whose*
10 *principal function is to provide educational services shall be considered to be*
11 *dedicated to fund the public school system unless the sole purpose of a par-*
12 *ticular, voter approved levy is for other than educational services or support*
13 *services as defined in this section.]*

14 “[~~(3)~~ *Taxes on property levied or imposed by a unit of government whose*
15 *principal function is to perform government operations other than educational*
16 *services shall be considered to be dedicated to fund the public school system*
17 *only if the sole purpose of a particular, voter approved levy is for educational*
18 *services or support services as defined in this section.]*

19 “[~~(4)~~] **(2)** As used in this section[,]:

20 **“(a)(A)** ‘Educational services’ includes:

21 “[~~(a)~~] **(i)** Establishment and maintenance of preschools, kindergartens, el-
22 ementary schools, high schools, community colleges and the public universi-

1 ties listed in ORS 352.002.

2 “[*(b)*] **(ii)** Establishment and maintenance of career schools, adult educa-
3 tion programs, evening school programs and schools or facilities for persons
4 with physical, mental or emotional disabilities.

5 **“(B) ‘Educational services’ does not include community recreation**
6 **programs, civic activities, public libraries, programs for custody or**
7 **care of children or community welfare activities if those programs or**
8 **activities are provided to the general public and not for the benefit of**
9 **students or other participants in the programs and activities described**
10 **in subparagraph (A) of this paragraph.**

11 “[*(5)*] **(b)** [*As used in this section,*] ‘Support services’ includes clerical,
12 administrative, professional and managerial services, property maintenance,
13 transportation, counseling, training and other services customarily performed
14 in connection with the delivery of educational services.

15 “[*(6)*] *‘Educational services’ does not include community recreation pro-*
16 *grams, civic activities, public libraries, programs for custody or care of chil-*
17 *dren or community welfare activities if those programs or activities are*
18 *provided to the general public and not for the benefit of students or other*
19 *participants in the programs and activities described in subsection (4) of this*
20 *section.*]

21 **“SECTION 2. This 2015 Act takes effect on the 91st day after the**
22 **date on which the 2015 regular session of the Seventy-eighth Legisla-**
23 **tive Assembly adjourns sine die.”.**
