PROPOSED AMENDMENTS TO **HOUSE BILL 2571**

- On page 1 of the printed bill, delete line 3 and insert "41.910, 136.295, 1
- 165.540 and 192.501; and declaring an emergency.". 2
- In line 6, before "storage" insert "use,". 3
- Delete lines 9 and 10 and insert: 4

- "(b) The policies and procedures described in paragraph (a) of this sub-5 section must include: 6
- "(A) A requirement that a recording be retained for at least 180 days but 7 no more than 30 months for a recording not related to a court proceeding, 8 or for the same period of time that evidence is retained in the normal course 9 of the court's business for a recording related to a court proceeding.
- "(B) A requirement that a camera worn upon a law enforcement officer's 11 person be set to record continuously, beginning when the officer develops 12 reasonable suspicion or probable cause to believe that a crime or violation 13 has occurred, is occurring or will occur and the law enforcement officer be-14 gins to make contact with the person suspected of committing the offense. 15 The policies and procedures must also require that the camera may subse-16 quently cease recording no sooner than the termination of the officer's par-17 ticipation in the contact. 18
- "(C) A requirement that in any contract with a third party vendor for 19 data storage, recordings from the camera are the property of the law 20 enforcement agency, are not owned by the vendor and cannot be used by the 21 vendor for any purpose inconsistent with the policies and procedures of the 22

- 2 "(D) A prohibition on the use of facial recognition or other biometric 3 matching technology to analyze recordings obtained through the use of the
- 4 camera.

- 5 "(E) A prohibition on the use of any recordings obtained from the camera 6 for any purpose other than a legitimate law enforcement purpose.
- "(c) Notwithstanding paragraph (b)(B) of this subsection, a law enforcement agency may in its policies and procedures provide for exceptions to the recording requirements of paragraph (b)(B) of this subsection, provided that the exceptions are based on reasonable privacy concerns, exigent circumstances or the safety of law enforcement officers or other persons."
- On page 2, line 36, after "unless" insert a colon and delete the rest of the line and lines 37 and 38 and insert:
- 14 "(i) The officer has an opportunity to announce at the beginning of the 15 interaction that the conversation is being obtained; and
- "(ii) The announcement can be accomplished without causing jeopardy to the officer or any other person and without unreasonably impairing a criminal investigation; or".

"SECTION 4. ORS 136.295 is amended to read:

- "136.295. (1) ORS 136.290 does not apply to persons charged with crimes that are not releasable offenses under ORS 135.240 or to persons charged with conspiracy to commit murder, or charged with attempted murder, or to prisoners serving sentences resulting from prior convictions.

 - "(b) The offense with which the arrested person is charged;
- 28 "(c) The conditions of release pursuant to ORS 135.230 to 135.290;
- "(d) The identity of and biographical information concerning both complaining party and victim;

- "(e) The identity of the investigating and arresting agency and the length of the investigation;
- 3 "(f) The circumstances of arrest, including time, place, resistance, pursuit 4 and weapons used; and
- 5 "(g) Such information as may be necessary to enlist public assistance in 6 apprehending fugitives from justice.
 - "(4) Test questions, scoring keys, and other data used to administer a licensing examination, employment, academic or other examination or testing procedure before the examination is given and if the examination is to be used again. Records establishing procedures for and instructing persons administering, grading or evaluating an examination or testing procedure are included in this exemption, to the extent that disclosure would create a risk that the result might be affected.
- "(5) Information consisting of production records, sale or purchase records 14 or catch records, or similar business records of a private concern or enter-15 prise, required by law to be submitted to or inspected by a governmental 16 body to allow it to determine fees or assessments payable or to establish 17 production quotas, and the amounts of such fees or assessments payable or 18 paid, to the extent that such information is in a form which would permit 19 identification of the individual concern or enterprise. This exemption does 20 not include records submitted by long term care facilities as defined in ORS 21 442.015 to the state for purposes of reimbursement of expenses or determining 22 fees for patient care. Nothing in this subsection shall limit the use which 23 can be made of such information for regulatory purposes or its admissibility 24 in any enforcement proceeding. 25
- 26 "(6) Information relating to the appraisal of real estate prior to its acquisition.
- "(7) The names and signatures of employees who sign authorization cards or petitions for the purpose of requesting representation or decertification elections.

- "(8) Investigatory information relating to any complaint filed under ORS 659A.820 or 659A.825, until such time as the complaint is resolved under ORS 659A.835, or a final order is issued under ORS 659A.850.
- "(9) Investigatory information relating to any complaint or charge filed under ORS 243.676 and 663.180.
- 6 "(10) Records, reports and other information received or compiled by the 7 Director of the Department of Consumer and Business Services under ORS 8 697.732.
- "(11) Information concerning the location of archaeological sites or objects as those terms are defined in ORS 358.905, except if the governing body of an Indian tribe requests the information and the need for the information is related to that Indian tribe's cultural or religious activities. This exemption does not include information relating to a site that is all or part of an existing, commonly known and publicized tourist facility or attraction.
- 15 "(12) A personnel discipline action, or materials or documents supporting 16 that action.
- "(13) Information developed pursuant to ORS 496.004, 496.172 and 498.026 or ORS 496.192 and 564.100, regarding the habitat, location or population of any threatened species or endangered species.
 - "(14) Writings prepared by or under the direction of faculty of public educational institutions, in connection with research, until publicly released, copyrighted or patented.
- "(15) Computer programs developed or purchased by or for any public body for its own use. As used in this subsection, 'computer program' means a series of instructions or statements which permit the functioning of a computer system in a manner designed to provide storage, retrieval and manipulation of data from such computer system, and any associated documentation and source material that explain how to operate the computer program. 'Computer program' does not include:
 - "(a) The original data, including but not limited to numbers, text, voice,

- "(b) Analyses, compilations and other manipulated forms of the original data produced by use of the program; or
- "(c) The mathematical and statistical formulas which would be used if the manipulated forms of the original data were to be produced manually.
- 6 "(16) Data and information provided by participants to mediation under 7 ORS 36.256.
- "(17) Investigatory information relating to any complaint or charge filed under ORS chapter 654, until a final administrative determination is made or, if a citation is issued, until an employer receives notice of any citation.
- "(18) Specific operational plans in connection with an anticipated threat to individual or public safety for deployment and use of personnel and equipment, prepared or used by a public body, if public disclosure of the plans would endanger an individual's life or physical safety or jeopardize a law enforcement activity.
- "(19)(a) Audits or audit reports required of a telecommunications carrier. 16 As used in this paragraph, 'audit or audit report' means any external or 17 internal audit or audit report pertaining to a telecommunications carrier, as 18 defined in ORS 133.721, or pertaining to a corporation having an affiliated 19 interest, as defined in ORS 759.390, with a telecommunications carrier that 20 is intended to make the operations of the entity more efficient, accurate or 21 compliant with applicable rules, procedures or standards, that may include 22 self-criticism and that has been filed by the telecommunications carrier or 23 affiliate under compulsion of state law. 'Audit or audit report' does not mean 24 an audit of a cost study that would be discoverable in a contested case pro-25 ceeding and that is not subject to a protective order; and 26
- "(b) Financial statements. As used in this paragraph, 'financial statement' means a financial statement of a nonregulated corporation having an affiliated interest, as defined in ORS 759.390, with a telecommunications carrier, as defined in ORS 133.721.

- "(20) The residence address of an elector if authorized under ORS 247.965
- and subject to ORS 247.967.
- 3 "(21) The following records, communications and information submitted
- 4 to a housing authority as defined in ORS 456.005, or to an urban renewal
- 5 agency as defined in ORS 457.010, by applicants for and recipients of loans,
- 6 grants and tax credits:
- 7 "(a) Personal and corporate financial statements and information, in-
- 8 cluding tax returns;
- 9 "(b) Credit reports;
- "(c) Project appraisals, excluding appraisals obtained in the course of
- 11 transactions involving an interest in real estate that is acquired, leased,
- rented, exchanged, transferred or otherwise disposed of as part of the project,
- but only after the transactions have closed and are concluded;
- "(d) Market studies and analyses;
- 15 "(e) Articles of incorporation, partnership agreements and operating 16 agreements;
- "(f) Commitment letters;
- "(g) Project pro forma statements;
- "(h) Project cost certifications and cost data;
- 20 "(i) Audits;
- "(j) Project tenant correspondence requested to be confidential;
- 22 "(k) Tenant files relating to certification; and
- 23 "(L) Housing assistance payment requests.
- "(22) Records or information that, if disclosed, would allow a person to:
- 25 "(a) Gain unauthorized access to buildings or other property;
- 26 "(b) Identify those areas of structural or operational vulnerability that
- 27 would permit unlawful disruption to, or interference with, services; or
- 28 "(c) Disrupt, interfere with or gain unauthorized access to public funds
- or to information processing, communication or telecommunication systems,
- 30 including the information contained in the systems, that are used or operated

- 1 by a public body.
- 2 "(23) Records or information that would reveal or otherwise identify se-
- 3 curity measures, or weaknesses or potential weaknesses in security measures,

- 7 "(c) Information processing, communication or telecommunication sys-

- "(24) Personal information held by or under the direction of officials of the Oregon Health and Science University, a public university listed in ORS 352.002 or the Oregon University System about a person who has or who is interested in donating money or property to the Oregon Health and Science University, the system or a public university, if the information is related to the family of the person, personal assets of the person or is incidental information not related to the donation.
- "(25) The home address, professional address and telephone number of a person who has or who is interested in donating money or property to the Oregon University System or a public university listed in ORS 352.002.
- "(26) Records of the name and address of a person who files a report with or pays an assessment to a commodity commission established under ORS 576.051 to 576.455, the Oregon Beef Council created under ORS 577.210 or the Oregon Wheat Commission created under ORS 578.030.
- "(27) Information provided to, obtained by or used by a public body to authorize, originate, receive or authenticate a transfer of funds, including but not limited to a credit card number, payment card expiration date, password, financial institution account number and financial institution routing number.
 - "(28) Social Security numbers as provided in ORS 107.840.

- "(29) The electronic mail address of a student who attends a public university listed in ORS 352.002 or Oregon Health and Science University.
- "(30) If requested by a public safety officer, as defined in ORS 181.610:
- "(a) The home address and home telephone number of the public safety officer contained in the voter registration records for the public safety officer.
- "(b) The home address and home telephone number of the public safety officer contained in records of the Department of Public Safety Standards and Training.
- "(c) The name of the public safety officer contained in county real property assessment or taxation records. This exemption:
 - "(A) Applies only to the name of the public safety officer and any other owner of the property in connection with a specific property identified by the officer in a request for exemption from disclosure;
- 15 "(B) Applies only to records that may be made immediately available to 16 the public upon request in person, by telephone or using the Internet;
- "(C) Applies until the public safety officer requests termination of the exemption;
 - "(D) Does not apply to disclosure of records among public bodies as defined in ORS 174.109 for governmental purposes; and
 - "(E) May not result in liability for the county if the name of the public safety officer is disclosed after a request for exemption from disclosure is made under this subsection.
- "(31) Unless the public records request is made by a financial institution, as defined in ORS 706.008, consumer finance company licensed under ORS chapter 725, mortgage banker or mortgage broker licensed under ORS 86A.095 to 86A.198, or title company for business purposes, records described in paragraph (a) of this subsection, if the exemption from disclosure of the records is sought by an individual described in paragraph (b) of this subsection using the procedure described in paragraph (c) of this subsection:

- "(a) The home address, home or cellular telephone number or personal electronic mail address contained in the records of any public body that has received the request that is set forth in:
- "(A) A warranty deed, deed of trust, mortgage, lien, deed of reconveyance, release, satisfaction, substitution of trustee, easement, dog license, marriage license or military discharge record that is in the possession of the county clerk; or
- 8 "(B) Any public record of a public body other than the county clerk.
 - "(b) The individual claiming the exemption from disclosure must be a district attorney, a deputy district attorney, the Attorney General or an assistant attorney general, the United States Attorney for the District of Oregon or an assistant United States attorney for the District of Oregon, a city attorney who engages in the prosecution of criminal matters or a deputy city attorney who engages in the prosecution of criminal matters.

Unless the claim is filed with the county clerk, the claim form shall list the public records in the possession of the public body to which the exemption applies. The exemption applies until the individual claiming the exemption requests termination of the exemption or ceases to qualify for the exemption.
 - "(32) The following voluntary conservation agreements and reports:
- 23 "(a) Land management plans required for voluntary stewardship agree-24 ments entered into under ORS 541.423; and
- 25 "(b) Written agreements relating to the conservation of greater sage 26 grouse entered into voluntarily by owners or occupiers of land with a soil 27 and water conservation district under ORS 568.550.
- "(33) Sensitive business records or financial or commercial information of the State Accident Insurance Fund Corporation that is not customarily provided to business competitors. This exemption does not:

 - "(36) Any document or other information related to an audit of a public body, as defined in ORS 174.109, that is in the custody of an auditor or audit organization operating under nationally recognized government auditing standards, until the auditor or audit organization issues a final audit report in accordance with those standards or the audit is abandoned. This exemption does not prohibit disclosure of a draft audit report that is provided to the audited entity for the entity's response to the audit findings.
 - "(37)(a) Personally identifiable information collected as part of an electronic fare collection system of a mass transit system.
 - "(b) The exemption from disclosure in paragraph (a) of this subsection does not apply to public records that have attributes of anonymity that are sufficient, or that are aggregated into groupings that are broad enough, to ensure that persons cannot be identified by disclosure of the public records.
 - "(c) As used in this subsection:
- "(A) 'Electronic fare collection system' means the software and hardware used for, associated with or relating to the collection of transit fares for a

"(c) A video recording disclosed under this subsection must, prior to disclosure, be edited in a manner as to render the faces of all persons within the recording unidentifiable.

"SECTION 7. This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect on its passage."
