  - "(6) 'Claim' means a written request for compensation from a subject worker or someone on the worker's behalf, or any compensable injury of which a subject employer has notice or knowledge.
- "(7)(a) A 'compensable injury' is an accidental injury, or accidental injury
  to prosthetic appliances, arising out of and in the course of employment requiring medical services or resulting in disability or death; an injury is accidental if the result is an accident, whether or not due to accidental means,
  if it is established by medical evidence supported by objective findings, subject to the following limitations:

  - "(d) 'Insured vehicle,' except as provided in paragraph (e) of this provision, means:
  - "(A) The vehicle described in the policy or a newly acquired or substitute vehicle, as each of those terms is defined in the public liability coverage of the policy, insured under the public liability provisions of the policy; or
  - "(B) A nonowned vehicle operated by the named insured or spouse if a resident of the same household, provided that the actual use thereof is with the permission of the owner of the vehicle and the vehicle is not owned by nor furnished for the regular or frequent use of the insured or any member of the same household.
  - "(e) 'Insured vehicle' does not include a trailer of any type unless the

- 1 trailer is a described vehicle in the policy.
- 2 "(f) 'Occupying' means in or upon or entering into or alighting from.
- "(g) 'Phantom vehicle' means a vehicle that causes bodily injury to an insured arising out of a motor vehicle accident that is caused by a vehicle that has no physical contact with the insured or the vehicle the insured is
- 6 occupying at the time of the accident, provided:
- "(A) The identity of either the operator or the owner of the phantom vehicle cannot be ascertained;
- "(B) The facts of the accident can be corroborated by competent evidence other than the testimony of the insured or any person having an uninsured motorist claim resulting from the accident; and
- "(C) The insured or someone on behalf of the insured reported the acci-12 dent within 72 hours to a police, peace or judicial officer, to the Department 13 of Transportation or to the equivalent department in the state where the 14 accident occurred, and filed with the insurer within 30 days thereafter a 15 statement under oath that the insured or the legal representative of the in-16 sured has a cause or causes of action arising out of the accident for damages 17 against a person or persons whose identities are unascertainable, and setting 18 forth the facts in support thereof. 19
- 20 "(h) 'State' includes the District of Columbia, a territory or possession 21 of the United States and a province of Canada.
- "(i) 'Stolen vehicle' means an insured vehicle that causes bodily injury to the insured arising out of a motor vehicle accident if:
  - "(A) The vehicle is operated without the consent of the insured;
- 25 "(B) The operator of the vehicle does not have collectible motor vehicle 26 bodily injury liability insurance;
- "(C) The insured or someone on behalf of the insured reported the accident within 72 hours to a police, peace or judicial officer or to the equivalent department in the state where the accident occurred; and
  - "(D) The insured or someone on behalf of the insured cooperates with the

- appropriate law enforcement agency in the prosecution of the theft of the vehicle.
- "(j) 'Sums that the insured, the heirs or the legal representative of the insured is legally entitled to recover as general and special damages from the owner or operator of an uninsured vehicle' means the amount of damages that:
- "(A) A claimant could have recovered in a civil action from the owner or operator at the time of the injury after determination of fault or comparative fault and resolution of any applicable defenses;

- "(A) A vehicle with respect to the ownership, maintenance or use of 16 which there is no collectible motor vehicle bodily injury liability insurance, 17 in at least the amounts or limits prescribed for bodily injury or death under 18 ORS 806.070 applicable at the time of the accident with respect to any person 19 or organization legally responsible for the use of the vehicle, or with respect 20 to which there is collectible bodily injury liability insurance applicable at 21 the time of the accident but the insurance company writing the insurance 22 denies coverage or the company writing the insurance becomes voluntarily 23 or involuntarily declared bankrupt or for which a receiver is appointed or 24 becomes insolvent. It shall be a disputable presumption that a vehicle is 25 uninsured in the event the insured and the insurer, after reasonable efforts, 26 fail to discover within 90 days from the date of the accident, the existence 27 of a valid and collectible motor vehicle bodily injury liability insurance ap-28 plicable at the time of the accident. 29
  - "(B) A hit-and-run vehicle.

- 1 "(C) A phantom vehicle.
- 2 "(D) A stolen vehicle.
- 3 "(E) A vehicle that is owned or operated by a self-insurer:
- 4 "(i) That is not in compliance with ORS 806.130 (1)(c); or
- 5 "(ii) That provides recovery to an insured in an amount that is less than 6 the limits for uninsured motorist coverage of the insured.
- 7 "(L) 'Uninsured vehicle' does not include:
- 8 "(A) An insured vehicle, unless the vehicle is a stolen vehicle;
- "(B) Except as provided in paragraph (k)(E) of this subsection, a vehicle that is owned or operated by a self-insurer within the meaning of any motor vehicle financial responsibility law, motor carrier law or any similar law;
- "(C) A vehicle that is owned by the United States of America, Canada, a state, a political subdivision of any such government or an agency of any such government;
- 15 "(D) A land motor vehicle or trailer, if operated on rails or crawler-treads 16 or while located for use as a residence or premises and not as a vehicle;
- 17 "(E) A farm-type tractor or equipment designed for use principally off 18 public roads, except while actually upon public roads; or
- 19 "(F) A vehicle owned by or furnished for the regular or frequent use of 20 the insured or any member of the household of the insured.
- "(m) 'Vehicle' means every device in, upon or by which any person or property is or may be transported or drawn upon a public highway, but does not include devices moved by human power or used exclusively upon stationary rails or tracks.
- "(3) This coverage applies only to accidents that occur on and after the effective date of the policy, during the policy period and within the United States of America, its territories or possessions, or Canada.
- "(4)(a) This coverage does not apply to bodily injury of an insured with respect to which the insured or the legal representative of the insured shall, without the written consent of the insurer, make any settlement with or

- prosecute to judgment any action against any person or organization who may be legally liable therefor.
- "(b) This coverage does not apply to bodily injury to an insured while occupying a vehicle, other than an insured vehicle, owned by, or furnished for the regular use of, the named insured or any relative resident in the same household, or through being struck by the vehicle.
- "(c) This coverage does not apply so as to inure directly or indirectly to
  the benefit of any workers' compensation carrier, any person or organization
  qualifying as a self-insurer under any workers' compensation or disability
  benefits law or any similar law or the State Accident Insurance Fund Corporation.
  - "(d) This coverage does not apply with respect to underinsured motorist benefits unless:
    - "(A) The limits of liability under any bodily injury liability insurance applicable at the time of the accident regarding the injured person have been exhausted by payment of judgments or settlements to the injured person or other injured persons;
    - "(B) The described limits have been offered in settlement, the insurer has refused consent under paragraph (a) of this subsection and the insured protects the insurer's right of subrogation to the claim against the tortfeasor;
  - "(C) The insured gives credit to the insurer for the unrealized portion of the described liability limits as if the full limits had been received if less than the described limits have been offered in settlement, and the insurer has consented under paragraph (a) of this subsection; or
  - "(D) The insured gives credit to the insurer for the unrealized portion of the described liability limits as if the full limits had been received if less than the described limits have been offered in settlement and, if the insurer has refused consent under paragraph (a) of this subsection, the insured protects the insurer's right of subrogation to the claim against the tortfeasor.
    - "(e) When seeking consent under paragraph (a) or (d) of this subsection,

"(5)(a) As soon as practicable, the insured or other person making claim 10 shall give to the insurer written proof of claim, under oath if required, in-11 cluding full particulars of the nature and extent of the injuries, treatment 12 and other details entering into the determination of the amount payable 13 hereunder. The insured and every other person making claim hereunder shall 14 submit to examinations under oath by any person named by the insurer and 15 subscribe the same, as often as may reasonably be required. Proof of claim 16 shall be made upon forms furnished by the insurer unless the insurer fails 17

to furnish the forms within 15 days after receiving notice of claim.

- "(b) Upon reasonable request of and at the expense of the insurer, the injured person shall submit to physical examinations by physicians, physician assistants or nurse practitioners selected by the insurer and shall, upon each request from the insurer, execute authorization to enable the insurer to obtain medical reports and copies of records.
- "(6) If, before the insurer makes payment of loss hereunder, the insured or the legal representative of the insured institutes any legal action for bodily injury against any person or organization legally responsible for the use of a vehicle involved in the accident, a copy of the summons and complaint or other process served in connection with the legal action shall be forwarded immediately to the insurer by the insured or the legal representative of the insured.

- "(7)(a) The limit of liability stated in the declarations as applicable to 'each person' is the limit of the insurer's liability for all damages because of bodily injury sustained by one person as the result of any one accident and, subject to the above provision respecting each person, the limit of liability stated in the declarations as applicable to 'each accident' is the total limit of the company's liability for all damages because of bodily injury sustained by two or more persons as the result of any one accident.
  - "(b) Any payment made under this coverage to or for an insured shall be applied in reduction of any amount that the insured may be entitled to recover from any person who is an insured under the bodily injury liability coverage of this policy.
  - "(c) Any amount payable under the terms of this coverage because of bodily injury sustained in an accident by a person who is an insured under this coverage shall be reduced by:
  - "(A) All sums paid on account of the bodily injury by or on behalf of the owner or operator of the uninsured vehicle and by or on behalf of any other person or organization jointly or severally liable together with the owner or operator for the bodily injury, including all sums paid under the bodily injury liability coverage of the policy; and
  - "(B) The amount paid and the present value of all amounts payable on account of the bodily injury under any workers' compensation law, disability benefits law or any similar law.
  - "(d) Any amount payable under the terms of this coverage because of bodily injury sustained in an accident by a person who is an insured under this coverage shall be reduced by the credit given to the insurer pursuant to subsection (4)(d)(C) or (D) of this section.
  - "(e) The amount payable under the terms of this coverage may not be reduced by the amount of liability proceeds offered, described in subsection (4)(d)(B) or (D) of this section, that has not been paid to the injured person. If liability proceeds have been offered and not paid, the amount payable un-

- der the terms of the coverage shall include the amount of liability limits
- 2 offered but not accepted due to the insurer's refusal to consent. The insured
- 3 shall cooperate so as to permit the insurer to proceed by subrogation or as-
- 4 signment to prosecute the claim against the uninsured motorist.
- 5 "(8) No action shall lie against the insurer unless, as a condition
- 6 precedent thereto, the insured or the legal representative of the insured has

- 8 "(9)(a) With respect to bodily injury to an insured:
- 9 "(A) While occupying a vehicle owned by a named insured under this 10 coverage, the insurance under this coverage is primary.
  - "(B) While occupying a vehicle not owned by a named insured under this coverage, the insurance under this coverage shall apply only as excess insurance over any primary insurance available to the occupant that is similar to this coverage, and this excess insurance shall then apply only in the amount by which the applicable limit of liability of this excess coverage exceeds the sum of the applicable limits of liability of all primary insurance available to the occupant.
  - "(b) If an insured is an insured under other primary or excess insurance available to the insured that is similar to this coverage, then the insured's damages are deemed not to exceed the higher of the applicable limits of liability of this insurance or the additional primary or excess insurance available to the insured, and the insurer is not liable under this coverage for a greater proportion of the insured's damages than the applicable limit of liability of this coverage bears to the sum of the applicable limits of liability of this insurance and other primary or excess insurance available to the insured.
- "(c) With respect to bodily injury to an insured while occupying any motor vehicle used as a public or livery conveyance, the insurance under this coverage shall apply only as excess insurance over any other insurance available to the insured that is similar to this coverage, and this insurance

- shall then apply only in the amount by which the applicable limit of liability of this coverage exceeds the sum of the applicable limits of liability of all other insurance.
- "(10) If any person making claim hereunder and the insurer do not agree 4 that the person is legally entitled to recover damages from the owner or 5 operator of an uninsured vehicle because of bodily injury to the insured, or 6 do not agree as to the amount of payment that may be owing under this 7 coverage, then, in the event the insured and the insurer elect by mutual 8 agreement at the time of the dispute to settle the matter by arbitration, the 9 arbitration shall take place as described in ORS 742.505. Any judgment upon 10 the award rendered by the arbitrators may be entered in any court having 11 jurisdiction thereof, provided, however, that the costs to the insured of the 12 arbitration proceeding do not exceed \$100 and that all other costs of arbi-13 tration are borne by the insurer. 'Costs' as used in this provision does not 14 include attorney fees or expenses incurred in the production of evidence or 15 witnesses or the making of transcripts of the arbitration proceedings. The 16 person and the insurer each agree to consider themselves bound and to be 17 bound by any award made by the arbitrators pursuant to this coverage in the 18 event of such election. At the election of the insured, the arbitration shall 19 be held: 20
- 21 "(a) In the county and state of residence of the insured;
- 22 "(b) In the county and state where the insured's cause of action against 23 the uninsured motorist arose; or
- 24 "(c) At any other place mutually agreed upon by the insured and the 25 insurer.
- 26 "(11) In the event of payment to any person under this coverage:
- "(a) The insurer shall be entitled to the extent of the payment to the proceeds of any settlement or judgment that may result from the exercise of any rights of recovery of the person against any uninsured motorist legally responsible for the bodily injury because of which payment is made;

- "(b) The person shall hold in trust for the benefit of the insurer all rights of recovery that the person shall have against such other uninsured person or organization because of the damages that are the subject of claim made under this coverage, but only to the extent that the claim is made or paid herein;
- "(c) If the insured is injured by the joint or concurrent act or acts of two 6 or more persons, one or more of whom is uninsured, the insured shall have 7 the election to receive from the insurer any payment to which the insured 8 9 would be entitled under this coverage by reason of the act or acts of the uninsured motorist, or the insured may, with the written consent of the 10 insurer, proceed with legal action against any or all persons claimed to be 11 liable to the insured for the injuries. If the insured elects to receive payment 12 from the insurer under this coverage, then the insured shall hold in trust for 13 the benefit of the insurer all rights of recovery the insured shall have 14 against any other person, firm or organization because of the damages that 15 are the subject of claim made under this coverage, but only to the extent of 16 the actual payment made by the insurer; 17
  - "(d) The person shall do whatever is proper to secure and shall do nothing after loss to prejudice such rights;
  - "(e) If requested in writing by the insurer, the person shall take, through any representative not in conflict in interest with the person, designated by the insurer, such action as may be necessary or appropriate to recover payment as damages from such other uninsured person or organization, such action to be taken in the name of the person, but only to the extent of the payment made hereunder. In the event of a recovery, the insurer shall be reimbursed out of the recovery for expenses, costs and attorney fees incurred by the insurer in connection therewith; and
  - "(f) The person shall execute and deliver to the insurer any instruments and papers as may be appropriate to secure the rights and obligations of the person and the insurer established by this provision.
