

**PROPOSED AMENDMENTS TO  
SENATE BILL 844**

1 In line 2 of the printed bill, delete “amending section 27, chapter 1,  
2 Oregon Laws 2015” and insert “creating new provisions; amending ORS  
3 181.534, 181.537, 475.300, 475.302, 475.303, 475.304, 475.306, 475.309, 475.312,  
4 475.314, 475.316, 475.319, 475.320, 475.323, 475.326, 475.328, 475.331, 475.334,  
5 475.338, 475.340 and 475.342 and section 2, chapter 79, Oregon Laws 2014, and  
6 section 5, chapter 1, Oregon Laws 2015; repealing ORS 475.324; and declaring  
7 an emergency.”.

10 **“OREGON MEDICAL MARIJUANA ACT**

11

**“(Definitions)”**

12

13 **“SECTION 1.** ORS 475.302 is amended to read:

14 “475.302. As used in ORS 475.300 to 475.346:

15 “(1) ‘Attending physician’ means a physician licensed under ORS chapter  
16 677 who has primary responsibility for the care and treatment of a person  
17 diagnosed with a debilitating medical condition.

18 “[2) ‘Authority’ means the Oregon Health Authority.]

19 **“(2) ‘Cannabinoid’ means any of the chemical compounds that are**  
20 **the active constituents of marijuana.**

21 **“(3) ‘Cannabinoid concentrate’ means a substance obtained by sep-**  
22 **arating cannabinoids from marijuana by:**

1       “(a) A mechanical extraction process;

2       “(b) A chemical extraction process using a nonhydrocarbon-based  
3 solvent, such as vegetable glycerin, vegetable oils, animal fats,  
4 isopropyl alcohol or ethanol;

5       “(C) A chemical extraction process using the hydrocarbon-based  
6 solvent carbon dioxide, provided that the process does not involve the  
7 use of high heat or pressure; or

8       “(D) Any other process identified by the Oregon Health Authority,  
9 in consultation with the Oregon Liquor Control Commission, by rule.

10       “(4) ‘Cannabinoid edible’ means food or potable liquid into which a  
11 cannabinoid concentrate, cannabinoid extract or dried leaves or flow-  
12 ers of marijuana have been incorporated.

13       “(5) ‘Cannabinoid extract’ means a substance obtained by separat-  
14 ing cannabinoids from marijuana by:

15       “(a) A chemical extraction process using a hydrocarbon-based sol-  
16 vent, such as butane, hexane or propane;

17       “(b) A chemical extraction process using the hydrocarbon-based  
18 solvent carbon dioxide, if the process uses high heat or pressure; or

19       “(c) Any other process identified by the Oregon Health Authority,  
20 in consultation with the Oregon Liquor Control Commission, by rule.

21       “[(3)] (6) ‘Debilitating medical condition’ means:

22       “(a) Cancer, glaucoma, agitation incident to Alzheimer’s disease, positive  
23 status for human immunodeficiency virus or acquired immune deficiency  
24 syndrome, or a side effect related to the treatment of [*these*] **those** medical  
25 conditions;

26       “(b) A medical condition or treatment for a medical condition that  
27 produces, for a specific patient, one or more of the following:

28       “(A) Cachexia;

29       “(B) Severe pain;

30       “(C) Severe nausea;

1 “(D) Seizures, including seizures caused by epilepsy; or

2 “(E) Persistent muscle spasms, including spasms caused by multiple  
3 sclerosis;

4 “(c) Post-traumatic stress disorder; or

5 “(d) Any other medical condition or side effect related to the treatment  
6 of a medical condition adopted by the **Oregon Health** Authority by rule or  
7 approved by the authority pursuant to a petition [*submitted*] **filed** under ORS  
8 475.334.

9 “[~~(4)(a)~~] **(7)(a)** ‘Delivery’ has the meaning given that term in ORS 475.005.

10 “(b) ‘Delivery’ does not include transfer of[:]

11 “[~~(A)~~] marijuana by a registry identification cardholder to another regis-  
12 try identification cardholder if no consideration is paid for the transfer[:].

13 “[~~(B)~~ *Usable marijuana or immature marijuana plants from a registry*  
14 *identification cardholder, the designated primary caregiver of a registry iden-*  
15 *tification cardholder or a marijuana grow site to a medical marijuana facility*  
16 *registered under ORS 475.314; or]*

17 “[~~(C)~~ *Usable marijuana or immature marijuana plants from a medical*  
18 *marijuana facility registered under ORS 475.314 to a registry identification*  
19 *cardholder or the designated primary caregiver of a registry identification*  
20 *cardholder.]*

21 “[~~(5)~~] **(8)(a)** ‘Designated primary caregiver’ means an individual:

22 “**(A) Who is 18 years of age or older;**

23 “**(B) Who has significant responsibility for managing the well-being of a**  
24 **person who has been diagnosed with a debilitating medical condition; and**

25 “**(C) Who is designated as [~~such on that~~] the person responsible for**  
26 **managing the well-being of a person who has been diagnosed with a**  
27 **debilitating medical condition on that** person’s application for a registry  
28 identification card or in other written notification **submitted** to the au-  
29 thority.

30 “**(b)** ‘Designated primary caregiver’ does not include [~~the~~] a person’s at-

1 tending physician.

2 “[~~(6)~~ *‘Marijuana’* has the meaning given that term in ORS 475.005.]

3 **“(9) ‘High heat’ means a temperature exceeding 180 degrees.**

4 **“(10) ‘Immature marijuana plant’ meant a marijuana plant that is**  
5 **not flowering.**

6 **“(11)(a) ‘Marijuana’ means the plant Cannabis family Cannabaceae,**  
7 **any part of the plant Cannabis family Cannabaceae and the seeds of**  
8 **the plant Cannabis family Cannabaceae.**

9 **“(b) ‘Marijuana’ does not include industrial hemp, as defined in**  
10 **ORS 571.300.**

11 **“[~~(7)~~] (12) ‘Marijuana grow site’ means a location registered under ORS**  
12 **475.304 where marijuana is produced for use by a registry identification**  
13 **cardholder.**

14 **“(13) ‘Marijuana processing site’ means a marijuana processing site**  
15 **registered under section 10 of this 2015 Act or a site for which an ap-**  
16 **plicant has submitted an application for registration under section 10**  
17 **of this 2015 Act.**

18 **“(14) ‘Mature marijuana plant’ means a marijuana plant, whether**  
19 **growing or cut and drying, that is not an immature marijuana plant.**

20 **“(15)(a) ‘Medical cannabinoid product’ means a cannabinoid edible**  
21 **and any other product intended for human consumption or use that**  
22 **contains cannabinoids or dried leaves or flowers of marijuana.**

23 **“(b) ‘Medical cannabinoid product’ does not include:**

24 **“(A) Usable marijuana by itself;**

25 **“(B) A cannabinoid concentrate by itself;**

26 **“(C) A cannabinoid extract by itself; or**

27 **“(D) Industrial hemp, as defined in ORS 571.300.**

28 **“(16) ‘Medical marijuana dispensary’ means a medical marijuana**  
29 **dispensary registered under ORS 475.314 or a site for which an appli-**  
30 **cant has submitted an application for registration under ORS 475.314.**

1        “[8] (17) ‘Medical use of marijuana’ means the production, **processing**,  
2 possession, delivery[, *distribution*] or administration of marijuana, or **use of**  
3 paraphernalia used to administer marijuana, [*as necessary for the exclusive*  
4 *benefit of a person*] to mitigate the symptoms or effects of [*the person’s*] a  
5 debilitating medical condition.

6        “[9] ‘Production’ has the meaning given that term in ORS 475.005.]

7        “(18) ‘Process’ means the **compounding or conversion of marijuana**  
8 **into medical cannabinoid products, cannabinoid concentrates or**  
9 **cannabinoid extracts.**

10       “(19) ‘Production’ means:

11       “(a) **Planting, cultivating, growing, trimming or harvesting**  
12 **marijuana; or**

13       “(b) **Drying marijuana leaves or flowers.**

14       “[10] (20) ‘Registry identification card’ means a document issued by the  
15 **Oregon Health Authority under ORS 475.309** that identifies a person au-  
16 thorized to engage in the medical use of marijuana and, if the person has a  
17 designated primary caregiver under ORS 475.312, the person’s designated  
18 primary caregiver.

19       “(21) ‘Registry identification cardholder’ means a person to whom  
20 **a registry identification card has been issued under ORS 475.309.**

21       “[11] (22)(a) ‘Usable marijuana’ means the dried leaves and flowers of  
22 [*the plant Cannabis family Moraceae, and any mixture or preparation thereof,*  
23 *that are appropriate for medical use as allowed in ORS 475.300 to 475.346*]  
24 **marijuana.**

25       “(b) ‘Usable marijuana’ does not include:

26       “(A) The seeds, stalks and roots of [*the plant.*] **marijuana; or**

27       “(B) **Waste material that is a by-product of processing marijuana.**

28       “[12] (23) ‘Written documentation’ means a statement signed by the at-  
29 tending physician of a person diagnosed with a debilitating medical condition  
30 or copies of the person’s relevant medical records.

1                                   **“(Registry Identification Cardholders**  
2                                   **and Designated Primary Caregivers)**

3  
4       **“SECTION 2.** ORS 475.309 is amended to read:

5       “475.309. *[(1) Except as provided in ORS 475.316, 475.320 and 475.342, a*  
6 *person engaged in or assisting in the medical use of marijuana is excepted*  
7 *from the criminal laws of the state for possession, delivery or production of*  
8 *marijuana, aiding and abetting another in the possession, delivery or pro-*  
9 *duction of marijuana or any other criminal offense in which possession, de-*  
10 *livery or production of marijuana is an element if the following conditions*  
11 *have been satisfied:]*

12       “*[(a)(A) The person holds a registry identification card issued pursuant to*  
13 *this section, has applied for a registry identification card pursuant to sub-*  
14 *section (9) of this section, is the designated primary caregiver of the cardholder*  
15 *or applicant, or is the person responsible for a marijuana grow site that is*  
16 *producing marijuana for the cardholder and is registered under ORS 475.304;*  
17 *and]*

18       “*[(B) The person who has a debilitating medical condition, the person’s*  
19 *primary caregiver and the person responsible for a marijuana grow site that*  
20 *is producing marijuana for the cardholder and is registered under ORS*  
21 *475.304 are collectively in possession of, delivering or producing marijuana for*  
22 *medical use in amounts allowed under ORS 475.320; or]*

23       “*[(b) The person is responsible for or employed by a medical marijuana*  
24 *facility registered under ORS 475.314 and does not commit any of the acts*  
25 *described in this subsection anywhere other than at the medical marijuana*  
26 *facility.]*

27       “*[(2) The Oregon Health Authority shall establish and maintain a program*  
28 *for the issuance of registry identification cards to persons who meet the re-*  
29 *quirements of this section. Except as provided in subsection (3) of this section,*  
30 *the authority shall issue a registry identification card to any person who pays*

1 *a fee in the amount established by the authority and provides the following:]*

2 *“[(a) Valid, written documentation from the person’s attending physician*  
3 *stating that the person has been diagnosed with a debilitating medical condi-*  
4 *tion and that the medical use of marijuana may mitigate the symptoms or ef-*  
5 *fects of the person’s debilitating medical condition;]*

6 *“[(b) The name, address and date of birth of the person;]*

7 *“[(c) The name, address and telephone number of the person’s attending*  
8 *physician;]*

9 *“[(d) The name and address of the person’s designated primary caregiver,*  
10 *if the person has designated a primary caregiver at the time of application;*  
11 *and]*

12 *“[(e) A written statement that indicates whether the marijuana used by the*  
13 *cardholder will be produced at a location where the cardholder or designated*  
14 *primary caregiver is present or at another location.]*

15 *“[(3) The authority shall issue a registry identification card to a person*  
16 *who is under 18 years of age if the person submits the materials required un-*  
17 *der subsection (2) of this section, and the custodial parent or legal guardian*  
18 *with responsibility for health care decisions for the person under 18 years of*  
19 *age signs a written statement that:]*

20 *“[(a) The attending physician of the person under 18 years of age has ex-*  
21 *plained to that person and to the custodial parent or legal guardian with re-*  
22 *sponsibility for health care decisions for the person under 18 years of age the*  
23 *possible risks and benefits of the medical use of marijuana;]*

24 *“[(b) The custodial parent or legal guardian with responsibility for health*  
25 *care decisions for the person under 18 years of age consents to the use of*  
26 *marijuana by the person under 18 years of age for medical purposes;]*

27 *“[(c) The custodial parent or legal guardian with responsibility for health*  
28 *care decisions for the person under 18 years of age agrees to serve as the des-*  
29 *ignated primary caregiver for the person under 18 years of age; and]*

30 *“[(d) The custodial parent or legal guardian with responsibility for health*

1 care decisions for the person under 18 years of age agrees to control the ac-  
2 quisition of marijuana and the dosage and frequency of use by the person un-  
3 der 18 years of age.]

4 “[4] A person applying for a registry identification card pursuant to this  
5 section may submit the information required in this section to a county health  
6 department for transmittal to the authority. A county health department that  
7 receives the information pursuant to this subsection shall transmit the infor-  
8 mation to the authority within five days of receipt of the information. Infor-  
9 mation received by a county health department pursuant to this subsection  
10 shall be confidential and not subject to disclosure, except as required to  
11 transmit the information to the authority.]

12 “[5](a) The authority shall verify the information contained in an applica-  
13 tion submitted pursuant to this section and shall approve or deny an applica-  
14 tion within thirty days of receipt of the application.]

15 “[b) In addition to the authority granted to the authority under ORS  
16 475.316 to deny an application, the authority may deny an application for the  
17 following reasons:]

18 “[A) The applicant did not provide the information required pursuant to  
19 this section to establish the applicant’s debilitating medical condition and to  
20 document the applicant’s consultation with an attending physician regarding  
21 the medical use of marijuana in connection with such condition, as provided  
22 in subsections (2) and (3) of this section;]

23 “[B) The authority determines that the information provided was falsified;  
24 or]

25 “[C) The applicant has been prohibited by a court order from obtaining a  
26 registry identification card.]

27 “[c) Denial of a registry identification card shall be considered a final  
28 authority action, subject to judicial review. Only the person whose application  
29 has been denied, or, in the case of a person under the age of 18 years of age  
30 whose application has been denied, the person’s parent or legal guardian, shall



1 *have standing to contest the authority's action.]*

2 *“(d) Any person whose application has been denied may not reapply for*  
3 *six months from the date of the denial, unless so authorized by the authority*  
4 *or a court of competent jurisdiction.]*

5 *“(6)(a) If the authority has verified the information submitted pursuant to*  
6 *subsections (2) and (3) of this section and none of the reasons for denial listed*  
7 *in subsection (5)(b) of this section is applicable, the authority shall issue a*  
8 *serially numbered registry identification card within five days of verification*  
9 *of the information. The registry identification card shall state:]*

10 *“(A) The cardholder's name, address and date of birth;]*

11 *“(B) The date of issuance and expiration date of the registry identification*  
12 *card;]*

13 *“(C) The name and address of the person's designated primary caregiver,*  
14 *if any;]*

15 *“(D) Whether the marijuana used by the cardholder will be produced at*  
16 *a location where the cardholder or designated primary caregiver is present or*  
17 *at another location; and]*

18 *“(E) Any other information that the authority may specify by rule.]*

19 *“(b) When the person to whom the authority has issued a registry iden-*  
20 *tification card pursuant to this section has specified a designated primary*  
21 *caregiver, the authority shall issue an identification card to the designated*  
22 *primary caregiver. The primary caregiver's registry identification card shall*  
23 *contain the information provided in paragraph (a) of this subsection.]*

24 *“(7)(a) A person who possesses a registry identification card shall:]*

25 *“(A) Notify the authority of any change in the person's name, address, at-*  
26 *tending physician or designated primary caregiver.]*

27 *“(B) If applicable, notify the designated primary caregiver of the*  
28 *cardholder, the person responsible for the marijuana grow site that produces*  
29 *marijuana for the cardholder and any person responsible for a medical*  
30 *marijuana facility that transfers usable marijuana or immature marijuana*

1 *plants to the cardholder under ORS 475.314 of any change in status including,*  
2 *but not limited to:]*

3 *“[(i) The assignment of another individual as the designated primary*  
4 *caregiver of the cardholder;]*

5 *“[(ii) The assignment of another individual as the person responsible for a*  
6 *marijuana grow site producing marijuana for the cardholder; or]*

7 *“[(iii) The end of the eligibility of the cardholder to hold a valid registry*  
8 *identification card.]*

9 *“[(C) Annually submit to the authority:]*

10 *“[(i) Updated written documentation from the cardholder’s attending phy-*  
11 *sician of the person’s debilitating medical condition and that the medical use*  
12 *of marijuana may mitigate the symptoms or effects of the person’s debilitating*  
13 *medical condition; and]*

14 *“[(ii) The name of the person’s designated primary caregiver if a primary*  
15 *caregiver has been designated for the upcoming year.]*

16 *“[(b) If a person who possesses a registry identification card fails to comply*  
17 *with this subsection, the card shall be deemed expired. If a registry identifi-*  
18 *cation card expires, the identification card of any designated primary caregiver*  
19 *of the cardholder shall also expire.]*

20 *“[(8)(a) A person who possesses a registry identification card pursuant to*  
21 *this section and who has been diagnosed by the person’s attending physician*  
22 *as no longer having a debilitating medical condition or whose attending phy-*  
23 *sician has determined that the medical use of marijuana is contraindicated for*  
24 *the person’s debilitating medical condition shall return the registry identifi-*  
25 *cation card and any other associated Oregon Medical Marijuana Program*  
26 *cards to the authority within 30 calendar days of notification of the diagnosis*  
27 *or notification of the contraindication.]*

28 *“[(b) If, due to circumstances beyond the control of the registry identifica-*  
29 *tion cardholder, a cardholder is unable to obtain a second medical opinion*  
30 *about the cardholder’s continuing eligibility to use medical marijuana before*

1 *the 30-day period specified in paragraph (a) of this subsection has expired, the*  
2 *authority may grant the cardholder additional time to obtain a second opinion*  
3 *before requiring the cardholder to return the registry identification card and*  
4 *any associated cards.]*

5 *“(9) A person who has applied for a registry identification card pursuant*  
6 *to this section but whose application has not yet been approved or denied, and*  
7 *who is contacted by any law enforcement officer in connection with the person’s*  
8 *administration, possession, delivery or production of marijuana for medical use*  
9 *may provide to the law enforcement officer a copy of the written documentation*  
10 *submitted to the authority pursuant to subsection (2) or (3) of this section and*  
11 *proof of the date of mailing or other transmission of the documentation to the*  
12 *authority. This documentation shall have the same legal effect as a registry*  
13 *identification card until such time as the person receives notification that the*  
14 *application has been approved or denied.]*

15 *“(10)(a) A registry identification cardholder has the primary responsibility*  
16 *of notifying the designated primary caregiver, the person responsible for the*  
17 *marijuana grow site that produces marijuana for the cardholder and any per-*  
18 *son responsible for a medical marijuana facility that transfers usable*  
19 *marijuana or immature marijuana plants to the cardholder under ORS 475.314*  
20 *of any change in status of the cardholder.]*

21 *“(b) If the authority is notified by the cardholder that a primary caregiver*  
22 *or person responsible for a marijuana grow site has changed, the authority*  
23 *shall notify the primary caregiver or the person responsible for the marijuana*  
24 *grow site by mail at the address of record confirming the change in status and*  
25 *informing the caregiver or person responsible for the marijuana grow site that*  
26 *their card is no longer valid and must be returned to the authority.]*

27 *“(11) The authority shall revoke the registry identification card of a*  
28 *cardholder if a court has issued an order that prohibits the cardholder from*  
29 *participating in the medical use of marijuana or otherwise participating in the*  
30 *Oregon Medical Marijuana Program under ORS 475.300 to 475.346. The*

1 cardholder shall return the registry identification card to the authority within  
2 seven calendar days of notification of the revocation. If the cardholder is a  
3 patient, the patient shall return the patient's card and all other associated  
4 Oregon Medical Marijuana Program cards.]

5 “[12) The authority shall revoke the registration of a medical marijuana  
6 facility registered under ORS 475.314 if a court has issued an order that pro-  
7 hibits the person responsible for the medical marijuana facility from partic-  
8 ipating in the Oregon Medical Marijuana Program under ORS 475.300 to  
9 475.346.]

10 “[13) The authority and employees and agents of the authority acting  
11 within the course and scope of their employment are immune from any civil  
12 liability that might be incurred or imposed for the performance of or failure  
13 to perform duties required by this section.]

14 **“(1) The Oregon Health Authority shall establish a program for the**  
15 **issuance of registry identification cards to applicants who meet the**  
16 **requirements of this section.**

17 **“(2) The authority shall issue a registry identification card to an**  
18 **applicant who is 18 years of age or older if the applicant pays a fee in**  
19 **an amount established by the authority by rule and submits to the**  
20 **authority an application containing the following information:**

21 **“(a) Written documentation from the applicant's attending physi-**  
22 **cian stating that the attending physician has diagnosed the applicant**  
23 **as having a debilitating medical condition and that the medical use**  
24 **of marijuana may mitigate the symptoms or effects of the applicant's**  
25 **debilitating medical condition;**

26 **“(b) The name, address and date of birth of the applicant;**

27 **“(c) The name, address and telephone number of the applicant's**  
28 **attending physician;**

29 **“(d) Proof of residency, as required by the authority by rule;**

30 **“(e) The name and address of the applicant's designated primary**

1 caregiver, if the applicant is designating a primary caregiver under  
2 ORS 475.312; and

3 “(f) The information described in ORS 475.304 (2), if the applicant  
4 is applying to produce marijuana or designate another person under  
5 ORS 475.304 to produce marijuana.

6 “(3)(a) The authority shall issue a registry identification card to an  
7 applicant who is under 18 years of age if:

8 “(A) The applicant pays the fee and submits the application de-  
9 scribed in subsection (2) of this section; and

10 “(B) The custodial parent or legal guardian who is responsible for  
11 the health care decisions of the applicant signs and submits to the  
12 authority a written statement that:

13 “(i) The applicant’s attending physician has explained to the appli-  
14 cant and to the custodial parent or legal guardian the possible risks  
15 and benefits of the medical use of marijuana;

16 “(ii) The custodial parent or legal guardian consents to the medical  
17 use of marijuana by the applicant;

18 “(iii) The custodial parent or legal guardian agrees to serve as the  
19 applicant’s designated primary caregiver; and

20 “(iv) The custodial parent or legal guardian agrees to control the  
21 acquisition, dosage and frequency of the medical use of marijuana by  
22 the applicant.

23 “(b) An applicant who is under 18 years of age may not apply to  
24 produce marijuana under subsection (2)(f) of this section.

25 “(4) The authority shall approve or deny an application within 30  
26 days after receiving the application.

27 “(5)(a) If the authority approves an application, the authority shall  
28 issue a serially numbered registry identification card to the applicant  
29 within five days after approving the application. The registry identifi-  
30 cation card must include the following information:

1       **“(A) The registry identification cardholder’s name, address and date  
2 of birth;**

3       **“(B) The issuance date and expiration date of the registry identifi-  
4 cation card;**

5       **“(C) If the registry identification cardholder designated a primary  
6 caregiver under ORS 475.312, the name and address of the registry  
7 identification cardholder’s designated primary caregiver; and**

8       **“(D) Any other information required by the authority by rule.**

9       **“(b) If the registry identification cardholder designated a primary  
10 caregiver under ORS 475.312, the authority shall issue an identification  
11 card to the designated primary caregiver. The identification card must  
12 contain the information required by paragraph (a) of this subsection.**

13       **“(6) A registry identification cardholder shall:**

14       **“(a) In a form and manner prescribed by the authority, notify the  
15 authority of any change concerning the registry identification  
16 cardholder’s:**

17       **“(A) Name, address or attending physician;**

18       **“(B) Designated primary caregiver, including the designation of a  
19 primary caregiver made at a time other than at the time of applying  
20 for or renewing a registry identification card; or**

21       **“(C) Person responsible for a marijuana grow site, including the  
22 designation of a person responsible for a marijuana grow site made at  
23 a time other than at the time of applying for or renewing a registry  
24 identification card.**

25       **“(b) Annually renew the registry identification card by paying a fee  
26 in an amount established by the authority by rule and submitting to  
27 the authority an application that contains the following information:**

28       **“(A) Updated written documentation from the registry identifica-  
29 tion cardholder’s attending physician stating that the registry iden-  
30 tification cardholder still has a debilitating medical condition and that**

1 the medical use of marijuana may mitigate the symptoms or effects  
2 of the registry identification cardholder’s debilitating medical condi-  
3 tion;

4 “(B) The information described in subsection (2)(b) to (f) of this  
5 section; and

6 “(C) If the registry identification cardholder is under 18 years of  
7 age, a statement signed by the custodial parent or legal guardian of  
8 the registry identification cardholder that meets the requirements of  
9 subsection (3) of this section.

10 “(7)(a) If the registry identification cardholder’s attending physician  
11 determines that the registry identification cardholder no longer has a  
12 debilitating medical condition or determines that the medical use of  
13 marijuana is contraindicated for the registry identification  
14 cardholder’s debilitating medical condition, the registry identification  
15 cardholder shall return the registry identification card to the author-  
16 ity within 30 calendar days after receiving notice of the determination.

17 “(b) If, because of circumstances beyond the control of the registry  
18 identification cardholder, a registry identification cardholder is unable  
19 to obtain a second medical opinion about the registry identification  
20 cardholder’s continuing eligibility for the medical use of marijuana  
21 before having to return the registry identification card to the author-  
22 ity, the authority may grant the registry identification cardholder ad-  
23 ditional time to obtain a second medical opinion.

24 “(8)(a) The authority may deny an application for a registry iden-  
25 tification card or an application to renew a registry identification card,

27 “(A) The applicant or registry identification cardholder does not

9       tification card is revoked, under this subsection may not reapply for  
10      a registry identification card for six months from the date of the de-  
11      nial or revocation unless otherwise authorized by the authority.

12      “(9)(a) The authority may deny a designation of a primary caregiver  
13      made under ORS 475.312, or suspend or revoke an associated identifi-  
14      cation card issued under subsection (5)(b) of this section, if the au-  
15      thority determines that the designee or the registry identification  
16      cardholder violated a provision of ORS 475.300 to 475.346 or a rule  
17      adopted under ORS 475.300 to 475.346.

18      “(b) A person whose designation has been denied, or whose iden-  
19      tification card has been revoked, under this subsection may not be  
20      designated as a primary caregiver under ORS 475.312 for six months  
21      from the date of the denial or revocation unless otherwise authorized  
22      by the authority.

23      “**SECTION 3.** ORS 475.312 is amended to read:

24      “475.312. (1) If a person who [*possesses a registry identification card issued*  
25      *pursuant to ORS 475.309*] **is applying for a registry identification card**  
26      **under ORS 475.309, or who is a registry identification cardholder,**  
27      chooses to [*have a designated*] **designate, or to change the designation**

18 for each registry identification cardholder for whom marijuana is being  
19 produced at a marijuana grow site.]

20 “[(5) All usable marijuana, plants, seedlings and seeds associated with the  
21 production of marijuana for a registry identification cardholder by a person  
22 responsible for a marijuana grow site are the property of the registry identifi-  
23 cation cardholder and must be provided to the registry identification  
24 cardholder, or, if the marijuana is usable marijuana or an immature  
25 marijuana plant, transferred to a medical marijuana facility registered under  
26 ORS 475.314, upon request.]

27 “[(6)(a) The authority shall conduct a criminal records check under ORS  
28 181.534 of any person whose name is submitted as a person responsible for a  
29 marijuana grow site.]

30 “[(b) A person convicted of a Class A or Class B felony under ORS 475.752

1 to 475.920 for the manufacture or delivery of a controlled substance in Schedule  
2 I or Schedule II may not be issued a marijuana grow site registration card  
3 or produce marijuana for a registry identification cardholder for five years  
4 from the date of conviction.]

5 “[c) A person convicted more than once of a Class A or Class B felony  
6 under ORS 475.752 to 475.920 for the manufacture or delivery of a controlled  
7 substance in Schedule I or Schedule II may not be issued a marijuana grow  
8 site registration card or produce marijuana for a registry identification  
9 cardholder.]

10 “[7) A registry identification cardholder or the designated primary  
11 caregiver of the cardholder may reimburse the person responsible for a  
12 marijuana grow site for the costs of supplies and utilities associated with the  
13 production of marijuana for the registry identification cardholder. No other  
14 costs associated with the production of marijuana for the registry identification  
15 cardholder, including the cost of labor, may be reimbursed.]

16 “[8) The authority may adopt rules imposing a fee in an amount estab-  
17 lished by the authority for registration of a marijuana grow site under this

19 **“(1)(a) The Oregon Health Authority shall establish by rule a**  
20 **marijuana grow site registration system to track and regulate the**  
21 **production of marijuana by a registry identification cardholder or a**

7 **(6)(b), or notifying the authority of a change under ORS 475.309 (6)(a):**

8       **“(a) The name of the person responsible for the marijuana grow**

10       **“(b) Proof that the person responsible for the marijuana grow site**  
11 **has been a resident of this state for 4 or more years and is 21 years**  
12 **of age or older;**

13       **“(c) The address of the marijuana grow site; and**

14       **“(d) Any other information that the authority considers necessary**  
15 **to track the production of marijuana under ORS 475.300 to 475.346.**

16       **“(3)(a) The authority shall conduct a criminal records check under**  
17 **ORS 181.534 of any person whose name is submitted under this section**  
18 **as the person responsible for a marijuana grow site.**

19       **“(b) A person convicted of a Class A or Class B felony under ORS**  
20 **475.752 to 475.920 for the manufacture or delivery of a controlled sub-**  
21 **stance in Schedule I or Schedule II may not act as or be designated a**  
22 **person responsible for a marijuana grow site for five years from the**  
23 **date of conviction.**

24       **“(c) A person convicted more than once of a Class A or Class B**  
25 **felony under ORS 475.752 to 475.920 for the manufacture or delivery of**  
26 **a controlled substance in Schedule I or Schedule II may not act as or**  
27 **be designated a person responsible for a marijuana grow site.**

28       **“(4) Subject to subsection (11) of this section, the authority shall**  
29 **issue a marijuana grow site registration card if the requirements of**  
30 **subsections (2) and (3) of this section are met.**

1       “(5) A person who holds a marijuana grow site registration card  
2 under this section must display the card at the marijuana grow site  
3 at all times.

4       “(6) A marijuana grow site registration card must be obtained and  
5 posted for each registry identification cardholder for whom marijuana  
6 is being produced at a marijuana grow site.

7       “(7)(a) All seeds, immature marijuana plants, mature marijuana  
8 plants and usable marijuana associated with the production of  
9 marijuana for a registry identification cardholder by a person respon-  
10 sible for a marijuana grow site are the property of the registry iden-  
11 tification cardholder.

12       “(b) All seeds, immature marijuana plants, mature marijuana

15 sible for a marijuana grow site must be transferred to the registry

6 “(8) A registry identification cardholder, or the designated caregiver  
7 of a registry identification cardholder, may reimburse a person re-  
8 sponsible for a marijuana grow site for all costs associated with the  
9 production of marijuana for the registry identification cardholder.

10 “(9) The authority may inspect:

11 “(a) A marijuana grow site to ensure compliance with this section  
12 and section 6 of this 2015 Act and ORS 475.320 and any rule adopted  
13 under this section and section 6 of this 2015 Act and ORS 475.320; and

14 “(b) The records of a marijuana grow site to ensure compliance with  
15 this section and section 6 of this 2015 Act and any rule adopted under  
16 this section and section 6 of this 2015 Act.

17 “(10) The authority may refuse to register a registry identification  
18 cardholder or a designee under this section or may suspend or revoke  
19 the registration of a person responsible for a marijuana grow site if  
20 the authority determines that the applicant or the person responsible  
21 for a marijuana grow site violated a provision of ORS 475.300 to 475.346,  
22 a rule adopted under ORS 475.300 to 475.346 or an ordinance adopted  
23 pursuant to section 2, chapter 79, Oregon Laws 2014.

24 “(11) The authority may require a person responsible for a  
25 marijuana grow site, prior to issuing a marijuana grow site registra-  
26 tion card under subsection (4) of this section, to pay a fee reasonably  
27 calculated to pay costs incurred under this section and sections 6 and  
28 14 of this 2015 Act.

29 **“SECTION 6. (1) A person designated to produce marijuana for a**  
30 **registry identification cardholder under ORS 475.304 must submit to**

13 *plants and 24 ounces of usable marijuana.]*

14       *“[(b) Notwithstanding paragraph (a) of this subsection, if a registry iden-*  
15 *tification cardholder has been convicted of a Class A or Class B felony under*  
16 *ORS 475.752 to 475.920 for the manufacture or delivery of a controlled sub-*  
17 *stance in Schedule I or Schedule II, the registry identification cardholder or*  
18 *the designated primary caregiver of the cardholder may possess one ounce of*  
19 *usable marijuana at any given time for a period of five years from the date*  
20 *of the conviction.]*

21       *“[(2) A person authorized under ORS 475.304 to produce marijuana at a*  
22 *marijuana grow site:]*

23       *“[(a) May produce marijuana for and provide marijuana:]*

24       *“[(A) To a registry identification cardholder or a cardholder’s designated*  
25 *primary caregiver as authorized under this section; or]*

26       *“[(B) If the marijuana is usable marijuana or an immature marijuana plant*  
27 *and the registry identification cardholder authorizes the person responsible for*  
28 *the marijuana grow site to transfer the usable marijuana or immature*  
29 *marijuana plant to a medical marijuana facility registered under ORS 475.314,*  
30 *to the medical marijuana facility.]*



1       “[(b) *May possess up to six mature plants and up to 24 ounces of usable*  
2 *marijuana for each cardholder or caregiver for whom marijuana is being*  
3 *produced.*]

4       “[(c) *May produce marijuana for no more than four registry identification*  
5 *cardholders or designated primary caregivers concurrently.*]

6       “[(d) *Must obtain and display a marijuana grow site registration card is-*  
7 *ssued under ORS 475.304 for each registry identification cardholder or desig-*  
8 *nated primary caregiver for whom marijuana is being produced.*]

9       “[(e) *Must provide all marijuana produced for a registry identification*

28 *registry identification cardholder for whom the person responsible for the*  
29 *marijuana grow site is producing marijuana.*]

30       **“(1) Subject to subsection (2) of this section, a registry identifica-**

1 tion cardholder and the designated primary caregiver of the registry  
2 identification cardholder may jointly possess six or fewer mature  
3 marijuana plants.

4 “(2)(a) A person may be designated to produce marijuana under  
5 ORS 475.304 by no more than four registry identification cardholders.

9 “(3) If the address of a person responsible for a marijuana grow site

14 “(b) Subject to subsection (5) of this section, if each person re-

17 January 1, 2015, no more than the amount of mature marijuana plants

9 **“SECTION 9. Notwithstanding ORS 475.304 (7), a person responsible**  
10 **for a marijuana grow site may enter into an agreement with a registry**

13 **site, a portion of the right to possess the seeds, immature marijuana**  
14 **plants and usable marijuana that are the property of the registry**  
15 **identification cardholder.**

19 **“SECTION 9a. ORS 475.306 is amended to read:**

20 *“475.306. [(1) A person who possesses a registry identification card issued*  
21 *pursuant to ORS 475.309 may engage in, and a designated primary caregiver*  
22 *of such a person may assist in, the medical use of marijuana only as justified*  
23 *to mitigate the symptoms or effects of the person’s debilitating medical condi-*  
24 *tion.]*

24 **submit an application to the authority that includes:**

25 **“(a) The name of the individual who owns the marijuana processing**  
26 **site or, if a business entity owns the marijuana processing site, the**  
27 **name of each individual who has a financial interest in the marijuana**  
28 **processing site;**

29 **“(b) The name of the individual or individuals responsible for the**  
30 **marijuana processing site, if different from the name of the individual**

1 who owns the marijuana processing site;

2 “(c) The address of the marijuana processing site;

3 “(d) Proof that each individual responsible for the marijuana pro-  
4 cessing site has been a resident of this state for four or more years;

5 “(e) Documentation, as required by the authority by rule, that  
6 demonstrates the marijuana processing site meets the requirements  
7 of subsection (3) of this section; and

8 “(f) Any other information that the authority considers necessary.

9 “(3) To qualify for registration under this section, a marijuana  
10 processing site:

11 “(a) May not be located in an area that is zoned for residential use;

12 “(b) May not be located at the same address as a marijuana grow  
13 site;

14 “(c) Must be registered as a business, or have filed an application  
15 to register as a business, with the office of the Secretary of State; and

16 “(d) Must meet the requirements of any rule adopted by the au-  
17 thority under subsection (10) of this section.

18 “(4)(a) The authority shall conduct a criminal records check under  
19 ORS 181.534 for each individual named in an application under sub-  
20 section (2) of this section.

21 “(b) An individual convicted for the manufacture or delivery of a  
22 controlled substance in Schedule I or Schedule II may not own or be  
23 responsible for a marijuana processing site for five years from the date  
24 the individual is convicted.

25 “(c) An individual convicted more than once for the manufacture  
26 or delivery of a controlled substance in Schedule I or Schedule II may  
27 not own or be responsible for a marijuana processing site.

28 “(5) If a person submits the application required under subsection  
29 (2) of this section, if the marijuana processing site identified in the  
30 application meets the requirements of this section and any rules

1 adopted under this section and if each individual named in the appli-  
2 cation passes the criminal records check required under subsection (4)  
3 of this section, the authority shall register the marijuana processing  
4 site and issue proof of registration. Proof of registration must be dis-  
5 played on the premises of the marijuana processing site at all times.

6 “(6) A marijuana processing site that is registered under this sec-  
7 tion is not required to register with the State Board of Pharmacy un-  
8 der ORS 475.125.

9 “(7) The individual or individuals responsible for a marijuana pro-  
10 cessing site shall maintain documentation of each transfer of usable  
11 marijuana, medical cannabinoid products, cannabinoid concentrates  
12 and cannabinoid extracts.

13 “(8) The authority may inspect:

14 “(a) The premises of a proposed marijuana processing site or a  
15 registered marijuana processing site to ensure compliance with this  
16 section and sections 11 and 12 of this 2015 Act and any rules adopted  
17 under this section and sections 11 and 12 of this 2015 Act; and

18 “(b) The records of a registered marijuana processing site to ensure  
19 compliance with subsection (7) of this section.

20 “(9) Subject to the provisions of ORS chapter 183, the authority may  
21 refuse to register an applicant under this section or may suspend or  
22 revoke the registration of a marijuana processing site if the authority  
23 determines that the applicant, the owner of the marijuana processing  
24 site, a person responsible for the marijuana processing site, or an  
25 employee of the marijuana processing site, violated a provision of ORS  
26 475.300 to 475.346, a rule adopted under ORS 475.300 to 475.346 or an  
27 ordinance adopted pursuant to section 2, chapter 79, Oregon Laws 2014.

28 “(10) The authority shall adopt rules to implement this section, in-  
29 cluding rules that:

30 “(a) Require a registered marijuana processing site to annually re-

1 new the registration for that site;

2 “(b) Establish fees for registering, and renewing the registration of,  
3 a marijuana processing site;

4 “(c) Require installation at each marijuana processing site of a  
5 minimum security system that includes video surveillance, an alarm  
6 system and a safe;

7 “(d) Require that medical cannabinoid products, cannabinoid con-  
8 centrates and cannabinoid extracts transferred by a marijuana pro-  
9 cessing site be tested to ensure the public health and safety; and

10 “(e) Impose any other standard on the operation of a marijuana  
11 processing site to ensure the public health and safety.

12 “SECTION 11. (1) A marijuana processing site must meet any public  
13 health and safety standards established by the Oregon Health Au-  
14 thority by rule related to:

15 “(a) Cannabinoid edibles, if the marijuana processing site processes  
16 marijuana into cannabinoid edibles;

17 “(b) Cannabinoid concentrates, if the marijuana processing site  
18 processes marijuana into cannabinoid concentrates;

19 “(c) Cannabinoid extracts, if the marijuana processing site pro-  
20 cesses marijuana into cannabinoid extracts; or

21 “(d) Any other type of medical cannabinoid product identified by  
22 the authority by rule, if the marijuana processing site processes  
23 marijuana into that type of medical cannabinoid product.

24 “(2) A marijuana processing site that processes marijuana into  
25 cannabinoid edibles must be licensed by the State Department of Ag-  
26 riculture in accordance with ORS 616.695 to 616.755. In licensing a  
27 marijuana processing site under this subsection, the department may  
28 not:

29 “(a) Establish standards prescribing cannabinoid concentrates,  
30 cannabinoid extracts or the dried leaves or flowers of marijuana to be



1 a food additive, as defined in ORS 616.205; or

2 “(b) Consider cannabinoid concentrates, cannabinoid extracts or the  
3 dried leaves or flowers of marijuana to be an adulterant, except as  
4 provided by the authority by rule.

5 “(3) The authority shall adopt rules to implement this section.

6 **“SECTION 12. (1) The authority may require by rule a marijuana  
7 processing site to submit to the authority for inclusion in the database  
8 developed and maintained pursuant to section 15 of this 2015 Act the  
9 following information:**

10 “(a) The amount of usable marijuana transferred to the marijuana  
11 processing site;

12 “(b) The amount and type of medical cannabinoid products trans-  
13 ferred by the marijuana processing site;

14 “(c) The amount and type of cannabinoid concentrates transferred  
15 by the marijuana processing site; and

16 “(d) The amount and type of cannabinoid extracts transferred by  
17 the marijuana processing site.

18 “(2) The authority by rule may require a marijuana processing site  
19 to submit to the authority for inclusion in the database developed and  
20 maintained pursuant to section 15 of this 2015 Act information that is  
21 in addition to the information described in subsection (1) of this sec-  
22 tion as the authority considers necessary to fulfill the authority’s du-  
23 ties under section 10 (1) of this 2015 Act.

24 **“SECTION 13. (1) A marijuana processing site may not transfer  
25 medical cannabinoid products, cannabinoid concentrates or  
26 cannabinoid extracts to a person other than a registry identification  
27 cardholder, a designated primary caregiver or a medical marijuana  
28 dispensary.**

29 “(2) A person other than a marijuana processing site may not  
30 transfer medical cannabinoid products, cannabinoid concentrates or

1 cannabinoid extracts to a medical marijuana dispensary.

2 **“SECTION 14.** Section 10 of this 2015 Act does not apply to:

3 **“(1) A medical cannabinoid product processed by a registry iden-**  
4 **tification cardholder or the designated primary caregiver of a registry**  
5 **identification cardholder who processes marijuana for the registry**  
6 **identification cardholder’s personal use, provided that the medical**  
7 **cannabinoid product is not transferred to a person other than the**  
8 **registry identification cardholder; or**

9 **“(2) A cannabinoid concentrate processed by a registry identifica-**  
10 **tion cardholder for the registry identification cardholder’s personal**  
11 **use, provided that the cannabinoid concentrate is not transferred to**  
12 **a person other than the registry identification cardholder.**

14 **“(Database)**

15

16 **“SECTION 15. (1) The Oregon Health Authority shall develop and**  
17 **maintain a database of information related to the production of**  
18 **marijuana by persons responsible for a marijuana grow site under ORS**  
19 **475.304 and the processing of marijuana by persons responsible for a**  
20 **marijuana processing site under section 10 of this 2015 Act. At a min-**  
21 **imum, the database must include all information submitted to the**  
22 **authority under sections 6 and 12 of this 2015 Act.**

23 **“(2)(a) Subject to paragraph (b) of this subsection, if the authority**  
24 **determines after conducting an investigation of a marijuana grow site,**  
25 **marijuana processing site or medical marijuana dispensary, or after**

28 **site, marijuana processing site or medical marijuana dispensary is not**  
29 **in compliance with the provisions of ORS 475.300 to 475.346 or a rule**  
30 **adopted under ORS 475.300 to 475.346, the authority may provide in-**

1 **formation that is stored in the database developed and maintained**  
2 **under this section to a law enforcement agency.**

3 **“(b) Except for the address where a marijuana grow site is located,**  
4 **or where a marijuana processing site is located, the authority may not**  
5 **provide to the commission or a law enforcement agency any personally**  
6 **identifiable information stored in the database developed and main-**  
7 **tained under this section.**

8

9 **“(Medical Marijuana Dispensaries)**

10

11 **“SECTION 16.** ORS 475.314, as amended by section 5, chapter 79, Oregon  
12 Laws 2014, is amended to read:

13 *“475.314. [(1) The Oregon Health Authority shall establish by rule a med-*  
14 *ical marijuana facility registration system to authorize the transfer of usable*  
15 *marijuana and immature marijuana plants from:]*

16 *“[(a) A registry identification cardholder, the designated primary caregiver*  
17 *of a registry identification cardholder, or a person responsible for a marijuana*  
18 *grow site to the medical marijuana facility; or]*

19 *“[(b) A medical marijuana facility to a registry identification cardholder*  
20 *or the designated primary caregiver of a registry identification cardholder.]*

21 **“(1)(a) The Oregon Health Authority shall establish by rule a med-**  
22 **ical marijuana dispensary registration system for the purpose of**

24 **“(A) Usable marijuana, immature marijuana plants and seeds from**  
25 **registry identification cardholders, designated primary caregivers and**  
26 **persons responsible for marijuana grow sites to medical marijuana**

29 **cannabinoid extracts from persons responsible for marijuana process-**  
30 **ing sites to medical marijuana dispensaries; and**

1       “(C) Usable marijuana, immature marijuana plants, seeds, medical  
2       cannabinoid products, cannabinoid concentrates and cannabinoid ex-  
3       tracts from medical marijuana dispensaries to registry identification  
4       cardholders and designated primary caregivers.

5       “(b) A person may not operate an establishment for the purpose of  
6       providing the services described in paragraph (a) of this subsection  
7       unless the person is registered under this section.

8       “(2) The registration system established under subsection (1) of this sec-  
9       tion must require **an applicant for** a medical marijuana [*facility*]  
10       **dispensary** to submit an application to the authority that includes:

11       “(a) **The name of the individual who owns the medical marijuana**  
12       **dispensary or, if a business entity owns the medical marijuana**  
13       **dispensary, the name of each individual who has a financial interest**  
14       **in the medical marijuana dispensary;**

15       “[(a)] (b) The name of the [*person*] **individual or individuals** responsible  
16       for the medical marijuana [*facility*] **dispensary, if different from the name**  
17       **of the individual who owns the medical marijuana dispensary;**

18       “[(b)] (c) The address of the medical marijuana [*facility*] **dispensary;**

19       “[(c)] (d) Proof that [*the person*] **each individual** responsible for the  
20       medical marijuana [*facility is a resident of Oregon*] **has been a resident of**  
21       **this state for four or more years;**

22       “[(d)] (e) Documentation, as required by the authority by rule, that dem-  
23       onstrates the medical marijuana [*facility*] **dispensary** meets the [*qualifica-*  
24       *tions for a medical marijuana facility as described in*] **requirements of**  
25       subsection (3) of this section; and

26       “[(e)] (f) Any other information that the authority considers necessary.

27       “(3) To qualify for registration under this section, a medical marijuana  
28       [*facility*] **dispensary:**

29       “[(a) *Must be located in an area that is zoned for commercial, industrial*  
30       *or mixed use or as agricultural land;*]

1       “(a) **May not be located in an area that is zoned for residential use;**

2       “(b) May not be located at the same address as a marijuana grow site;

3       “(c) Must be registered as a business, or have filed [*a pending*] **an** appli-  
4 cation to register as a business, with the office of the Secretary of State;

5       “[(d) *Must not be located within 1,000 feet of the real property comprising*  
6 *a public or private elementary, secondary or career school attended primarily*  
7 *by minors;*]

8       “(d) **May not be located within 1,000 feet of:**

9       “(A) **A public elementary or secondary school for which attendance**  
10 **is compulsory under ORS 339.020; or**

11       “(B) **A private or parochial elementary or secondary school, teach-**  
12 **ing children as described in ORS 339.030 (1)(a);**

13       “(e) Must not be located within 1,000 feet of another medical marijuana  
14 [*facility*] **dispensary; and**

15       “[(f) *Must comport with rules adopted by the authority related to:*]

16       “[(A) *Installing a minimum security system, including a video surveillance*  
17 *system, alarm system and safe; and]*

18       “[(B) *Testing for pesticides, mold and mildew and the processes by which*  
19 *usable marijuana and immature marijuana plants that test positive for pesti-*  
20 *cides, mold or mildew must be returned to the registry identification*  
21 *cardholder, the cardholder’s designated primary caregiver or the cardholder’s*  
22 *registered grower.*]

23       “(f) **Must meet the requirements of any rule adopted by the au-**  
24 **thority under subsection (10) of this section.**

25       “(4)(a) The authority shall conduct a criminal records check under ORS  
26 181.534 [*of a person whose name is submitted as the person responsible for a*  
27 *medical marijuana facility*] **for each individual named in an application**  
28 **submitted** under subsection (2) of this section.

29       “(b) [*A person*] **An individual** convicted for the manufacture or delivery  
30 of a controlled substance in Schedule I or Schedule II may not [*be the*

1 *person*] **own or be** responsible for a medical marijuana [*facility*] **dispensary**  
2 for five years from the date the [*person*] **individual** is convicted.

3 “(c) [*A person*] **An individual** convicted more than once for the manu-  
4 facture or delivery of a controlled substance in Schedule I or Schedule II  
5 may not [*be the person*] **own or be** responsible for a medical marijuana [*fa-*  
6 *cility*] **dispensary**.

7 “(5) If a person submits the application required under subsection (2) of  
8 this section, **if** the medical marijuana [*facility*] **dispensary** identified in the  
9 application meets the [*qualifications for a medical marijuana facility de-*  
10 *scribed in subsection (3) of this section and the person responsible for the*  
11 *medical marijuana facility*] **requirements of this section and any rules**  
12 **adopted under this section and if each individual named in the appli-**  
13 **cation** passes the criminal records check required under subsection (4) of  
14 this section, the authority shall register the medical marijuana [*facility*]  
15 **dispensary** and issue [*the person responsible for the medical marijuana fa-*  
16 *cility*] proof of registration. [*The person responsible for the medical marijuana*  
17 *facility shall display the*] Proof of registration **must be displayed** on the  
18 premises of the medical marijuana [*facility at all times when usable*  
19 *marijuana or immature marijuana plants are being transferred as described*  
20 *in subsection (1) of this section*] **dispensary at all times**.

21 “(6) **A medical marijuana dispensary that is registered under this**  
22 **section is not required to register with the State Board of Pharmacy**

24 “[*(6)(a) A registered medical marijuana facility may receive usable*  
25 *marijuana or immature marijuana plants only from a registry identification*  
26 *cardholder, designated primary caregiver or person responsible for a*  
27 *marijuana grow site if the registered medical marijuana facility obtains au-*  
28 *thorization, on a form prescribed by the authority by rule and signed by a*  
29 *registry identification cardholder, to receive the usable marijuana or immature*  
30 *marijuana plants.*]

1       “[(b) A registered medical marijuana facility shall maintain:]

2       “[(A) A copy of each authorization form described in paragraph (a) of this  
3 subsection; and]

4       “[(B) Documentation of each transfer of usable marijuana or immature  
5 marijuana plants.]

6       **“(7) The individual or individuals responsible for a medical  
7 marijuana dispensary shall maintain documentation of each transfer  
8 of usable marijuana, medical cannabinoid products, cannabinoid con-  
9 centrates, cannabinoid extracts, immature marijuana plants and  
10 seeds.**

11       “[(7) A medical marijuana facility registered under this section may possess  
12 usable marijuana and immature marijuana plants in excess of the limits im-  
13 posed on registry identification cardholders and designated primary caregivers  
14 under ORS 475.320.]

15       “[(8)(a) A registered medical marijuana facility may not transfer any  
16 tetrahydrocannabinol-infused product that is meant to be swallowed or  
17 inhaled, unless the product is packaged in child-resistant safety packaging that  
18 meets standards established by the authority by rule.]

19       “[(b) A registered medical marijuana facility may not transfer any  
20 tetrahydrocannabinol-infused product that is manufactured or packaged in a  
21 manner that is attractive to minors, as determined by the authority by rule.]

22       “[(9)] **(8)** The authority may inspect:

23       “[(a) The premises of an applicant for a medical marijuana facility or a  
24 registered medical marijuana facility to ensure compliance with the qualifica-  
25 tions for a medical marijuana facility described in subsection (3) of this sec-  
26 tion; and]

27       **“(a) The premises of a proposed medical marijuana dispensary or a  
28 registered medical marijuana dispensary to ensure compliance with  
29 this section and section 18 of this 2015 Act and any rules adopted under  
30 this section or section 18 of this 2015 Act; and**

1 “(b) The records of a registered medical marijuana [*facility*] **dispensary**  
2 to ensure compliance with subsection [(6)(b)] **(7)** of this section.

3 “[*(10)(a) A registry identification cardholder or the designated primary*  
4 *caregiver of a registry identification cardholder may reimburse a medical*  
5 *marijuana facility registered under this section for the normal and customary*  
6 *costs of doing business, including costs related to transferring, handling, se-*  
7 *curing, insuring, testing, packaging and processing usable marijuana and im-*  
8 *mature marijuana plants and the cost of supplies, utilities and rent or*  
9 *mortgage.*.]

10 “[*(b) A medical marijuana facility may reimburse a person responsible for*  
11 *a marijuana grow site under this section for the normal and customary costs*  
12 *of doing business, including costs related to transferring, handling, securing,*  
13 *insuring, testing, packaging and processing usable marijuana and immature*  
14 *marijuana plants and the cost of supplies, utilities and rent or mortgage.*.]

15 “[*(11) the authority may revoke the registration of a medical marijuana fa-*  
16 *cility registered under this section for failure to comply with ORS 475.300 to*  
17 *475.346, rules adopted under ORS 475.300 to 475.346 or ordinances adopted*  
18 *pursuant to section 2, chapter 79, Oregon Laws 2014. The authority may release*  
19 *to the public a final order revoking a medical marijuana facility*  
20 *registration.*.]

21 “**(9) Subject to the provisions of ORS chapter 183, the authority may**  
22 **refuse to register an applicant under this section or may suspend or**  
23 **revoke the registration of a medical marijuana dispensary if the au-**  
24 **thority determines that the applicant, the owner of the medical**  
25 **marijuana dispensary, a person responsible for the medical marijuana**  
26 **dispensary, or an employee of the medical marijuana dispensary, vio-**  
27 **lated a provision of ORS 475.300 to 475.346, a rule adopted under ORS**  
28 **475.300 to 475.346 or an ordinance adopted pursuant to section 2, chap-**  
29 **ter 79, Oregon Laws 2014.**

30 “[*(12)*] **(10)** The authority shall adopt rules to implement this section, in-



1 cluding rules that:

2 “(a) Require a **registered** medical marijuana [*facility registered under this*  
3 *section*] **dispensary** to annually renew [*that registration; and*] **the registra-**  
4 **tion for that dispensary;**

5 “(b) Establish fees for registering, and renewing **the** registration [*for*] **of,**  
6 a medical marijuana [*facility under this section.*] **dispensary;**

7 “(c) **Require that each medical marijuana dispensary install and**  
8 **maintain a minimum security system that includes video surveillance,**  
9 **an alarm system and a safe;**

10 “(d) **Require that usable marijuana, medical cannabinoid products,**  
11 **cannabinoid concentrates, cannabinoid extracts and immature**  
12 **marijuana plants transferred by a medical marijuana dispensary be**  
13 **tested to ensure the public health and safety; and**

14 “(e) **Impose any other standard on the operation of a medical**  
15 **marijuana dispensary to ensure the public health and safety.**

16 “**SECTION 17. If a school described in ORS 475.314 (3)(d) is estab-**  
17 **lished within 1,000 feet of a medical marijuana dispensary, the medical**  
18 **marijuana dispensary may remain at its current location unless the**  
19 **authority revokes the registration of the medical marijuana**  
20 **dispensary.**

21 “**SECTION 18. (1) The authority may require by rule a medical**  
22 **marijuana dispensary to submit to the authority for inclusion in the**

25 “(a) **The amount of usable marijuana transferred to and by the**  
26 **medical marijuana dispensary;**

27 “(b) **The amount and type of medical cannabinoid products trans-**

29 “(c) **The amount and type of cannabinoid concentrates transferred**  
30 **to and by the medical marijuana dispensary;**

1       “(d) The amount and type of cannabinoid extracts transferred to  
2 and by the medical marijuana dispensary; and

3       “(e) The quantity of immature marijuana plants transferred to and  
4 by the medical marijuana dispensary.

5       “(2) The authority by rule may require a medical marijuana  
6 dispensary to submit to the authority for inclusion in the database  
7 developed and maintained pursuant to section 15 of this 2015 Act in-  
8 formation that is in addition to the information described in sub-  
9 section (1) of this section as the authority considers necessary to fulfill  
10 the authority’s duties under ORS 475.314 (1).

12                   “(Designation, Assignment and Foreclosure)

13

14       “SECTION 19. (1) A person responsible for a marijuana processing  
15 site, or a person responsible for a medical marijuana dispensary, may  
16 designate that responsibility to another person.

17       “(2) If a designation is made under this section, the designee must  
18 submit to the Oregon Health Authority proof that the designee meets  
19 the requirements and restrictions set forth in:

20       “(a) For marijuana processing sites, section 10 (2)(d) and (4); or

21       “(b) For medical marijuana dispensaries, ORS 475.314 (2)(d) and (4).

22       “(3) The authority may prescribe the form and manner of submit-  
23 ting proof under subsection (2) of this section.

24       “SECTION 20. (1) A person responsible for a marijuana processing  
25 site, or a person responsible for a medical marijuana dispensary, may  
26 assign that responsibility to another person.

27       “(2) If an assignment is made under this section, the assignee must  
28 submit to the Oregon Health Authority proof that the assignee meets  
29 the requirements and restrictions set forth in:

30       “(a) For marijuana processing sites, section 10 (2)(d) and (4); or

1       “(b) For medical marijuana dispensaries, ORS 475.314 (2)(d) and (4).

2       “(3) The authority may prescribe the form and manner of submit-  
3       ting proof under subsection (2) of this section.

4       “SECTION 21. (1) In the event that a marijuana processing site or  
5       a medical marijuana dispensary is foreclosed or otherwise ceases op-  
6       erations as described in ORS chapter 79, a secured party, as defined in  
7       ORS 79.0102, may continue operations at the marijuana processing site  
8       or medical marijuana dispensary upon submitting to the Oregon  
9       Health Authority proof that the secured party or, if the secured party  
10      is a business entity, any individual who has a financial interest in the  
11      secured party, meets the requirements and restrictions set forth in:

12      “(a) For marijuana processing sites, section 10 (2)(d) and (4); or

13      “(b) For medical marijuana dispensaries, ORS 475.314 (2)(d) and (4).

14      “(2) The authority may prescribe the form and manner of submit-  
15      ting proof under subsection (1) of this section.

16  
17                               “(Exemptions from Criminal Liability  
18                               and Affirmative Defense)  
19

20      “SECTION 22. Except as provided in ORS 475.316, a person engaged  
21      in or assisting in the medical use of marijuana is exempt from the  
22      criminal laws of this state for possession, delivery or manufacture of  
23      marijuana, aiding and abetting another in the possession, delivery or  
24      manufacture of marijuana, or any other criminal offense in which  
25      possession, delivery or manufacture of marijuana is an element if:

26      “(1) The person holds a registry identification card.

27      “(2) The person has applied for a registry identification card under  
28      ORS 475.309 and the person has proof of written documentation de-  
29      scribed in ORS 475.309 (2)(a) and proof of the date on which the person

21 “(d) May not adopt rules that are more restrictive than is necessary  
22 to protect the public health and safety.

23 “SECTION 60. Sections 56 to 63 of this 2015 Act do not apply to a  
24 person responsible for a marijuana grow site under ORS 475.304, or a  
25 person who has been designated as a primary caregiver under ORS  
26 475.312, who transfers usable marijuana, a cannabinoid product or a  
27 cannabinoid concentrate or extract to a person who holds a registry  
28 identification card issued under ORS 475.309 or a person who has been  
29 designated as a primary caregiver.

30 “SECTION 61. (1) The Oregon Health Authority may inspect the

1 premises of a medical marijuana dispensary registered under ORS  
2 475.314, or the premises of a person who holds a license under section  
3 19, 20, 21 or 22, chapter 1, Oregon Laws 2015, to ensure compliance with  
4 sections 56 to 63 of this 2015 Act and any rule adopted under sections  
5 56 to 63 of this 2015 Act.

6 “(2) The authority may enter into an agreement with the Oregon  
7 Liquor Control Commission for the purpose of conducting investi-  
8 gations under this section. If the authority enters into an agreement  
9 with the commission under this section, the commission shall have the  
10 power to conduct investigations under sections 56 to 63 of this 2015 Act  
11 in the same manner that the commission is authorized to conduct in-  
12 vestigations under sections 3 to 70, chapter 1, Oregon Laws 2015, with  
13 respect to premises for which persons hold a license under section 19,  
14 20, 21 or 22, chapter 1, Oregon Laws 2015.

15 “SECTION 62. Subject to the applicable provisions of ORS chapter  
16 183:

17 “(1) The Oregon Health Authority may refuse to register a person  
18 under ORS 475.304 or 475.314, may suspend activities conducted by a  
19 registrant pursuant to ORS 475.304 or 475.314, or may remove a regis-  
20 trant from a registry kept pursuant to ORS 475.304 or 475.314, if the  
21 person violates any provision of sections 56 to 63 of this 2015 Act or  
22 any rule adopted under sections 56 to 63 of this 2015 Act.

23 “(2) The Oregon Liquor Control Commission may refuse to issue or  
24 renew, or may suspend or revoke, a license issued under section 19,  
25 20, 21 or 22, chapter 1, Oregon Laws 2015, if the applicant or licensee  
26 violates a provision of sections 56 to 63 of this 2015 Act or any rule  
27 adopted under sections 56 to 63 of this 2015 Act.

28 “SECTION 63. (1) In addition to any other liability or penalty pro-  
29 vided by law, the Oregon Health Authority may impose for each vio-  
30 lation of a provision of sections 56 to 63 of this 2015 Act, or a rule

1 adopted under a provision of sections 56 to 63 of this 2015 Act, a civil  
2 penalty that does not exceed \$500 for each day that the violation oc-  
3 curs.

4 (2) The authority shall impose civil penalties under this subsection  
5 in the manner provided by ORS 183.745.

6 (3) Moneys collected under this section shall be deposited in the  
7 Oregon Health Authority Fund established under ORS 413.101 and are  
8 continuously appropriated to authority for the purpose of carrying out  
9 the duties, functions and powers of the authority under sections 56 to  
10 63 of this 2015 Act.

11 **“SECTION 64.** The rules of the Oregon Health Authority adopted  
12 under ORS 475.314 (8) as that statute was in effect before the operative  
13 date specified in section 70 of this 2015 Act continue in effect until  
14 superseded or repealed by rules of the authority adopted under section  
15 59 of this 2015 Act.

19 **“SECTION 65.** ORS 181.534 is amended to read:

20 “181.534. (1) As used in this section:

21 “(a) ‘Authorized agency’ means state government as defined in ORS  
22 174.111 and the Oregon State Bar. ‘Authorized agency’ does not include:

23 “(A) The Oregon State Lottery Commission or the Oregon State Lottery;

24 or

25 “(B) A criminal justice agency, as defined in ORS 181.010, that is au-  
26 thorized by federal law to receive fingerprint-based criminal records checks  
27 from the Federal Bureau of Investigation.

28 “(b) ‘Subject individual’ means a person from whom an authorized agency  
29 may require fingerprints pursuant to statute for the purpose of enabling the  
30 authorized agency to request a state or nationwide criminal records check.



1       “(2) An authorized agency may request that the Department of State Po-  
2 lice conduct a criminal records check on a subject individual for non-  
3 criminal justice purposes. If a nationwide criminal records check of a subject  
4 individual is necessary, the authorized agency may request that the Depart-  
5 ment of State Police conduct the check, including fingerprint identification,  
6 through the Federal Bureau of Investigation.

7       “(3) The Department of State Police shall provide the results of a criminal  
8 records check conducted pursuant to subsection (2) of this section to the  
9 authorized agency requesting the check.

10       “(4) The Federal Bureau of Investigation shall return or destroy the fin-  
11 gerprint cards used to conduct the criminal records check and may not keep  
12 any record of the fingerprints. If the federal bureau policy authorizing return  
13 or destruction of the fingerprint cards is changed, the Department of State  
14 Police shall cease to send the cards to the federal bureau but shall continue  
15 to process the information through other available resources.

16       “(5) If the Federal Bureau of Investigation returns the fingerprint cards  
17 to the Department of State Police, the department shall destroy the finger-  
18 print cards and shall retain no facsimiles or other material from which a  
19 fingerprint can be reproduced.

20       “(6) If only a state criminal records check is conducted, the Department  
21 of State Police shall destroy the fingerprint cards after the criminal records  
22 check is completed and the results of the criminal records check provided to  
23 the authorized agency and shall retain no facsimiles or other material from  
24 which a fingerprint can be reproduced.

25       “(7) An authorized agency may conduct criminal records checks on sub-  
26 ject individuals through the Law Enforcement Data System maintained by  
27 the Department of State Police in accordance with rules adopted, and pro-  
28 cedures established, by the Department of State Police.

29       “(8) An authorized agency and the Department of State Police shall per-  
30 mit a subject individual for whom a fingerprint-based criminal records check

1 was conducted to inspect the individual's own state and national criminal  
2 offender records and, if requested by the subject individual, provide the in-  
3 dividual with a copy of the individual's own state and national criminal  
4 offender records.

5 “(9) Each authorized agency, in consultation with the Department of State  
6 Police, shall adopt rules to implement this section and other statutes relating  
7 to criminal offender information obtained through fingerprint-based criminal  
8 records checks. The rules shall include but need not be limited to:

9 “(a) Identifying applicable categories of subject individuals as specified  
10 by the Oregon Department of Administrative Services under ORS 181.547 who  
11 are subject to criminal records checks by the authorized agency.

12 “(b) Identifying applicable information that may be required from a sub-  
13 ject individual to permit a criminal records check as specified by the Oregon  
14 Department of Administrative Services under ORS 181.547.

15 “(c) Specifying which programs or services are subject to this section.

16 “(d) If the authorized agency uses criminal records checks for agency  
17 employment purposes:

18 “(A) Determining when and under what conditions a subject individual  
19 may be hired on a preliminary basis pending a criminal records check; and

20 “(B) Defining the conditions under which a subject individual may par-  
21 ticipate in training, orientation and work activities pending completion of  
22 a criminal records check.

23 “(e) Establishing fees in an amount not to exceed the actual cost of ac-  
24 quiring and furnishing criminal offender information.

25 “(10) The Department of State Police shall verify that an authorized  
26 agency has adopted the rules required by subsection (9) of this section.

27 “(11)(a) Except as otherwise provided in ORS 181.612, 342.143, 342.223,  
28 443.735 and [475.304] **475.300 to 475.346** and paragraph (b) of this subsection,  
29 an authorized agency, using the rules adopted by the authorized agency un-  
30 der subsection (9) of this section and the rules adopted by the Oregon De-

1 partment of Administrative Services under ORS 181.547, shall determine  
2 whether a subject individual is fit to hold a position, provide services, be  
3 employed or be granted a license, certification, registration or permit, based  
4 on the criminal records check obtained pursuant to this section, on any false  
5 statements made by the individual regarding the criminal history of the in-

14 agency making a fitness determination of an individual under this subsection  
15 may request results of a previously made fitness determination from an au-  
16 thorized agency that has already made a fitness determination for the indi-  
17 vidual. An authorized agency that receives a request under this paragraph  
18 shall provide the requested information.

19 “(B) An authorized agency may make a request under this paragraph only  
20 for individuals:

21 “(i) Who are applying to hold a position, provide services, be employed  
22 or be granted a license, certification, registration or permit;

23 “(ii) Who are in a category of individuals as specified by the Oregon De-  
24 partment of Administrative Services under ORS 181.547; and

25 “(iii) For whom a fitness determination has already been made.

26 “(12) Except as otherwise provided in ORS 181.612, in making the fitness  
27 determination under subsection (11) of this section, the authorized agency  
28 shall consider:

29 “(a) The nature of the crime;

30 “(b) The facts that support the conviction or pending indictment or that

1 indicate the making of the false statement;

2 “(c) The relevancy, if any, of the crime or the false statement to the spe-  
3 cific requirements of the subject individual’s present or proposed position,  
4 services, employment, license, certification or registration; and

5 “(d) Intervening circumstances relevant to the responsibilities and cir-  
6 cumstances of the position, services, employment, license, certification, reg-  
7 istration or permit. Intervening circumstances include but are not limited  
8 to:

9 “(A) The passage of time since the commission of the crime;

10 “(B) The age of the subject individual at the time of the crime;

11 “(C) The likelihood of a repetition of offenses or of the commission of  
12 another crime;

13 “(D) The subsequent commission of another relevant crime;

14 “(E) Whether the conviction was set aside and the legal effect of setting  
15 aside the conviction; and

16 “(F) A recommendation of an employer.

17 “(13) An authorized agency and an employee of an authorized agency  
18 acting within the course and scope of employment are immune from any civil  
19 liability that might otherwise be incurred or imposed for determining, pur-  
20 suant to subsection (11) of this section, that a subject individual is fit or not  
21 fit to hold a position, provide services, be employed or be granted a license,  
22 certification, registration or permit. An authorized agency and an employee  
23 of an authorized agency acting within the course and scope of employment  
24 who in good faith comply with this section are not liable for employment-  
25 related decisions based on determinations made under subsection (11) of this  
26 section. An authorized agency or an employee of an authorized agency acting  
27 within the course and scope of employment is not liable for defamation or  
28 invasion of privacy in connection with the lawful dissemination of informa-

30 “(14)(a) Each authorized agency shall establish by rule a contested case

1 process by which a subject individual may appeal the determination that the  
2 individual is fit or not fit to hold a position, provide services, be employed  
3 or be granted a license, certification, registration or permit on the basis of  
4 information obtained as the result of a criminal records check conducted  
5 pursuant to this section. Challenges to the accuracy or completeness of in-  
6 formation provided by the Department of State Police, the Federal Bureau  
7 of Investigation and agencies reporting information to the Department of  
8 State Police or Federal Bureau of Investigation must be made through the  
9 Department of State Police, Federal Bureau of Investigation or reporting  
10 agency and not through the contested case process required by this para-  
11 graph.

12 “(b) A subject individual who is employed by an authorized agency and  
13 who is determined not to be fit for a position on the basis of information  
14 obtained as the result of a criminal records check conducted pursuant to this  
15 section may appeal the determination through the contested case process  
16 adopted under this subsection or applicable personnel rules, policies and  
17 collective bargaining provisions. An individual’s decision to appeal a deter-  
18 mination through personnel rules, policies and collective bargaining pro-  
19 visions is an election of remedies as to the rights of the individual with  
20 respect to the fitness determination and is a waiver of the contested case  
21 process.

22 “(c) An individual prohibited from receiving public funds for employment  
23 under ORS 443.004 (3) is not entitled to appeal a determination under para-  
24 graph (a) or (b) of this subsection.

25 “(15) Criminal offender information is confidential. Authorized agencies  
26 and the Department of State Police shall adopt rules to restrict dissem-  
27 ination of information received under this section to persons with a demon-  
28 strated and legitimate need to know the information.

29 “(16) If a subject individual refuses to consent to the criminal records  
30 check or refuses to be fingerprinted, the authorized agency shall deny the

1 employment of the individual, or revoke or deny any applicable position,  
2 authority to provide services, license, certification, registration or permit.

3 “(17) If an authorized agency requires a criminal records check of em-  
4 ployees, prospective employees, contractors, vendors or volunteers or appli-  
5 cants for a license, certification, registration or permit, the application forms  
6 of the authorized agency must contain a notice that the person is subject to  
7 fingerprinting and a criminal records check.

8 **“SECTION 66.** ORS 181.537 is amended to read:

9 “181.537. (1) As used in this section:

10 “(a) ‘Care’ means the provision of care, treatment, education, training,  
11 instruction, supervision, placement services, recreation or support to chil-  
12 dren, the elderly or persons with disabilities.

13 “(b) ‘Native American tribe’ has the meaning given that term in ORS  
14 181.538 (4).

15 “(c) ‘Qualified entity’ means a community mental health program, a com-  
16 munity developmental disabilities program, a local health department, the  
17 government of a Native American tribe or an agency of a Native American  
18 tribe responsible for child welfare or an individual or business or organiza-  
19 tion, whether public, private, for-profit, nonprofit or voluntary, that provides  
20 care, including a business or organization that licenses, certifies or registers  
21 others to provide care.

22 “(2) For the purpose of requesting a state or nationwide criminal records  
23 check under ORS 181.534, the Department of Human Services, the Oregon

26 “(a) Who is employed by or is applying for employment with either de-  
27 partment or the authority;

28 “(b) Who provides or seeks to provide services to either department or the  
29 authority as a contractor, subcontractor, vendor or volunteer who:

30 “(A) May have contact with recipients of care;

1 “(B) Has access to personal information about employees of either de-  
2 partment or the authority, recipients of care from either department or the  
3 authority or members of the public, including Social Security numbers, dates  
4 of birth, driver license numbers, medical information, personal financial in-  
5 formation or criminal background information;

6 “(C) Has access to information the disclosure of which is prohibited by  
7 state or federal laws, rules or regulations, or information that is defined as  
8 confidential under state or federal laws, rules or regulations;

9 “(D) Has access to property held in trust or to private property in the  
10 temporary custody of the state;

11 “(E) Has payroll or fiscal functions or responsibility for:

12 “(i) Receiving, receipting or depositing money or negotiable instruments;

13 “(ii) Billing, collections, setting up financial accounts or other financial  
14 transactions; or

15 “(iii) Purchasing or selling property;

16 “(F) Provides security, design or construction services for government  
17 buildings, grounds or facilities;

18 “(G) Has access to critical infrastructure or secure facilities information;  
19 or

20 “(H) Is providing information technology services and has control over  
21 or access to information technology systems;

22 “(c) For the purposes of licensing, certifying, registering or otherwise  
23 regulating or administering programs, persons or qualified entities that pro-  
24 vide care;

25 “(d) For the purposes of employment decisions by or for qualified entities  
26 that are regulated or otherwise subject to oversight by the Department of  
27 Human Services or the Oregon Health Authority and that provide care;

28 “(e) For the purposes of employment decisions made by a mass transit  
29 district or transportation district for qualified entities that, under contracts  
30 with the district or the Oregon Health Authority, employ persons to operate

1 motor vehicles for the transportation of medical assistance program clients;  
2 or

3 “(f) For the purposes of licensure, certification or registration of foster  
4 homes by the government of a Native American tribe or an agency of a Na-  
5 tive American tribe responsible for child welfare.

6 “(3) The Department of Human Services and the Oregon Health Authority  
7 may conduct criminal records checks on a person through the Law Enforce-  
8 ment Data System maintained by the Department of State Police, if deemed  
9 necessary by the Department of Human Services or the Oregon Health Au-  
10 thority to protect children, elderly persons, persons with disabilities or other  
11 vulnerable persons.

12 “(4) The Department of Human Services and the Oregon Health Authority  
13 may furnish to qualified entities, in accordance with the rules of the De-  
14 partment of Human Services or the Oregon Health Authority and the rules  
15 of the Department of State Police, information received from the Law  
16 Enforcement Data System. However, any criminal offender records and in-

8 “(a) The nature of the crime;

9 “(b) The facts that support the conviction or pending indictment or indi-  
10 cate the making of the false statement;

11 “(c) The relevancy, if any, of the crime or the false statement to the spe-  
12 cific requirements of the person’s present or proposed position, services, em-  
13 ployment, license, certification or registration; and

14 “(d) Intervening circumstances relevant to the responsibilities and cir-  
15 cumstances of the position, services, employment, license, certification or  
16 registration. Intervening circumstances include but are not limited to the  
17 passage of time since the commission of the crime, the age of the person at

21 “(7) The Department of Human Services, the Oregon Health Authority

24 of Investigation through the Department of State Police only as described in  
25 ORS 181.534.

26 “(8) A qualified entity and an employee of a qualified entity acting within  
27 the course and scope of employment are immune from any civil liability that  
28 might otherwise be incurred or imposed for determining pursuant to sub-  
29 section (5) of this section that a person is fit or not fit to hold a position,  
30 provide services or be employed, licensed, certified or registered. A qualified

1 entity, employee of a qualified entity acting within the course and scope of  
2 employment and an employer or employer's agent who in good faith comply  
3 with this section and the decision of the qualified entity or employee of the  
4 qualified entity acting within the course and scope of employment are not  
5 liable for the failure to hire a prospective employee or the decision to dis-  
6 charge an employee on the basis of the qualified entity's decision. An em-  
7 ployee of the state acting within the course and scope of employment is not  
8 liable for defamation or invasion of privacy in connection with the lawful

10 “(9) The Department of Human Services and the Oregon Health Author-  
11 ity, subject to rules adopted by the Oregon Department of Administrative  
12 Services under ORS 181.547, shall develop systems that maintain information  
13 regarding criminal records checks in order to minimize the administrative  
14 burden imposed by this section and ORS 181.534. Records maintained under  
15 this subsection are confidential and may not be disseminated except for the  
16 purposes of this section and in accordance with the rules of the Department  
17 of Human Services, the Oregon Health Authority and the Department of  
18 State Police. Nothing in this subsection permits the Department of Human

25 formation;

26 “(c) Specifying which qualified entities are responsible for deciding, sub-  
27 ject to rules adopted by the Oregon Department of Administrative Services  
28 under ORS 181.547, whether a subject individual is not fit for a position,  
29 service, license, certification, registration or employment; and

30 “(d) Specifying when a qualified entity, in lieu of conducting a completely

1 new criminal records check, may proceed to make a fitness determination

9 “(12) If the qualified entity requires a criminal records check of employees  
10 or other persons, the application forms of the qualified entity must contain  
11 a notice that employment is subject to fingerprinting and a criminal records

13 **“SECTION 67.** Section 5, chapter 1, Oregon Laws 2015, is amended to  
14 read:

15 **“Sec. 5.** As used in sections 3 to 70, **chapter 1, Oregon Laws 2015** [*of*  
16 *this Act*]:

17 “(1) ‘Authority’ means the Oregon Health Authority.

18 “(2) ‘Commission’ means the Oregon Liquor Control Commission.

19 “(3) ‘Consumer’ means a person who purchases, acquires, owns, holds[,]  
20 or uses marijuana items other than for the purpose of resale.

21 “(4) ‘Department’ means the State Department of Agriculture.

22 “(5)(a) [*Financial consideration, except as provided in paragraph (b) of*  
23 *this subsection,*] **‘Financial consideration’** means value that is given or re-  
24 ceived directly or indirectly through sales, barter, trade, fees, charges, dues,  
25 contributions or donations.

26 “(b) ‘Financial consideration’ does not mean any of the following:

27 “(A) Homegrown marijuana made by another person.

28 “(B) Homemade marijuana products made by another person.

29 “(6) ‘Homegrown’ or ‘homemade’ means grown or made by a person 21  
30 years of age or older for noncommercial purposes.

1 “(7) ‘Household’ means a housing unit[,] and [*includes*] any place in or  
2 around the housing unit at which the occupants of the housing unit are  
3 producing, processing, keeping[,] or storing homegrown marijuana or home-  
4 made marijuana products.

5 “(8) ‘Housing unit’ means a house, an apartment[,] **or** a mobile home, **or**  
6 a group of rooms[,] or a single room that is occupied as separate living  
7 quarters, in which the occupants live and eat separately from any other  
8 persons in the building and [*which have*] **that has** direct access from the  
9 outside of the building or through a common hall.

10 “(9) ‘Immature marijuana plant’ means a marijuana plant with no ob-  
11 servable flowers or buds.

12 “(10) ‘Licensee’ means any person holding a license issued under **sections**  
13 **3 to 70, chapter 1, Oregon Laws 2015** [*this Act*], or any person holding a  
14 license or permit issued under any [*regulation promulgated*] **rule adopted**  
15 under **section 7 (2)(e), chapter 1, Oregon Laws 2015** [*paragraph (e) of*  
16 *subsection (2) of section 7 of this Act*].

17 “(11) ‘Licensee representative’ means an owner, director, officer, manager,  
18 employee, agent[,] or other representative of a licensee, to the extent [*such*]  
19 **the** person acts in [*such*] **a** representative capacity.

20 “(12)(a) ‘Marijuana’ means all parts of the plant Cannabis family  
21 Moraceae, whether growing or not, other than marijuana extracts.

22 “(b) ‘Marijuana’ does not include industrial hemp, as defined in ORS  
23 571.300, or industrial hemp commodities or products.

24 “(13) ‘Marijuana extract’ means a product obtained by separating resins  
25 from marijuana by solvent extraction, using solvents other than vegetable  
26 glycerin, such as butane, hexane, isopropyl alcohol, ethanol[,] and carbon  
27 dioxide.

28 “(14)(a) ‘Marijuana flowers’ means the flowers of the plant Cannabis  
29 family Moraceae.

30 “(b) ‘Marijuana flowers’ does not include any part of the plant other than

1 the flowers.

2 “(15) ‘Marijuana items’ means marijuana, marijuana products[,] and  
3 marijuana extracts.

4 “(16)(a) ‘Marijuana leaves’ means the leaves of the plant Cannabis family  
5 Moraceae.

6 “(b) ‘Marijuana leaves’ does not include any part of the plant other than  
7 the leaves.

8 “(17) ‘Marijuana processor’ means a person who processes marijuana  
9 items in this state.

10 “(18) ‘Marijuana producer’ means a person who produces marijuana in  
11 this state.

12 “(19)(a) ‘Marijuana products’ means products that contain marijuana or  
13 marijuana extracts and are intended for human consumption.

14 “(b) ‘Marijuana products’ does not mean:

15 “(A) Marijuana, by itself; or

16 “(B) A marijuana extract, by itself.

17 “(20) ‘Marijuana retailer’ means a person who sells marijuana items to a  
18 consumer in this state.

19 “(21) ‘Marijuana wholesaler’ means a person who purchases marijuana  
20 items in this state for resale to a person other than a consumer in this state.

21 “(22) ‘Mature marijuana plant’ means any marijuana plant that is not an  
22 immature marijuana plant.

23 “(23) ‘Noncommercial’ means not dependent or conditioned upon the pro-  
24 vision or receipt of financial consideration.

25 “(24) ‘Person’ means any natural person, corporation, professional corpo-  
26 ration, nonprofit corporation, cooperative corporation, profit or nonprofit  
27 unincorporated association, business trust, limited liability company, general  
28 or limited partnership, joint venture[,] or any other legal entity.

29 “(25) ‘Premises’ or ‘licensed premises’ means a location licensed under  
30 sections 3 to 70, **chapter 1, Oregon Laws 2015**, [*of this Act*] and includes:

1 “(a) All enclosed areas at the location that are used in the business op-  
2 erated at the location, including offices, kitchens, rest rooms and storerooms,  
3 including all public and private areas;

4 “(b) All areas outside [of] a building that the Oregon Liquor Control  
5 Commission has specifically licensed for the production, processing, whole-  
6 sale sale[,] or retail sale of marijuana items; and

7 “(c) For a location that the commission has specifically licensed for the  
8 production of marijuana outside [of] a building, the entire lot or parcel, as  
9 defined in ORS 92.010, that the licensee owns, leases[,] or has a right to oc-  
10 cupy.

11 “(26)(a) ‘Processes’ means:

12 “(A) The processing, compounding[,] or conversion of marijuana into  
13 marijuana products or marijuana extracts; **or**

14 “(B) The processing, compounding[,] or conversion of marijuana, either  
15 directly or indirectly by extraction from substances of natural origin, or in-  
16 dependently by means of chemical synthesis, or by a combination of ex-  
17 traction and chemical synthesis[;].

18 “[C] *The packaging or repackaging of marijuana items; or*]

19 “[D] *The labeling or relabeling of any package or container of marijuana*  
20 *items.*]

21 “(b) ‘Processes’ does not include[:]

22 “[A] the drying of marijuana by a marijuana producer, if the marijuana  
23 producer is not otherwise processing marijuana; or

24 “[B] *The packaging and labeling of marijuana by a marijuana producer*  
25 *in preparation for delivery to a marijuana processor.*]

26 “(27)(a) ‘Produces’ means the manufacture, planting, cultivation,  
27 growing[,] or harvesting of marijuana.

28 “(b) ‘Produces’ does not include:

29 “(A) The drying of marijuana by a marijuana processor, if the marijuana  
30 processor is not otherwise producing marijuana; or

1 “(B) The cultivation and growing of an immature marijuana plant by a  
2 marijuana processor, marijuana wholesaler[,] or marijuana retailer if the  
3 marijuana processor, marijuana wholesaler[,] or marijuana retailer purchased  
4 or otherwise received the plant from a licensed marijuana producer.

5 “(28) ‘Public place’ means a place to which the general public has access  
6 and includes, but is not limited to, hallways, lobbies and other parts of  
7 apartment houses and hotels not constituting rooms or apartments designed  
8 for actual residence, and highways, streets, schools, places of amusement,  
9 parks, playgrounds and [*premises*] **areas** used in connection with public  
10 passenger transportation.

11 “(29) ‘Usable marijuana’ means dried marijuana flowers and dried  
12 marijuana leaves, and any mixture or preparation [*thereof*] **of the flowers  
13 or leaves.**

14  
15 **“TEMPORARY RESIDENCY PROVISION**

16  
17 **“SECTION 67a. The Oregon Health Authority, in addition to the  
18 information required under ORS 475.304 for registering as a marijuana  
19 grow site or renewing a marijuana grow site registration, and in ad-  
20 dition to information required under ORS 475.314 for registering as a  
21 medical marijuana dispensary or renewing a medical marijuana  
22 dispensary registration, shall require all applications for registering  
23 or renewing registration under ORS 475.304 and 475.314 to contain proof  
24 that any person whose name is included in the application has been a  
25 resident of this state for:**

26 **“(1) Except as provided in subsection (2) of this section, four or  
27 more years; or**

28 **“(2) If the person first registered with the authority on or before  
29 January 1, 2015, one year.**

1 "SERIES PLACEMENT

2  
3 "SECTION 68. Sections 6, 9, 10 to 15, 17 to 22 and 25 to 32 of this 2015  
4 Act are added to and made a part of ORS 475.300 to 475.346.

5  
6 "REPEALS

7  
8 "SECTION 69. ORS 475.324 is repealed.

9 "SECTION 69a. Section 67a of this 2015 Act is repealed on January  
10 1, 2019.

11  
12 "OPERATIVE DATE

13  
14 "SECTION 70. (1) Sections 6, 9, 10 to 15, 17 to 22, 25 to 32 and 44 to  
15 64 of this 2015 Act and the amendments to statutes and session law  
16 by sections 1 to 3, 5, 7, 9a, 16, 23, 24, 33 to 43 and 65 to 67 of this 2015  
17 Act and the repeal of ORS 475.324 by section 69 of this 2015 Act become  
18 operative on March 1, 2016.

19 "(2) The Oregon Health Authority, the Oregon Liquor Control  
20 Commission and the State Department of Agriculture may take any  
21 action before the operative date specified in subsection (1) of this sec-  
22 tion that is necessary to enable the authority and the commission to  
23 exercise, on and after the operative date specified in subsection (1) of  
24 this section, all the duties, powers and functions conferred on the au-  
25 thority, commission and department by sections 6, 9, 10 to 15, 17 to 22,  
26 25 to 32 and 44 to 64 of this 2015 Act and the amendments to statutes  
27 and session law by sections 1 to 3, 5, 7, 9a, 16, 23, 24, 33 to 43 and 65  
28 to 67 of this 2015 Act.
