

**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 840**

1 On page 3 of the printed A-engrossed bill, line 44, delete “physician” and
2 insert “licensed independent practitioner”.

3 On page 6, line 24, after “other” delete the rest of the line.

4 In line 25, delete “Health Authority” and insert “licensed independent
5 practitioners”.

6 On page 9, line 22, delete “physician licensed by the Oregon Medical
7 Board” and insert “licensed independent practitioner”.

8 On page 10, line 34, delete “physician licensed by the Oregon Medical
9 Board” and insert “licensed independent practitioner”.

10 In line 37, delete “physician” and insert “licensed independent practi-
11 tioner”.

12 In line 39, delete “physician licensed by the Oregon Medical Board” and
13 insert “licensed independent practitioner”.

14 In line 40, delete “physician” and insert “licensed independent practi-
15 tioner”.

16 In line 41, delete “a” and insert “the”.

17 On page 11, delete lines 23 through 43 and insert:

18 **“SECTION 12.** ORS 426.231 is amended to read:

19 “426.231. (1) A [*physician licensed by the Oregon Medical Board*] **licensed**
20 **independent practitioner** may hold a person for transportation to a treat-
21 ment facility for up to 12 hours in a health care facility licensed under ORS
22 chapter 441 and approved by the Oregon Health Authority if:

1 “(a) The [*physician*] **licensed independent practitioner** believes the
2 person is dangerous to self or to any other person and is in need of emer-
3 gency care or treatment for mental illness;

4 “(b) The [*physician*] **licensed independent practitioner** is not related to
5 the person by blood or marriage; and

6 “(c) [*An admitting physician*] **A licensed independent practitioner with**
7 **admitting privileges** at the receiving facility consents to the transporting.

8 “(2) Before transporting the person, the [*physician*] **licensed independent**
9 **practitioner** shall prepare a written statement that:

10 “(a) The [*physician*] **licensed independent practitioner** has examined
11 the person within the preceding 12 hours;

12 “(b) [*An admitting physician*] **A licensed independent practitioner with**
13 **admitting privileges** at the receiving facility has consented to the trans-
14 porting of the person for examination and admission if appropriate; and

15 “(c) The [*physician*] **licensed independent practitioner** believes the
16 person is dangerous to self or to any other person and is in need of emer-
17 gency care or treatment for mental illness.

18 “(3) The written statement required by subsection (2) of this section au-
19 thorizes a peace officer, an individual authorized under ORS 426.233 or the
20 designee of a community mental health program director to transport a per-
21 son to the treatment facility indicated on the statement.”.

22 In line 45, delete “physician licensed to practice medicine by the Oregon
23 Medical Board” and insert “licensed independent practitioner”.

24 On page 12, line 4, delete “physician” and insert “licensed independent
25 practitioner”.

26 In line 5, delete “a” and insert “the”.

27 On page 13, line 20, delete “physician” and insert “licensed independent
28 practitioner”.

29 On page 15, line 41, delete “physician licensed by the Oregon Medical
30 Board” and insert “licensed independent practitioner”.

1 On page 16, line 6, delete “a” and insert “the”.

2 In line 29, delete “physician” and insert “licensed independent practi-
3 tioner”.
