"(7) The task force shall meet at times and places specified by the
call of the chairperson or of a majority of the members of the task
force.

5 "(8) The task force may adopt rules necessary for the operation of
6 the task force.

"(9) The task force shall submit a report in the manner provided
by ORS 192.245, and may include recommendations for legislation, to
the interim committees of the Legislative Assembly related to rules
no later than December 31, 2015.

"(10) The staff of the Committee Services office of the Legislative
 Administration Committee shall provide staff support to the task
 force.

"(11) Members of the task force who are not members of the Legislative Assembly are not entitled to compensation, but may be reimbursed for actual and necessary travel and other expenses incurred by them in the performance of their official duties in the manner and amounts provided for in ORS 292.495. Claims for expenses incurred in performing functions of the task force shall be paid out of funds appropriated to the Legislative Assembly for purposes of the task force.

"(12) All agencies of state government, as defined in ORS 174.111, are directed to assist the task force in the performance of its duties and, to the extent permitted by laws relating to confidentiality, to furnish such information and advice as the members of the task force consider necessary to perform their duties.

"SECTION 2. Section 1 of this 2015 Act is repealed on December 31,
 27 2016.

"<u>SECTION 3.</u> This 2015 Act being necessary for the immediate
 preservation of the public peace, health and safety, an emergency is
 declared to exist, and this 2015 Act takes effect on its passage.".
