

**PROPOSED AMENDMENTS TO  
SENATE BILL 217**

1 On page 1 of the printed bill, line 2, after “327.800” delete the rest of the  
2 line and line 3 and insert “, 327.810, 327.815 and 327.820; repealing sections  
3 30, 31, 32 and 33, chapter 27, Oregon Laws 2015 (Enrolled Senate Bill 342);  
4 and declaring an emergency.”.

5 Delete lines 5 through 30 and delete pages 2 and 3 and insert:
