

**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 3339**

1 In line 2 of the printed A-engrossed bill, after the semicolon insert “cre-
2 ating new provisions; amending ORS 342.137;”.

3 Delete lines 4 through 14 and insert:

4 **“SECTION 1. (1) The Secretary of State shall conduct an audit re-
5 lated to the Teacher Standards and Practices Commission.**

6 **“(2) The audit required by this section must address:**

7 **“(a) The finances and resources of the commission;**

8 **“(b) The commission’s licensing and educator oversight responsi-
9 bilities, including the workload of the commission, the work processes
10 of the commission and performance indicators for the commission;**

11 **“(c) Recommendations to improve commission activities that affect
12 educators, teacher education institutions and teacher education pro-
13 grams; and**

14 **“(d) The commission’s governance role in setting expectations, en-
15 suring accountability and acting transparently.**

16 **“(3) The Secretary of State shall submit a report on the audit re-
17 quired by this section to the interim legislative committees on educa-
18 tion no later than January 15, 2016.**

19 **“SECTION 2. Section 1 of this 2015 Act is repealed on June 30, 2016.**

20 **“SECTION 3. ORS 342.137 is amended to read:**

21 **“342.137. (1) A teacher leader license shall designate that its holder is
22 qualified to provide leadership that may include mentoring, curriculum de-**

1 velopment support, teacher preparation support and other educational lead-
2 ership.

3 “(2) A teacher leader license shall be issued on application to an other-
4 wise qualified person who:

5 “(a) Has a valid professional teaching license; and

6 “(b) Has been deemed to be effective to highly effective in teaching, as
7 shown by:

8 “(A) **A combination of** evaluations conducted in compliance with ORS
9 342.856 [*or as shown by*] **and evidence of current professional leadership**
10 **practices, as determined based on standards adopted by the Teacher**
11 **Standards and Practices Commission by rule; or**

12 “(B) Other evidence identified by the [*Teacher Standards and Practices*]
13 commission by rule.

14 “(3) A teacher leader license may be renewed if the applicant meets the
15 requirements established by the [*Teacher Standards and Practices*] commis-
16 sion by rule.

17 “(4) The [*Teacher Standards and Practices*] commission shall develop a
18 process by which a teacher holding a teacher leader license is automatically
19 issued a professional teaching license upon nonrenewal of a teacher leader
20 license if the teacher meets the requirements for a professional teaching li-
21 cense.”.

22 In line 15, delete “3” and insert “4”.
