- "(6) An election held pursuant to this section shall be held at the time of the next statewide general election.
- "(7) An election held pursuant to this section shall be conducted under ORS chapters 246 to 260.
- "(8) The filing of a petition under subsection (2) of this section does not suspend any city or county ordinance prohibiting or allowing marijuana producers, marijuana processors, marijuana wholesalers or marijuana retailers. In each city or county that returns a majority vote to prohibit or allow the operation of marijuana producers, marijuana processors, marijuana wholesalers or marijuana retailers, the ordinance takes effect January 1 following the date of the statewide general election."
