PROPOSED AMENDMENTS TO **HOUSE BILL 3400**

- On page 1 of the printed bill, line 2, after "marijuana;" delete the rest of 1 the line and lines 3 through 5 and insert "; and declaring an emergency.".
- Delete lines 7 through 27 and delete pages 2 through 33 and insert: 3
- "SECTION 1. As used in sections 1 to 4 of this 2015 Act: 4
- "(1) 'Limited marijuana retail product' means: 5

- "(a) The dried leaves and flowers of marijuana; or 6
- "(b) A marijuana plant that is not flowering. 7
- "(2) 'Marijuana' means the plant Cannabis family Cannabaceae, any 8 part of the plant Cannabis family Cannabaceae and the seeds of the 9 plant Cannabis family Cannabaceae. 10
- "SECTION 2. (1) Notwithstanding any other provision of law, a 11 medical marijuana facility registered under ORS 475.314 may sell lim-12 ited marijuana retail products to a person who is 21 years of age or 13 older if: 14
- "(a) The person presents proof of age to the medical marijuana fa-15 cility at the time of the sale; 16
- "(b) The medical marijuana facility verifies that the person is 21 17 years of age or older at the time of the sale; and 18
- "(c) The medical marijuana facility is located within the jurisdiction 19 of a city or county that has not adopted an ordinance prohibiting sales 20 as described in this subsection. 21
 - "(2) For purposes of this section, proof of age may be substantiated

- by presenting to a registered medical marijuana facility acceptable proof of age adopted by the Oregon Liquor Control Commission by rule.
- "(3) The Oregon Health Authority and the commission shall enter into an agreement under which the commission may conduct an onsite inspection of the premises where a registered medical marijuana facility is located to ensure that the medical marijuana facility is in compliance with applicable provisions of law or rules as described in section 4 of this 2015 Act.
 - "SECTION 3. (1) Notwithstanding any other provision of law, a marijuana grow site registered under ORS 475.304 may sell limited marijuana retail products to a medical marijuana facility registered under ORS 475.314 for purposes described in section 2 of this 2015 Act if:
 - "(a) The person responsible for the marijuana grow site under ORS 475.304 obtains the consent of the registry identification cardholder for whom the person responsible for the marijuana grow site produces or processes the limited marijuana retail products;
 - "(b) Subject to subsection (2) of this section, the person responsible for the marijuana grow site applies to the Oregon Liquor Control Commission in a form and manner prescribed by the commission; and
 - "(c) The commission determines that the person responsible for the marijuana grow site is qualified to sell limited marijuana retail products to a registered medical marijuana facility for purposes described in section 2 of this 2015 Act.
 - "(2) For purposes of this section, obtaining consent as described in subsection (1)(a) of this section constitutes an assignment of the right to possess the limited marijuana retail products.
- 29 "(3) In prescribing the form and manner of making an application 30 under subsection (1)(b) of this section, the commission shall require

an applicant to complete an online application.

- "(4) If the commission determines that an applicant under this section is qualified to sell limited marijuana retail products to a registered medical marijuana facility for purposes described in section 2 of this 2015 Act, the commission shall provide the applicant with a certificate that verifies that the applicant is qualified to sell limited marijuana retail products to a registered medical marijuana facility.
 - "(5) The commission may conduct an onsite inspection of the premises where an applicant or holder of a certificate produces or processes marijuana under this section to ensure that the applicant or holder of the certificate is in compliance with applicable provisions of law or rules as described in section 4 of this 2015 Act.
 - "SECTION 4. (1) A medical marijuana facility registered under ORS 475.314 that makes sales of limited marijuana retail products as described in section 2 of this 2015 Act is subject to any applicable provision of sections 3 to 70, chapter 1, Oregon Laws 2015, or any rule adopted under sections 3 to 70, chapter 1, Oregon Laws 2015, related to the regulation of a person who holds a license under section 22, chapter 1, Oregon Laws 2015, including any provision or rule related to the imposition of a tax on the sale of limited marijuana retail products by a person who holds a license under section 22, chapter 1, Oregon Laws 2015.
 - "(2) A marijuana grow site registered under ORS 475.304 that makes sales of limited marijuana retail products as described in section 2 of this 2015 Act is subject to any applicable provision of sections 3 to 70, chapter 1, Oregon Laws 2015, or any rule adopted under sections 3 to 70, chapter 1, Oregon Laws 2015, related to the regulation of a person who holds a license under section 19, chapter 1, Oregon Laws 2015, including any provision or rule related to the imposition of a tax on the production or processing of limited marijuana retail products by

a person who holds a license under section 19, chapter 1, Oregon Laws 2015.

"SECTION 5. Sections 1 to 4 of this 2015 Act are repealed on December 31, 2016.

"SECTION 6. This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect on its passage."
