PROPOSED AMENDMENTS TO SENATE BILL 61

- On page 1 of the printed bill, line 3, delete "317.715" and insert "317.267,

- Delete lines 5 through 29 and delete page 2 and insert:
- "SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 317.
- "SECTION 2. (1)(a) For purposes of determining Oregon taxable in-
- 7 come, the taxable income or loss of any corporation that is a member
- 8 of a unitary group or that is a corporation that files a separate return
- 9 and that is incorporated in any of the jurisdictions listed in paragraph
- 10 (b) of this subsection shall be added to the federal consolidated taxable
- income of the unitary group filing a consolidated Oregon return or to
- 12 the federal taxable income of the corporation filing a separate return.
- 13 "(b) This section applies to Andorra, Anguilla, Antigua and
- 14 Barbuda, Aruba, the Bahamas, Bahrain, Barbados, Belize, Bermuda,
- 15 Bonaire, the British Virgin Islands, the Cayman Islands, the Cook Is-
- 16 lands, Curacao, Cyprus, Dominica, Gibraltar, Grenada, Guatemala,
- 17 Guernsey-Sark-Alderney, Hong Kong, the Isle of Man, Jersey, Liberia,
- 18 Liechtenstein, Luxembourg, Malta, the Marshall Islands, Mauritius,
- 19 Montserrat, Nauru, Niue, Panama, Saba, Samoa, San Marino,
- 20 Seychelles, Sint Eustatius, Sint Maarten, St. Kitts and Nevis, St.
- 21 Lucia, St. Vincent and the Grenadines, Trinidad and Tobago, the

- "(2) After making any addition required by subsection (1)(a) of this section, any item of income, gain, loss or expense of a corporation that is a member of a unitary group and that is incorporated in any of the jurisdictions that are listed in subsection (1)(b) of this section shall be eliminated from federal taxable income if the item is not attributable directly or indirectly to activity of or transactions with a unitary group member included in a federal consolidated or separate return.
 - "(3) If the Department of Revenue deems that a jurisdiction that is not listed in subsection (1)(b) of this section meets the requirements provided in ORS 317.717 for inclusion on the list in subsection (1)(b) of this section, corporations that are incorporated in the jurisdiction:
 - "(a) May be required by the department to add back income to federal taxable income; and
 - "(b) If required to add back income, are eligible for elimination of items of income, gain, loss or expense as provided in subsection (2) of this section.
 - "(4) The department shall adopt rules:

- "(a) To determine the computation of income or loss for a corporation that is a member of a unitary group and that is not otherwise required to file a consolidated federal return.
- "(b) To prevent double taxation or double deduction of any amount included in the computation of income under this section.
 - "(c) To implement this section.
- **"SECTION 3.** ORS 317.715 is amended to read:
- "317.715. (1) If a corporation required to make a return under this chapter is a member of an affiliated group of corporations making a consolidated federal return under sections 1501 to 1505 of the Internal Revenue Code, the corporation's Oregon taxable income shall be determined beginning with federal consolidated taxable income of the affiliated group as provided in this section.

"[(2)(a) For purposes of determining Oregon taxable income, the taxable income or loss of any corporation that is a member of a unitary group and that is incorporated in any of the following jurisdictions shall be added to federal consolidated taxable income:]

"[(b) Andorra, Anguilla, Antigua and Barbuda, Aruba, the Bahamas, 5 Bahrain, Barbados, Belize, Bermuda, the British Virgin Islands, the Cayman 6 Islands, the Cook Islands, Cyprus, Dominica, Gibraltar, Grenada, Guernsey-7 Sark-Alderney, the Isle of Man, Jersey, Liberia, Liechtenstein, Luxembourg, 8 Malta, the Marshall Islands, Mauritius, Monaco, Montserrat, Nauru, the 9 Netherlands Antilles, Niue, Samoa, San Marino, Seychelles, St. Kitts and 10 Nevis, St. Lucia, St. Vincent and the Grenadines, the Turks and Caicos Is-11 lands, the U.S. Virgin Islands and Vanuatu.] 12

"[(3)] (2) If the affiliated group, of which the corporation subject to tax-13 ation under this chapter is a member, consists of more than one unitary 14 group, before the additions, subtractions, adjustments and modifications to 15 federal taxable income provided for in this chapter are made, and before al-16 location and apportionment as provided in ORS 317.010 (10), if any, modified 17 federal consolidated taxable income shall be computed. Modified federal 18 consolidated taxable income shall be determined by eliminating from the 19 federal consolidated taxable income of the affiliated group the separate tax-20 able income, as determined under Treasury Regulations adopted under sec-21 tion 1502 of the Internal Revenue Code, and any deductions or additions or 22 items of income, expense, gain or loss for which consolidated treatment is 23 prescribed under Treasury Regulations adopted under section 1502 of the 24 Internal Revenue Code, attributable to the member or members of any 25 unitary group of which the corporation is not a member. 26

"[(4)(a)] (3)(a) After modified federal consolidated taxable income is determined under subsection [(3)] (2) of this section, the additions, subtractions, adjustments and modifications prescribed by this chapter shall be made to the modified federal consolidated taxable income of the remaining

- 2 were subject to taxation under this chapter. After those modifications are
- made, Oregon taxable income or loss shall be determined as provided in ORS

- 5 "(b) In the computation of the Oregon apportionment percentage for a
- 6 corporation that is a member of an affiliated group filing a consolidated
- 7 federal return, there shall be taken into consideration only the property,

 - "(3) Facilitates the establishment of foreign-owned entities without the need for a local substantive presence or prohibits these entities from having any commercial impact on the local economy.
 - "(4) Explicitly or implicitly excludes the jurisdiction's resident taxpayers from taking advantage of the tax regime's benefits or prohibits enterprises that benefit from the regime from operating in the jurisdiction's domestic market.
 - "(5) Has created a tax regime that is favorable for tax avoidance, based upon an overall assessment of relevant factors, including whether the jurisdiction has a significant untaxed offshore financial or other services sector relative to its overall economy.
 - **"SECTION 5.** ORS 317.267 is amended to read:
- "317.267. (1) To derive Oregon taxable income, there shall be added to 26 federal taxable income amounts received as dividends from corporations de-27 ducted for federal purposes pursuant to section 243 or 245 of the Internal 28 Revenue Code, except section 245(c) of the Internal Revenue Code, amounts 29 paid as dividends by a public utility or telecommunications utility and de-30

- ducted for federal purposes pursuant to section 247 of the Internal Revenue
- 2 Code or dividends eliminated under Treasury Regulations adopted under

- 22 965(c)(3) of the Internal Revenue Code may not be treated as a dividend for
- 23 purposes of this subsection.
- 24 "(d) If a dividends received deduction is not allowed for federal tax pur-
- poses because of section 246(a) or (c) of the Internal Revenue Code, a sub-
- 26 traction may not be made under this subsection for received dividends that
- 27 are described in section 246(a) or (c) of the Internal Revenue Code.
- 28 "(3) There shall be excluded from the sales factor of any apportionment
- 29 formula employed to attribute income to this state any amount subtracted
- 30 from federal taxable income under subsection (2) of this section.

"SECTION 6. Section 2 of this 2015 Act and the amendments to ORS 317.715 and 317.267 by sections 3 and 5 of this 2015 Act apply to tax years beginning on or after January 1, 2016.

"SECTION 7. This 2015 Act takes effect on the 91st day after the date on which the 2015 regular session of the Seventy-eighth Legislative Assembly adjourns sine die."
