14 **Services to ensure that the department fulfills the duties, implements**
15 **the functions and exercises the powers that remain to the department**
16 **with respect to enterprise information technology and telecommuni-**
17 **cations in a manner that is consistent with the manner in which the**
18 **State Chief Information Officer fulfills the duties, implements the**
19 **functions and exercises the powers that are imposed upon, transferred**
20 **to and vested in the State Chief Information Officer under section 1**
21 **of this 2015 Act;**

22 **“(b) Deliver to the State Chief Information Officer all records and**

1 property within the jurisdiction of the director that relate to the du-
2 ties, functions and powers transferred by section 1 of this 2015 Act; and

3 “(c) Transfer to the State Chief Information Officer those employ-
4 ees engaged primarily in fulfilling the duties, implementing the func-
5 tions and exercising the powers transferred by section 1 of this 2015
6 Act.

7 “(2) The State Chief Information Officer shall take possession of the
8 records and property and shall take charge of the employees and em-
9 ploy the employees in fulfilling the duties, implementing the functions
10 and exercising the powers transferred under section 1 of this 2015 Act
11 without a reduction in the employees’ compensation but subject to
12 change or termination of employment or compensation as provided by
13 law.

14 “(3) The Governor shall resolve any dispute between the State Chief
15 Information Officer and the department that relates to transfers of
16 records, property and employees, or the apportionment of duties,
17 functions and powers under section 1 of this 2015 Act, and with respect
18 to the director’s management of the department in accordance with
19 subsection (1)(a) of this section. The Governor’s decision under this
20 subsection is final.

21 **“SECTION 3. (1) The unexpended balances of amounts the Oregon**
22 **Department of Administrative Services is authorized to expend during**
23 **the biennium beginning July 1, 2015, from revenues dedicated, contin-**
24 **uously appropriated, appropriated or otherwise made available for the**
25 **purpose of administering and enforcing the duties, functions and**
26 **powers transferred by section 1 of this 2015 Act are transferred to and**
27 **are available for the State Chief Information Officer to expend during**
28 **the biennium beginning July 1, 2015, for the purpose of administering**
29 **and enforcing the duties, functions and powers transferred by section**
30 **1 of this 2015 Act.**

1 “(2) The expenditure classifications, if any, established by Acts that
2 authorize or limit expenditures by the department remain applicable
3 to expenditures that the State Chief Information Officer directs or
4 oversees under this section.

5 “SECTION 4. The transfer of duties, functions and powers to the
6 State Chief Information Officer by section 1 of this 2015 Act does not
7 affect any action, proceeding or prosecution involving or with respect
8 to duties, functions and powers that began before and was pending at
9 the time of the transfer, except that the State Chief Information Of-
10 ficer is substituted for the Oregon Department of Administrative Ser-
11 vices in the action, proceeding or prosecution.”.

25 “182.126. As used in this section and ORS 182.128 and 182.132:

26 “(1) ‘Convenience fee’ means a fee for using an electronic government
27 portal or governmental services available by means of an electronic govern-
28 ment portal that the [*Oregon Department of Administrative Services*] **State**
29 **Chief Information Officer** charges or authorizes an electronic government
30 portal provider to charge under ORS 182.132 (3).

1 “(2) ‘Electronic government portal’ means an electronic information de-
2 liverly system accessible by means of the Internet that a state agency desig-
3 nates officially as a means by which the state agency delivers information,
4 products or services.

5 “(3) ‘Electronic government portal provider’ means a person that on be-
6 half of a state agency provides facilities, goods or services necessary to de-
7 velop, host, operate, maintain or otherwise implement an electronic
8 government portal or provides facilities, goods or services that assist a state
9 agency in designing, developing, hosting, operating, maintaining or otherwise
10 implementing an electronic government portal.

11 “(4) ‘State agency’ means the executive department, as defined in ORS
12 174.112.

13 **“SECTION 14.** ORS 182.128 is amended to read:

14 “182.128. (1) There is created the Electronic Government Portal Advisory
15 Board consisting of 13 members appointed as follows:

16 “(a) The President of the Senate shall appoint two nonvoting members
17 from among members of the Senate.

18 “(b) The Speaker of the House of Representatives shall appoint two non-
19 voting members from among members of the House of Representatives.

20 “(c) The Governor shall appoint:

21 “(A) Three members who represent state agencies;

22 “(B) Two members who represent the public; and

23 “(C) One member who attends a school, community college or university
24 in this state.

25 “(d) The [*Director of the Oregon Department of Administrative Services*]
26 **State Chief Information Officer** shall appoint two members as follows:

27 “(A) [*The*] **A representative of the State Chief Information Officer**; and

28 “(B) A representative of the Oregon Department of Administrative Ser-
29 vices.

30 “(e) The State Treasurer shall appoint one member who represents the

1 State Treasurer.

2 “(2) Members of the Legislative Assembly who are members of the advi-
3 sory board are nonvoting members and may act only in an advisory capacity.

4 “(3) The advisory board shall:

5 “(a) Advise the **State Chief Information Officer and the Oregon De-**
6 **partment of Administrative Services** concerning:

7 “(A) The development of electronic government portals for the **State**
8 **Chief Information Officer, the** department and other state agencies;

9 “(B) The amount, collection methods or other aspects of a convenience fee
10 that the [*department*] **State Chief Information Officer** or an electronic
11 government portal provider collects;

12 “(C) The priority of new governmental service applications that may be
13 provided by means of an electronic government portal;

14 “(D) Terms and conditions of contracts between state agencies and elec-
15 tronic government portal providers; and

16 “(E) Rules necessary to implement electronic government portals.

17 “(b) Monitor the layout, content and usability of electronic government
18 portals and advise **the State Chief Information Officer and** the depart-
19 ment on ways to improve the delivery of government services by means of
20 electronic government portals, the accountability of state agencies’ use of
21 electronic government portals to provide government services and user sat-
22 isfaction with electronic government portals.

23 “(c) Study, propose, develop or coordinate activities that:

24 “(A) Consider the needs of residents of this state;

25 “(B) Evaluate the performance and transparency of state agency delivery
26 of government services; and

27 “(C) Further the effectiveness of and user satisfaction with:

28 “(i) Electronic government portals; and

29 “(ii) State agencies’ performance and accountability in [*the use of*] **using**
30 electronic government portals to provide government services.

1 “(4) A majority of the members of the advisory board constitutes a quo-
2 rum for [*the transaction of*] **transacting** business.

3 “(5) [*Official action by the advisory board requires the approval of*] A ma-
4 jority of the members of the advisory board **must approve official action**
5 **by the advisory board.**

6 “(6) The advisory board shall elect one of the members of the advisory
7 board to serve as chairperson.

8 “(7) If a vacancy on the advisory board occurs for any cause, the ap-
9 pointing authority shall make an appointment [*to become*] **that becomes**
10 immediately effective.

11 “(8) The advisory board shall meet at times and places [*specified by the*
12 *call of*] **that** the chairperson or [*of*] a majority of the members of the advi-
13 sory board **specifies.**

14 “(9) The advisory board may adopt rules necessary [*for the operation of*]
15 **to operate** the advisory board.

16 “(10) The Oregon Department of Administrative Services shall provide
17 staff support to the advisory board.

18 “(11) Members of the advisory board who are not members of the Legis-
19 lative Assembly [*are not entitled to*] **may not receive** compensation, but may
20 be reimbursed for actual and necessary travel and other expenses the mem-
21 bers incur in the performance of the members’ official duties in the manner
22 and amounts provided for in ORS 292.495. Claims for expenses [*incurred*] **the**
23 **members incur** in performing functions of the advisory board shall be paid
24 out of funds appropriated to the Oregon Department of Administrative Ser-
25 vices for purposes of the advisory board.

26 “(12) All state agencies shall assist the advisory board in the advisory
27 board’s performance of the advisory board’s duties and, to the extent per-
28 mitted by laws relating to confidentiality, to furnish information and advice
29 as the members of the advisory board consider necessary to perform the du-
30 ties of the advisory board.

1 **“SECTION 15.** ORS 182.132 is amended to read:

2 “182.132. (1) The [*Oregon Department of Administrative Services*] **State**
3 **Chief Information Officer**, with the advice of the Electronic Government
4 Portal Advisory Board, shall provide the ability for state agencies to offer
5 government services by means of an electronic government portal. The elec-
6 tronic government portal must be secure and must [*meet*] **comply with the**
7 **information security rules, policies and standards that the State Chief**
8 **Information Officer adopts under ORS 182.122 and meet the** usability
9 standards developed in cooperation with the advisory board.

10 “(2) For the purposes of subsection (1) of this section, the [*department*]
11 **State Chief Information Officer**, under the provisions of the Public Con-
12 tracting Code, may contract with an electronic government portal provider
13 **in a manner that is consistent with the State Chief Information**
14 **Officer’s rules, policies and standards.**

15 “(3)(a) The [*department*] **State Chief Information Officer** may charge
16 members of the public a convenience fee or may authorize an electronic
17 government portal provider to charge a convenience fee for an electronic
18 government service if the advisory board recommends that the [*department*]
19 **State Chief Information Officer** charge or authorize a convenience fee for
20 the electronic government service. The convenience fee must reflect the costs
21 incurred in hosting, operating, maintaining or implementing the electronic
22 government portal.

23 “(b) The [*department*] **State Chief Information Officer** shall cooperate
24 with the advisory board to identify the electronic government portals or
25 governmental services to which the convenience fee applies.

26 “(4) The [*department*] **State Chief Information Officer** may adopt rules
27 to implement the provisions of this section.

28 “(5) Not later than the beginning of each odd-numbered year regular leg-
29 islative session, the [*department*] **State Chief Information Officer** shall
30 prepare and submit to the Legislative Assembly a report in the manner pro-

1 vided in ORS 192.245 that summarizes the [*department's*] **State Chief In-**
2 **formation Officer's** activities under the provisions of this section.

3 **“SECTION 15a.** ORS 184.305 is amended to read:

4 “184.305. The Oregon Department of Administrative Services is created.
5 The purpose of the Oregon Department of Administrative Services is to im-
6 prove the efficient and effective use of state resources [*through the provision*
7 *of*] **by providing:**

8 “(1) Government infrastructure services that can best be provided cen-
9 trally, including but not limited to purchasing, risk management, facilities
10 management, surplus property and motor fleet;

11 “(2) Rules and associated performance reviews of agency compliance with
12 statewide policies;

13 “(3) Leadership in [*the implementation of*] **implementing** a statewide
14 performance measurement program;

15 “(4) State employee workforce development and training;

16 “(5) Personnel systems that promote fair, responsive and cost-effective
17 human resource management;

18 “(6) Objective, credible management information for, and analysis of,
19 statewide issues for policymakers; **and**

20 “(7) Statewide financial administrative systems[; *and*].

21 “[*(8) Statewide information systems and networks to facilitate the reliable*
22 *exchange of information and applied technology.*]”.

22 provide general government administrative functions [to] **for** state agencies.

23 [*The cost of these services, or portions thereof, as determined by the department
24 shall be allocated to state agencies as determined by the department and paid
25 to the department in the same manner as other claims against the agency are
26 paid.*] **The State Chief Information Officer shall provide information**

27 **technology and telecommunications functions for state agencies. The**
28 **department or the State Chief Information Officer shall allocate the**
29 **costs that the department or the State Chief Information Officer de-**
30 **termines for the services, or a portion of the services, to state agen-**

1 **cies, which shall pay the costs to the department or the State Chief**

12 **“(b) Require a state agency to subject employees of the state agency**
13 **to the State Chief Information Officer’s direct supervision;**

14 **“(c) Require a state agency to consolidate information technology**
15 **or telecommunications equipment, assets or resources with another**
16 **state agency’s information technology or telecommunications equip-**
17 **ment, assets or resources; or**

18 **“(d) Prevent a state agency from providing information technology**
19 **or telecommunications functions for the state agency.**

20 **“SECTION 25. ORS 283.120 is amended to read:**

21 **“283.120. Subject to rules [*prescribed by*] that the Oregon Department of**
22 **Administrative Services prescribes, or that the State Chief Information**
23 **Officer prescribes for information technology and**
24 **telecommunications, any state agency may establish a service unit within**
25 **the agency to furnish to other units of [*such*] the agency the services, facil-**
26 **ities and materials that the agency establishes the service unit [*is estab-***
27 **lished] to provide. The state agency shall charge the service unit’s**
28 **expenses [*of the service unit shall be charged*] to the units served and, except**
29 **as provided in ORS 283.076 (3), the amounts [*so charged*] the state agency**
30 **charges must [*shall*] be credited to the miscellaneous receipts account es-**

1 tablished pursuant to ORS 279A.290. **The moneys in the account** [*and*
2 *hereby*] are appropriated continuously for expenditure by the state agency
3 subject to the allotment system provided by ORS 291.234 to 291.260.

4 **“SECTION 26.** ORS 283.140 is amended to read:

5 *“283.140. [(1) The Oregon Department of Administrative Services shall ex-*
6 *ercise budgetary management, supervision and control over all telephone and*
7 *telecommunications service for all state agencies. The department may operate*
8 *central mail, shuttle bus or messenger services for agencies located in Salem,*
9 *Portland or other cities, where it would be economical so to do. The cost of*
10 *maintaining and operating any central telephone exchange, switching system,*
11 *network service and facility, intercity or intracity network trunk or line or*
12 *switchboard, or the cost of mail, shuttle bus and messenger services, shall be*
13 *charged to the various agencies served and paid to the department in the same*
14 *manner as other claims against the agencies are paid.]*

15 **“(1) The State Chief Information Officer shall exercise budgetary**
16 **management, supervision and control over all telephone and telecom-**
17 **munications service for all state agencies in a manner that is con-**
18 **sistent with plans, standards, policies, goals, directives and rules that**
19 **the State Chief Information Officer sets, specifies or adopts. The**
20 **Oregon Department of Administrative Services may operate central**
21 **mail, shuttle bus or messenger services for state agencies located in**
22 **Salem, Portland or other cities, if doing so is economical. The State**
23 **Chief Information Officer may charge the cost of maintaining and**
24 **operating any central telephone exchange, switching system, network**
25 **service and facility, intercity or intracity network trunk or line or**
26 **switchboard to the state agencies that the State Chief Information**
27 **Officer serves. The department shall charge the cost of providing mail,**
28 **shuttle bus and messenger services to the state agencies that the de-**
29 **partment serves. The state agencies shall pay the costs to the State**
30 **Chief Information Officer or the department, as appropriate, in the**

1 **same manner in which the state agencies pay other claims. The State**
2 **Chief Information Officer shall deposit all moneys that the State Chief**
3 **Information Officer receives from state agencies for services under**
4 **this section into the State Information Technology Operating Fund.**

5 “(2) If the department operates central mail service, [it] **the department**
6 shall:

7 “(a) Approve or disapprove all state agency mail equipment or mail ser-
8 vice acquisitions.

9 “(b) Report biennially to the Director of the Oregon Department of Ad-
10 ministrative Services on opportunities for savings through state agency mail
11 room centralization, consolidation and automation and through mail route
12 coordination.

13 “[3] (c) [The department shall] Adopt rules [pursuant to] **under** which
14 persons associated with government either temporarily or otherwise, includ-
15 ing but not limited to unsalaried volunteers, part-time employees, contractors
16 with the state and employees of contractors, political subdivisions and the
17 federal government may use shuttle bus services.

18 “[4] (3) [For the purposes of] **As used in** this section, ‘telecommuni-
19 cations’ means media that communicate voice, data, text, images or video
20 over a distance using electrical, electronic or light wave transmission media.

21 **“SECTION 27.** ORS 283.143 is amended to read:

22 “283.143. [(1) *To encourage utilization of statewide integrated*
23 *videoconferencing and statewide online access services, the Oregon Department*
24 *of Administrative Services shall, in addition to any other charge or assessment*
25 *for providing telecommunications services to state agencies, impose upon each*
26 *agency and public corporation a surcharge, in an amount established by the*
27 *department. All surcharge moneys collected shall be deposited in the Oregon*
28 *Department of Administrative Services Operating Fund, and may be expended*
29 *only for state agency and public corporation telecommunication and*
30 *videoconferencing activities, under such terms and conditions as the depart-*

1 *ment may prescribe.]*

2 *“(2) Notwithstanding subsection (1) of this section, the Oregon Department*
3 *of Administrative Services shall not impose the surcharge established by this*
4 *section on the Oregon University System or the Oregon Health and Science*
5 *University. The Oregon Department of Administrative Services shall enter into*
6 *an agreement with the Oregon University System and the Oregon Health and*
7 *Science University on the amounts to be paid by the Oregon University System*
8 *and the Oregon Health and Science University to the Oregon Department of*
9 *Administrative Services in lieu of the surcharge provided for in this section.]*

10 **“(1) To encourage utilization of statewide integrated**
11 **videoconferencing and statewide online access services, the State Chief**
12 **Information Officer may, in addition to any other charge or assess-**
13 **ment for providing telecommunications services to state agencies,**
14 **impose upon each state agency and public corporation a surcharge, in**
15 **an amount the State Chief Information Officer establishes. The State**
16 **Chief Information Officer shall deposit all surcharge moneys into the**
17 **State Information Technology Operating Fund. The State Chief Infor-**
18 **mation Officer may expend moneys in the fund for state agency and**
19 **public corporation telecommunication and videoconferencing activ-**
20 **ities, under such terms and conditions as the State Chief Information**
21 **Officer may prescribe and in a manner that is consistent with plans,**
22 **standards, policies, goals, directives and rules that the State Chief**
23 **Information Officer sets, specifies or adopts.**

24 **“(2) Notwithstanding subsection (1) of this section, the State Chief**
25 **Information Officer may not impose the surcharge established by this**
26 **section on the Oregon University System or the Oregon Health and**
27 **Science University. The State Chief Information Officer shall enter**
28 **into an agreement with the Oregon University System and the Oregon**
29 **Health and Science University on the amounts that the Oregon Uni-**
30 **versity System and the Oregon Health and Science University must**

1 **pay to the State Chief Information Officer in lieu of the surcharge**
2 **provided for in this section.**

3 **“SECTION 28.** ORS 283.505 is amended to read:

4 “283.505. *[(1) The Oregon Department of Administrative Services shall co-*
5 *ordinate the consolidation and operation of all telecommunications systems*
6 *used by the state and state agencies. Notwithstanding any other provision of*
7 *law, no agent or agency of the state shall construct, purchase or otherwise gain*
8 *access to a telecommunications system without the prior approval of the de-*
9 *partment.]*

10 **“(1) The State Chief Information Officer shall coordinate, in a**
11 **manner that is consistent with plans, standards, policies, goals, di-**
12 **rectives and rules that the State Chief Information Officer sets, spec-**
13 **ifies or adopts, the consolidation and operation of all**
14 **telecommunications systems, including emergency telecommuni-**
15 **cations systems, that the state and state agencies use. Notwith-**
16 **standing any other provision of law, an agent or agency of the state**
17 **may not construct, purchase or otherwise gain access to a telecom-**
18 **munications system without the prior approval of the State Chief In-**
19 **formation Officer.**

20 **“(2) [The department shall coordinate the consolidation and operation of**
21 **emergency telecommunications systems used by the state and state agencies.**
22 **The provisions of this section shall not be construed to require consolidation**
23 **of] The provisions of this section do not require emergency service**
24 **providers, as defined by the State Chief Information Officer, to con-**
25 **solidate telecommunications systems [used by] that emergency service pro-**
26 **viders use [, as defined by the department,] into nonemergency networks.**

27 **“SECTION 29.** ORS 283.510 is amended to read:

28 “283.510. (1) As used in this section:

29 “(a) ‘Advanced digital communications’ means equipment, facilities and
30 capability to distribute digital communications signals for *[the transmission*

1 of] **transmitting** voice, data, image and video over distance.

2 “(b) ‘Telecommunications provider’ means any person **that is** capable of
3 providing advanced digital communications including, but not limited to, a
4 telecommunications utility as defined in ORS 759.005, a competitive tele-
5 communications provider as defined in ORS 759.005, a cable television pro-
6 vider or an interstate telecommunications provider.

7 “[*(2) Notwithstanding ORS chapters 279A, 279B and 279C, the Oregon*
8 *Department of Administrative Services by contract shall acquire advanced*
9 *digital communications services from telecommunications providers or a con-*
10 *sortium of such providers. Contracts under this section shall provide that all*
11 *responsibility for construction, installation, operation and maintenance of the*
12 *network shall remain with the contracting provider.*]

13 “[*(3) Upon installation of an advanced digital communications network, the*
14 *Oregon Department of Administrative Services shall provide all telecommuni-*
15 *cations services and operations for the state and its agencies. The department*
16 *shall not approve the procurement of any telecommunications system or equip-*
17 *ment that is incompatible with the network.*]

18 “**(2) Notwithstanding ORS chapters 279A, 279B and 279C, the State**
19 **Chief Information Officer may provide advanced digital communi-**
20 **cations services directly, may enter into an interagency or intergov-**
21 **ernmental agreement under ORS chapter 190 to have another state**
22 **agency or governmental agency provide advanced digital communi-**
23 **cations services or may acquire advanced digital communications ser-**
24 **vices by entering into contracts with telecommunications providers**
25 **or a consortium of telecommunications providers in a manner that is**
26 **consistent with the State Chief Information Officer’s rules, policies**

10 the following:

11 “(A) The reason for the fee decrease; and

12 “(B) The conditions under which the fee will be increased to not more
13 than its prior level.
