

**PROPOSED AMENDMENTS TO  
SENATE BILL 247**

1 On page 1 of the printed bill, after line 9, insert:

2  
3 **“LEGISLATIVE PURPOSE**

4  
5 **“SECTION 1. It is the intent of the Legislative Assembly to repeal**  
6 **sections 5 and 6 of this 2015 Act, which provide for increases beginning**  
7 **on January 1, 2020, to the fees listed in the fee schedule under section**  
8 **2 of this 2015 Act, if prior to January 1, 2020, the Legislative Assembly**  
9 **adopts by law an alternative mechanism for funding the State De-**  
10 **partment of Fish and Wildlife that will result in a revenue increase**  
11 **to the department that is equal to or greater than the revenue in-**  
12 **crease to the department that is anticipated to be realized under the**  
13 **fee increases in section 5 of this 2015 Act.**

14 **“SECTION 1a. Section 1 of this 2015 Act is repealed on January 2,**  
15 **2020.”.**

16 In line 14, delete “1” and insert “1b”.

17 Delete lines 15 through 28 and delete pages 2 through 10.

18 On page 11, delete lines 1 through 21 and insert:

19 **“SECTION 2. (1) Except as otherwise provided for by law, the State**
