

**PROPOSED AMENDMENTS TO
SENATE BILL 460**

1 Delete lines 4 through 19 of the printed bill and insert:

2 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part**
3 **of ORS 475.300 to 475.346.**

4 **“SECTION 2. (1) As used in this section:**

5 **“(a) ‘Cannabinoid extract’ means a substance that is not incorpo-**
6 **rated into a food or potable liquid and that is obtained by separating**
7 **cannabinoids from marijuana by a chemical extraction process using**
8 **carbon dioxide, provided that the process uses high heat or pressure.**

9 **“(b) ‘Limited marijuana retail product’ means:**

10 **“(A) The seeds of marijuana;**

11 **“(B) The dried leaves and flowers of marijuana;**

12 **“(C) A marijuana plant that is not flowering; and**

13 **“(D) A cannabinoid extract by itself.**

14 **“(c) ‘Marijuana’ means the plant Cannabis family Cannabaceae, any**
15 **part of the plant Cannabis family Cannabaceae and the seeds of the**
16 **plant Cannabis family Cannabaceae.**

17 **“(d) ‘Medical marijuana dispensary’ means an entity registered with**
18 **the Oregon Health Authority under ORS 475.314.**

19 **“(2) Notwithstanding any other provision of law, on and after the**
20 **effective date of this 2015 Act, a medical marijuana dispensary may sell**
21 **limited marijuana retail product to a person who is 21 years of age or**
22 **older if:**

1 “(a) The person presents proof of age to the medical marijuana
2 dispensary before entering into the medical marijuana dispensary;

3 “(b) The medical marijuana dispensary verifies that the person is
4 21 years of age or older at the time of the sale;

5 “(c) The medical marijuana dispensary sells no more than one-
6 quarter ounce of limited marijuana retail product to the person per
7 day if the person is purchasing the dried leaves and flowers of
8 marijuana;

9 “(d) The medical marijuana dispensary sells no more than four
10 units of limited marijuana retail product to the person if the person
11 is purchasing a marijuana plant that is not flowering; and

12 “(e) The medical marijuana dispensary sells no more than 3.5 grams
13 of the limited marijuana retail product to the person if the person is
14 purchasing a cannabinoid extract.

15 “(3) A city or county may adopt ordinances prohibiting the sale of
16 limited marijuana retail product as described in this section in the
17 area subject to the jurisdiction of the city or the unincorporated area
18 subject to the jurisdiction of the county.

19 “SECTION 3. Section 2 of this 2015 Act is repealed on December 31,
20 2016.

21 “SECTION 4. This 2015 Act being necessary for the immediate
22 preservation of the public peace, health and safety, an emergency is
23 declared to exist, and this 2015 Act takes effect on its passage.”.
