

**PROPOSED AMENDMENTS TO
SENATE BILL 75**

1 On page 1 of the printed bill, line 2, after the first semicolon delete the
2 rest of the line and delete line 3 and insert “and declaring an emergency.”.

3 Delete lines 5 through 28 and delete pages 2 through 4 and insert:

4 **“SECTION 1. (1) The Task Force on Campaign Finance Reform is**
5 **established, consisting of 17 members as follows:**

6 **“(a) The Secretary of State shall appoint:**

7 **“(A) Five members to represent the interests of political parties in**
8 **Oregon, with at least one member representing each of the major**
9 **political parties in Oregon.**

10 **“(B) Two members to represent the interests of electors who are**
11 **not affiliated with any political party.**

12 **“(C) One member to represent the interests of the League of**
13 **Women Voters of Oregon.**

14 **“(D) One member to represent the interests of organizations that**
15 **focus on campaign finance reform.**

16 **“(E) One member to represent the interests of nonprofit organiza-**
17 **tions.**

18 **“(F) One member to represent the interests of for-profit organiza-**
19 **tions.**

20 **“(G) One member to represent the interests of nonprofit organiza-**
21 **tions that focus on voter registration.**

22 **“(b) The Secretary of State shall serve as a member of the task**

1 **force.**

2 **“(c) The President of the Senate shall appoint two members from**
3 **among members of the Senate, one of whom is a Democrat and one**
4 **of whom is a Republican.**

5 **“(d) The Speaker of the House of Representatives shall appoint two**
6 **members from among members of the House of Representatives, one**
7 **of whom is a Democrat and one of whom is a Republican.**

8 **“(2) The task force shall conduct an analysis and determine the best**
9 **method or methods to address campaign finance reforms.**

10 **“(3) A majority of the members of the task force constitutes a**
11 **quorum for the transaction of business.**

12 **“(4) Official action by the task force requires the approval of a**
13 **majority of the members of the task force.**

14 **“(5) The Secretary of State shall serve as chairperson of the task**
15 **force.**

16 **“(6) If there is a vacancy for any cause, the appointing authority**
17 **shall make an appointment to become immediately effective.**

18 **“(7) The task force shall meet at times and places specified by the**
19 **call of the chairperson or of a majority of the members of the task**
20 **force.**

21 **“(8) The task force may adopt rules necessary for the operation of**
22 **the task force.**

23 **“(9) The task force shall submit a report in the manner provided**
24 **by ORS 192.245, and may include recommendations for legislation, to**
25 **the interim committees of the Legislative Assembly related to rules**
26 **no later than December 31, 2015.**

27 **“(10) The staff of the Committee Services office of the Legislative**
28 **Administration Committee shall provide staff support to the task**
29 **force.**

30 **“(11) Members of the task force who are not members of the Leg-**

1 **islative Assembly are not entitled to compensation, but may be reim-**
2 **bursed for actual and necessary travel and other expenses incurred by**
3 **them in the performance of their official duties in the manner and**
4 **amounts provided for in ORS 292.495. Claims for expenses incurred in**
5 **performing functions of the task force shall be paid out of funds ap-**
6 **propriated to the Legislative Assembly for purposes of the task force.**

7 **“(12) All agencies of state government, as defined in ORS 174.111,**
8 **are directed to assist the task force in the performance of its duties**
9 **and, to the extent permitted by laws relating to confidentiality, to**
10 **furnish such information and advice as the members of the task force**
11 **consider necessary to perform their duties.**

12 **“SECTION 2. Section 1 of this 2015 Act is repealed on July 2, 2017.**

13 **“SECTION 3. This 2015 Act being necessary for the immediate**
14 **preservation of the public peace, health and safety, an emergency is**
15 **declared to exist, and this 2015 Act takes effect on its passage.”.**
