PROPOSED AMENDMENTS TO SENATE BILL 61

- "SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 317.
- "SECTION 2. (1)(a) For purposes of determining Oregon taxable in-
- 7 come, the taxable income or loss of any corporation that is a member
- 8 of a unitary group or that is a corporation that files a separate return
- and that is incorporated in any of the jurisdictions listed in paragraph
- 10 (b) of this subsection shall be added to the federal consolidated taxable
- income of the unitary group filing a consolidated Oregon return or to
- 12 the federal taxable income of the corporation filing a separate return.
- 13 "(b) This section applies to Andorra, Anguilla, Antigua and
- 14 Barbuda, Aruba, the Bahamas, Bahrain, Barbados, Belize, Bermuda,
- 15 Bonaire, the British Virgin Islands, the Cayman Islands, the Cook Is-
- 16 lands, Curacao, Cyprus, Dominica, Gibraltar, Grenada, Guatemala,
- 17 Guernsey-Sark-Alderney, the Isle of Man, Jersey, Liberia,
- 18 Liechtenstein, Luxembourg, Malta, the Marshall Islands, Mauritius,
- 19 Montserrat, Nauru, Niue, Saba, Samoa, San Marino, Seychelles, Sint

- "(2) After making any addition required by subsection (1)(a) of this section, any item of income, gain, loss or expense of a corporation that is a member of a unitary group and that is incorporated in any of the jurisdictions that are listed in subsection (1)(b) of this section shall be eliminated from federal taxable income if the item is not attributable directly or indirectly to activity of or transactions with a unitary group member included in a federal consolidated or separate return.

- "(a) To determine the computation of income or loss for a corporation that is a member of a unitary group and that is not otherwise required to file a consolidated federal return.
- "(b) To prevent double taxation or double deduction of any amount included in the computation of income under this section.
 - "(c) To implement this section.
 - **"SECTION 3.** ORS 317.715 is amended to read:
- "317.715. (1) If a corporation required to make a return under this chapter is a member of an affiliated group of corporations making a consolidated federal return under sections 1501 to 1505 of the Internal Revenue Code, the corporation's Oregon taxable income shall be determined beginning with federal consolidated taxable income of the affiliated group as provided in this section.
 - "[(2)(a) For purposes of determining Oregon taxable income, the taxable income or loss of any corporation that is a member of a unitary group and that is incorporated in any of the following jurisdictions shall be added to federal consolidated taxable income:]
- "[(b) Andorra, Anguilla, Antigua and Barbuda, Aruba, the Bahamas, Bahrain, Barbados, Belize, Bermuda, the British Virgin Islands, the Cayman Islands, the Cook Islands, Cyprus, Dominica, Gibraltar, Grenada, Guernsey-Sark-Alderney, the Isle of Man, Jersey, Liberia, Liechtenstein, Luxembourg, Malta, the Marshall Islands, Mauritius, Monaco, Montserrat, Nauru, the

- 1 Netherlands Antilles, Niue, Samoa, San Marino, Seychelles, St. Kitts and

- "[(3)] (2) If the affiliated group, of which the corporation subject to taxation under this chapter is a member, consists of more than one unitary
- 6 group, before the additions, subtractions, adjustments and modifications to
- 7 federal taxable income provided for in this chapter are made, and before al-
- 8 location and apportionment as provided in ORS 317.010 (10), if any, modified
- 9 federal consolidated taxable income shall be computed. Modified federal
- 10 consolidated taxable income shall be determined by eliminating from the
- 11 federal consolidated taxable income of the affiliated group the separate tax-
- 12 able income, as determined under Treasury Regulations adopted under sec-
- tion 1502 of the Internal Revenue Code, and any deductions or additions or
- 14 items of income, expense, gain or loss for which consolidated treatment is
- prescribed under Treasury Regulations adopted under section 1502 of the
- 16 Internal Revenue Code, attributable to the member or members of any

- "[(4)(a)] (3)(a) After modified federal consolidated taxable income is de-

- 21 made to the modified federal consolidated taxable income of the remaining
- 22 members of the affiliated group, where applicable, as if all such members
- 23 were subject to taxation under this chapter. After those modifications are
- 24 made, Oregon taxable income or loss shall be determined as provided in ORS
- 25 317.010 (10)(a) to (c), if necessary.
- 26 "(b) In the computation of the Oregon apportionment percentage for a
- corporation that is a member of an affiliated group filing a consolidated
- 28 federal return, there shall be taken into consideration only the property,
- 29 payroll, sales or other factors of those members of the affiliated group[, and
- 30 of those corporations described in subsection (2) of this section,] whose items

- of income, expense, gain or loss remain in modified federal consolidated
- 2 taxable income after the eliminations required under subsection [(3)] (2) of

- "[(b) To prevent double taxation or double deduction of any amount included in the computation of income under this section.]

"SECTION 4. ORS 317.717 is amended to read:

- "317.717. On or before January 1 of each odd-numbered year, the Depart-16 ment of Revenue shall submit a report to the Legislative Assembly in the 17 manner provided by ORS 192.245. The report shall include recommendations 18 for legislation related to jurisdictions listed in [ORS 317.715 (2)(b)] section 19 2 of this 2015 Act, including recommendations for additions to or sub-20 tractions from the list of jurisdictions in [ORS 317.715 (2)(b).] section 2 of 21 this 2015 Act. In making the determination of which jurisdictions to 22 recommend for inclusion, the department shall determine whether a 23 jurisdiction is one that for the tax year has no or nominal effective 24 tax on the relevant income and for which at least one of the following 25 applies: 26
 - "(1) The jurisdiction has laws or practices that prevent effective exchange of information for tax purposes with other governments about taxpayers benefiting from the tax regime.
 - "(2) The jurisdiction has a tax regime that lacks transparency. A

- tax regime lacks transparency if the details of legislative, legal or administrative provisions are not open and apparent or are not consistently applied among similarly situated taxpayers, or if the information needed by tax authorities to determine a taxpayer's correct tax liability, such as accounting records and underlying documentation, is not
 - "(3) The jurisdiction facilitates the establishment of foreign-owned entities without the need for a local substantive presence or prohibits these entities from having any commercial impact on the local economy.
 - "(4) The jurisdiction explicitly or implicitly excludes the jurisdiction's resident taxpayers from taking advantage of the tax regime's benefits or prohibits enterprises that benefit from the regime from operating in the jurisdiction's domestic market.
 - "(5) The jurisdiction has created a tax regime that is favorable for tax avoidance, based upon an overall assessment of relevant factors, including whether the jurisdiction has a significant untaxed offshore financial or other services sector relative to its overall economy.

"SECTION 5. ORS 317.267 is amended to read:

- "317.267. (1) To derive Oregon taxable income, there shall be added to federal taxable income amounts received as dividends from corporations deducted for federal purposes pursuant to section 243 or 245 of the Internal Revenue Code, except section 245(c) of the Internal Revenue Code, amounts paid as dividends by a public utility or telecommunications utility and deducted for federal purposes pursuant to section 247 of the Internal Revenue Code or dividends eliminated under Treasury Regulations adopted under section 1502 of the Internal Revenue Code that are paid by members of an affiliated group that are eliminated from a consolidated federal return pursuant to ORS 317.715 [(3)] (2).
 - "(2) To derive Oregon taxable income, after the modification prescribed

- 25 "SECTION 6. Section 2 of this 2015 Act and the amendments to ORS
- 26 317.715 and 317.267 by sections 3 and 5 of this 2015 Act apply to tax
- years beginning on or after January 1, 2016.
- 28 "SECTION 7. Not later than March 15, 2017, the Legislative Revenue
- 29 Officer, after consultation with the Department of Revenue, shall
- 30 prepare a report for submission to a committee of the Legislative As-

sembly related to revenue. The Legislative Revenue Officer shall include in the report an assessment of the cost-effectiveness of the enactment by the Legislative Assembly of the policy, such as the provisions of section 2 of this 2015 Act, governing the tax treatment of corporations incorporated in offshore jurisdictions.

"SECTION 8. This 2015 Act takes effect on the 91st day after the date on which the 2015 regular session of the Seventy-eighth Legislative Assembly adjourns sine die.".
