6 Center Fund had section 1 [*of this 2015 Act*], **chapter __, Oregon Laws**
7 **2015 (Enrolled House Bill 3012)**, remained in effect, shall be transferred to
8 and deposited in the Fish Endowment Subaccount in the Fish and Wildlife
9 Account, and are appropriated for expenditure as in the case of other moneys
10 in the Fish Endowment Subaccount.

11 “(3) Any balance in the Hatchery Construction Fund that is unexpended
12 and unobligated on the date of the repeal of section 2 [*of this 2015 Act*],
13 **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, and all moneys
14 that would have been deposited in the Hatchery Construction Fund had
15 section 2 [*of this 2015 Act*], **chapter __, Oregon Laws 2015 (Enrolled**

17 in the Fish Endowment Subaccount in the Fish and Wildlife Account, and
