

**PROPOSED AMENDMENTS TO RESOLVE CONFLICTS TO
B-ENGROSSED HOUSE BILL 2728**

1 On page 1 of the printed B-engrossed bill, line 2, after “284.711” insert
2 “and section 10, chapter 519, Oregon Laws 2011, and sections 66 and 72,
3 chapter ___, Oregon Laws 2015 (Enrolled Senate Bill 215)”.

8 **“SECTION 9.** ORS 284.706, as amended by section 1, chapter 196, Oregon
9 Laws 2015 (Enrolled House Bill 2288), is amended to read:

10 “284.706. (1) There is created the Oregon Innovation Council consisting
11 of the following voting members:

12 “(a) The Governor or the Governor’s designated representative, who shall
13 be chairperson of the council.

14 “(b) Seven members appointed by the Governor who are experienced en-
15 trepreneurs or investors or are engaged in the operations of Oregon traded
16 sector industries or Oregon growth businesses.

17 “(c) One member appointed by the Governor who is a representative of
18 an Oregon-based, generally accredited, not-for-profit private institution of
19 higher education.

20 “(d) One member appointed by the Governor who is a representative of
21 an Oregon-based, generally accredited public institution of higher education
22 as defined in ORS 284.633.

1 “(e) A member of the Oregon Growth Board, appointed by the board, who
2 is experienced in making direct investments in new growth-based companies.

3 “(f) A private sector member of the [*Engineering and Technology Industry*
4 *Council, appointed by the Engineering and Technology Industry Council*]

5 **Oregon Talent Council.**

6 “(g) The Director or an executive officer of the Oregon Business Devel-
7 opment Department.

8 “(h) The executive director of the Higher Education Coordinating Com-
9 mission.

10 “(i) The State Treasurer.

11 “(2)(a) The Speaker of the House of Representatives shall appoint two
12 members to the council who are members of the House of Representatives.

13 “(b) The President of the Senate shall appoint two members to the council
14 who are members of the Senate.

15 “(c) Members of the Legislative Assembly appointed to the council are
16 nonvoting members and may act in an advisory capacity only.

17 “(3) The presiding officer of the Oregon Business Development Commis-
18 sion shall serve as an ex officio, nonvoting member of the council.

19 “(4) The term of office of each appointed voting member of the council is
20 two years, but an appointed member serves at the pleasure of the appointing
21 authority. Before the expiration of the term of an appointed voting member,
22 the appointing authority shall appoint a successor whose term begins on July
23 1 next following. An appointed member is eligible for reappointment for one
24 additional term. If there is a vacancy for any cause, the appointing authority
25 shall make an appointment to become immediately effective for the remain-
26 der of the unexpired term.

27 “(5) A majority of the voting members of the council constitutes a quorum
28 for the transaction of business.

29 “(6) Official action by the council requires the approval of a majority of
30 the voting members of the council.

1 “(7) The council shall meet at least four times per fiscal year at a place,
2 day and time determined by the chairperson. The council may also meet at
3 other times and places specified by a call of the chairperson or by written
4 request of a majority of the voting members of the council.

5 “(8) The council may adopt rules necessary for the operation of the
6 council.

7 “(9) The council shall establish an audit and accountability committee
8 that shall monitor performance of council contracts and benchmark Oregon’s
9 performance against nationally accepted innovation metrics.

10 “(10) The council may establish other committees and delegate to the
11 committees duties as the council considers desirable.

12 “(11) The Oregon Business Development Department shall provide staff
13 support to the council.

14 “(12) Members of the council who are members of the Legislative Assem-
15 bly are entitled to compensation and expense reimbursement as provided in
16 ORS 171.072.

17 “(13) Members of the council who are not members of the Legislative
18 Assembly are entitled to compensation and expenses incurred by them in the
19 performance of their official duties in the manner and amounts provided for
20 in ORS 292.495. Claims for compensation and expenses of members of the
21 council who are public officers shall be paid out of funds appropriated to the
22 public agency that employs the member. Claims for compensation and ex-
23 penses of members of the council who are not public officers shall be paid
24 out of funds appropriated to the Oregon Business Development Department
25 for that purpose.

26 “(14) All agencies of state government, as defined in ORS 174.111, are di-
27 rected to assist the council in the performance of its duties and, to the extent
28 permitted by laws relating to confidentiality, to furnish such information and
29 advice as the members of the council consider necessary to perform their
30 duties.”.
