HB 4066

CARRIED OVER FROM THE 2/8/2016 AGENDA: Modifies provisions relating to unmanned aircraft systems, commonly known as drones.

HB 4087

CARRIED OVER FROM THE 2/8/2016 AGENDA: Prohibits official action relating to employment or certification of police officer solely because police officer is on impeachment list or because of unproven allegation that police officer committed act or omission of kind for which name of police officer may be placed on impeachment list.
