#### Public Hearing and Work Session

SB 1553

CARRIED OVER FROM 2/8/2016 AGENDA: Authorizes prosecution of first-degree sex crimes any time after commission of crime if prosecuting attorney obtains corroborating evidence of crime.

#### Possible Work Session

SB 1555

CARRIED OVER FROM 2/8/2016 AGENDA: Allows polygraph test as condition of employment for preemployment screening of law enforcement officers.

SB 1576

CARRIED OVER FROM 2/8/2016 AGENDA: Prohibits person that manufactures or distributes prescription contact lenses from preventing retailer from advertising or selling prescription contact lenses at price for consumers that is less than price that person sets or specifies.

SB 1550 \*\*

Directs presiding judges of judicial districts within state to ensure proceedings before grand jury are recorded.

SB 1556

Expands definition of physical injury in Oregon Criminal Code to include physical trauma when injured person is vulnerable victim.

Directs Department of State Police to adopt rules concerning prioritization of testing untested sexual assault forensic evidence kits.
