

What is a public charter school?

An elementary or secondary school offering a comprehensive instructional program operating under a written agreement entered into between a sponsor and an applicant and operating pursuant to ORS 338.

- Public school of choice
- Considered a component school within a school district
- Authorized by and accountable to a sponsoring board
- Must comply with federal law
- Must comply with many state laws but not all

2015-16 Oregon public charter schools

- 196 Total Public Charter Schools
 - 77 District Sponsors
 - 18 Single-School District Charters
 - 12 Virtual Public Charter Schools
 - **4** State Board of Education Sponsored Charters

In 2014-15 school year, **29,833** Students enrolled in public charter schools.

This is **5.5%** of enrolled students in Oregon



What is a Virtual Public Charter School?

A public school established through a performance contract with a sponsor that offers online courses and does not serve students primarily in a physical location.

- Instruction and content are delivered primarily through electronic means
- Student and teachers are in different physical locations
- Online instructional activities are integral to the academic program
- Students are not required to be located in physical location of a school to participate
- More than 50% of core courses are offered online
- More than 50% of students attending receive instructional services online
- More than 50% of the required instructional time is provided online




Sponsorship Changes for 2015-16

 - Crook County SD did not renew the charter school after it's first term. The operators started a new virtual public charter school sponsored by the Mitchell SD named Insight School of Oregon – Painted Hills
- Oregon Connections Academy
 - ORCA terminated its contract with Scio SD and was sponsored by Santiam Canyon SD


Academic Performance: 2014-15 SBAC ELA




Academic Performance: 2014-15 SBAC MATH

Funding

ORS 338.155 Distributions of State School Fund amounts

A sponsor must contractually establish payment to the public charter school

School District Sponsor

K-8 students = at least 80%

9-12 students = at least 95%

State Board/Higher Ed Sponsor

K-8 students = at least 90%

9-12 students = at least 95%

The payment is a negotiated percentage of the *Charter Rate* (the district's general purpose grant divided by the district's current year ADMw)
