Floor guys Pulled up tile Floor was rotten UNDER. When Home FORWARD came toilet was in Bath tub, "My APT Failed,"

The work was done poorly & failed.

- 2 more City of Portland Inspections: Fail
- 3 Home Forward inspections: Fail

I could not find a place. Then after <sup>several</sup> some weeks a Senior Building called me & said they had an apt coming in "Dec 2014". Someone gave notice to move, I found housing.

I came close to becoming homeless
