If it were not for the work of Jason Lee. Oregon would be part of Great Britian. John McLoughlin was employed by the Hudson Bay Company and under the control of Great Britian. McLoughlin did not advocate that the Oregon Country become part of the US, It was Jason Lee who was our advocate for US protection and statehood.

The Nez Pierce people met with Gen. William Clark in St Louis in 1832 and requested "The book of heaven" be given to them. That set in motion a call for missionaries to bring God's 'book of heaven', their words for the bible, to their peoples. Jason Lee answered that call. It is fitting that bothJason Lee carring statehood petition and his bible, remain on display representing our true Oregon history in Washington DC. Jason Lee understood government. He knew the northwest would be settled by someone, therefore he sought Congress to establish it for the US.
