WHAT THE MEASURE DOES:

Ratifies fee changes approved by the Department of Administrative Services and adopted administratively by the Oregon Liquor Control Commission, the Board of Accountancy, the Department of Aviation, the Real Estate Agency, the Department of Consumer and Business Services, and the Board of Medical Imaging. The measure provides the enabling legislation necessary to approve fees adopted through Administrative Rule.

The Oregon Liquor Control Commission established nineteen fees associated with the regulation of marijuana. Fees were established for application and issuance of licenses for marijuana producers, processors, wholesalers, and retailers; and for regulated laboratories, researchers, and marijuana handlers. These fees are expected to generate \$5.9 million in 2015-17, and will likely be updated in 2017-19 after review of program experience. The Oregon Board of Accountancy made changes in fees for application for, renewal of, and permit to practice accountancy for individuals and firms.

The Department of Aviation changed tie-down fees at state-owned airports from a percentage basis to a flat rate of \$10 per tie-down. The agency also established fees for the use of Unmanned Aerial Systems by public bodies required by HB 2710 (2013). The new fees are \$25 per year for UAS weighing less than 55 pounds and \$50 per year for UAS weighing more than 55 pounds. The Real Estate Agency increased the statutory Land Development fee associated with review of condominium projects from \$46 to \$200 per hour. The Department of Consumer and Business Services established administrative service fees for all insurers participating in the Oregon Health Insurance Marketplace. Fees of \$9.66 per-member per-month for insurers offering qualified health plans and \$0.97 per-member per-month, for insurers offering stand-alone dental plans for the 2015 and 2016 plan years mirror those set by Cover Oregon prior to the program's transfer to DCBS.

ORS 291.055(1)(e) mandates that all new state agency fees or fee increases adopted between regular sessions of the Legislative Assembly are rescinded upon adjournment of the next regular session unless authorized by enabling legislation setting forth the approved fees.
