

## HOUSE AMENDMENTS TO HOUSE BILL 4016

- 1       On page 1 of the printed bill, line 2, after the semicolon delete the rest of the line and insert  
2 “creating new provisions; amending ORS 676.190”.
- 3       In line 3, delete “678.112 and 687.081”.
- 4       Delete lines 5 through 29.
- 5       On page 2, delete lines 1 through 3.
- 6       In line 4, delete “2” and insert “1”.
- 7       In line 5, delete “(a)” and after “The” delete the rest of the line and insert “health profession  
8 licensing boards”.
- 9       In line 6, delete the boldfaced material and delete “shall” and insert “may”.
- 10       Delete lines 8 through 10.
- 11       On page 3, delete lines 35 through 43.
- 12       In line 44, delete “(b)” and insert “(8)” and delete “listed in subsection (1)(b) of this section”.
- 13       On page 4, line 2, delete “listed in”.
- 14       In line 3, delete “subsection (1)(b) of this section”.
- 15       In line 6, delete the boldfaced material and restore the bracketed material and delete  
16 “authority” and insert “health profession licensing boards, in consultation with one another,”.
- 17       Delete lines 7 through 45 and delete pages 5 through 9.
- 18       On page 10, delete lines 1 through 25.
- 19       After line 25, insert:
- 20       **“SECTION 2. Section 3 of this 2016 Act is added to and made a part of ORS 676.185 to**  
21 **676.200.**
- 22       **“SECTION 3. (1) The Impaired Health Professional Program Work Group is established.**  
23       **“(2) The work group consists of the designees of any health profession licensing boards**  
24 **that elect to establish or contract for an impaired health professional program as described**  
25 **in ORS 676.190.**
- 26       **“(3) The work group shall facilitate the establishment and continuation of the impaired**  
27 **health professional program described in ORS 676.190.**
- 28       **“(4) A majority of the members of the work group constitutes a quorum for the trans-**  
29 **action of business.**
- 30       **“(5) Official action by the work group requires the approval of a majority of the members**  
31 **of the work group.**
- 32       **“(6) The work group shall elect one of its members to serve as chairperson.**
- 33       **“(7) The work group shall meet at times and places specified by the call of the chair-**  
34 **person or of a majority of the members of the work group.**
- 35       **“(8) The work group may adopt rules necessary for the operation of the work group.**

1       “(9) The Oregon Medical Board shall provide staff support to the work group.

2       “(10) Members of the work group are not entitled to compensation, but may be reim-  
3       bursed for actual and necessary travel and other expenses incurred by them in the per-  
4       formance of their official duties in the manner and amounts provided for in ORS 292.495.  
5       Claims for expenses shall be paid out of funds appropriated to the health professional li-  
6       censing board that the member represents for purposes of the work group.

7       “(11) All agencies of state government, as defined in ORS 174.111, are directed to assist  
8       the work group in the performance of duties of the work group and, to the extent permitted  
9       by laws relating to confidentiality, to furnish information and advice the members of the  
10      work group consider necessary to perform their duties.

11      “SECTION 4. The amendments to ORS 676.190 by section 1 of this 2016 Act become op-  
12      erative on July 1, 2017.”.

13      In line 26, delete “7” and insert “5”.
