SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates and modernizes certain laws pertaining to intestacy, wills and estate administration.
Declares emergency, effective on passage.

2 Relating to estates; creating new provisions; amending ORS 111.005, 111.015, 111.095, 111.115,
3 111.175, 111.185, 111.275, 112.025, 112.035, 112.045, 112.058, 112.065, 112.135, 112.145, 112.155,
4 112.175, 112.238, 113.005, 113.242, 114.305, 115.125 and 179.610; repealing ORS 112.390; and de-
5 claring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 111.005 is amended to read:

8 111.005. As used in ORS chapters 111, 112, 113, 114, 115, 116 and 117, unless the context requires
9 otherwise:

10 (1) "Abate" means to reduce a devise on account of the insufficiency of the estate to pay all
11 claims, expenses and devises in full.

12 (2) "Action" includes suits and legal proceedings.

13 (3) "Administration" means any proceeding relating to the estate of a decedent, whether the
14 decedent died testate, intestate or partially intestate.

15 (4) "Advancement" means a gift by a decedent to an heir [*to enable the donee to anticipate the*
16 *inheritance to the extent of the gift*] **or devisee with the intent that the gift satisfy in whole or**
17 **in part the heir's share of an intestate estate or the devisee's share of a testate estate.**

18 [(5) "*All purposes of intestate succession*" means succession by, through or from a person, both
19 *lineal and collateral.*]

20 [(6)] **(5)** "Assets" includes real, personal and intangible property.

21 [(7)] **(6)** "Claim" includes liabilities of a decedent, whether arising in contract, in tort or other-
22 wise.

23 [(8)] **(7)** "Court" or "probate court" means the court in which jurisdiction of probate matters,
24 causes and proceedings is vested as provided in ORS 111.075.

25 [(9)] **(8)** "Decedent" means a person who has died [*leaving property that is subject to adminis-*
26 *tration*].

27 **(9)(a) "Descendant" means a person who is descended from a specific ancestor.**

28 **(b) When used to refer to persons who take by intestate succession, "descendant" does**

1 **not include a person who is the descendant of a living descendant.**

2 (10) "Devise," when used as a noun, means property disposed of by a will[, *and includes*
3 *"legacy" and "bequest."*].

4 (11) "Devise," when used as a verb, means to dispose of property by a will[, *and includes*
5 *"bequeath."*].

6 (12) "Devisee" [*includes "legatee" and "beneficiary."*] **means a person designated in a will to**
7 **receive a devise.**

8 (13) "Distributee" means a person entitled to any property of a decedent under the will of the
9 decedent or under intestate succession.

10 (14) "Domicile" means the place of abode of a person, where the person intends to remain and
11 to which, if absent, the person intends to return.

12 (15) "Estate" means the real and personal property of a decedent, as from time to time changed
13 in form by sale, reinvestment, **substitutions** or otherwise, [*and*] augmented by any accretions or
14 additions [*thereto and substitutions therefor*] or diminished by any decreases [*and*] **or** distributions
15 [*therefrom*].

16 (16) "Funeral" includes **the** burial or other disposition of the remains of a decedent, [*including*
17 *the*] **any** plot or tomb and other necessary incidents to the disposition of the remains, **any memorial**
18 **ceremony or other observance and related expenses.**

19 (17) "General devise" means a devise chargeable generally on the estate of a testator [*and*] **so**
20 **that the devise is** not distinguishable from other parts [*thereof or not so given as to amount to*] **of**
21 **the estate and does not constitute** a specific devise.

22 [(18) "*Generation*" means a group of human beings, living or deceased, that constitute a single step
23 in the line of descent from an ancestor.]

24 [(19)] (18) "Heir" means any person[, *including the surviving spouse,*] who is **or would be** entitled
25 under intestate succession to [*the property of a decedent who died wholly or partially intestate*]
26 **property of a person upon that person's death.**

27 [(20)] (19) "Interested person" includes heirs, devisees, children, spouses, creditors and any oth-
28 ers having a property right or claim against the estate of a decedent that may be affected by the
29 proceeding. [*It*] "**Interested person**" also includes fiduciaries representing interested persons.

30 [(21)] (20) "Intestate" means one who dies without leaving a valid will, or the circumstance of
31 dying without leaving a valid will, effectively disposing of all the estate.

32 [(22)] (21) "Intestate succession" means succession to property of a decedent who dies intestate
33 or partially intestate.

34 [(23)] (22) "Issue" [*includes adopted children and their issue and, when used to refer to persons*
35 *who take by intestate succession, includes all lineal descendants, except those who are the lineal de-*
36 *scendants of living lineal descendants*] **means a descendant or descendants.**

37 [(24)] (23) "Net estate" means the real and personal property of a decedent, except property used
38 for the support of the surviving spouse and children and for the payment of expenses of adminis-
39 tration, funeral expenses, claims and taxes.

40 [(25)] (24) "Net intestate estate" means any part of the net estate of a decedent not effectively
41 disposed of by the will.

42 [(26)] (25) "Personal property" includes all property other than real property.

43 [(27)] (26) "Personal representative" includes executor, administrator, administrator with will
44 annexed and administrator de bonis non, but does not include special administrator.

45 [(28)] (27) "Property" includes both real and personal property.

1 [(29)] **(28)** “Real property” includes all legal and equitable interests in land, in fee and for life.

2 [(30)] **(29)** “Settlement” includes, as to the estate of a decedent, the full process of adminis-
3 tration, distribution and closing.

4 [(31)] **(30)** “Specific devise” means a devise of a specific thing or specified part of the estate of
5 a testator that is so described as to be capable of identification. *[It]* **A specific devise** is a gift of
6 a part of the estate identified and differentiated from all other parts.

7 [(32)] **(31)** “Will” includes codicil[; *it*] **and** also includes a testamentary instrument that merely
8 appoints an executor or that merely revokes or revives another will.

9 **SECTION 2.** ORS 112.025 is amended to read:

10 112.025. If the decedent leaves a surviving spouse and *[issue]* **one or more descendants**, the
11 intestate share of the surviving spouse is:

12 (1) If there are *[surviving issue]* **one or more surviving descendants** of the decedent all of
13 whom are *[issue]* **descendants** of the surviving spouse also, the entire net intestate estate.

14 (2) If there are *[surviving issue]* **one or more surviving descendants** of the decedent one or
15 more of whom are not *[issue]* **descendants** of the surviving spouse, one-half of the net intestate es-
16 tate.

17 **SECTION 3.** ORS 112.035 is amended to read:

18 112.035. If the decedent leaves a surviving spouse and no *[issue, the surviving spouse shall have*
19 *all of the net intestate estate]* **descendant, the intestate share of the surviving spouse is the**
20 **entire net intestate estate.**

21 **SECTION 4.** ORS 112.045 is amended to read:

22 112.045. The part of the net intestate estate not passing to the surviving spouse shall pass:

23 (1) To the *[issue]* **descendants** of the decedent **by representation as described in ORS**
24 **112.065.** *[Issue of different generations in relation to the decedent take by representation as defined in*
25 *ORS 112.065.]*

26 (2) If there is no surviving *[issue or spouse]* **descendant**, to the surviving parents of the
27 decedent.

28 (3) If there is no surviving *[issue, spouse]* **descendant** or parent, **equally** to the brothers and
29 sisters of the decedent and *[the issue]* **by representation as described in ORS 112.065 to the de-**
30 **scendants** of any deceased brother or sister of the decedent *[by representation as defined in ORS*
31 *112.065]*. If there is no surviving brother or sister, the *[issue]* **descendants** of brothers and sisters
32 take equally if they are all of the same generation in relation to the decedent, but if of different
33 generations, then those of later generations take by representation as *[defined]* **described** in ORS
34 112.065.

35 (4)(a) If there is no surviving *[issue, spouse, parent or issue]* **descendant, parent or descendant**
36 of a parent, equally to the grandparents of the decedent and *[the issue]* **by representation as de-**
37 **scribed in ORS 112.065 to the descendants** of any deceased grandparent of the decedent *[by rep-*
38 *resentation as defined in ORS 112.065]* **who left descendants surviving at the time of the**
39 **decedent’s death.** If one or more grandparents of the decedent do not survive the decedent, the
40 *[issue of the]* **descendants of each of the deceased** grandparents take equally if they are all of the
41 same generation in relation to the decedent, but if of different generations, then those of later gen-
42 erations take by representation as *[defined]* **described** in ORS 112.065.

43 (b) If there is no surviving grandparent, the *[issue]* **descendants** of grandparents take equally
44 if they are all of the same generation in relation to the decedent, but if of different generations, then
45 those of later generations take by representation as *[defined]* **described** in ORS 112.065.

1 (5) If, at the time of taking, surviving parents or grandparents of the decedent are married to
2 each other, they shall take real property as tenants by the entirety and personal property as joint
3 owners with the right of survivorship.

4 **SECTION 5.** ORS 112.058 is amended to read:

5 112.058. (1) In any proceeding to determine the escheat share of the estate of a decedent whose
6 estate is wholly or partially subject to probate in this state:

7 (a) No preference shall be given to any person over escheat; and

8 (b) After diligent search and inquiry appropriate to the circumstances, the following
9 presumptions apply in a proceeding to determine whether a missing person has died:

10 (A) A missing person whose death cannot be proved by other means lives to 100 years of age.

11 (B) A missing person who was exposed to a specific peril at the time the person became missing
12 has died if it is reasonable to expect from the nature of the peril that proof of death would be im-
13 practical.

14 (C) A missing person whose absence is unexplained has died if the character and habits of the
15 person are inconsistent with a voluntary absence for the time that the person has been missing.

16 (D) A missing person known to have been alive who has not been seen or heard from for seven
17 years has died if the person has been absent from the person's usual residence, the absence is un-
18 explained, there are other persons who would have been likely to have heard from the missing per-
19 son during that period were the missing person alive, and those other persons have not heard from
20 the missing person.

21 (2) In any proceeding described by subsection (1) of this section, a missing person who is pre-
22 sumed to be dead is also presumed to have had two children in addition to any known [*issue*] **de-**
23 **scendants** of the person unless the presumption of death arises by reason of the application of
24 subsection (1)(b)(B) or (C) of this section.

25 **SECTION 6.** ORS 112.065 is amended to read:

26 112.065. "Representation" means the method of determining the passing of the net intestate es-
27 tate when the distributees are of different generations in relation to the decedent. Representation
28 is accomplished as follows: [*The estate shall be divided into as many shares as there are surviving*
29 *heirs of the generation closest in relation to the decedent and deceased persons of the same generation*
30 *who left issue who survive the decedent, each surviving heir of the nearest generation in relation to the*
31 *decedent receiving one share and the share of each deceased person of the same generation being di-*
32 *vided among the issue of the deceased person in the same manner.]*

33 **(1) If a distributive share of a wholly or partially intestate estate passes by represen-**
34 **tation to a person's descendants, the share is divided into as many equal shares as there are:**

35 **(a) Surviving descendants in the generation nearest to the person that contains one or**
36 **more surviving descendants; and**

37 **(b) Deceased descendants, in the generation nearest to the person that contains one or**
38 **more surviving descendants, who left surviving descendants, if any.**

39 **(2) Each share created for a surviving descendant in the nearest generation is distributed**
40 **to that descendant. Each share created for a deceased descendant is distributed to the de-**
41 **scendants of the deceased descendant by representation as described in this section.**

42 **SECTION 7.** ORS 112.390 is repealed.

43 **SECTION 8.** ORS 112.135 is amended to read:

44 112.135. (1)(a) If a person dies intestate as to all **or part of** the estate of the person, property
45 [*which*] **that** the person [*gave in*] **gives during** the lifetime of the person to an heir [*shall be*] **is**

1 treated as an advancement against the heir's share of the estate if declared in writing by the
2 decedent or acknowledged in writing by the heir to be an advancement.

3 **(b) [For that purpose] For purposes of applying the gift against the heir's share of the**
4 **intestate estate**, the property advanced [shall] **must** be valued as of the time the heir came into
5 possession or enjoyment of the property or as of the time of death of the decedent, whichever occurs
6 first, **unless otherwise directed in the decedent's writing.**

7 **(2)(a) Except as provided in ORS 112.385, property that a testator gives during the**
8 **testator's lifetime to a devisee is treated as an advancement of the devisee's share in whole**
9 **or in part if:**

10 **(A) The will provides for deduction of the gift;**

11 **(B) The testator declared in writing that the gift is in satisfaction of the devise or that**
12 **its value is to be deducted from the value of the devise; or**

13 **(C) The devisee acknowledges in writing, before or after the testator's death, that the**
14 **gift was made in satisfaction of the devise or that its value was to be deducted from the**
15 **value of the devise.**

16 **(b) For purposes of applying the gift against the devisee's share of the testate estate, the**
17 **property advanced must be valued as of the time the devisee came into possession or enjoy-**
18 **ment of the property or as of the time of the testator's death, whichever occurs first, unless**
19 **otherwise directed in the testator's will or a writing described in paragraph (a)(B) of this**
20 **subsection.**

21 **(3)(a) Property not subject to probate administration, the transfer of which is intended**
22 **by the decedent to take effect on death, is treated as an advancement against the heir's**
23 **share of the estate or the devisee's devise under the will if declared in writing by the**
24 **decedent, or acknowledged in writing by the heir or devisee, to be an advancement. Examples**
25 **of transfers under this subsection include but are not limited to beneficiary designation,**
26 **right of survivorship and transfer on death deed or transfer on death designation.**

27 **(b) The property transferred under this subsection must be valued as of the time of the**
28 **decedent's death, unless otherwise directed in the testator's will or in a writing by the**
29 **decedent.**

30 **SECTION 9.** ORS 112.145 is amended to read:

31 112.145. (1) If the value of [the] **an** advancement exceeds the heir's **or devisee's** share of the
32 estate, the heir **or devisee** shall be excluded from any further share of the estate, but the heir **or**
33 **devisee** shall not be required to refund any part of the advancement. If the value of [the] **an** ad-
34 vancement is less than the heir's **or devisee's** share, the heir **or devisee** shall be entitled upon
35 distribution of the estate to such additional amount as will give the heir **or devisee** the heir's **or**
36 **devisee's** share of the estate.

37 (2) The property advanced is not a part of the estate, but for the purpose of determining the
38 shares of the heirs **or devisees** the advancement shall be added to the **value of the** estate, the sum
39 then divided among the heirs **or devisees according to the laws of intestate succession or the**
40 **testator's will** and the advancement then deducted from the share of the heir **or devisee** to whom
41 the advancement was made.

42 **SECTION 10.** ORS 112.155 is amended to read:

43 112.155. If the recipient of the property advanced fails to survive the decedent, the amount of
44 the advancement shall be taken into account in computing the share of the [issue] **descendants** of
45 the recipient, whether or not the [issue] **descendants** take by representation.

1 **SECTION 11.** ORS 112.175 is amended to read:

2 112.175. (1) An adopted person, the *[issue]* **descendants** and kindred of the adopted person shall
3 take by intestate succession from the adoptive parents, their *[issue]* **descendants** and kindred, and
4 the adoptive parents, their *[issue]* **descendants** and kindred shall take by intestate succession from
5 the adopted person, the *[issue]* **descendants** and kindred of the adopted person, as though the
6 adopted person were the biological child of the adoptive parents.

7 (2) An adopted person shall cease to be treated as the child of any person other than the
8 adopted person's adoptive parents for all purposes of intestate succession except in the following
9 circumstances:

10 (a) If a person is adopted by a stepparent or a domestic partner of a parent in a domestic
11 partnership registered under ORS 106.300 to 106.340 or under a similar law in another state, the
12 adopted person shall continue also to be treated, for all purposes of intestate succession, as the child
13 of the parent who is the spouse of, or other domestic partner in the domestic partnership with, the
14 adoptive parent.

15 (b) If a parent of a person dies, and the other parent of the person marries or enters into a do-
16 mestic partnership registered under ORS 106.300 to 106.340 or under a similar law in another state,
17 and the person is adopted by a stepparent or the other domestic partner, the adopted person shall
18 continue also to be treated, for all purposes of intestate succession, as the child of the deceased
19 parent.

20 (3) ORS chapters 111, 112, 113, 114, 115, 116 and 117 apply to adopted persons who were adopted
21 in this state or elsewhere.

22 **SECTION 12.** ORS 111.015 is amended to read:

23 111.015. Except as specifically provided otherwise in chapter 591, Oregon Laws 1969, on July
24 1, 1970[:],

25 *[(1)]* chapter 591, Oregon Laws 1969, applies to wills of decedents dying *[thereon or]* thereafter,
26 and a will executed before July 1, 1970, shall be considered lawfully executed if the application of
27 ORS 112.255 would make it so, but the construction of a will executed before July 1, 1970, shall be
28 governed by the law in effect on the date of execution unless a contrary intent is established by the
29 will.

30 *[(2)]* *The procedure prescribed by chapter 591, Oregon Laws 1969, applies to any proceedings com-*
31 *menced thereon or thereafter regardless of the time of the death of a decedent, and also as to any fur-*
32 *ther procedure in proceedings then pending except to the extent that in the opinion of the court the*
33 *former procedure should be made applicable in a particular case in the interest of justice or because*
34 *of infeasibility of application of the procedure prescribed by chapter 591, Oregon Laws 1969.]*

35 *[(3)]* *A personal representative, guardian or conservator holding an appointment on that date shall*
36 *continue to hold the appointment, but shall have only the powers conferred and be subject to the duties*
37 *imposed by chapter 591, Oregon Laws 1969, with respect to any act occurring or done thereon or*
38 *thereafter, other than acts pursuant to powers or duties validly conferred or imposed by a will executed*
39 *before July 1, 1970.]*

40 *[(4)]* *An act done before July 1, 1970, in any proceeding and any accrued right shall not be impaired*
41 *by chapter 591, Oregon Laws 1969. When a right is acquired, extinguished or barred upon the expi-*
42 *ration of a prescribed period of time which has commenced to run by the provisions of any statute be-*
43 *fore July 1, 1970, those provisions shall remain in force with respect to that right.]*

44 **SECTION 13.** ORS 111.095 is amended to read:

45 111.095. (1) The general legal and equitable powers of a circuit court *[are applicable to effectuate*

1 *the jurisdiction of* **apply to** a probate court[, *punish contempts and carry out its determinations, or-*
 2 *ders and judgments as a court of record with general jurisdiction, and*]

3 (2) The same validity, finality and presumption of regularity shall be accorded to *[its]* **the** de-
 4 terminations, orders and judgments **of a probate court**[, *including determinations of its own juris-*
 5 *isdiction,*] as to those of a *[court of record with general jurisdiction]* **circuit court**.

6 [(2)] (3) A probate court has full, legal and equitable powers to make declaratory judgments, as
 7 provided in ORS 28.010 to 28.160, in all matters involved in the administration of an estate, including
 8 *[those]* **matters** pertaining to the title of real property **and ownership of personal property**, the
 9 determination of heirship and the distribution of the estate.

10 **SECTION 14.** ORS 111.115 is amended to read:

11 111.115. (1) An estate proceeding[, *including all probate matters, causes and proceedings pertain-*
 12 *ing thereto,*] may be transferred at any time from a county court *[sitting in probate]* to the circuit
 13 court for the county by order of the county court.

14 (2) An estate proceeding[, *including all probate matters, causes and proceedings pertaining*
 15 *thereto,*] commenced in a county court *[sitting in probate]* and in which the county judge is a party
 16 or directly interested *[shall]* **must** be transferred from the county court to the circuit court for the
 17 county by order of the county court.

18 (3) Upon transfer of an estate proceeding from a county court to the circuit court **for the**
 19 **county** under this section[,]:

20 (a) The county clerk shall certify and cause to be filed in the records of the circuit court all
 21 original papers and proceedings pertaining to the estate proceeding[, *and thereafter jurisdiction of*
 22 *all probate matters, causes and proceedings pertaining to the estate proceeding is vested in the circuit*
 23 *court as if that jurisdiction had been originally and exclusively vested in the circuit court*]; **and**

24 (b) **Jurisdiction over the estate proceeding vests in the circuit court as if the jurisdiction**
 25 **had been originally and exclusively vested in the circuit court.**

26 **SECTION 15.** ORS 111.175 is amended to read:

27 111.175. *[The court may appoint the clerk of the probate court or some other suitable person at the*
 28 *county seat to act as probate commissioner within the county. If the clerk of the probate court is ap-*
 29 *pointed probate commissioner, the deputy of the clerk has the power to perform any act as probate*
 30 *commissioner that the clerk has, and the clerk is responsible for conduct of the deputy so acting.]* **The**
 31 **presiding judge of a circuit court or the county judge of a county court may appoint a pro-**
 32 **bate commissioner and one or more deputy probate commissioners and, if such appointments**
 33 **are made, shall prescribe, by rule or order, the duties and responsibilities of the probate**
 34 **commissioner and deputy probate commissioners, subject to ORS 111.185.**

35 **SECTION 16.** ORS 111.185 is amended to read:

36 111.185. (1) **To the extent prescribed or otherwise authorized by rule or order made under**
 37 **ORS 111.175**, a probate commissioner **or deputy probate commissioner** may:

38 (a) Act upon uncontested petitions for appointment of special administrators, for probate of wills
 39 and for appointment of personal representatives, guardians and conservators[, *to the extent author-*
 40 *ized by rule of the court. Pursuant thereto the probate commissioner may*];

41 (b) Make and enter orders **and judgments** *[on behalf of the court]* admitting wills to probate and
 42 appointing and setting the amount of the bonds of special administrators, personal representatives,
 43 guardians and conservators[, *subject to the orders of the probate commissioner being set aside or*
 44 *modified by the judge of the court within 30 days after the date an order is entered*]; **and**

45 (c) **Appoint court visitors.**

1 (2) Any matter presented to the probate commissioner **or deputy probate commissioner** may
2 be referred [*by the probate commissioner*] to the judge **of the court**.

3 (3) **Any order or judgment made by a probate commissioner or deputy probate commis-**
4 **sioner is subject to being set aside or modified by the judge of the court within 30 days after**
5 **the date of the order or judgment.**

6 (4) **Any interested person may object to an order or judgment of a probate commissioner**
7 **or deputy probate commissioner within 30 days after the date of the order or judgment, and**
8 **the judge of the court may set aside or modify the order or judgment.**

9 [(3)] (5) Unless set aside or modified by the judge **of the court**, the orders **and judgments** of
10 the probate commissioner **or deputy probate commissioner** have the same effect as if made by the
11 judge **of the court**.

12 **SECTION 17.** ORS 112.238 is amended to read:

13 112.238. (1) Although a writing was not executed in compliance with ORS 112.235, the writing
14 may be treated as if it had been executed in compliance with ORS 112.235 if the proponent of the
15 writing establishes by clear and convincing evidence that the decedent intended the writing to
16 constitute:

- 17 (a) The decedent's will;
- 18 (b) A partial or complete revocation of the decedent's will; or
- 19 (c) An addition to or an alteration of the decedent's will.

20 [(2) *The proponent of the writing must file a petition with the court to establish the decedent's in-*
21 *tention with respect to the writing. The proponent shall provide notice of the petition to heirs, devisees*
22 *under prior wills and persons interested in the estate of the decedent that would be required to be*
23 *identified and set forth in a petition for the appointment of a personal representative under ORS*
24 *113.035. Persons receiving notice and other interested persons shall have 20 days after service of the*
25 *notice under this subsection to file written objections to the petition. The court may make a determi-*
26 *nation regarding the decedent's intent after a hearing or on the basis of affidavits.]*

27 (2) **A writing described in subsection (1) of this section may be filed with the court for**
28 **administration as the decedent's will pursuant to ORS 113.035. The proponent of the writing**
29 **shall give notice of the filing of the petition to those persons identified in ORS 113.035 (5), (7),**
30 **(8) and (9). Persons receiving notice under this subsection shall have 20 days after the notice**
31 **was given to file written objections to the petition. The court may make a determination**
32 **regarding the decedent's intent after a hearing or on the basis of affidavits.**

33 [(3) *If the court determines that clear and convincing evidence exists showing that the writing was*
34 *intended by the decedent to accomplish one of the purposes set forth in subsection (1) of this section,*

23 performing enforceable contracts by the decedent to convey or lease real property, the personal
24 representative, among other courses of action, may:

25 (a) Execute and deliver a deed upon satisfaction of any sum remaining unpaid or upon receipt
26 of the note of the purchaser adequately secured; or

27 (b) Deliver a deed in escrow with directions that the proceeds, when paid in accordance with
28 the escrow agreement, be paid to the successors of the decedent, as designated in the escrow
29 agreement.
